## **Ambulance Service Availability Depends On Membership**

The continued availability of emergency ambulance service for Cisco, Eastland and surrounding communities depends on the immediate expansion of its membership lists, officials have announced.

A concentrated effort is underway to expand the number of participating members so that the emergency service can remain in operation.

Mr. and Mrs. Tommy Patterson, owner-operators, had previously announced that they would have to terminate the service at the end of July because of lack of support, have, after being assured by officials in Eastland and Cisco of the need for such service, agreed to extend for three months, their efforts in order to maintain the service.

"The encouragement we have received," Mr. Patterson said, "indicates that the public does want our service to continue, and with sufficient participation, we'll attempt to continue.

The \$36.00 membership, in effect, helps provide the availability of the service, but does not, in fact, underwrite the total cost of providing the service, in view of the equipment, trained personnel and mandatory requirements necessary to
