# **December 7, 1941 Memories**

nual event

December the 7th, 1941, seems so far in the past - it was only yesterday to a lot of people. A lot of historic WWII battle sites have badly deteriorated, wide spread scrap metal salvaging of gun emplacements have occured and many sites are in serious disrepair.

Congress passed a bill that directs the American Battle Monuments Commission to restore, operate and maintain the Pacific War Memorial and other memorial sites on Corregidor in the Philippines we are grateful for that.

All said such services were badly needed. But there were questions about the ability of people to pay for them, and

The problem of patients who do not pay bills and the high percentage of Eastland County people who go elsewhere for medical care was addressed. The recruitment of young Doctors, and regulations preventing visiting specialists and the use of centralized equipment also received a lot of attention.

"I'd like to compliment you on what you're doing," Alfred Gilchrist said. On cooperation between the three Hospitals, he urged the group: "Document what you are trying to do - Document the road blocks. Then seek Legislative help.'

Dr. Gilmer was also complimentary of the meeting, and took extensive notes as issues were outlined.

Roy Cartee brought three main points from a letter from Congressman Stenholm. One was the recommendation of an application for Rural Hospital Grant money. The Congressman also recommended a cooperative effort between the three county Hospitals, and he said a strong commitment to local health care would be needed from a number of people in the county.








group that Eastland Memorial was the only place in the County where babies are now being delivered. The high cost of malpractice insurance (around 900 per baby if one is delivered at the Ranger Hospital) has discouraged doctors from this type of practice.

She said that some way needs to be found to make the work of a Doctor more equitable in small communities, and also to make the medicare payments more equitable. Regulations that are not a quality issue should be more flexible, she said. She told of regulations which made the cooperation of the three county hospitals more difficult.

Marvin Cole, Cisco Hospital Administrator, told of skyrocketing insurance premiums - and how 90-95% of the patients in the Cisco Hospital are under Medicare. Most people are underinsured or have no other insurance, Barker said that he felt the

rural hospital areas were felling the brunt of cuts in medi-

cal services. The problem was that the Government was running out of money, and had to reduce benefits or increase taxes. Since 65% of the elderly do not live in urban areas, a way to save money is to do away with access to medical services, he indicated.

Sunday near Olden after a couple was reported leaving a Cisco service station without paying for gas.








A holiday safety list you should check twice includes: Artificial trees

· Buy only those with a safety approved label. · Never use electrical decorations in a metallic tree. Keep a safe distance away from any flames.

Candles Never use candles on a tree or near other decorations.

Keep candles away from Christmas wrappings.

· Place candles where they won't be easily knocked over. · Use glass, metal, or other non-flammable candle holders.

Natural trees

· Select only a fresh tree that is deep green in color, has a strong scent of pine, the needles do not fall readily, and has a sticky tree butt.

· Do not rely on chemical sprays to make your tree flame resistant.

· Keep your tree in a water-holding stand and keep it full of water.

· Place the tree away from heat sources and out of the traffic pattern of the room.

Trimmings

· Use non-flammable trimmings; never use paper, fabric, cotton or anything that can burn.

· Avoid decorations that may break easily or have sharp edges.

· Never use ornaments that could be mistaken for food. Keep pets and small children away from small trimming and breakable ornaments.

Lights

Use only testing laboratory approved lights.

· Discard any lights that have frayed or worn cords, broken or cracked sockets, loose connections, or bare wires.

Never use indoor lights outdoors.

 Never use more than 3 sets of lights per single extension. · Keep young children away from all electrical decorations and lights.

Never place presents too near the lights of your tree. · Always turn off all tree lights and electrical decorations

when you leave your house or go to bed at night. Other tips ...

Never allow smoking near trees or decorations. Safely dispose of Christmas wrappings immediately after opening gifts.

Never burn Christmas wrappings in the fireplace.

· Be extra careful when wearing long loose flowing clothing near open flames of a fireplace, candle, or stove.


"The Endangered Species Act is a priority issues now and will be for some time to come," he said. "We must have some balance between the environment and the economy. We need amendments providing for economic impact statements before damaging regulations are implemented."

# **Don Shepard Talks To Lions Club About Prisons**

There will be six new prison systems built in the state of Texas, and Eastland County has filed for one of those prisons, according to Cisco Chamber of Commerce manager Don Shepard. Shepard talked to the Cisco Lions Club at their regular meeting held last Wednesday at Tradition's Restaurant

A group of Eastland County citizens travelied to Palestine and then to Huntsville to see if this area would qualify for one of the sites.

The type of prison Eastland County was advised to apply for is where families of inmates would not have to travel more than 2-3 hours to visit. A plus for Eastland County will be the Interstate that goes through here.

Shepard said the support of the entire community is needed for a city to even be thought of for a prison site. Pros for Eastland County receiving the prison is that the prison is a permanent job source. This will not a job that will leave in a few years. The prison will also provide 750 jobs. He said other counties will benefit from this.

Shepard said the prison will bring a \$1,600,000 plus payroll for this area and \$21,000,000 worth of income for Eastland County. He said this will rejuvinate the downtown areas here, keep the youth and bring in more business. He added that this would be a sure way to keep

The Wranglers placed five players on the First Team All-Conference list, four on the honorable mention team, and three on the All-

Tim Duncan, a 6-2, 255 pound sophomore center from Burnet; Cam Pepper, a 6-5, 285 sophomore tackle from Katy; Gabe Smith, a 5-7, 160 sophomore wide receiver from Bellville; Stacey Hunter, a 6-5, 280 sophomore tight end from Jacksonville; and Tim Bryant, a 6-4, 240 sophomore defensive end

Wide receiver Gabe Smith was the conference's leading receiver with 32 catches for 735 yards and one touchdown. Tight end Stacey Hunter was the conference's third leading receiver with 24 catches for 234 yards and three touchdowns. The lone first team all-conference defensive player for Cisco was Tim Bryant. Bryant led the Wranglers in total

tackles with 55. He also had two safeties for the Wranglers. Although Tim Duncan and

Cam Pepper don't have any offensive statistics their great blocking allowed the team to finish first in total offense with 3,676 total yards.

The Wranglers also placed four defensive players on the Honorable Mention Team. They were Chris Cooper, a 6-2, 265 sophomore defensive tackle from Houston; Derrick Gibson, a 6-3, 225 sophomore linebacker from Forney; Perry Kyles, a 5-9, 170 sophomore defensive back from Houston; and Roderick Tatum, a 6-2, 205 sophomore defensive back from Jacksonville.

Defensive back Roderick Tatum set a school record with most tackles in one season. He had a total of 111 solos and 27 assists. Defensive back, Perry Kyles, was second in the conference with a total of five interceptions. Defensive tackle Chris Cooper finished the season with a total of 76 tackles which placed him second on the team behind Tatum. Linebacker Derrick Gibson was the third leading tackler

# **Wranglers** Beat


# **Angelo JV**
