New Mayor Thanks Voters, Issues **Statement On Role**

Newly-elected Mayor Eris Ritchie has requested that the Cisco Press publish the following statement on his behalf:

"On Saturday, May 30, the voters of Cisco elected me mayor, and at the same time chose four fine gentlemen to serve along with two other councilmen and me as your city government officials. We took office Monday night. I wish to thank each of you who showed your confidence in us at the polls, and I also would like to express my appreciation to all of you who have indicated to us that you would lend your help and encouragement.

"Our city government situation is somewhat unusual now, with six brand new councilmen and a new mayor. Most of us are completely inexperienced in matters of city government, but we are all pledged to give our best efforts in service to those who elected us. As one councilman expressed Monday night, we ask that you be patient with us as we do our homework and attempt to become better informed city

leaders "I believe that I speak for all of the councilmen when I state that we believe in our city charter and in our Council-Manager form of government. A great deal seems to have been made of the question of who "runs" the city. Although perhaps some semantics are involved in the usage of the word "runs," I wish to be completely understood in my personal view of the matter. I believe exactly what the charter stipulates in this regard, and I feel that our councilmen support the charter position as well. My views were perhaps overly simplified in the Wednesday Abilene-Reporter News, and for that reason I felt that this statement was in order.

"Following some exact

"Section 41: The City Manager shall be the Chief Administrative and Executive Officer of the City. He shall be chosen and appointed by the Council solely

on the basis of his executive and administrative training, experience, and ability, and need not, when appointed, be a resident of the City of Cisco; however, during the tenure of his office, he shall reside within the City. The City Manager shall not be appointed for a definite term, but may be removed at the will and pleasure of the Council with or without cause.'

"The charter then goes on to further define the City Manager's various powers and duties as Chief Administrative and Executive Officer of the City. I would encourage our citizens who have not read the charter to do so, as it is a very workable and practical document which provides the guidelines for the functioning of our city government.

"I feel that we as a mayor and council can function effectively by setting policy and providing policy guidelines, and then directing and making use of the City Manager and various city staff and departments to carry out the goals and objectives of these policies. Whatever we do, we should do our best to responsive to the will of the citizens who elected us, and we should always keep the good of the public uppermost in our minds, deliberations, and subsequent actions. We obviously should also watch carefully that the taxpayer's money is used for the best overall benefit of the city and its citizens

"We hope that controversy can be kept to a minimum and that the only publicity you'll be seeing for Cisco will be positive. Your prayers,

Both Dash Crofts and Jim Seals are former students at CJC and have been in music together since starting here. Seals now lives in Costa Rico where he has a coffee plantation. Dash divides his times between his home near Los Angeles, a ranch in Oregon and a home in Mexico. He manages brief trips to Cisco to visit his parents every few months.-JWS







Some good grain crops are being harvested in Eastland County. A lot of this grain will be stored in bins on the farm. Stored-grain insects will cause considerable damage if insect prevention and treatment measures are not taken. Proper attention to reducing or eliminating factors prior to and at storage time helps greatly in preventing later insect infestations

When storing grain in farm bins, make sure the moisture content is 12% or less. Grain containing more moisture attracts insects, promotes mold growth and may induce heating.

Prior to storage, clean and treat bins thoroughly with an approved residual spray. Remove old grain, trash, feed sacks and other debris that furnish living quarters for insects. Sometimes it is necessary to sweep down the




County 4-H Camp June 12 & 13



Society's View Of **The Handicapped**

Handicapped Americans are the targets of social oppression that is possibly more damaging to their lives than their physical disabilities, a family life education specialist says.

"Unfortunately, a typical view of the handicapped person is 'someone who is ill or a perpetual patient' - a view that defines the person primarily in terms of the physical condition," Diane Welch explains.

"That view holds in spite of well-meaning and humane intentions that include most people saying they are sensitive to persons with disabilities," the specialist continues.

Mrs. Welch is on the home economics staff of the Texas children. Agricultural Extension Service, The Texas A&M University System, which as part of its special "Thrust for the 80's" Program, has defined "Social Condition" as one of the six major concerns of Texans for this decade.

Promotion of positive attitudes toward the handciapped by society is among the chief recommendations from the 1980 White House Conference on Families, Mrs. Welch says.

That conference also recommended integrating people with handicaps into the mainstream of society as fully as possible, she adds. Techniques for ac-

complishing those goals could be the use of media, education, training, counseling and self-help groups, conference participants suggested

Natural Gas Decontrol -When & How?

By Viola M. Payne The latest prediction on price decontrol of natural gas came on June 1st from a Senator who probably knows as much about it as anyone -Lloyd Bentsen of Texas. Bentsen and Rep. Bill Archer, R-Texas, speaking before a meeting of Texas Independent oil operators in Ft. Worth, said opponents in the 97th Congress have made it clear that any move toward decontrol would be counteracted by threats to extend the windfall profit tax on oil to natural gas.

The Senator from Texas also told members of the Texas Independent Producers and Royalty Owners Association (TIPRO) that the so-called experts were wrong in two predictions regarding energy. Later he cited the "wrong predictions" in this way:

"Just a few years ago the so-called experts were unanimous in telling us about two trend lines that would never change. They pointed to an inevitable, increasing dependence on imported sources of energy and an inevitable decline in domestic production," the Senator said

'Look at it today. We are not becoming increasingly dependent on foreign sources. Back in 1977 we imported 8.8 million barrels per day. In April of this year we were down to 5.4 million.

'Those who wrote of America's energy assets were sadly mistaken. Today there are more than 3,800 rigs operating in the United States, a thousand more than at this time last year. 'They're drilling deeper,

more expensive wells, and the operators are taking bigger risks to find energy in America. And they're succeeding, finding new energy assets not just for today but for the future."

The reasons for the improvement in our energy situation, he said, is deregulation, free market pricing, and the incentives for producers to produce. The Democratic Senator said that the nation has had enough controls and enough "punishing taxation". He warned, however, that "the fight is far from over", especially in the field of Windfall Profit Taxes and

Under a truly free enterprise system, the products of the earth go to those who can afford to pay for them. It is hoped, however, that the decontrol of natural gas would react on the market about like the decontrol of crude oil - first cause the price to find a higher worldmarket level, then taper off as an abundance of gas became available. At the present time American consumers are paying \$1.65 per thousand cubic feet for gas imported from Mexico and Canada costs \$4.50 per thousand cubic feet.

One good thing Americans have going for them is that the country actually has an abundance of natural gas resources, if properly developed. Most experts agree that "It's here - and in the lower 48 States." The record new drilling in 1980 included over 14,000 newly completed gas wells. But with controlled prices at a level which is only one-third the equivalent heating value of crude oil, drilling and completion of new gas wells is not expanding fast enough to meet the future energy needs of the United States. It is expected that the price gap between natural gas and crude oil will be even wider by 1985 - unless corrections are made - leading to an even greater price shock to consumers when gas finally is decontrolled. (And economists feel that it enevitable must be, at some future time).

prices. "Under the present system we will find curtailment biting again sometime in the early to middle 1980's," he states.

He also believes that if incentives for increased natural gas drilling were to be increased immediately, that reserve additions and annual production would balance by 1985. But he is less optimistic about immediate changes, and points out there is not route around the present National Gas Act that approaches the efficiency with which the President decontrolled crude oil.

The U.S. Geological Survey believes there are huge undiscovered reserves of natural gas in America. A 16 month study by the agnecy indicate that from 475 to 740 trillion cubic ft. of natural gas remain to be drilled. This compares with slightly less than 200 trillion cubic ft. of reserves recorded at the beginning of 1981. In 1980, 743 wells were drilled to over 15,000 ft., about 1.5 per cent of the total wells drilled. The Anadarko Basin of Texas and Oklahoma, and the Tuscaloosa Trend - which stretches across Louisiana into southeastern Texas - are both prolific producers of gas below 15,000 ft. some 20,000 ft. wells in the Tuscaloosa Trend cost more than \$12 million, and \$8 million wells in the Anadarko Basin are reported to be very common. The deep Texas drilling included a well in Pecos County to 29,622 ft., which is the deepest hole in Texas. Absolute open flow of gas was calculated at 5.185 million cubic ft. per day from this well.

Early this year a number of independent oil and gas producers took the stand that the 97th Congress should decontrol all natural gas at the earliest possible date, repeal the natural gas use prohibition of the Fuel Use Act, and establish a natural

gas import policy which does not encourage imports as a replacement for domestically produced gas.

So the stage is probably set for another long and bitter

fight over natural gas pricing. Senior Railroad Commissioner Mack Wallace attempted to sum up the issue by saying:

"The American public is making an investment of (energy) prices. To be sure, the removal of these Federal artificial pricing schemes is painful, but our energy position is such that nothing less than the security of our nation is at stake.

'Under these conditions, I believe the American consumer will accept this responsibility."

On the surface of the red blood cells are many projections (things that stick out) called antigens. In the fluid portion of the blood there are substances floating around called antibodies which can attach to the antigens, causing the red blood cells to clump. Most importantly, only one kind of antibody will combine with one kind of antigen in the cells.

Thus, the two major antigens were identified and called A and B. A person can either have antigen A, antigen B, both, or neither one, and the four basic types are named after the antigens: A, B, AB, and O. If a person has one of the

antigens, he will not have that antibody. If he lacks one of the antigens, he will have the antibody in his fluid, as shown in the diagram: Type A - Antigen A - An-

tibody b Type B - Antigen B - An-

tibody a Type AB - Antigen A & B -

None Type O - Antigen - None -Antibody a & b

So we see that if a type A person is given type B blood, his antibodies will attack the donor's cells and cause a reaction. The same would be true with a type B recipient and a type A donor. Type AB can receive any type of blood, since it has neither the a or b antibody. This person is known as the Universal recipient.

Type O can only receive type O, but since it lacks the A & B antigens, it is termed the Universal donor. Problems could arise from the antibodies present but they represent only about 1 percent of the fluid. So if a person was given one pint of blood, only .16 ounces of antibody would be present, and wouldn't create a problem.

In practice, however, the types are matched as closely as possible, and before each transfusion a two-step crossmatching is done. In the first step, or major match, the donor's cells are mixed with the recipient's fluid. Secondly, the recipient's cells are mixed with the donor's fluid. If clumping occurs in either step, the transfusion is usually not given.

The cross matching is necessary, since A & B are not the only blood antigens present. Many more of lesser importance have been discovered. Among these is the RH factor, found in 1940 by Landsteiner and Weiner, which is the major cause of

the Blue Babies syndrome. Most of the other types do not cause serious reactions, and are useful mainly for identification. To date, over 50 different blood types have been found. In fact, it has been said that in the near future a person can be iden-
