## Small Business Administration Offers Flood Assistance

Mayor Eris Ritchie has announced that the city has received word from the U.S. Small Business Administration that four temporary offices have been opened in the areas of Texas affected by the recent flooding, for the purpose of distributing information and providing assistance to those persons and business owners who suffered physical losses during the October 12-16 flooding.

The mayor said that any persons or business owners in Cisco who feel that they have suffered sufficient damage to warrant SBA assistance may contact one of the offices for further information. The offices nearest Cisco are in Breckenridge at 1904 West Walker and in Abilene at the City Hall, Room 101. There is also an office open in Weatherford at the Courts Memorial Methodist Church Gym. The offices will stay open until December 24, when the filing period for assistance ends. Office hours are 8:00 a.m.-4:30 p.m. Monday through Friday.

Word of the availability of possible assistance came through John Carey, Dallas District Director for the SBA. Mr. Carey said, "We are moving rapidly to respond to the needs of the victims of the flooding and severe storms. I encourage those who suffered damages to visit our offices as soon as possible."

Persons or business owners can come to the office to discuss application procedures with loan officers on duty. No documentation is needed on the first visit.

The home loan program will require a test for ability to obtain credit elsewhere. Currently, that rate is 16 percent for persons who can obtain credit elsewhere. Home loan applicants unable to obtain credit elsewhere will be charged an interest rate of 8 percent.

Business loans are also based on a credit elsewhere test. Business applicant who can obtain credit elsewhere will be charged an interest rate of 18 1/2 percent. A disaster home loan is limited to a maximum of \$50,000 to restore a residence; \$10,000 to restore residential contents, or \$55,000 or 85 percent for actual amount suffered. The maximum allowable term for both kinds of loans is 30 years; however, terms are set in accordance with victims ability to repay.

SBA may limit any disaster loan to an amount that can be repaid. SBA can approve a loan only when there is reasonable assurance that the loan will be repaid.

Mayor Ritchie pointed out that Cisco and Eastland County were NOT among the seven Texas counties covered by President Reagan's disaster declaration, but that we are covered

by the Small Business Administration's declaration for eligibility to apply for disaster recovery assistance if affected by the flooding.

The counties that are covered by the President's declaration are Cooke, Grayson, Palo Pinto, Parker, Stephens, Tarrant and Taylor. Counties in addition to Eastland County covered by the SBA are Callahan, Coleman, Hood, Jack, Montague, Shackelford, and Wise.

Mr. Ritchie stated that persons or businesses seeking more information should contact one of the SBA offices rather than the City Hall, as the information in this release is all that the mayor or City Manager have knowledge of regarding available assistance.

This was a good year for fruit production in Eastland County. Most people tell me they produced more peaches, plums, apples, pears and other fruit this year than in many years.

We take care of the fruit trees in the spring, but often fruit tree is forgotten or neglected in the fall. Fall is a critical time for controlling many peach and plum tree diseases to insure a good crop next year. With the arrival of fall, there is often a tendency to forget our peach and plum trees that served us so well last spring and summer.

Fungicides applied now can stop or reduce three of the six diseases that attack peach and plum trees. These are peach leaf curl, bacterial leafspot and bacterial canker.

Puckered and distorted peach tree leaves that were either bright red or light

green in diseased areas last spring were due to peach leaf curl fungus. The only time to effectively control this disease is in the fall with a copper containing fungicide such as Kocide 101.

Timing of the fall spray is critical for effective control and for avoiding the damage. Copper is a metal and may cause severe defoliation unless applied correctly.

Spray when 70% of the leaves fall off the tree. Spraying too early will cause

leaf shed or cause the spray to be ineffective later.

Bacterial leaf spot and bacterial canker can be partially controlled by fall spraying with a copper fungicide. But again, it is important to spray at the right time to prevent foliage burn.

Bacterial leaf spot affects both fruit and foliage. The infection causes fruit to crack and leaves develop angular spots which drop out. Bacterial canker will kill trees slowly. Infected trees will have gum or wax forming on the trunk and main limbs.

Fall spray in Eastland County is most often applied around November 1 and December 1. Application time will vary with the

season. Keep a watch on the fruit trees and spray when 70% of the leaves have fallen.

Fall spraying is important to the health and production of fruit trees because there is no other time when 50% of peach and plum tree diseases can be controlled with one spray.

The peanut combines are very busy this week. The weather has been ideal and the soil moisture is good in sandy upland fields. Some peanut fields containing a lot of clay are still too wet for harvesting equipment. The yields have been very good in most areas. I have seen many dryland fields yielding 1,200 to 1,500 pounds per acre.

## Insect-Induced Galls On Oaks

GORDON WOOLAM

Recently a lot of attention has been given to Insect-Induced Galls on area Oak trees. Galls are abnormal swellings of plant tissue caused by insects, fungi or nematodes. Insect-Induced Galls are the most common Galls in urban areas. The most abundant Gall in the area is about the size and color of a large sorghum grain. Due to recent rainfall and winds, thousands of these Galls have fallen onto lawns, sidewalks and patios. These Galls can be a nuisance, but one which must be tolerated as control measures are largely ineffective.

Galls are caused by the abnormal growth of plant cells, formed in response to a specific stimulus. Among the insects causing Galls are certain Moth Caterpillars, Beetles, Flies, Aphids and small Wasps. The Galls provide the insects food and shelter during certain stages of their developmental cycles. Galls always take on characteristic sizes, shapes and colors.

After a usually brief period of cell growth, Gall development stops completely. The insect becomes confined within its "House" and feeds only on Gall tissue during its development. It is important to understand that once formed, these growths do not continue to drain the host plant of its nutrients.

Galls may cause concern to Homeowners from fear that these abnormal swellings may increase to the

## A Gardner's Dream Come True

For hundreds of years there has been various methods of irrigation used. The Romans had the Aqueducts during the time of the Roman Empire. Man has tried many, many forms of irrigation. He has used just the water hose to what is described as flood irrigate, to more recently the sprinkler system. There are more plants killed both outside and indoors from over watering than from any other cause. Just too much TLC. (Tender, Loving, Care).

Each form of irrigation has improved on its

point that plant health is endangered. Evidence to date suggests that Insect-Induced Galls in Texas do not result in noticeable or measurable plant injury. The exception is found in the damage caused by Phylloxera Galls on Pecans.

Galls occur on a wide variety of plants. Some host plants support only one or two species of Gall-Inducing Insects. Oaks are particularly susceptible, some such as Live Oak may have more than five different types of Galls at a given time.

Once a Gall begins its development, it is impossible to stop its growth with chemicals. Unless chemicals can be applied when Gall-Inducing Insects fly they offer no effective means of control. Lack of actual plant damage from Galls and the difficulty in proper timing of insecticide applications pose strong arguments against the use of insecticides. predecessor but still there have been problems even though each new system was an improvement. With the sprinkler system you have had evaporation loss as well as the cutting of the sprinkler heads when you mowed your lawn.

The basic purpose for irrigation is to water the plants, trees and lawns. Where does this plant material take in this water? Of course, it is at the root system of the plants. Therefore the best place to put the water for these plants is down at their roots. Some ten years ago I built a new Chrysanthemum bed and placed PVC pipe that had been perforated about six inches below the surface of the bed. The Chrysanthemums that were produced in this particular bed had fantastic color and were extremely large with the most beautiful foliage. Recently a new method of irrigation was introduced to the Gardening World called "Leaky Pipe."

There is no trenching and no damage to the yard for installation. "Leaky Pipe" is so versatile one system can water both the lawn, garden, flower beds and planter boxes. It is completely automatic even when you are on vacation the moisture sensor maintains the desired amount of moisture. The water goes to the roots, not on the top of the grass and beds. The basic principle is that the water weeps droplets through the wall of the pipe. "Leaky Pipe" can be placed at a depth of ten inches in order to allow normal yard work including rototilling. Nutrients (fertilizer) and health giving chemicals can

## A Balanced Budget For The U.S.

Oct. 26th looked like a normal day in Eastland County, with people enjoying the bright fall weather.

Most citizens didn't act like they were \$12,000 in debt—on top of personal obligations.

But that figure rolled in on them when — for the first time in history — the United States reached the 1 Trillion

dollar debt mark. The Reagan economic policies had slowed the drift—but it hadn't been stopped.

If all government commitments were counted, that 1 Trillion figure would reach nearer 10 Trillion, according to economists of the National Taxpayers Union, located in Washington, D.C.

These liabilities, besides the debt, include Insurance Commitments totaling 2 Trillion dollars (such as Federal Flood Insurance and Nuclear Reactor Insurance, undelivered defense orders, Loan and Trade Guarantees, International commitments, Annuity Programs, Federal Pensions, and the Social Security System.

Six years ago, according to figures available, the National Debt and Liabilities totaled about 4 Trillion instead of 10 Trillion.

A law requiring a balanced Federal Budget is being considered in Washington now. Senators Lloyd Benson and John Tower has indicated that they are undecided on the measure. All persons who have opinions on the matter should contact these Senators.

# Eastland County Oil News Report

EnRe Corp., San Antonio, staked location for No. 1-C Parmer in the Tee-Jay (3,900) Field in Eastland County.

Location is 12 miles northwest of Cisco, spotting 330 feet from the south and 2,310 feet from the west lines of Section 480, SP Survey.

Permit depth applied for is 4,200 feet.

Comanche Investments, operating from Cisco, will drill No. 1 Jon Jon in the regular field three miles northeast of Ranger.

The planned 4,500-foot venture is located on a 160-acre lease.

It spots 717 feet from the south and 330 feet from the east lines of S. Lemley Survey, A-1530.

Another regular field project will be drilled three miles southeast of Carbon as L.T. Aberger, Abilene, No. 6 John J. Holland.

The planned 950-foot project spots 2,190 feet from the north and 1,250 feet from the west lines of Section 3, Block 2, H&TC Survey.

The lease is composed of 99 acres.

# Supreme Court Ruling Affects Oil Recovery

A recent ruling by the Texas Supreme Court issued an opinion which could have far-reaching impacts on obligation of oil producers to protect landowners against premature "watering out" of leases because of field wide drainage.

The unanimous opinion in Amoco Production Co. v. Alexander, No. 8-9131, held that Amoco owes \$1.8 million to John Alexander and other royalty owners in the Hasting, West Field of Brazoria County.

This significant ruling held that Amoco had an implied duty to protect its downp

lessors in the water-flood field from field-wide drainage - more obligation than the usual contract to drill offset wells to prevent local drainage. The Court indicated it did not feel it was creating a new duty, however, but cited the long-standing rule that the producer must operate the lease as would a reasonably prudent operator under these circumstances.

The Court said that Amoco might have to drill replacement wells, rework existing wells, drill additional wells, seek field-wide regulatory action, or seek "voluntary" unitization.

The Court also stated that such duties do not exist "unless an amount of oil can be recovered to equal the cost of administrative expenses, drilling or reworking and equipping a protection well, producing and marketing the oil, and yield to the lessee a reasonable expectation of profit."

The Eastland County water-flooding project, now engaged in by Sun Oil, is already arranged under the unitization plan. This will enable all royalty owners in the old Ranger field to share in the recovery of oil. The actual water injection phase of this project is expected to begin around Jan. 1st.

## Brogdon scholarship established

The establishment of the William M. Brogdon Memorial Scholarship Fund has been announced by Weatherford College to honor the memory of Dr. William M. Brogdon, Trustee of Weatherford College and outstanding physician and member of this community, following his recent death on Oct. 12, 1981.

Each year a scholarship will be given to a second semester freshman or a sophomore student majoring in nutrition or in a pre-professional program. Interested students should apply to the Director of Student Financial Aid.

In addition to his service as a Weatherford College Trustee, Dr. Brogdon, at the time of his death, was

actively involved in the First United Methodist Church where he had been both a member of the Administrative Board and teacher of the Brogdon Class for the past 16 years. During those years he served in almost every official capacity of the church, including Delegate to the Annual Conference for several continuous terms. Most recently he was appointed to the special Conference Committee to work with Harris Hospital-Methodist for the long range purpose of determining church responsibility to the Hospital; vice-chairman of the Campus Ministry and High Education Committee and the committee for re-design of the chancel area of his local church.

Born on Nov. 15, 1925 in Gorman, Texas, Dr. Brogdon had been a resident of Weatherford since 1964. He was a 32nd degree Mason, member of the Knights of the Phythias Lodge; Texas Academy of Family Practice for which he was serving on the State Membership Committee. He was the current President of the local Three Rivers Chapter of the Texas Medical Assoc., and a member of the American Medical Assoc.; a past president of the Parker County Medical Assoc.; former Chief-of-Staff at Campbell Memorial Hospital; former member of the Weatherford ISD Board of Trustees; the Planning and Zoning Board for the City and was the present City Health Officer.

He received his bachelor degree

from the University of Texas in Austin, which was interrupted by service in the United States Army, where he was trained as a Japanese interpreter. After Army duty, he entered Baylor College of Medicine in Houston and received his medical degree. In 1952, he was married to Helen Gatlin, of Athens, Texas.

The memory of Dr. Brogdon will be a vivid one for a very long time for many people who knew and associated with him as patient, colleague, friend, Christian, husband and father. A person of many interests, he enjoyed a life-long hobby and passion for the automobile and its history; appreciated and collected various art forms, especially watercolor paintings and always showed positive support for budding artists. His creative abilities were evident by way of his upholstery work and decorating interests.

His special interest was in people, people of all ages and from all walks of life and especially his family. He showed great pride in his wife, Helen, and their four adult children, Mrs. Nan Hilliard of Fort Worth; Martin Brogdon of Houston; Steve Brogdon and Lynn Brogdon of Austin and a number of other special young people who at different periods during recent years called the Brogdon home, their home also.

His influence and compassion for others will be felt in the community for years to come.







## Homemaking Hints

By Janet Thomas

How much does it cost to raise a child? Fortunately, we now can get a good idea of the monetary costs of child rearing. Mr. Thomas Espenshade, senior research associate with the Urban Institute in Washington, D.C. has calculated the direct, out-of-pocket expenditure for childbirth, food, housing, transportation, clothing, medical care, educational materials and four years of college in the United States. The most recently updated figures were published in the fall of 1980.

It was estimated that the average middle-income family, with an after-tax income in the \$22,500 to \$27,000 range would spend approximately \$85,000 to rear a child from birth through four years at a publicly supported college in 1980 dollars, that is. A low-income family, with an after-tax income of \$14,000 to \$18,000 would spend approximately \$58,000. (These standards of living originated through the USDA, which uses family food expenditures to determine them) Although many Americans found the figures sobering, probably none were surprised at the increase of 33% since 1977, when the costs were last tabulated. This corresponds with the increase in the Consumer Price Index during that period of time.

It is also important to note that these figures vary from region to region and from urban to rural families. In addition, there are variations resulting from the educational levels of the parents, their tastes and preferences for an alternative lifestyle. A family's standard of living, in fact, is one of the most important determinants in any expenditures related to child rearing. Housing is an excellent example of this. Our needs can be met by the simplest of shelters, but we generally want the finest home our money can buy. Thus, if a family can afford a mansion, this becomes part of their child-rearing expenses. The same is true for high-priced clothing, cars, recreation, etc.

It also should be noted that many children are raised at one cost level for a few years, then at another, higher one. College expenses too vary greatly, depending upon whether the child attends a public or private institution. Unfortunately, as long as inflation continues, all estimates have to be revised upward from one year to the next anyway.

RECIPE FOR THE WEEK

This week I am featuring a recipe for Refrigerator Wheat Rolls. This recipe is printed in the Texas Agricultural Products pamphlet entitled "Recipes for Diabetics". These refrigerator rolls would be good to prepare ahead of time before your Thanksgiving company arrives.

Refrigerator Wheat Rolls

- 2 cakes yeast
- 1/4 cup lukewarm water
- 1 cup milk
- 1/4 cup honey
- 1 tablespoon salt
- 3 cups whole wheat flour, divided
- 2 beaten eggs
- 1/2 cup melted shortening
- 3 cups white flour

Soften yeast in lukewarm water; set aside. Scald milk, add honey and salt; cook to lukewarm. Add 2 cups whole wheat flour and beat well. Add yeast mixture, eggs and shortening; blend well. Add remaining whole wheat flour and white flour to make a soft dough. Knead until smooth and satiny. Place in lightly greased bowl; grease top of dough. Cover well and put into refrigerator. After no less than 12 hours or more than 4 days, remove and punch down. Shape rolls as desired and place rolls in non-stick pans. Let rise until doubled in bulk. Bake at 425 degrees F. for 15-20 minutes. Yield: 30 rolls, 1 roll per serving.



RAINFALL IN RELATION TO GRASS PRODUCTION  
EASTLAND COUNTY, TEXAS

A rancher looking on the basis of expected grass production from rainfall could look for these results:  
By receiving 25% above normal he could expect to have enough grass 14 years out of 50 or 21.9% of the time.  
On the basis of average rainfall, he could expect to have enough grass 50% of the time.  
Staying on the basis of 25% below average rainfall, he would look enough grass only 10 years out of 50 or 20.0% of the time.

## Records & Rainfall

Eastland County rainfall for this October of 1981 was by far the largest on record, according to all data available. T.E. Owens of Cisco, a barber who maintained a private recording

station at his home, kept complete records from Jan. 1946 until July 1981. Anton White, who lives south of Cisco on the Rising Star Highway, has kept rainfall totals since 1955. His recorded total for October was

13.30, slightly less than the 13.92 recorded in Eastland by De Marquis Gordon, County Agent. Much more apparently fell on watersheds nearby.

The records of Mr. Owens showed that October of 1974, with its total of 7.20 inches of rain, was the only October with a total of even half as much rain as fell last month. October is a traditionally dry month in Eastland County, and few of its totals have risen above 5 inches. October of 1959 had 5.20 inches, 1972 6.16 inches, and 1976 5.35. Most totals for this month range from 1 to 3 inches. In 1952 there was no measureable precipitation in October - the only such totally dry month on record here.

"I always enjoyed studying the weather," Mr. Owens says. "So I started this and found it so interesting that I kept going. But this year, right after I retired from barbering, my eyesight bothered me so much I had to give it up."

Mr. Owens's weather record is fascinating to anyone interested in the outdoors, nature, or history. His data is carefully written on sheets of columnar paper, each containing the records for a month, and all bound into yearly volumes. The data, recorded by sophisticated instruments, includes rain totals for each day and the month, barometer readings for morning and evening, temperature, snow or sleet, whether the sky is clear or cloudy and wind direction. Notations were made on unusual occurrences, such as "blue norther", "Bad sand-storm", "ice on trees", or extreme weather affecting

the area near Cisco. One notation records: "Bad hail north of town."

To read the data is to feel the past recreated, and preserved forever on these sheets of paper.

Mr. Owens faithfully read his instruments each morning at 6:30, before opening his barber shop. Late each afternoon, after closing, he would go to his home on East 13th St. and make notations on the weather data. During all the years there are a few days in which he failed to follow this routine. Occasionally there is a notation in the spring "Gone fishing", and once - "Gone to Arkansas", and "Went to Odessa".

There is very little "sick leave" recorded by the weatherman, just an occasional day out in February. But one January even T.E. Owens became so disgusted with the weather that he wrote across several spaces: "Too cold and too wet".

The Owens rainfall records were utilized by the Cisco Press some years ago to prepare a rain chart for Cisco. Mr. Owens's data corresponds closely to Weather Bureau material for Eastland County which is used by the Department of Agriculture. The Weather Bureau has kept County data since 1911, and the rainfall chart shows an erratic pattern which has varied from below 15 in. in 1917 to the highest year's total on record - 1957 with almost 45 inches. Mr. Owens recorded 45.57 inches for that year in Cisco.

The intricate data kept by Mr. Owens gives clues to underlying conditions affecting the dry years since 1976. For one thing, the barometric pressure has been running unusually high for the last few years. The highest barometric record ever taken in Cisco was on Mar. 4, 1981, when the barometer reached 30.55. Barometer readings, on the average, run about 29.90, with quick downturns as

unsettled weather approaching. A low barometer can signal a windstorm as often as rain in Cisco. The 1950's were characterized by dropping barometer readings and notations such as "Bad dust storm" to one side.

Oddities in the Cisco weather records include the lowest barometer reading, which was noted on Jan. 5th, 1946, as a startling 29.20. The barometer ran low all that winter and spring, with various upheavals.

Other interesting features of the Owens records include an even barometer reading morning and evening 30.50 - on March 1, 1980.

Two days have the doubtful honor of being the coldest recorded in Cisco - Jan. 12, 1973, and Feb. 11, 1981. Each had a chilling 6 degrees. The hottest day recorded was 112 on Aug. 11, 1964. The 24th and 25th of July, 1964, had the same temperature of 108.

The most prolonged cold weather for each year was always recorded in January and February, with the hottest temperatures always falling in July and August. And May was recorded as the wettest month of each year - not October! Until 1981, that is.

Few things affect our lives as much as weather, and Mr. Owens local records have contributed to the sum total of our knowledge. Historians and others will be studying this data for a long time - those records which become a part of his own life. Probably this was one of the most interesting hobbies he could have picked.
