A NOTE OF interest was sent to the Press office this week by Charles A. Spears of Sherman, Tx., a former banker in Cisco. The note contains a clipping from the Wall Street Journal talking about new inventions and practices in oil fields.

Mr. Spears said, "This insert from Wall Street Journal 2/12/82 brings to mind Harry Reynolds of Cisco and Robert E. Lee of Coleman with fond recollections of their friendship.

"For several years before 1940-Reynolds and Lee were working on the lateral drilling idea. They had a working set of tools for this Lee invention that Mr. Reynolds financed. You could drill out in every direction by pulling out the many-knuckled tool that when pushed back down rotated it some 20 degrees. Any oil man can understand the power of such a drilling tool to increase production.

"Well-what happened? From 1930 to 1940 the price of oil was so rotten that any new idea changing technology was not of much interest. Oil that in 1920 was worth \$4 per barrel was by 1932 worth 10 cents. The reserves was discovered in 1928 and the East Texas 1930 bonanza still in 1982 #2 in reserves-these two giants just flooded the market. Harry Reynolds just couldn't finance Robert Lee to finish their development.

"Inventive genius seldom gets reward. Another, there in Cisco in the 1920s was Cap. Judy. His dual "Ideal Theatre" was air conditioned with 300 lb. blocks of ice before a giant fan, and you had a choice of two pictures from the same box office. Fifty years later it finally came-you have a choice of four pictures through one box office.

"P.S. Harry Reynolds was in on developing some of the early great oil fields of Mexico before 1920. There was some dispute (with Gen. Crude) over that early day oil game--that was life threatening to Harry.

"Col. Robert Lee was one of earliest licensed air pilots in U.S.-and had many experiences in World War I in France. He was a genius and an extroverted leader."

RECIPE FOR THE WEEK: **OVEN STEW** 4 cup celery, minced 4 cup green pepper, thinly

sliced 1 clove garlic, minced ½ cup onion, minced 21/4 tablespoons margarine 2 pounds stew meat or round steak

21/2 tablespoons flour 11/2 teaspoons salt 1/4 teaspoon pepper ½ teaspoon sugar 1 tomato, peeled and diced 1 10% ounce can mushroom

2 cups broth or water 1/2 cup red cooking wine

Saute celery, pepper, garlic and onion in margarine until slightly brown. Cut meat into 1" cubes; dust with flour and seasonings. Add to mixture in skillet and saute until meat is brown. Stir in remaining ingredients. Transfer to buttered 3 quart casserole. Cover and let stand several hours or overnight in refrigerator. Bake at 350° F. for 2 hours. Serve over rice or noodles. Yield: 4-6 servings. (If you are an employed homemaker, instead of cooking the stew in the oven, put the stew in your crockpot. When you get off work, you will have a delicious meal by just adding a salad.)

Have you given your fruit and nut trees their annual 'lube" job? This refers, of course, to an application of dormant oil to control scale insects.

It is important to spray fruit trees, especially, with the dormant oil each year. Once every three years is usually adequate for nut trees.

The purpose of the oil spray is to kill scale insects. If a scale insect such as the San Jose scale or white peach scale gets started, it can kill your trees.

Dormant oil can be purchased at many different stores where garden sup-

By DeMarquis Gordon plies are sold. Be sure to follow all label directions and apply the mixture when the temperature is between 40-70 degrees F. Do not apply if a freeze is likely within 48 hours after application, and do not apply after the tree has budded out. Dormant oil is applied when the tree is dormant. Spraying blooms and leaves could cause leaf

burn and flower drop. Scale insects are difficult for most people to detect, so dormant oil should be applied once each year. Sooner or later your tree will probably be attacked by sacle insects, so be ready by guarding against them with an application of dormant oil.

This is also a good time to spray ornamentals that normally have scale insects. The most common plant that is always attracting scale is the euonymus. The scale insects are found on the shrub's leaves, stems and trunks.

You should spray the eyonymus now with oil spray. Two or three insecticidal sprays may be needed through out the year to control the scale insects. After the new leaves begin to grow you should use the summer oil plus malathion or diaginon. Be sure to follow directions on the insecticide

It is also time to control soil insects in home gardens. Soil pests feed on sprouting seed, tender shoots and roots of developing plants. They are usually most severe where gardens are planted in new areas previously covered with grass.

Soil insects include cutworms, wireworms, false wineworms, white grubs, soil maggots and rootworms.

For best results inspect the proposed garden plot before planting. Examine a spade full of soil at several locations. If soil pests are found, apply an approved insecticide at least two weeks before planting.

Diazinon will control most soil pests. For each 1,000 square feet use 34 cups of diazinon 25% liquid in three gallons of water. Apply the mixture evenly and work it into the soil to a depth of 4 to

I SMELL A RAT

Rats have lived with man for so long, they have also developed the sense to come in out of the rain - or snow or heat. Extreme weather will send rats and mice scampering for the nearest shelter. And that shelter is usually someone's home or business

The best control for rodents is prevention. Prevention is making certain there is no food, water or shelter available to rats. Homes and businesses can be made rodent proof by sealing all holes with gnawproof materials.

However, these dangerous and costly pests have a way of getting into even the most rodent-proof buildings. Once inside, there are two basic control methods: traps and toxicants.

Traps are best used when the infestation is light or there is danger to children or pets from toxicants. The most readily available type of trap is the old-fashioned wood base snap trap. Some of the best baits are bread, oatmeal, bacon, candy, pecans or peanut butter. Make sure baits are securely attached to the trigger.

Use plenty of traps (at least a half dozen for the home) and keep them set. Dispose of all dead rodents as soon as possible and avoid touching them with bare hands. Always place traps along walls in out of the way places where rodents prefer

For large infestations, tox-

icants should be used. The least hazardous toxicant available is the anticoagulant. Anticoagulants can be purchased at most feed or hardware stores. Anticoagulants are available under such chemical names as Warfarin, Fumarin, Diphacin, Pival, or Prokin. (These are not trade

Anticoagulants affect the clotting ability of the blood and cause the rodent to bleed to death internally. They are multi-dose toxicants. That is they have to be taken in repeated doses to be effective. Therefore, they pose less danger to children or pets accidentally eating enough to harm them.

names).

Ready mixed baits can be obtained and placed in out of the way places which the rodents frequent. Water baits (anticoagulants dissolved in water) placed nearby will increase the effectivenss of the dry baits.

Because the anticoagulants require repeated feedings to be effective, the baits should be left out for at least 15 consecutive days. The amount of bait to use will depend on the level of infestation, but it is better to use too much than too little.

Once all of the rodents have been eliminated, a few bait stations should be maintained permanently to help prevent reinfestations.

## Farm Program Signup Underway also be eligible for loan rates

We will begin accepting applications for the 1982 farm programs on February 16. James Chesshir, Chairman of the Eastland County Agricultural Stabilization and Conservation Committee, said. Secretary of Agriculture John Block mediate entry in the farmerrecently announced acreage owned grain reserve. Feed reduction programs for grain reserve loan rates are wheat, corn, grain sorghum, barley, oats, rice and upland cotton.

To be eligible for loans and target price protection farmers must sign up and comply with the acreage reduction program requirements, Chesshir said.

For reducing their wheat acres by 15 percent, farmers will be eligible for the \$4.05 per bushel 1982 target price for wheat, a regular loan rate of \$3.55 per bushel, and a grain reserve loan rate of

\$4.00 a bushel. Farmers who reduce their feed grain acrage by 10 percent will receive federal target prices of \$2.70 per bushel for corn; \$2.60 for soghum and barley and \$1.50 per bushel for oats. They will

DRY YOUR FRUITS AND VEGETABLES AT HOME!

Food dehydration is an age-old survival technique that's enjoying a rebirth of popularity thanks to today's sky-high grocery prices. For the person who wants to save money and have "fresh" viands year round-but is also faced with a limited amount of cabinet space-dehydration is a simple, inexpensive, and nutritious means of storing food.

It's possible to dehydrate produce in a low-temperature oven, build a cabinet-type food dryer (the free reprint offered at the end of this article contains complete directions for constructing your own), or to simply rely on ol' Sol to do the job (just find a flat surface outside . . . use cookie sheets, aluminum foil, or butcher paper on which to dry the edibles . . . and drape a protective netting to keep insects off the food).

The key factors to remember in drying are: (1) The food(s) should be clean and ripe. (2) Juicy items should be thinly sliced before they're dehydrated. (3) The chunks of food must be arranged so that air can circulate freely between them.

The list of foodstuffs that can be dried is long. Herbs, for example, maintain a pure flavor when deprived of their liquids. To process them, simply tie the plants in bundles and hang them in a dry place for a few days.

Fresh fruit is another popular dryable. To dehydrate pears, place them-quartered-on the rack, skin side down. The same process is used for apples, which you can also slice into rings if you prefer. And to make your own raisins, simply pull seedless grapes from bunches and spread them out on the drying tray or table. Stone fruits (the category includes apricots, cherries, peaches, plums, etc.) need only be sliced in half and pitted prior to drying.

Remember, fruits should contain no moist spots after drying. The dehydrated edibles can be softened by soaking them in water or juice before they're eaten . or can simply be left lying out in the kitchen to soften naturally in the moist air.

Many kinds of vegetables-including beans, peas, peppers, carrots, potatoes, onions, squash, and cereal grains-can also be dehydrated. Corn can be dried right on the cob . . . while dehydrated zucchini and cucumber slices make delightfully good-tasting chips for dipping and nibbling.

Drying food at home can bring you joy and satisfac-

tion, plus help you save money and improve your diet! There's hardly a better way to (1) cut your yearly food bill, (2) free up valuable cupboard and freezer space, and (3) enjoy a greater variety of more flavorful foods than to dry your own herbs, fruits, and vegetables



When asked about Australia, and how he can handle property so far away, Kamon simply states that he has a lawyer in Australia who keeps him informed of what is going on. Of course, he makes numerous trips, not to mention the phone calls back and forth. As for the Australian Land and Cattle Co., in which he is a partner - that ranch has a foreman who handles things well. It lies in an area on the

east coast which as 43 inches of rain annually, contrasting with the 7 inches in the interior.

"I feel at home in that interior of Australia - it is almost exactly like some parts of west Texas." Kamon says. "A few cattle ranches operate on the fringes of it, and occasionally an aborigine will come through hunting. There are herds of kangaroo and packs of dingos (wild dogs) in the area. Generally the natives have moved to reservations set up by the government, where they find living easier.'

Kamon mentions that the roads are rough back in the area of the domes - that it takes a 4 wheel drive Land Rover to get there. Drinking water is scarce, and must be carried in with other supplies. The Australian people - if you meet any in the back country - are friendly and easy to communicate with. They look and act like Texans, in fact, until you notice their speech.

Mr. Kamon belives that Golden Triangle has good oil prospects in the United States as well as Australia, and these will go along with the production it already has. He mentions a deep gas well in Pecos County as an example. There are others in Oklahoma and Louisiana, oil wells in the Austin Chalk formation, and production in Kansas

GTRO owns a 4% working interest in 5 wells drilled in Clyde Houston here in Eastland County. Furthermore, in a joint venture with Houston Oil & Energy. GTRO recently formed G&H Water Injection Co. for the purpose of disposing of salt water from area wells for 65 cents per barrel. The Company has converted one of its wells in the Foster Field to a salt water injection well.

With all these projects going on, there is little chance that the Kamon family or associates will be idle or bored in the foreseeable future. They are looking foward to this future - which is an attitude which will probably pay dividends along with oil.







## An American Success Story

One of the best examples of youth in action on the American scene today is the FFA, the national organization for the students studying vocational agriculture in the public high schools. The Future Farmers of America is an organization run by the student-members under adult guidance.

Soon after vocational agriculture became a subject many of the nation's high schools in 1917, instructors became aware of the need to provide practical training beyond the traditional classroom approach. Their idea was to make the instruction more in teresting by making practical work experience competitive livestock judging, and agricul-tural leadership development tural leadership development activities part of the instruction. Vocational agriculture instructors and students eagerly accepted the learn by doing principle of a new organization called, Future Farmers of

The FFA was founded nationally in 1928 after similar organizations had started in several states. Right from the beginning, the FFA has stressed leadership, cooperation and citizenship-all vital to success in modern agriculture.

Today the FFA has a mem-bership of 485,000 with chapters in approximately 8,000 high schools throughout the nation. The organization has state as-sociations in all states and Puerto Rico.

Vocational agriculture or agribusiness programs are funded in part by the National Vocational Education Acts through the U.S. Office of Education, state departments of education and the local school systems. The FFA operates under a federal charter

granted by an Act of Congress in 1950 (Public Law 740, 81st Congress). The charter provides for all national board of direc-tors and a board of student officers elected from the mem-

FFA activities are specifically designed to be a part of the instructional program in voca-tional agriculture. Members learn through active participation how to conduct and take part in public meetings, how to speak in public, and how to take a leadership role in their school and community.

Each local chapter and each state association elects its own officers each year. In all cases the teacher of vocational agriculture is the advisor of the local FFA chapter and the state supervisor of agricultural edu-cation is the advisor of the state association.

FFA members have full opportunity to practice the prin-ciples of democracy in conducting the affairs of their organization by excercising their privilege to vote at chapter meetings, serve on committees, and otherwise assist in carrying on the work of their organization. Elected delegates to the state and national convention, held each year, are asked to decide on

Advancement through the degrees in the organization from the Greenhand through the Chapter Farmer, State Farmer, and American Farmer or Agribusinessman is based on achievement in farming, ranch-

major issues facing the organi-

ing, or agribusiness careers. Nearly 8,000 public high schools have FFA chapters. One of the requirements for mem-bership in FFA is that a student be enrolled in vocational agricul-

ture. Students may retain their membership until they are 21. Competition is a key element of the FFA from the chapter to the national level. Each year the FFA recognizes more than 80,000 members at local, state and national levels for outstanding achievement in activities related to agriculture career and leadership development.

Funds for awards are pro-vided by more than 800 businesses, organizations, and individuals that sponsor FFA programs through the National FFA Foundation, Inc. The Foundation provides over a million dollars to make the incentive awards available to deserving FFA members in the deserving FFA members in the following award programs: Star Farmer and Star Agribusinessman awards, 22 agricultural proficiency awards, public speaking, national chapter awards, national chapter awards, national chapter awards, national communities Awards, national judging contest, establishment in agriculture awards, and through agriculture awards, and through state initiated programs for improving agricultural leader-ship. The cry for food in this country and around the world reaffirmed the need for continuing a strong program of vocational agriculture and the FFA. Thus there is a bright future for trained agriculturists growing for America.

STROKE

The brain is a glutton. It demands one-fifth of the blood the heart pumps. But it also starves quickly. If its supply of blood is hindered for any reason, permanent damage can occur within five minutes. That's what happens when a stroke strikes-a sudden interruption in the blood flow to the brain and subsequent brain damage. Four out of five victims will survive the first stroke with only partial brain damage and handicaps of varying degrees. But strokes account for one of every five deaths from cardio-vascular disease. About 80 percent of these occur in people over 65

years of age. The symptoms of stroke can develop within minutes. The victim usually loses consciousness and collapses. The face may be flushed. Vomiting or convulsions may follow. Often the damage is only on one side of the brain, so it affects only one side of the body. The pupil in one eye may appear larger than the other. The muscles may be weakened on one side of the body. The mouth may be pulled to one side. Immediate medical attention is governmentones of the medical attention is governmentones.

important. Recovery is slow and tedious and often involves a program of muscle therapy. Exercises may help a person regain some of the functions that were affected by the stroke. Many have to learn how to walk again. Though it takes time and patience, the effort often means being able to resume former responsibili-

The tragedy of stroke is that though it strikes suddenly, the weakened health condition which leads to it is one that develops slowly and is usually preventable. The cause of stroke is often traceable to lifestyle-lack of exercise, high stress, or a diet high in fats, particularly hard or

animal fats. If a person has arteriosclerosis, a floating piece of blood clot can lodge in one of the narrow arteries in the brain. Sometimes, because of high blood pressure a brain artery may rupture at a weak point, causing blood to flow into the brain tissue and cutting off the supply of blood to other areas of the brain.

Developing a lifestyle that includes attention to health habits will pay off in the long run. Reducing the chances of becoming a stroke victim is just one of the benefits you'll

## Plans For A Texas **Independence Express'**

With the Texas Sesquicentennial coming up in 1986, various plans are being formulated for the celebration. The State Commission which aids in preparation would like to see a special train traveling through Texas during the year, carrying historic material of interest to citizens. During a January meeting in Austin the Commission explored the possibility, indicated that the train would be named the "Texas Independence Ex-

press" The Commission already has a special train in mind a 19 car life-size train that toured the United States during the Bicentennial. The Freedom Train, as it was called during the Bicentennial, traveled 17,000 miles through 48 states in 21 months carrying historical

After the tour, the train was sold to the Canadian Government, which used it for another touring exhibit. State Rep. Chris Semos, commission chairman, stated the Canadian officials wanted to sell the train soon, but have indicated they may delay if the Commission can find a group to buy the train.

The major drawback to the plan, Semos said, is a \$700,000 price tag.

"Unfortunately we don't have state funds to buy it, but we are looking into private funds," he added. He called the concept of a traveling exhibit "one of the finer projects" of the Commission.

"This is one of the things that could go around to some of the smaller and mediumsized towns," he said.
