
The article sent is as follows:

The bald eagle is a winter visitor throughout northeastern Washington and northern Idaho. Many birds are now making their home on the Columbia River and surrounding areas.

The bald eagle migrates to the Columbia and Kettle **Rivers** during October and stays in the area until spring. The bald eagle population reaches its peak around January and February. The Colville River has often been a nesting place for the eagles; however, no nests have been spotted this year. Nesting sites are also located on the Pend Oreille River on the eastern half of the Colville National Forest and the Harvey Creek area in Pend Oreille County.

The eagles main source of food during the winter is waterfowl, dead carcasses of winter-kill deer, cattle and fish in the surrounding rivers.

The bald engle is a threatened species in Washington and Oregon. This means they are protected by law. Washington

# **Child Abuse and Neglect Can Be Curtailed or Prevented**

Cisco, Texas 76437

Child abuse and neglect can be curtailed or prevented by citizens building a network of services to help families in distress, the chairman of the Eastland County Child Welfare Boards said this week.

"We can help parents learn how to discipline their children without injuring them," said Mrs. Ernest Reich of Cisco.

"Where local communities support a wide range of family services, child abuse can be reduced. And, there's a bonus in keeping an abused youngster from repeating the cycle of abuse when the child grows up and becomes a parent," Mrs. Reich said at a Board meeting Monday to plan the 50th anniversary of 1982 of the beginning of child protective services in Texas.

Today, more than 1,800 Texans on 172 county boards offer time and service to protect children from abuse and

neglect in partnership with the Texas Department of Human Resources. Mrs. group. Reich noted that the likelihood for abuse or neglect goes up in families under great stress from financial difficulties,

marital discord, social isolation, or poor health. "Something as simple as talking to a neighborhood father who has lost his job can defuse the frustration


The National Wildlife Federation conducts their mid-winter surveys on the bald eagle in this area to determine the amount of nesting sites.



# Is Earth in line for a catastrophe?

While economic disasters and wars are drawing eyes inward, the nine known planets that circle the sun have begun their movement into a rare configuration that some have predicted will lead to catastrophies far graver than any man has created.

The nine planets are gathering on one side of the sun for a reunion that comes only every 179 years and at least two scientists predict ed in 1974 the joint gravitational pull on the sun would lead to disast erous results on Earth.

Predictions in the doomsday book. The Jupiter Effect, have sparked interest and discussion among not only scientists, but laymen.

Despite continued discrediting of the theory by scientists around the world and the retraction of some of the predictions by one of the authors, the rumors of pending disasters continue to circulate.


Even now, eight years later, the paperback book remains on many current bookstands (it has sold "steadily" at one Fort Worth bookstore, an employee of the store said) and as the March 10 peak date for the alignment nears? telephone calls are on the increase to area planetariums seeking more information.

From the beginning, scientists rejected the theories about the "Grand Alignment" ("it is neither grand nor an alignment," one said) proposed by John Gribbin and Stephen Plagemann, both respected in their astronomy-related fields. And even Gribbin has back

tracked somewhat on the conclusion to his theories.

Most do not believe the clustering of planets within a 95-degree angle on one side of the sun will lead to the predictions that result ing changes in the Earth's rotation could trigger earthquakes that will devastate Southern California.

It just won't happen, the majori-



even if it isn't Gribbin's and Plagemann's proposals had one major flaw. They expected the alignment to concide with a peak in the sunspot cycle. Normally, sunspot activity runs in 11 year cycles, although they can vary from 8 to 16 years.

When Gribbin and Plagemann predicted their chain of events in 1974, they had expected the peak this year. Instead, the sunspot cycle reached its zenith in late 1979. Had the sunspot cycle hit as predicted, his theory would have been proven correct, Gribbin said.

What has bothered him, however, is the way some religious organ izations have linked the predictions with biblical references calling for the end of the world.

"He (Gribbin) is probably correct in saying if everything worked exactly as he thought, we could have cotten the effect." said John Williams, director of the new Fort Worth Museum of Science and History. Science. Theater. "But the chances from the word go of it operating was essentially nil."

Jupiter's gravitational pull is greater than all the other planets put together. Williams said. If the pull of the all the planets could affect the sun. Jupiter alone would have the strength to do the same thing. Williams said. And the gaseous planet has had many chances to do just that.

None of the planets will be positioned in a straight line as the book suggests, but instead will be grouped on one side of the sun, filling a 95-degree angle.

The Fort Worth museum receives calls daily asking about the alignment, said Don Garland, director of the Fort Worth museum's Noble Planetarium. To answer some of those questions, they have included a lecture on the Jupiter Effect in the Texas Sky production at 1 p.m. each Saturday through March 27.

In addition, the University of Texas at Arlington Planetarium has scheduled a show on the alignment at 2 and 4 p.m. Sunday, Cost is \$2 for adults and \$1 for UTA students and children under 12.

quently occur.

One of the most active areas is the western coast of the United States. Along the San Andreas Fault in California, the Pacific and the North American plates are locked together in a struggle for supremacy. On occasion, as the Pacific plate continues its northward movement, sliding underneath the North American plate, the two bodies of land lock, allowing the pressue to build up until it releases all at once. That's an earthquake.

Scientists agree that pressure has been building up in the area for some time and that a massive earthquake is in the making. But they don't believe that a celestial event will be the triggering mechanism.

While a few are worried about the renting and tearing of the Earth's surface, most astronomers are readying their equipment to take a closer look at the astronomical event.

Last fall, they got a sneak preview of what was to come when eight of the nine planets — Mars was antisocial — moved into a 90degree angle of the sun. The arrangement in the sky was spectacular to look at even though three of the farthest planets — Uranius, Neptune and Pluto — were visible only through a telescope.

On the morning of March 10, those looking into the western sky will see Mars. Saturn and Jupiter. To the east will be Venus and Mercury. The three invisible planets will be located in between.

Planets began moving into place for the alignment Jan. 24 and they will remain in the same general area through April 10. March 10 is important because that's the time they will be grouped the closest on one side of the sun.

Although the March date had held the attention of stargazers since *The Jupiter Effect* first hit the newsstands, the best date for studying the skies will be April 7 and 8, Williams said.

On those nights, the full moon will join the brightest planets in the sky in an evening show. Looking to the east from the ground up will be Jupiter, then Saturn and then the moon. Sitting above the moon will be Mars. Then there are some who say the alignment itself is assurance of a peaceful time on Earth. After all, at the end of the period, the moon will be in the seventh house (Virgo constallation) and Jupiter aligns with Mars; Peace will guide the planet and love will steer the stars. (From the song, The Age of Aquarius.)

ty of scientists have said. Gribbin, who has served as editor of the respected scientific journal. Nature, in England where heresides, has admitted the predictions under testing won't hold water. But in a recent interview printed in Science 82 magazine, he continued to hold fast to his theories provided the chain of events he and Plagemann had predicted had occurred. What the book predicts is:



What few argue with in the book is the section on plate movements and the constant threat of a major earthquake in California.

Scientists today are in general agreement that land masses were once part of one common world which split apart. The plates — portions of which cover the ocean floor — are floating on molten rock and in some areas have collided.





### Center staff will help you determine if medical attention is required, or if the problem can be handled at

home. "About 85% of our inquiries can be handled at home," Ellis noted, "thus rushing the person to the hospital, is usually unnecessary. If the poisoning is serious enough to need medical attention, the Poison Center will direct you to the emergency room and then call ahead so that the child will be treated quickly."

March 21-27 is National Poison Prevention Week and a perfect time to inspect your home for poison hazards. The fact that no small children live in the home, does not mean that a poisoning cannot occur. "Nearly everyone has a small niece or nephew, grandchild, or a friend with small children - all of whom may visit occasionally," Ellis said, "and that makes them prime candidates for a poisoning accident." Every home should have a bottle of syrup of Ipecac, particularly if small children live there. This nauseating liquid is used to cause vomiting in the poisoned child, if vomiting is indicated. "Sometimes, we don't want the child to vomit," Ellis said, "so the parent needs to talk with the Poison Center first, before using the Ipecac. But it is the only safe way to induce vomiting. Other household remedies like, mustard and water, salt water, etc. - are quite themselves."

#### REFERENDUM AND ELECTION OF T.P.P.B. APPROACHING Joe Boswel **Executive Director**

Texas Peanut Producers Board The Texas Peanut Producers Board is required by law to hold biennial elections for the purpose of electing board members. In the 1976 biennial election, three board members were elected for six-year terms. Those whose terms expire April 30, 1982 are: J.O. Jackson, Jr., District No. 2; Bill Huff-District No. 3; and Billie Wayne Heiser-District No. 4 (B.W. Heiser resigned July, 1980 and J.M. Lindsey, III, was appointed to fill the unexpired term

DISTRICT NO. 2 includes the northwestern counties of the State. the southernmost boundary of this district includes the following counties: Loving, Wheeler, Ector, Midland, Glasscock, Sherling, Coke, Nolan, Taylor, Callahan, Eastland, Palo Pinto, Parker, Wise, Denton, Grayson, Fannin and Lamar. All peanut producers north of this line are in District No. 2. DISTRICT NO. 3 - The westernmost boundary of this district includes the following counties: Red River, Delta, Hunt, Collie, Dallas, Tarrant, Hood, Erath, Bosque, McLennan, Bell, Milam, Lee, Bastrop, Fayette, Colorado, Wharton, and

Matagorda. Producers east of this line are in District No. 3. DISTRICT NO. 4 - The northernmost counties of this district includes the following counties: Maverick, Zavalla, Medina Bexar, Guadalupe, Gonzales, Lavaca, and Jackson. Producers south of this line are in District No. 4.

REFERENDUM STATE AT LARGE-The Texas Peanut Producers Board proposes to increase the current assessment rate from \$1.00 to \$2.00 per ton to be collected at the point of first sale to finance programs of advertising, promotion, market and product development, education and research designed to increase the profitability of peanut production. All peanut producers within the State are included in the referendum.

The referendum and election of board members must be completed and tabulated by May 6, 1982

All producers of peanuts within the area defined, including the owners of farms on which peanuts are produced, are eligi-

Box 398, Gorman, Texas 76454, an application to have his name placed on the ballot. The application must be signed by the candidate and by at least ten peanut producers who are qualified to vote in the election and must be filed at least thirty (30) days prior to the election (April 6). No candidate, unless so nominated, shall have his name placed on the official ballot. However, this does not prevent the

writing of the name of any candidate on the ballot by any qualified voter at the election. Spaces shall be provided on the ballot for such write-in candidates. (3-18)







John Clark was a family man. Now that is not to use the term as it is far too frequently used when one fails to find any commendable characteristic in an individual, and just makes a feeble attempt to sort of consolidate all the better traits into that cobbler-pie kind of well-meaning title ... "A Family Man". John Clark was not that kind of a family man. Nor are these words meant to hide any of John's faults.

But John Clark had a peculiar right to being a family man. He loved his family, as all fathers love their families. But there was a kind of unspoken bond between John Clark and his family. Whether his children felt it is not known, but John Clark had a love of the closeness of his family that was deep rooted. While he had been brought up in a surrounding of love and care, he was separated from the members of his immediate family

It is often said that we are inclined to re-live our lives in the lives of our children. Perhaps John had something of a subconscious un-expressed desire to hold his family together in a closer bond than he had known as a youngster.

But John Clark's love for his children extended perhaps to all children. There are men like that. They just love children. Little people are their favourite segment of society. Perhaps John Clark was one of those people. And his love for children, perhaps influenced his own personality. Jovial, goodnatured, kindly ... and very hard-working, John Clark was liked, even loved, by everyone who knew him. And while John Clark was an outgoing person, he was not one to seek the position of center stage, front.


Yet, on a chilly, gray, overcast morning in February John Clark became a hero. Making a split-second decision, perhaps spawned in his love for children, John Clark sacrificed his life to save that of more than a dozen school children who mangled bodies would undoubtedly have been picked from the wreckage of a school bus had not John Clark not driven his eighteen-wheeler into the ditch on the left-hand side of the road when he saw what faced him. And in that moment John Clark became a hero. Perhaps the sacrifice of his life made it possible for John to have become the sort of hero he would have become ... without having to face the plaudits of admiring people.

But plaudits there are. The people of Eastland, "a city without a heart", as it has been described by unqualified critics, joined by the people throughout the County have come forward to express in a tangible manner their recognition of the heroism of John Clark. In demonstrating their recognition of the sacrifice of his life, the people of Eastland County are helping make it possible for the family of John Clark to be held together in a unit as he would have it.

The response of the people of the County to the suggestion that something be done for the family has been an outstanding demonstration of heart, in the fullest sense. As surviving mortals, we are inclined to feel so helpless and yet so grateful lieving is a Bible worth for the John Clarks in the world. 
