



### Price Of Electricity Will Increase

The price of electricity to residential and commercial customers of West Texas Utilities Co. will increase slightly this month as the company's summer rates go into effect.

The summer-winter rate differential for the two classes of customers was proposed by the Public Utility Commission of Texas staff during negotiations in WTU's rate case last fall.

Beginning with May billings, residential and commercial customers will be charged 3/4-cent more per kilowatt-hour. Residential base rates rise from 3.22 cents to 3.97 cents per KWh, while commercial base rates rise from 3.43 cents to 4.18 cents per KWh.

Coincidentally, there will be a fuel factor adjustment raising the cost of fuel from 3.14 cents per KWh to 3.5949 cents. This means that residential rates, including fuel costs, will go from 6.36 cents per KWh to 7.5649 cents, and commercial rates, including fuel costs, will go from 6.5 cents to 7.77 cents per KWh.

The new base rates and fuel cost factor will be effective for bills rendered during the month of May. The summer rates continue through October.

The seasonal rate differential has been used by many companies for many years. The main reason is that the cost of service is higher during the peak usage season, or summer months. Also, higher rates serve as an incentive for customers to conserve and trim the peak demand

lemon, peppermint, apple or nutmeg scent to mention only a few. Then the geranium may have no scent what so ever. The fragrance emanates from the leaves and not the flowers.

You may use the ivy and common geranium as borders, beds and pot plants because they will bloom through out the growing season. The ivy geranium is particularly effective in hanging baskets and window boxes. They can also be used as ground cover.

The Lady Washington is not successful in many sections of the country as other geraniums since it needs temperature below 60 uegrees to bud. It is usually grown by florist for Mother's Day and Memorial Day.

Most geraniums thrive in climates with dry summers, warm days and cool nights. They do best in full sun but

will grow in partial shade if they have sun for at least half a day. The soil should be well drained and only medium rich. Most gardeners buy

geraniums as budded or flowering pot plants ready to set out in the yard. It takes five months for geraniums to flower from seed therefore most plants are raised from cuttings. If you plan to grow geraniums from seed plant them 10 to 12 weeks before the last frost inside. Seedlings should be transplanted

to two-inch pots when the first leaves appear and shifted up to four inch pots as they grow Keep the pots in a sunny

# **Area News Briefs**

#### CISCO

One hundred and forty-three students of Cisco Junior College received Associate of Arts Degrees at the Commencement program the night of May 3 in Harrell Fine Arts Building. The program concluded the school year for the graduating class. Freshman students of the College will complete final examinations during the coming week. Degrees were conferred by Dr. Henry E. McCullough, President of the College. Highest honor students were Kendall Anderson of Cisco, Georgiana Blankenship of Abilene, Connie Melinda Gosnell of Cisco, Linday G. Krenrich of Abilene, Denise Dueser of Breckenridge, Mary Kethleen Taylor of Clyde, and Donald Turnbeaugh of Cisco.

Work is beginning this week on water distribution lines and water storage improvements for Cisco. The new 8 to 6 inch looping water lines will be installed throughout the city by Stegemoller Construction of Breckenridge, and the water tower rehabilitation and painting will be done by G and S Sandblasting and Painting of Abilene. This is the third part of water system improvements by the city, with the first begun in November, 1983.

For about 20 years there have been no services at the Baptist Church at Nimrod. Now services will be resumed next Sunday, May 12, beginning at 11:00 a.m. Lee Rodgers will be in charge of this missionary project, which is sponsored by the Mangum Baptist Church. 


