Dr. C.M. Cleveland Honored By Church Of The Nazarene

Sunday, September 30, a Homecoming was held at the Cisco Church of the Nazarene to observe the 80th anniversary of the founding of the church in Cisco and to honor along time member, Dr. C.M. Cleveland

When Dr. Cleveland arrived at the services he was unaware that the members, former pastors and their families, and friends had come to show their appreciation for the many years of faithful service to the church.

Dr. Cleveland, a native son of Cisco, had grown up on a ranch ten miles north of Cisco. He graduated from Cisco High School and spent a short time after his graduation helping his parents, Grover and Ella Cleveland, "work the soil." A desire to see the world lead him to join an older brother at Southern Nazarene University in Oklahoma City. After completing three years at the university in Oklahoma City he transferred to the Luscombe School of Aeronautics in Dallas. He was then employed as an Inspector Supervisor by Glenn L. Martin Aircraft, Baltimore, Maryland. While in Baltimore he married Josephine Cleveland, a native of Nebraska.

In 1944, Charles entered the U.S. Air Force as an aviation cadet and a year later received his wings and was commissioned as an officer. After the war, he entered the Northern Illinois College of Optometry in Chicago. Four years later he graduated with scholastic honors. With his degree in hand he returned to Cisco with his wife and small son, Charles Bruce. His plans were to visit his parents and then find a location somewhere in Texas to practice his chosen profession.

While visiting in Cisco, the local Optometrist came to the ranch and asked him to take over his practice as he wished to relocate. After consideration he opened his practice in 1949 in The Reynolds Building. He practiced there until a new office was built at its present location.

Along with his work, he began to assume more responsibilities. He and his wife's lives were enriched by the birth of a daughter, Carolyn Cleveland Knippers. He and his family also united with Cisco Nazarene Church. His mother, Ella, was a charter member of the church and her husband, Grover, joined the church after their marriage. It. was here that he and his brothers and one sister were introduced to Christian principles.

Charles early training was to shape his life. He served well his church for 40 years. Five years were spent supervising the youth program. Later, Charles was elected Sunday School Superintendent and served in this capacity for 35 years. He resigned

this position in April, 1990. Concurrently he served on the Church Board of Directors. Along with others, he assisted in the planning and building of the present church at the corner of 10th and Avenue N.

Dr. Cleveland soon became known to many in the church and community as "Doc." He became a friend, helper and counselor to many. Members of the church often come to his home to share with him their concerns and to seek his counsel.

His interest in the young people lead him and his wife to establish a scholarship fund for young people at the church. This enabled them to begin their education. Some became ministers and are now serving faithfully in their pastorates.

In 1981, Dr. Cleveland received the Outstanding Laymen's Award from the West Texas District of the Church of the Nazarene.

During the Homecoming services, Dr. Cleveland was presented by the local church the Distinguished Service Award issued from the demonstrations headquarters. Kansas City, Ks.

Dr. Clevelan ited his time only to his local church but is currently a member of Gideon International. He is a Gideon speaker,

formerly a Chaplain of the local Gideon Camp and is presently serving as President of the Gideon Camp which comprises five towns in Eastland County.

Charles joined in with many others to assist in any way he could to make Cisco a better place to live. He is a member of the Cisco Lion's Club; a member and former Director of the Chamber of Commerce; served on the CJC Board of Regents; the board of the Cisco Independent School District; and for several years Chairman of the Cisco Community Chest drive; besides being a former member for several years of the Cisco Hospital Board.

He is also a member of the Texas Optometric Association. In 1984 the American Optometric Association recognized him for his contribution to the field of Optometry and presented him a life membership.

A rugged man, endowed with the ancestral family traits of honesty, and a desire to do right toward his fellowman has endured Dr. Cleveland to many. Mrs. Trude Pettigrew, local pastor's wife, stated before the presentation that the poem written by William Dromgoole in 1934 could well be the summary of Dr. Cleveland's life:

"On old man, going along a highway, Came at the evening, cold

Dental Emergency

Q.What is considered a true dental emergency?

Q. What are the four stages of the personality identification

A. There are f pathways to identity:

1. Identity Foreclosure occurs when the individual lives according to standards and goals set forth by the parents. Family ties and stong religious affiliation usually predominate. The parents have spent a great deal of quality time with the child and then in adolescence and early adulthood these expectations are carried out. Peer influence is not as strong as family and religious regulations. The type of person who has Idnetty Forecloure does not experience identity crises as compared to the other pathways to identity.

2. Identity Achievement is the process of testing options. Once they have been personally tested the individual commits to a way of living. These individuals may have had parents who were absent or unabailable for comments about the delemm in the child's early years. It is possible also that the parents may have encouraged the child's own decisionmaking to find out for themselves what they liked.

3. Moratorium is the active exploratory phase. Peer pressures cause much experimentation with morality, drugs or religions. There is a lack of commitment. There is often a lack of follow through. These individuals are usually easily persuaded to try new things.

Pharmacy **Topics**

It's flu-shot season. Almost 50 million Americans are at risk -- especially those over 65 and the chronically ill.

New drug to dissolve blood clots after a heart attack -anistreplase --- is said to work faster than other clotbusters. The injectable drug is now being tested at the University of Utah Medical School.

Heavy alcohol consumption by fathers in the months before conception not only produces smaller babies (as a University of Michigan study found), but seems to result in slower-learning offspring. New research, on rats, comes from Washington University in St. Louis.

Short-pulse ultrasound seems to be effective in helping heal wrist and leg fractures, researchers found at Mount Sinai School of Medicine in New York. Therapy aims waves through a tiny hole in the cast.

Combination regimen -- short-term use of drug, etidronate, followed by long-term calcium use -- can strengthen the bones of elderly women and reduce the risk of spinal fractures, a Danish study reported.





Cruising is the most popular form of pleasure boating, but it also is responsible for more accidents than any other boating activity.

In 1989 there were 126 cruising accidents reported in Texas, 277 boating accidents in 1990 of which 42 were water hazards while cruising.

Boating accidents can be divided into two categories: vessel casualty and personal casualty. Vessel casualty includes collisions with other vessels, fixed or floating objects, capsizing, sinking, grounding and flooding. Per-

sonal casualties involve death by drowning and disappearance. Personal injuries are represented by falls overboard, falls in a boat, burns and hit-by-prop.

More than 90 percent of deaths in boating accidents are drowning incidences while 80 pecent of drowning victims were not wearing a personal flotation device.

Factors that will help reduce the risk of water hazards include having a nautical chart and knowing how to navigate with one. Charts are your road maps. Most areas have govemment or locally prepared charts available that give water depth, show navigated aids, major landmarks and underwater danger areas, as well as shorelines, waterways and harbor areas.

Another preparatory factor is knowing navigational aids on your right while heading upstream, or from seaward, is a fundamental example of proper navigation. The phrase, 'red right returning' helps boaters remember this

are a compass, piloting skills, tide and time tables; range markers, lighthouses and knowledge about currents. Also, weather conditions, excessive speed, no proper lookout, overloading, improper loading, restricted vision, alcohol use, faulty hull, machinery and equipment are other causes of boating accidents and death."

The operation of a vessel must submit an accident report form to TPWD, 4200 Smith School Road, Austin, TX 78744, for any accident in which a person dies; a person is injured; or property damage is more than \$500.00. This report must be submitted within 30 days of the accident.

A vessel operator involved in an accident must render all practical and necessary assistance possible to the victims without seriously endangering his own vessel or persons aboard. The operator shall give his name, address and vessel identification to any person injured or to the owner of any property damage in the accident.







LETTERS TO EDITOR

Dear Editor: The front page article in the Oct. 14th issue on the Hospital tax rate was sure the best magic show and sleight of hand act I've seen. First the tax on a \$18,347 house at .50 \$19.74. (Editor's Note: This newspaper made a typographical error in the amount of tax. The correct amount was on the orginal copy submitted by the Hospital Board. We ran a correction in the next issue of the newspaper.) Second, \$18,347 is only an average; what about the folks who live out of town and own several hundred acres? They may be a retired couple still living on a family farm worth over \$100,000. Their simple arithmetic is for simple minds; to tell us that the difference between what was tried to put on us first and what they are trying to put on us now is only \$22.83. The difference between what? Do they mean the difference between the .28 per \$100 they tried to get and the .50 per \$100 they want now? Well, we are not stupid, we know the difference is really between the .14135 per \$100 and the .50 per \$00 which is .35865 per \$100. Next that statement that there are voters who can vote but don't have to pay any taxes; is that suppose to get them to vote for the tax increase, to get something for nothing? Well, let them beware, if they don't own a house, then they have to rent. If taxes go up on their landlord's house and on the rent house, where do they think the landlord is going to be able to get the money to pay the extra taxes with? He is going to raise your rent, thats where, and he isn't going to get no tax breaks either on that rent house. The facts are this, with the hospital closed we are not stranded 40 miles from a hospital or a doctor.

Eastland is only 10 miles away and there is at least 5 or 6 doctors in Eastland. If Dr. Cermin decides he can not remain in Cisco and treat patients at the hospital in Eastland, that would be a loss, per \$100 is \$91.74, not but not the life threatening, gloom and doom we are led to believe. The hospital is not profitable, the hospital is not used by hardly any of the total population of the district, only higher and higher taxes would keep it open. Using our tax money to guarantee one or two doctors they will make \$90,000 to \$100,000 a year is nothing more than socialized medicine. Even the leader of the Soviet Union realizes that socialism doesn't work, it just destroys every thing it touches. There are people who are afraid to speak out for fear of their jobs or some kind of economic realiation, but they can speak out at the ballot box; that is where they have nothing to fear.



"The Authority elected Mr. McGrew president. Appointed to the committee to select a site for a hospital were Dr. Wallach, Mr. Graham and Mr. Smothers. The committee that will contact out-oftown foundations for contributions is composed of Dr. Addy, Mr. Hammett and Mr. Yardley.

"Working with the Hospital Authority is the Parker-Croston architect firm of Fort Worth. This company will make a survey of the Cisco area to determine the size and type facility needed.

"Parker-Croston, once the survey and Authority's study is finished, will file an application with the Texas State Department of Health for a Hill-Burton federal grant for half the amount of the determined cost.

"To be considered for a grant under the Hill-Burton Act of 1954, an area must be in the 1-A priority category of hospital financing, explained Mr. Smothers. Cisco is in this classification, and is, therefore eligible for the grant. Application for the grant must be made by May 31, 1967, to be considered in the coming year's appropriations under the H-B Act.

"To help cover the other half of the cost, A.C. Edwards & Sons, bondmen and member of the New York Stock Exchange, was contracted by the Authority to issue small interest revenue bonds to outof-town companies. These bonds would be retired by profits from the "non-profit" hospital. It will be non-profit in the sense that the money made will be used for maintenance, payroll, etc. Extra income will be used to retire the bonded debt and eventually for expanding.

"Mr. Smothers and the Parker-Croston representatives emphasized that should the hospital plan be carried out, no taxes will be required from the citizenry, and the city will have no cost obligation whatsoever. Though most of half of the cost of

"The architect and bond men told the Commission that they recommend that the Authority purchase the present Graham Hospital and include it in the program if possible.

"In reply to questions, it was brought out that the city will be under absolutely no tax burden as a result of the revenue bonds. The only local obligation would be to raise one-third of one-half of the cost through contributions.

"A Tuesday night's meeting, three commissioners voted "yea" for the establishment of the Authority, while Water Commissioner C.F.
