Funeral services were held Monday, November 9 for Mrs. Mary Ela Van Meter in the First Methodist Church here in Quitaque at 2:00 p. m. with Earl Cantwell, minister of the Rock Creek Church of Christ officiating, assisted by the Rev. Al Jennings, local Methodist pastor.

Mrs. Van Meter, widow of the late A. F. Van Meter, Sr., died in the Kent County Nursing Home at Jayton last Saturday, November 7. Burial was in Rest Haven Cemetery under the direction of Quitaque Funeral Home.

She was converted and has been a member of the Church of Christ since she was thirteen years old.

State's '65 Cotton Allotment Is Set

Texas farmers have been allotted 6,835,945.0 acres on which to grow their 1965 upland cotton crop under the national cotton program. R. T. Price, Chairman, Agricultural Stabilization and Conservation State Committee announced today. This represents the State's share of the 16-million-acre allotment and of the 200,000-acre national reserve (to take care of minimum farm allotments), announced by the Department of Agriculture on October 13.

At the same time, marketing quotas were proclaimed for the 1965 cotton crop, and Dec. 15, 1964, was set as the date for a national referendum on the quotas.

The Chairman explained that the State allotment will be apportioned among counties and the county allotments among

farms according to provisions of the law. Notices of farm allotments will be mailed to operators of cotton farms prior to the referendum.

Cotton growers voting in the December referendum will determine whether marketing quotas will be operative for the 1965 crop of upland cotton. Approval by at least two-thirds of these voting is necessary in order to put the quotas into effect.

Mr. Price pointed out that the domestic allotment program, authorized by legislation enacted last spring, will be in effect for the 1965 upland cotton crop if marketing quotas are approved in the December 15 referendum. Under this program, a cotton farmer has the option of planting within his farm's effective allotment or the domestic allotment. (The effective allotment is the farm allotment after any release or reapportionment). For those voluntarily reducing their acreage, growers may qualify for price-support payments in addition to the regular price-support loans.

Marketing quotas for the 1964 crop of upland cotton were approved by 94 percent of the growers voting in a referendum in December, 1963.

The domestic allotment program was in effect for the 1964 upland cotton crop.

The referendum this year therefore presents these alternatives to voters:

If marketing quotas are approved, marketing penalties will apply to any excess cotton of growers who exceed their farm's effective allotments. Price Support (at a level within 65 to 90 percent of parity) will be available to growers who do not exceed their effective allotments, and additional price-support payments will be made to growers who voluntarily reduce their cotton acreage to the farm's domestic allotment. (In general, the farm marketing quota — which a farmer may market free of penalty — is the production from the farm's effective acreage allotment).

If quotas are not approved, the regular allotment program will remain in effect, and price support at 50 percent of parity will be available to growers who do not exceed their effective allotments. Without quotas, the domestic allotment program providing additional price-support payments would not be in effect.

Agricultural Census Plans Announced

Plans for taking the 1964 Census of Agriculture, in Briscoe County were announced today by W. V. Swinburn, newly-appointed census crew leader for the county.

The job will be done in three stages, the crew leader said. First will come recruitment and training of enumerators to count all farms in the county. About one enumerator for each 150 farms will be needed.

Shortly after November 19 the Bureau of the Census, an agency of the U. S. Department of Commerce, will start the second stage by mailing agricultural census questionnaires to all rural boxholders in the county. This will give farm and ranch operators who are required by law to fill out the forms, a time to consult their records and fill in answers to the questions.

In the final stage, enumerators will visit each farm in the county to collect the questionnaires. At the time of this visit, the enumerators will help farmers complete answers to any questions the farmers may have had difficulty with. Enumerators will take about 3 weeks to complete their work, the crew leader estimates.

The Census of Agriculture is taken every five years in the years ending with "4" and "9" to gather up-to-date information on the nation's agricultural resources and production. Such information is vital in making decisions affecting many segments of the U. S. economy. Data gathered include the number and size of farms, acreage and harvest of crops, livestock inventory, information on farm equipment and facilities, farm products sold, and use of fertilizers, insecticides, and herbicides.

Panthers Win No. 2

Quitaque's High School basketball teams swapped out with Samnorwood here last Friday night with the Pantherettes losing to a fine Eaglette team, 50-65, a game that was more interesting than the score would indicate, while the Panthers won their second game of the season by slamming past the Eagles 70-57, a game that was not as close as the score indicates.

The Pantherettes played their best game of the season against the Norwood lasses, who in the opinion of most observers, have the best girls team the Pantherettes have faced this year. The Quitaque girls got off to a fast start, running up a 9-0 lead before the visitors could find the scoring range, and for the first time this year the Pantherettes were in the lead at the end of a period of play. The score was 14-11 in favor of Quitaque at the end of the first quarter. The Eaglettes came on fast, however, in the second period and were ahead 33-27 at half time. The Eaglettes have a Sophomore member of their team named Eunice Stice who was the difference in the ball game. Miss Stice played most of the first half at guard, then was switched to forward, and it was then that the visitors started to build a commanding lead. That young lady has all the equipment to make a great basketball player. She is tall enough, scores well and has the moves to get plenty of shots.

Patricia Brunson led the scoring parade for the Pantherettes with 21 points; Deborah McKay notched 16, Barbara Reagan 11 and Carol Myers 2.

Kay Purkev, another fine forward, topped the scoring list for Norwood with 24 points. Eunice Stice, playing the early part of the game at guard, still

chalked up 21 points; Breeding made 19 points and Martindale 2 points.

In the second game of the evening the Panthers had some trouble getting started and were behind 12-16 at the end of the first period of play. With 6:20 left to play in the second quarter however, the Quitaque lads tied the count at 16-16 and soon indicated they were going to be hard to catch, and were going away at half-time 31-22. The starting five Panthers plus Lonnie McDonald, who got into action during the second period, were all hitting well after the shaky start. Jamie Johnson got four quick fouls, had to be pulled in the first quarter and did not score a point in the first half. He started the second half, however, went the rest of the way (except for the last 3 minutes) without fouling and wind up top point maker for the Panthers. However all five of the starters scored in the double figures for a well-balanced effort. Warren Lee Merrell made only one field goal but dropped in 11 of 12 free tosses for 13 points and here is a young fellow who comes as near giving a 100 percent effort all the time as is possible. Monte Stephens and Eddie Monk each netted 12 points and Larry Tipton contributed 11 points. Lonnie McDonald played only a little more than a quarter but made 8 quick points. The Panthers were leading 70-48 when the starters were pulled by Coach King. Cavazos, Leal, Harmon, Taylor and Ramsey played the remaining three minutes and were unable to score.

Kendrick was high for the Eagles with 26 points.

Friday night the local teams take on the teams from Quail.

Both Quail teams took wins over the local teams in earlier season games. The Quail girls team is not as strong as some of the teams the Pantherettes have met this season. They have lost to the McAdoo girls twice this season, the first time by 13 points and the second time by 9. With an effort such as put out against Samnorwood last Friday night, the Pantherettes might win themselves a ballgame.

On the other side of the ledger, however, the Panthers will be meeting a toughie, probably the best team they have faced yet. The Quails won the first meeting by 6 points and the Panthers played well in that game. The Quails won over McAdoo by 6 points in their first meeting, then belted the Eagles 81-65 with the reserves playing the last four minutes of the game. So the Quails will be hard to handle but the Panthers looked pretty good Friday night in defeating Samnorwood and they like to win. It should be a good game. The Quails are led by the "jumping-jack" in these parts, Dale Morris, who is not over 5-9 at the most but who outjumps boys half a foot taller. He is a fine player.

Next Tuesday night the local teams journey to McAdoo to try to reverse two decisions the Eaglettes and Eagles won here last week. (The Tribune mistakenly announced that the games were to have been played the past Tuesday night).

Although the Eagles won the first meeting between the two teams, the Panthers just might knock off the proud charges of Fabian Lemley. In addition to the two losses to Quail, the Hedley Owls took a 20-point win (70-50) over McAdoo on Tuesday night of this week.

Emergency Loans Are Available

Briscoe County has been designated as an Emergency Loan Area by the Secretary of Agriculture, Orville L. Freeman, according to Donald B. Cruce, County Supervisor of Farmers Home Administration in Tulia.

Farmers or ranchers are eligible for emergency loans who have suffered production losses due to the drought in the designated area and must meet certain eligibility requirements as follows: (A) Be a citizen of the United States. (B) Be an established farmer or rancher. (C) Operate a farm or ranch in the designated emergency loan area and had severe production losses. (D) Possess legal capacity to contract for the loan. (E) Possess the character, industry and experience necessary to carry out the proposed farming or ranching his own resources or to obtain operations. (F) Be unable to provide the necessary funds from his own resources or to obtain sufficient credit elsewhere to finance his actual needs at reasonable rates and terms.

Loans may be made for the purchase of feed, seed, fertilizer, replacement equipment and livestock, and for other essential farm and home operating expenses. The interest rate is 3 percent. Repayment schedule depends upon the purpose for which the funds are advanced.

Further information concerning emergency loans may be obtained at the Farmers Home Administration Office, located on the second floor of the Court House in Silverton or at 222 West Broadway, Tulia.

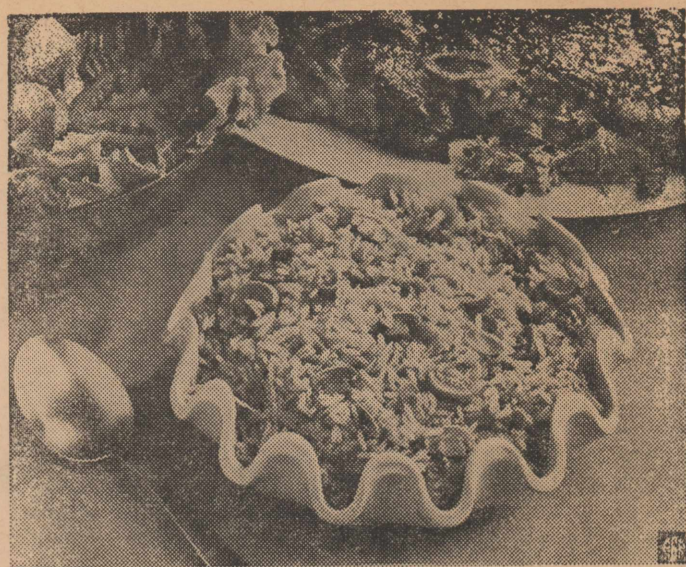

Perfect Partner for Steak

Families in the rice producing states (Arkansas, Louisiana, Mississippi, and Texas) like big, thick, juicy steaks just as much as families in other parts of the country. But what they like to eat with their steak may differ from the steak accompaniments served elsewhere.

As you may have guessed, rice is a frequent partner for steak in the southern states which produce most of the rice used in this country. For example, Mushroom-Almond Rice, a favorite recipe from the files of a Texas homemaker, is often served with steak, and with roast beef, too. It is a savory mixture of rice cooked in beef bouillon with onion, then mixed with sauteed almonds and mushrooms, and it takes lots less time to prepare than it does to broil a thick beef steak.

Indeed, families of the men who produce rice in this country like to eat rice in every conceivable way and rice is kept on hand at all times, uncooked and cooked — the latter stored in their refrigerators and home freezers. They know how easy it is to cook rice and how simple it is to reheat refrigerated and frozen rice. The magic 1-2-1 method of cooking rice, originated in the rice belt, is as follows: Combine 1 cup regular milled white rice, 2 cups water, and 1 teaspoon salt in a saucepan. Heat to boiling, stir once, cover, lower heat. Simmer 14 minutes. Do not peek. To reheat cooked rice, add 2 tablespoons liquid to each cup and cook, covered, for 4 to 5 minutes.

Mushroom Almond Rice

- 1 cup chopped onions
- 4 tablespoons butter or margarine
- 1 cup uncooked rice
- 2 cups beef bouillon
- 1/4 teaspoon pepper
- 1/2 cup sliced almonds
- 1 can (4 1/2 oz.) sliced mushrooms

Cook onions in 2 tablespoons butter until tender. Add rice and continue cooking until golden. Add bouillon and pepper. Stir well. Heat to boiling. Cover pan, reduce heat and simmer 15 minutes or until liquid is absorbed. Saute almonds and mushrooms in remaining butter. When rice is tender, add almonds and mushrooms and toss lightly. Makes 6 servings.

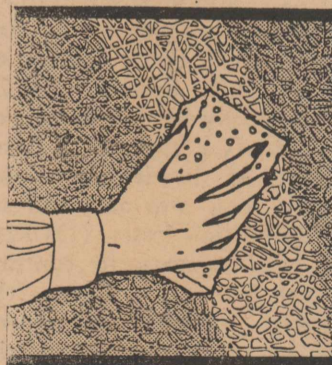

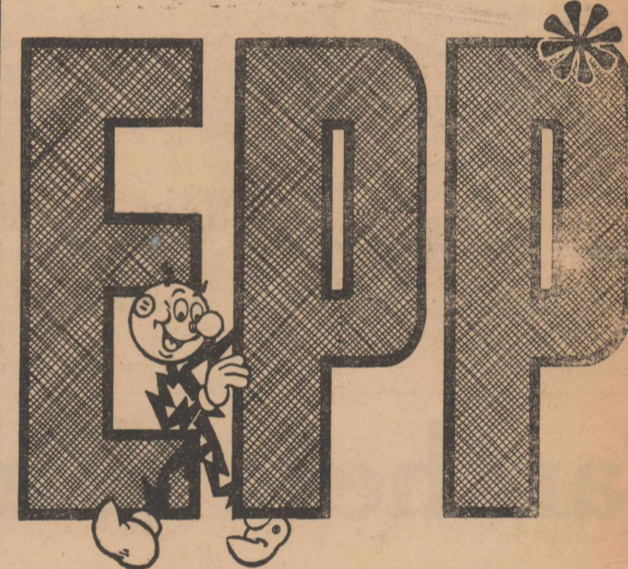

CONGRESSMAN WALTER ROGER'S WASHINGTON REPORT

POLITICAL CROSSROADS

The 89th Congress convening in the early days of January, 1965 will face many problems. Some will be national, some will be international, some will involve local domestic matters. One of the most important from a domestic standpoint, in my opinion, will be some affirmative action to bring the people the truth, the whole truth and nothing but the truth on issues and matters concerning the political life of this nation.

The recent election should have brought into clear focus in the minds of all honest, fair-minded Americans that attempts were made to mislead and misguide the average citizen. This was done by misrepresentation, misstatement, distortion of fact, innuendoes, unfounded insinuation, deliberate falsehoods, and malicious lies. In many instances it was being done by groups or organizations engaged in the

business of peddling hate for dollar bills. Some of these supposed organizations were nothing more than one individual or small group organizations plagiarizing statistics gathered by legitimate organizations, distorting these statistics and facts, and selling them at a profit to hate-oriented and misguided individuals. In many instances these same individuals were called upon for substantial contributions which were received with glee and laughter by the con men spreading their propaganda.

Many of the candidates in the recent election resorted to these same tactics of misrepresentation, misstatement, falsehoods and lies in an effort to gain public office and trust. Some were undoubtedly successful, but a large majority were not, for which the country can be thankful.

The question is, what can be done about it? On the national level, in the national Congress, something can be done about it because the House of Representatives can determine the qualifications of its own members. It can investigate the activities of the election and can refuse to seat a person pursuing such tactics. In my opinion the Congress of the United States should establish an effective and active Fair Campaign Committee with proper authority to stop this cancerous growth which is eating at the vitals of the political body. This should be done before it is too late.

I expect to propose a procedure and provide further for the full disclosure to the public of all the facts and the truth associated with particular activities. Another method should also be provided with which to attack this problem. I refer to effective Federal libel laws, which will be difficult to write but which can be written. These laws should deal not only with the problem of civil libel but should also provide strong penalties from a criminal standpoint.

The recent decisions of the Supreme Court would indicate that when a man presents himself for public office he becomes a prime target for any kind of malicious slander or libel that anyone wants to hurl at him, the basis being that when he announces for public office he opens himself for any kind of vilification, unfair criticism, slander and libel that anyone wants to direct his way. This should not be the law and in my opinion is not the law as intended by the founders of this

nation. Every individual should be responsible for his actions regardless of who or they are directed at or why. Unless this responsibility is the same with regard to a person in politics as it is with a person who does not desire to seek public office,

it will soon be impossible to acquire the services of any honest, law-abiding, God-fearing, educated person to accept public trust for fear of personal character assassination or injury that might be done his family and loved ones.

Apricot Delight . . . Happy-Day Dessert



Whatever the happy occasion — birthday, shower, anniversary, or plain or fancy family get-together, Apricot Delight is the dessert to make it more memorable. Time was when marshmallow creme had just two major uses — as an ingredient in fudge, and as a topping for sundaes. These days the clever homemaker uses it in a variety of dishes — as an ingredient in frostings, meringues, confections and desserts such as Apricot Delight; as a topping for numberless dishes ranging from baked sweet potatoes to fruit salads; as a sauce when thinned with a little water. It keeps beautifully on a pantry shelf at room temperature; an extra jar or two; in addition to the one required for Apricot Delight, is not likely to stay there long, however.

APRICOT DELIGHT

- 1 envelope unflavored gelatin
- ¼ cup cold water
- 3½ cups (1-lb. 14-oz. can) peeled apricots, drained
- 1 7-oz. jar Kraft Marshmallow Creme
- ¾ cup (6-oz. can) evaporated milk, chilled, whipped
- Ladyfingers, split, cut in half crosswise
- Chopped nuts

Soften gelatin in cold water; dissolve over hot water. Puree apricots blend in marshmallow creme. Add gelatin; chill until slightly thickened. Fold in whipped milk. Pour into a 9-inch spring pan lined with ladyfingers. Top with nuts; chill until firm.
