## Lara Conviction Upheld By Appeals Court

The Third Court of Criminal Appeals has upheld all decisions and sentences made in the conviction of Luther Lara for the murder of a Robert Lee woman.

Lara was convicted in a jury trial on March 3, 1983 in the 51st District Court before Judge Royal Hart for killing Victoria DeLa-Cruz Ortiz. He was sentenced to 70 years in prison by a Coke County jury.

Defense Attorney Richard C. Abalos appealed Lara's conviction on the grounds that Judge Hart improperly overruled his motion that Lara's trials on the four indictments, stemming from the shootings, be tried simultaneously, and that the court committed a fundamental error in its instruction to the jury offering four choices in the trial: murder, voluntary manslaughter, aggravated assault and acquittal. Abalos felt the instructions should have offered a choice between murder and aggravated assault, and that the instructions violated Lara's rights.

The appeals court ruled against Abalos on both issues.

Lara remains in the Tom Green County jail awaiting trial on the charges of attempted murder, aggravated assault and attempted capital murder. one basket

A sampling of rain reports around the area included a 2.25 reading in northern Robert Lee and 2" on the Cumbie Ivey ranch between Robert Lee and Bronte.

J.E. Quisenberry, who keeps the official rain total for Robert Lee reported 1.95 inches. Ben Boykin had 1.9 inches of rain on his place between Robert Lee and San Angelo, while Finis Millican received 2.0 at Edith.

In Bronte, H.J. Winchester gauged 1.9 inches, the Chadbourne Ranch, north of Bronte had 1.9 inches and west on the Duncan Ranch, 1.8 was recorded.

Don Edmiaston's place, east of Bronte received 2 inches and 1.63 inches was recorded at Tennyson.

Boykin was pleased with the rain and felt that the recent freeze didn't damage his wheat extensively. "The wheat is growing good," said Boykin. It didn't hurt my wheat like I thought it would."

Soil conservationist Don Fields added, "I haven't been out of town yet, but I know it will do some good. We'll know in a few days how bad the freeze hurt the wheat."

Fields said that the ASCS office can make a better determination of the effects of the recent weather after the moisture dries.

Tommy Antilley, Coke County
Extension Agent for Agriculture,
said rains around the area ranged

from 1-2 inches. "It's sure going to help the sheep and goats," said Antilley.

"The weeds and range grass were sitting close to the ground and this rain will bring them up he said. "We'll need more later to help the permanent pastures." Antilley said that the ground was becoming quite dry again. "For no more rain than we got, it wet the ground real good," he said.

The county agent was also concerned that the range forage was in danger before the rain. "The dry conditions and the freeze (in December) fluffed up the ground and the livestock was pulling it (forage) up by the roots," he said. "The rain did a good job of packing the ground back down. It will also help the grain hurt by the freeze. We would have lost the small grain," Antilley said.

Antilley said that he was hoping for good weather the rest of the week. Sunshine is needed to bring on the grass started by the rain, he added.

"The biggest benefit to this kind of rain will be to the winter weeds and range grass," Antilley said.

Most ranchers' herds are small now after last summer's drought forced them to sell off low producers and weak segments of the herd. "Most everybody culled down their herds," said Antilley. "With this rain, most will be in good shape (to support the livestock remaining)".

He added that the area still needs good spring rains to have an adequate supply of range forage.

## Gas Leaks Discovered At West Coke Hospital

Numerous gas leaks in the main supply pipes leading to the West Coke County Hospital and Nursing Home caused concern for patients and residents Monday, but a major evacuation was averted.

According to hospital administrator Charlzie Treece, the gas leaks were discovered Friday by Lone Star Gas personnel in a check of the buried lines leading from the meter to the hospital.

Treece said that an evacuation would have been necessary if repairmen had found it necessary to cut off the gas leaving the facilities without heat.

It was decided instead to run new lines and bypass the old ones, said Treece. "We are going to have to replace all of the buried gas lines," said Treece. "It will be less expensive and more effective to put in all new lines. That way, we know that we are safe."

Treece said that the leaks probably began with the cold weather. "We checked the gas bills from November forward and realized that a lot of gas had

leaked out," said Treece. "The expense of the gas is so much that stopping it will pay for new pipes in a couple of months and we won't have to repeat this."

According to Treece, Gaetjens Plumbing of San Angelo is installing the new lines and a representative explained that the extreme cold weather accelerated the deterioration of the lines. The pipes were apparently not treated properly when they were put down, said Treece. "The leaks started primarily at the joints and every pipe has leaks," she said.

Some residents of the nursing home were sent to relatives in anticipation of shutting off the gas, but it wasn't required. "We would have had to use electric heaters to keep the residents warm and that is just too expensive," she said.

"We like to take precautions," Treece said. "I've seen problems like this in other places. It is better to use an ounce of prevention. We wanted to prepare for any eventuality, so we came up with a plan to use if we had to."

Treece expects the work to take approximately 2-3 weeks.

### **DÉALING WITH** COLD-DAMAGED LANDSCAPE **PLANTS**

Record-breaking cold temperatures have caused devastating damaged to ornamental plants over much of Texas.

Excessively low temperatures over a prolonged period with little or no accompanying moisture caused damages and losses that will be remembered for many years.

He lists some of the most frequently asked questions about freeze-damaged plants and the best courses of action for homeowners:

1. Should I cut back plants that appear dead?

Tropical and herbaceous plants that appear dead probably are and can be cut back or removed immediately. Woody shrubs, broadleaf evergreens and trees that appear damaged are best left unpruned until they leaf out in the spring or when a definite assessment can be made.

2. Why can't I prune off the apparently dead growth now?

Pruning tends to stimulate new growth which could be easily damaged again by typical winter cold spells.

3. The leaves are falling from my live oaks-- are they dead?

Probably not. Live oaks often lose their foliage in mid- to late-winter just before new growth appears. This bare, dormant period likely will be longer than usual this year but not permanent!

4. Can I replace my dead plants Now?

Yes, but look for split bark and other freeze damage on plants in containers. Plants in containers are more susceptible to damage than those in the landscape, and if they have not received cold

protection, their root systems may be damaged or killed. Texas nurserymen have sustained severe damages and are making a concerted effort to restock with healthy, undamaged plants for winter and spring planting.

5. When will I know for sure if my plants are dead or alive?

It may be next summer or even later before all damage is evident. Damaged roots and stems may have sufficient conductive tissue to maintain a plant until it comes under stress from excessive heat or lack of water during the summer growing season.

6. What can I do to help my injured plants?

Be sure they have adequate moisture. This may mean irrigating plants in mid-winter. Apply nitrogen fertilizers in late winter and water them in thoroughly.

### NEW WTU RATES RECEIVE APPROVAL; NOW IN EFFECT

New rates for West Texas Utilities Co.'s retail customers have received final approval of the Public Utility Commission of Texas, and are now in effect.

The rates are designed to provide an annual revenue increase of \$11.97 million. The company, in its rate request filed last June 10, had asked for \$26.5 million.

Although the change means a 5.2 per cent increase in total retail rates, the current effect will be a decrease for customers who have been paying temporary rates the past 21/2 months. WTU had started collecting interim rates, as allowed by law, on Oct. 22 from all customers except those in 30 towns whose cases had been appealed to the PUC.

Because the final rates approved by the PUC are lower than the temporary rates, WTU will refund the difference plus interest. This will be done by crediting customer bills and should be accomplished during February and March.

Cash refunds will be mailed to customers who have moved off WTU lines or transferred to towns where the interim rates were not in effect. These checks will be sent to the customer's last known address.

If these customers have not received refunds by April 1, they should contact their former local WTU office.

Amount of refunds will vary according to the size of the customer bills. For example, for a

### **MEDICINE MIX-UP**

Combining different drugs inside the human body can produce some unusual reactions. Sometimes drugs are prescribed so they will interact in a certain way and produce a desired result. But mixing medicines haphazardly, without adequate knowledge, can result in an unexpected and dangerous drug interaction.

Drugs interact in a number of ways. One drug may make another act faster or slower, or more powerfully, or less powerfully than it normally would. In addition to drugs interacting with each other, combining drugs with certain foods may also produce undesirable results. This is because food also contains natural and added chemicals that can react with certain drugs in ways that make drugs virtually useless or may trigger a medical crisis. A major way food affects drugs is by enhancing or impeding absorption of the drug in the bloodstream. This is why your doctor may tell you to take certain medications on an empty stomach, others just before meals, and some with meals.

Alcohol should not be mixed with any drug, but becomes especially dangerous if mixed with antihistamines, sleeping pills, tranquilizers or antidepressants. This causes extreme drowsiness, which can be fatal if driving a car or operating


Aspirin and aspirin-containing products will increase the bloodthinning effects of certain drugs prescribed for heart disease, which, in turn, will increase the risk of hemorrhage. Aspirin also should not be taken with prescription drugs for diabetes, gout or arthritis except under doctor's advice and supervision.

Some antibiotics (like tetracycline) should not be combined with milk, cheese, or yogurt. The calcium in these foods greatly decreases the body's absorption of the drug. Combining tetracycline with antacids (for indigestion) or iron compounds will also decrease the effectiveness of the

Always ask your doctor or pharmacist about possible drug interaction problems. Also, read all label and insert information on drugs you buy. In general, it is unwise to take drugs with soda pop or acid fruit or vegetable juices unless you check with your physician first. These beverages can result in excess acidity that may cause some drugs to dissolve quickly in the stomach instead of the intestines where they can be more readily absorbed into the bloodstream.

"These checks are up a whopping 39.5 percent over last January's payments," Bullock said. "A big part of that increase came because 15,000 taxpayers who previously only paid taxes four times a year started paying every month and we got their money back to these 980 city halls that much quicker. But some of the increase is due to the economic recovery we're seeing in Texas."

Bullock explained the 15,000 quarterly taxpayers were converted to monthly payers as a part of a program of the last Legislature to get more money into the state's coffers without increasing taxes.

Houston received the largest check-- for \$8.2 million-- up 28 percent over \$6.4 million last January. Dallas' payment was \$5.4 million,

OSTEOPOROSIS ALERT FOR WOMEN

COLLEGE STAION--- More than five million women suffer from osteoporosis.

Yet a recent national survey shows that 77 percent of all women in the United States know nothing about this degenerative bone condition, says health educator Dr. Mary Ann Huessner.

Osteoporosis is a disorder which causes bones to lose calcium and become thin, weak and brittle, explains Huessner, who is a specialist with the Texas A&M University Agricultural Extension Service home economics program.

National figures show that osteoporosis affects one out of four postmenopausal women.

Complications resulting from osteoporosis are the twelfth leading cause of death in the United States today. The condition has also been directly linked to more than 200,000 hip fractures suffered by American women each year.

With awareness and understanding, this "silent epidemic" can be controlled, says the specialist. Preventative measures include a calcium-rich diet, consistent aerobic exercise, and when appropriate, hormone replacement therapy.

Women should inform themselves about osteoporosis and talk to their doctors about means of treatment and prevention, Huessner says.
