# Steers win District 16-A, set for playoffs

The Robert Lee Steers boys basketball team packed away the District 16-A championship Tuesday night and turned their eyes to the upcoming state playoffs.

The Steers sealed their right to the trophy Tuesday night by smashing the Garden City Bearkats 76-33 before a home crowd after avenging their only district loss with a 48-33 decision over the Forsan Buffaloes last Friday

Robert Lee ended the regular season with a 21-3 record overall and 7-1 in loop play. The girls also fared well last week as they upset 16-A frontrunner Forsan 44-42 and then tripped Garden City Tuesday by a 54-35 score. They end the year at 14-9 and 5-4.

Kirby Rasco, who has been averaging 12.5 points per game this season, doubled that output Tuesday with 24 points to pace the Steer effort. Rasco is also the top man at the free throw line with a 64 percent proficiency and is No. 2 in assists with five per Rasco hit nine points.

Greg Grim reached double figures Tuesday with a 12-point Friday, Grim scored seven

Tuesday were Larry Palmer and Bobby Boone with 10 each. Boone was the top scorer in the win over Forsan with 17.

Boone has been close to the top of the list in scoring with a 12.3 average and is the leading rebounder on the squad with 11 per

Rasco, Boone and Grim are all starters and will return next year for their senior season along with No. 1 reserve, Douglas Roberts, who had five points against Garden City.

Also starting this season are Jimmy Skinner and Eddie Hood.

Tuesday Hood scored seven points against the Bearkats and hit double figures against Forsan with 11. Hood is tops in assists on the squad with six per game and

game. In last Friday's game, hits charity shots 60 percent of the time while averaging six points per game.

Skinner contributed five points output which eclipes his seasonal in the Garden City game and average by five points. Last added four to the win over Forsan. He is just behind Boone on the boards with nine rebounds Also reaching double figures and averages 6.5 points per game. # Lara assessed additional 35-year prison sentence

Luther Lara, who was convicted of murder in the Sept. 7, 1982 shooting death of Victoria Delacruz Ortiz, confessed Tuesday in San Angelo to three more charges that were pending against

Lara, 37, who was convicted of murder and sentenced to 70 years in prison after a March 1983 trial, saw 35 years included in his jail term Tuesday for the attempted capital murder conviction. The sentence will run concurrently to the 70 year term.

The attempted capital murder sentencing came as a result of the wounding of state game warden Sparks Burdett in the same incident that took the life of Mrs. Ortiz. Lara also admitted to attempted murder and aggravated assault charges which stemmed from an incident following the shootings. Burdett's father,

Albert Burdett, a San Angelo police office, was shot at as Lara was leaving the scene.

There will be no legal proceedings on those confessions.

The incident occurred when Mrs. Ortiz went to Burdett's home seeking protection from Lara after a quarrel. Lara followed her and entered Burdett's house where he shot Mrs. Ortiz and Burdett and then, as he left. fired at Albert Burdett who was outside.

In the proceeding, which came before 51st District Court Judge Royal Hart, Lara's probation in a 1978 rape conviction was also revoked and he was sentenced to three years in that case.

Lara has 30 days to file an appeal on the revocation of probation after which he will be sent to the Texas Department of Corrections in Huntsville.

# preparations continue

Stock show

Preparations continue for the Coke County Livestock Show which will be held Feb. 17-18 in the county show barn in Robert Lee.

Stock show directors are talking with past contributors to see if they want to continue their support of the show. According to County Extension Agent Tommy Antilley, anyone interested can send a donation to the County Extension Office, Box 618, Robert Lee or come by the extension office at the Coke County Courthouse. Antilley said that some of the larger contributors can bid on animals themselves.

The procedure for the premium sale is that the directors take the money collected and pool it. They divide it up and bid on each of the top 50 animals in the premium sale. The remainder of the animals are divided into three groups, equally according to placing, and awarded premium money at \$50, \$40 and \$30, respectively.

"The kids keep the animals," stressed Antilley. "It is strictly premium money. They can show their animals at other livestock shows or send them to market.'

Antilley said that show officials expect approximately 200-225 lambs, 75 pigs and nine steers for the show. Judges for the show will be Rex Jones, County Agent for Tom Green County in the sheep division, Denny Belew, agriculture teacher for Tahoka High School in the swine division and Bob Benson, county agent of Mitchell County.

Serving as sheep classifier is Frank Brownfield, agriculture teacher at Colorado City High School and showmanship judge is Rodney Flanagan, agriculture teacher at Ballinger.

### Oak Creek **Fishing News**

The time is at hand to go looking for that trophy bass. This is well known among the ever growing group of dedicated bass fishermen. The next several weeks is the time of year when the ol' big bass will be looking for a place to build a nest and deposit her eggs and the ol' gal won't take kindly to anything that even attempts to interfere. This happens when you throw some kind of a lure near enough to get its attention -- live bait will work, but the odds of landing a six to eight pound bass that you have just made madder than a wet hen on a cane pole, ain't too good.

Check your line for weak spots, nicks or burrs that could cause it to break. If you are fishing where you know there are big fish, use line that will give you at least an even chance to land the fish. If there is brush or weeds to contend with, a light line just won't let you control a big fish. The most common cause big fish are lost is in the way the hook or lure is tied. You not only lose the fish but a three dollar bait, and even worse, the only one you have in your tackle box that's working on that particular day. Make sure your drag on the reel is set right... It's happened several times, but last fall I lost a big fish just because I did not take the time to set the drag on my reel. The drag was too tight and the fish was large enough to pull the rod tip down under the water before the hook gave under the force. In more than 25 years of fishing, I have hooked only a few fish of this size and its a shame to lose it just because of a simple mistake.

The fishing activity is beginning to come alive and it's because of what we have been talking about. It's time to be looking for that ol' trophy bass if that's the kind of fishing you like to do. Bass fishermen from all across West Texas are already making plans to fish Oak Creek later in the year, and with good reason-- they know there are some trophy fish to be caught.





#### by Tommy Antilley **CONTAINER PLANTS NEED** PROPER WATERING

The Extension Way People Helping People

Improper watering is probably the most frequent cause of failure with container plants, whether indoors or on the patio.

Over-watering causes more damage than under-watering. Too-wet soil damages plant roots and causes upper leaves to turn light green or yellowish and die.

Before watering, make sure soil is completey dry at the surface, particularly with large containers where roots in the bottom of the pot may still be moist enough to grow.

Since soil in a clay pot will dry more rapidly than in a plastic or metal one, let the soil become "dusty-dry" at the surface before watering plants in non-clay

When the soil is dry enough to water, set the entire soil mass and allow the excess water to drain out.

For containers with no drainage, watering becomes an art. A container that holds one quart of soil will probably require one-half pint of water to adequately moisten it without waterlogging the roots. Use only distilled water or rain water for plants in containers with no drainage.

Larger containers with no drainage present more problems. It is suggested to place a 3/8 inch copper tube into the soil when planting so that one end extends to the bottom of the container and the other end if above the soil. This allows use of a dipstock to check the water level. A baster such as used in cooking can be used to draw out excess water.

Saucers used under nots t catch excess water should be emptied to keep soil from becoming waterlogged and to prevent accumulation of soluble salts in





# Game warden applications being accepted for fall 1984 academy

AUSTIN-- Law Enforcement officials of the Texas Parks and Wildlife Department will accept applications during February for the next Game Warden Training Academy which will convene here in the fall of 1984.

Officials stressed that applications will be accepted only during the month of February 1984.

Completed application forms must be received by 5 p.m. Feb. 29 to be eligible. They may be obtained from Parks and Wildlife Department field offices, Austin headquarters at 4200 Smith School Road, Austin, TX 78744, or by calling toll-free 1-800-792-1112.

Extensive interviews and background investigations will be conducted before the successful applicants are announced. The exact number of cadets to be accepted will not be announced until later, but enrollment normally is limited to approximately 35, officials said.

Applicants must be at least 21 years of age upon commissioning, be in good physical condition, be a high school graduate or have passed a GED equivalent, have vision correctable to 20/20 and have a record free from driving while intoxicated, driving under influence of drugs or felony convictions.

After completion of four and a half months of intensive training, the graduates may be assigned to duty anywhere in the state.




According to Millican, "we usually have several burglaries this time of year. People don't come down as often and when they do, they find their houses broken into.'

**Deleting existing Section X and** adding a new Section X to the Ordinance governing the rules and regulations of E.V. Spence Reservoir adopted by the Board of Directors of the Colorado River Municipal Water District December 3, 1968, as it relates to use of public areas and trespass-

#### SECTION X **PUBLIC AREAS AND** TRESPASSING

The District shall provide and maintain certain areas along the shoreline of the reservoir as public areas for recreational purposes. Such areas will be clearly designated as "public areas" with public fishing, swimming, picnicing, camping and boat launching confined to those areas and the shoreline waters adjacent thereto. All other public use of District owned lands lying below elevation 1900 feet and the water's edge shall be unlawful. Any use of the shoreline (except in designated "public areas") by the public in engaging in any activity, including but not limited to the above stated recreational activities, is prohibited and shall be an unlawful trespass upon such shoreline.

Provided, however, that this section shall not apply to the Colorado River Municipal Water District, its employees and authorized representatives in the enforcement of the District's Rules and Regulations governing the Robert Lee Reservoir, and in carrying out its functions of maintaining said Reservoir and its watershed.

Further, this section shall not apply to the owners or lessees of shoreline property above elevation 1900 feet, as to their use for recreational and other authorized purposes of District land lying below elevation 1900 feet and the water's edge which is bounded by a projection of their lateral property lines to the water's edge. This section shall not apply to those persons having the consent of the owner or lessee to use such property described, however, in any prosecution for violation of this Section, the burden shall be upon the alleged trespasser to prove the consent of the owner or lessee of said property. The exemption herein provided shall in no way authorize any person to go upon the land of another and shall in no manner repeal or annul the applicability of the remaining provisions of this act as they relate to the use of said Reservoir, and the lands forming the margin of said waters.

# Intensive grazing systems now important

Range Conservationist, S.C.S.

Many Texas ranchers are discovering that more intensive grazing systems are becoming essential to their economic survival. Although the type of system used may vary a great deal, all have as their goal making the most efficient use of the grazing resources. Ranchers and stockfarmers alike, are looking for sustained high yields from their livestock and wildlife combined with protection of their most precious resource - the soil.

A well designed and operated grazing system should permit range improvement while increasing livestock production. Usually, livestock are the main harvesters of the forage produced and are the chief source of income on the average Coke County ranch. As rangeland carrying capacity is increased and the number of livestock on the ranch can be increased also, then many of the costs of ranch operation go down on a per head basis. In recent years wildlife income from hunting leases has become more important in this area. Grazing systems, as an extra benefit, usually improve wildlife habitat also, which may make their use more valuable. There is usually more pure profit per acre from wildlife than from most other ranching alternatives.

A grazing system consists of two or more pastures which are alternately grazed and rested in some type of planned sequence over a period of years. Many ranches in this area also utilize cropland planted to temporary summer or winter forage crops in their grazing system. Summer pastures especially, such as forage sorghums or Sudan, can be very beneficial to range im-

king rates during normal rainfall years. Summer pasture stocking rates are usually quite high and their use allows for valuable summer and fall deferment of native pastures which is essential for range condition improvement. Winter grazing is usually 'less harmful to rangeland than summer use, so ranchers should plan to utilize their lowest condition ranges during the dormant winter months and rest them during the growing season which will speed up pasture improvement.

Several factors should be taken into consideration when planning a grazing system. Probably the most critical is the manager's attitude. A higher level of management is required in almost any system and more record keeping - a chore despised by many ranchers. If a high intensity - short duration type of system is chosen more labor may be required. An early step in the planning process is to take a forage inventory of the ranching operation. Vegetational characteristics of the ranch or farm need to be considered, such as type of forage produced (cool or warm season grasses, crops, etc.); the presence of poisonous plants in some pastures (oak, sacahuista, etc.); or pastures heavy in plants damaging to wool or mohair. Physical aspects of the ranch need to be considered, such as topography, water, pens, and potential pasture carrying capaci-

A good grazing system allows range plants to recover from close grazing, make seed, regain vigor, and build up food reserves. The livestock are naturally a very important part of any system and your schedules for breeding; lambing, kidding or calving; and



lows better overall management.

GRAZING SYSTEMS BENEFIT both the livestock and the range. Crossfencing large pastures al-

livestock working operations need to be considered.

Be flexible in your system and keep it simple. Many Southwestern ranching experts now recommend keeping your base cow/calf herd at 50 to 60% of the ranch's carrying capacity and using some type of stocker animal to balance out. This gives you more flexibility which is desirable in any ranching operation and lessens the chance of having to cut deeply into your breeding herd during any but the worst of droughts. All of us are aware of the pain of having to cull deeply into a breeding herd that we've become "married" to during years of selection and manage-

Finally, in order to measure the effectiveness of your grazing system, maintain accurate records on all important animal and pasture performance indicators. Good cost/return records will

also be valuable in assessing the status of your operation. The Texas Agricultural Extension Service has a new record keeping book out which should be examined by every operator for possible use in their farm or ranch

business. Coke County Soil Conservation Service personnel will be happy to discuss the various types of grazing systems in use, analyze present ranch conditions and to help design your new grazing system if desired.
