## **Steers defeated** in regional play

Robert Lee's boys basketball season ended Friday night at South Plains College in Levelland when the Steers fell to Sundown 50-42 in the first game of the Class B-Region I Tournament.

The loss capped a successful season that included the District 16-A championship and a 25-5 record under basketball coach Ed Poehls.

Neither the Steers nor Sundown played well in Robert Lee's final outing, according to Coach Poehls. "We shot 35 percent from the field -- six percentage points below our average," he said. "Our free throw shooting was also below average."

"We were way too passive," Poehls said. "We didn't take the ball to them enough.'

But Sundown had troubles of its own. "They had a lot of foul trouble and didn't do well in the second and fourth quarters," said Poehls. "We outscored them in the second and fourth." Sundown also outrebounded the Steers 24-10 as Jimmy Skinner led the Robert Lee effort with five.

The Steers ran into problems in the first and third periods. "Neither one of us scored in the first four minutes of the second half and then Sundown hit several in a row" said Poehls. "After that, they (Sundown) settled down." Robert Lee scored four points in the third quarter after going into halftime trailing 20-19 with a 13-point second-period effort.

Leading scorer for the Steers points and Kirby Rasco was close added three and Gary Palmer hit

was Jimmy Skinner with 11 with 10. Bobby Boone hit eight, Eddie Hood and Greg Grim scored four each, Darryl Mulkey two points.

"I want to compliment the kids for their hard work and dedication throughout the season," said Poehls. "We also appreciate the parents' efforts and backing during the year.'

### **Bivins, Gardner named Child Welfare Board**

The Coke County Commissioners Court met in a regular meeting March 5. The court was called to order by County Judge Aubrey Denman and the Pledge of Allegiance to the Flag was led by Commissioner Millican.

Item one on the agenda was the appointment of Child Welfare Board members to fill the vacancies created by the resignation of Ron Exum and Leta Caston. Commissioner Newby motioned that Gary Bivins and Rodney Gardner be appointed to fill these vacancies. Commissioner Millican seconded and all voted in favor of these appointments.

Item II - The motion was made by Commissioner Tidwell and seconded by Commissioner Millican to participate in the establishment of the Juvenile Detention Center to be built in San Angelo, by paying to San Angelo an annual fee of \$600.00 plus approximately \$50 per day per person when Coke County uses the facility

by Commissioner Luckett and it was seconded by Commissioner Newby that Coke County participate in the Women, Infants and Children (WIC) Supplemental Food Program which provides nutritious foods for pregnant and nursing women, infants and children up to the age of five years who qualify under this program. The vote was unanimous.

Item IV - A letter was read by Judge Denman concerning a grant which Coke County has applied for to update the airport board in Robert Lee and it was the desire of the Commissioners that plans proceed toward the securing of this grant in the amount of \$25,000.00.

Item V - The monthly reports of Tommy Antilley and Debbie Reber were presented for the courts review and they were approved on the motion of Commissioner Newby with Commissioner Luckett seconding the motion. All voted in favor of approval. Item VI - The possibility of economizing on the electric bills, by placing a heat pump in the County Attorney's office to be used at night and on weekends instead of the present heating and cooling system was discussed. The County Attorney, Billy Helwig has offered to pay onehalf of the cost of the heat pump which is estimated to cost approximately \$600.00 for a 13,000 BTU unit. Commissioner Millican made the motion that the county purchase and install this unit with the County Attorney paying onehalf the cost of the heat pump. The motion was seconded by Commissioner Luckett and all voted in the affirmative.


### More than 100 attend musical





Joe Ash has recently completed the construction of a crossfence and a pond for livestock and water on his ranch east of Bronte. Dividing the larger pasture will enable each pasture to be rested a part of the growing season each year. This will help grasses such as K.R. bluestem and sideoats grama develop strong root systems and produce more high quality forage. A good cover of grasses such as these help prevent soil erosion and allow more water to soak into the soil.

The pond if 18' deep, and consists of about 5300 cubic yards of storage. These are a few of the practices Ash is applying in his land improvement program. Cost-share will be received on the pond as a part of an LTA contract through the ACP program.

Have you been looking for a way to reduce your feed bills? Mary Colvin of Blackwell has what she believes to be an answer. "You need to have the right number of cows for your place, and move them between pastures", says Mary. She adds that "my cows do better, and the grasses have a chance to grow. Fitness - it's the buzz word of the 1980's. It seems that everywhere we hear the advice to exercise, shape up, trim down or keep fit. In the past decade physical fitness has become a high priority goal for countless Texans, young and old, male and female. But in spite of the growing emphasis on exercise and diet, fitness is a goal few people achieve.

How many of us have begun exercise programs at one time or another in our lives? Did our commitment to maintain the exercise last and develop into a healthy habit? Or after losing a few pounds and inches or when the seasons changed or you began to work later did your motivation to exercise regularly just seem to fade away? If so, you're not alone. It's a problem many people experience. How can we deal with the desire to exercise regularly and make it a lifetime habit? Let's consider some guidelines that should help to make fitness a habit that will be hard to break.

Have vou ever experienced the "lead in your feet" syndrome? You're trying to convince yourself that you want to be playing tennis or jogging but your feet won't movel You've probably forgotten to warm up! All fitness programs should include 5 to 10 minutes of warm up exercises before the actual work out or training period. Then following your exercise session a 5 to 10 minute cool down lets your body gradually return to normal and helps prevent muscle cramps and sudden dizziness. In general, the more strenuous the fitness activity the longer and more vigorous the warm up period should be. A warm up period helps to raise body temperature and make the muscles and joints more flexible so they move more easily. It decreases the likelihood of straining or pulling a cold stiff muscle. A good rule of thumb is to use the main principal body joints through their full range of motion. (Refer to Hand-

out 1) Stretching exercises should be done slowly and deliberately allowing the muscles to relax and let go. Vigorous bouncing, bobbing and pulling in an attempt to stretch out tight muscles defeats your purpose. It confuses the muscles by sending out conflicting messages. When doing stretching exercises (for example: bending or twisting at the waist or touching your toes) more slowly; when the first sign of tension occurs, hold that position for several seconds, then relax. Repeat the exercise several times.

The next phase of an exercise program after warm up is called the training period. It's important here to remember that the key to any physical fitness program is to plan a reasonable schedule. Begin slowly, gradually building up endurance and speed. Always avoid overdoing it! If you do too much too soon, your muscles will become sore and there is a possibility of injury. And if your muscles ache the next day, you're not going to want to exercise. Don't set expectations too high for yourself


at the beginning or you'll become discouraged and discontinue your new routine altogether.

Although it's important to push harder as you progress. improvements should be made one step at a time. Muscle cells grow just so fast. Your circulation and breathing capacity will improve just so quickly. Let your body set the pace. If you want to make physical activity a part of your life, make your experiences enjoyable.

The third and last phase of an exercise program is the cool down. This allows the body muscles to relax. Cooling down is really just warming up in reverse. It gently returns your body to a less active state, helps prevent muscle cramps and sudden dizziness. The best way to cool down is to simply slow down your activity. For example, if you've been jogging, walk for a few minutes; if you've been swimming slow down your pace through the water. Or you could do some of the stretching exercises included in handout 1 to cool down. About 5 to 10 minutes should be devoted to cool down. You know you have cooled down enough when your heart rate is back to within 20 to 30 beats of your resting heart rate.
