In another special meeting Tuesday, the commission met to discuss applying for a Concho Valley Council of Governments grant which has been made available that could be used to renovate the old recreation hall in the County Park in Robert Lee.

The polls will be open from 7:00 a.m. to 7:00 p.m. May 5.



This action was followed by CRMWD amending their rules and regulations to where we can be arrested for trespassing, if we even get out of our boats for a picnic lunch on the banks of the

The latest move by CRMWD to ask for an amendment to their original permit, granting them the right to build a lake near Big Spring that will catch 8000 acre feet of water per year that now flows into Lake Spence. We have seen no objection to this request, so we assume the lake will be completed. The water is to be used for mining which we believe means water flooding of oil wells, and industrial use. When this much water is stopped from entering Lake Spence, we believe two of the four boat ramps on Lake Spence will soon become dry and useless.

The original permit states that the water diverted for mining must contain or exceed 500 parts per million chloride, which is salt.

The amended permit contains no such requirement, making it possible for them to use fresh

There is over 14,000 acres of land that they pay no taxes on, but lease it to ranchers when it is not under water. The taxes on this 14,000 acres must be made up by the other taxpayers of Coke

We believe that the two remaining commissioners who helped this happen should be replaced.

Roller chopping and seeding a mixture of adapted grasses was done recently on the Joe Ash farm on his place east of Bronte. About 100 acres was replanted on an area that did not develop a stand when seeded last year. A rake was used to prepare the seedbed. A mixture of Klein-

grass, K.R. bluestem, blue panic, and sideoats grama was seeded and roller chopped. The pasture will be rested for a full growing season. This will give the seeded area an opportunity to develop an adequate of stand of grass and hopefully, to produce a seed crop.

Technical assistance was furnished by the SCS assisting the Coke County Soil and Water Conservation District. Financial assistance was furnished by the ACP through a Long Term Agreement.






