Organizers Working On

A Lifeline program consists of parts: electronic equipment located in the home consisting of a portable help button and home unit linked to the telephone used to summon emergency aid; an emergency response center with 24 hour a day coverage; and people who will agree to respond to a call for help.

The Emergency Alert System is especially useful for the frail, elderly, or handicapped person who lives alone.

trator of West Coke County Hospital, stated that the hospital would serve as headquarters for the alert system.

Participants in the program would wear a small help button and when help was needed, day or night, the button could be pressed to signal the response center without dialing the tele- ' phone. The center would then contact a friend, relative, or neighbor who would check on the caller.

The home unit also has a timer which, when set, could tell the response center a person had not moved or could not be contacted in 12 or 24 hours.

The County hopes to begin the program in Robert Lee by Sept. 1. Bronte cannot participate until January when the city will be equipped with direct dialing service from General Telephone Company. At the present time only those with one-party lines will be able to utilize the Emergency Alert System.

The lease on the home alert unit is \$11.00 per month. For those unable to subscribe to the program, grants may be available for the system. For more information on the financial aid and the alert system, call Judge Denman's office in the County Courthouse.

Many civic organizations and other public service groups across the country are making Lifeline one of their volunteer projects, either financially or as response volunteers.

Lifeline can often mean the difference between an elderly or handicapped person remaining independent at home or being institutionalized. Everyone is urged to give some thought to the Emergency Alert System. A decision to sponsor the response system could spell reassurance and aid for your loved one.

Construction Continuing On New Robert Lee Post Office Building

Spacious work areas will highlight the interior with two rest rooms, a janitor's room, storage area, and private office space. New Post Office boxes will number 1074. A large lobby will contain customer convenience machines.

Visible progress has slowed while electrical contractors are at work inside.

Postmistress Coe Lewis stated that the target date for the finish of the new facility remains at August 15, barring unforseen problems.

Former Sanco Resident **Recalls Past**

EDITORS NOTE: Summer time is usually family reunion time for most folks. A lot of visiting and recalling the past is the main entertainment. Mrs. Vida B. McGee sent a picture and a story to the Observer and we think it is of interest to our readers and those who took part in the recent Sanco Homecoming.

This is under the arbor at Sanco. The young master of ceremony was Pentecost. I brought a picture I've painted of my old home place, the Eugene and Silia B. Austin Fletcher, in the cove of the mountains in the Yellow Wolf Valley near Sanco.

I left here when I was eleven years old, moving to Hobbs, N. Mex. in 1916.

I recall being bitten by a rattlesnake and my grandfather, Jim Fletcher, who lived a quarter mile down the road, came and cared for me until Dr. Turney could be notified by phone in Sanco. The doctor came from Robert Lee in a buggy. I remember all this very well tho' I was only four years old.

I attended school at Sanco along with my brother, riding Old Chunkie part time and walking part time. Later daddy boarded me at his sister, Mrs. Mary Benningfields or at our cousins, the Jack Adkins, for the school term. We sold the place to the

Whiteside Ranch. The picture was painted from memory and I brought it for "show and tell". Not many people living now remember our old place.

I'm the only one left in our family. My grandparents on both sides are buried in the Sanco Cemetery, also, my brother who passed away this past year. Other relatives are buried in Sanco, too. I love returning to Coke Co. and Sanco for these homecom-



EDITOR'S NOTE-Willis and Wanda Smith, accompanied by her sister and husband, Wendell and Betty Jo Lammers of Houston, have just returned from an 8 day vacation trip to the Hawaiian Islands. Below are highlights of that trip.

We left Robert Lee June 7 and flew with Betty and Wendell Lammers from Houston to Dallas for a non-stop flight to Honolulu.

We were on Waikiki Beach for 3 days sightseeing Pearl Harbor, the Arizona Memorial, Punchbowl National Cemetery, old Chinatown, Iolani Palace, the celebration of King Kamekamaha; first ruler of the islands, birthday with the traditional leidraping ceremony. We spent a day long tour of Oahu Island sightseeing mountains, volcanic craters, sugar cane and pineapple fields, cliff diving, and the famous beaches and historical ba ys. The highlight was a dinner cruise around Waikiki with Polynesian entertainment.

June 11, we flew on Mid Pacific Air to Maui, the second largest of the Hawaiian Islands. Here we stayed the remaining time on Kaanapali beach touring the remote regions of Haleakala Crater, a vast sleeping volcano, which is considered dormant (not extinct) because it last erupted in 1790, a relatively recent occurance in geological time. All roads wind along the coastline on the islands acquainting visitors with inter-island mountains with deep canyons, sharp ridges, and wave action carved cliffs going straight to the water's edge. On the road to La Perouse Bay the lava flow from Pu'u Pimoe cinder cone astounded us

volcanic eruptions. Miles of thick, black molten rocks slide from the cone into the bay.

The Lahaina region, which is 3 miles from our hotel, is rich in history. Tradition tells of powerful chiefs living here in ancient times. Lahaina became the capitol of Hawaii in 1820; it remained the seat of government for 34 years until Honolulu took that role.

In the mid 1840's, Lahaina was a popular whaling port with more than 400 ships calling every year. Now it is a National Historical Landmark area.

highlight of our stay was a sunset beachside Aloha Luau. An auth-entic luau encompassing all the, proud traidtion of the Hawaiian people with spectacular Polynesian music and entertainment with hula maidens, and a fire-knife dancer. A buffet with the kalua pig, poi, chicken-pineapple, sweet potatos, and rum punch was included.

During drought conditions, a rancher needs to reappraise his entire operation to look for ways to improve overall efficiency, says a livestock specialist with the Texas Agricultural Extension Service, Texas A&M University System. 




