

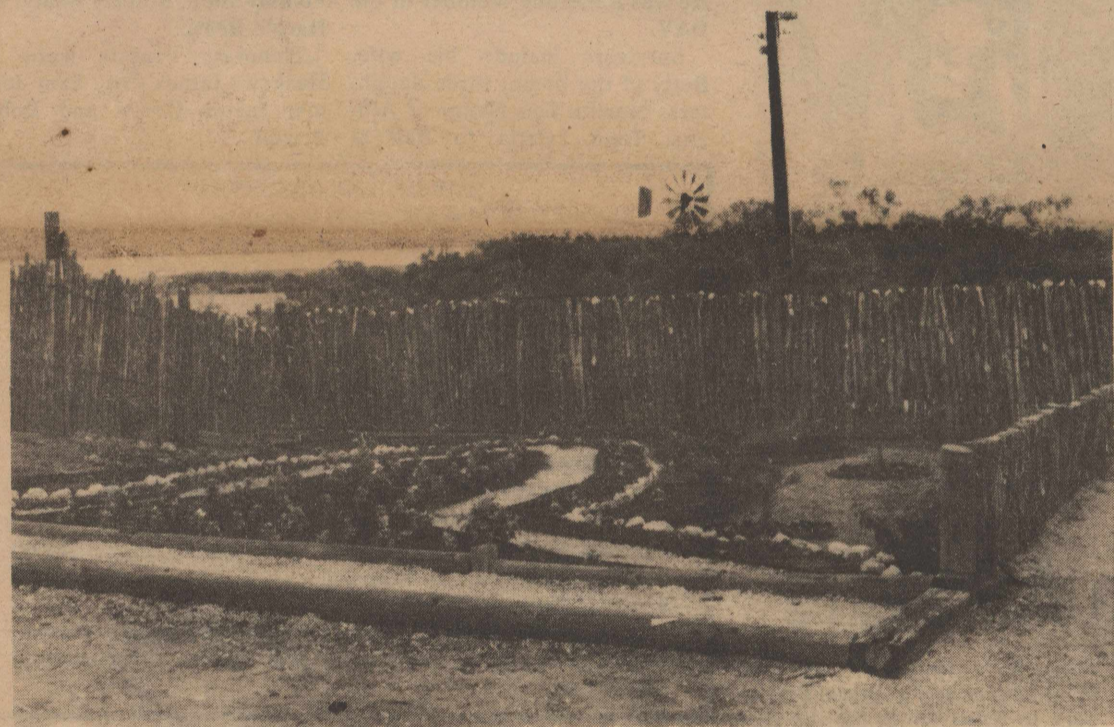

First on the agenda was the opening of bids concerning the renovation of the Robert Lee Senior Citizen's building. The lowest bid was accepted by the commissioners which had been submitted by George Weir of Robert Lee in the amount of \$7,855.00.

## LETTER TO THE EDITOR

Dear Sir:

Your Coke Co. Fishing Guide of May 11, 1984, reminded me to share a bit of information concerning the name of the creek in northeast Coke County referred to as Bouzer Creek. I have seen this spelled "Boozier" and both the SOIL SURVEY OF COKE COUNTY and THE HANDBOOK OF TEXAS call it Brushy Creek.

My mother, Mrs. Richard Copeland, had told me the creek was named for "Uncle Zack" Boozier, and I knew he and his wife Susan "Aunt Sook" (as in look or book) were buried in the Blackwell cemetery, so my husband and I stopped by the cemetery and made the enclosed picture of their marker. Since the inscription is rather difficult to read we made the enclosed rubbing of his birth and death, 1828 and 1919.

Just thought you might find this interesting.

the first state light rifle championships at the 4H Center on Lake Brownwood. On the same day the Brown Co. 4H will host the state smallbone silhouette champion-

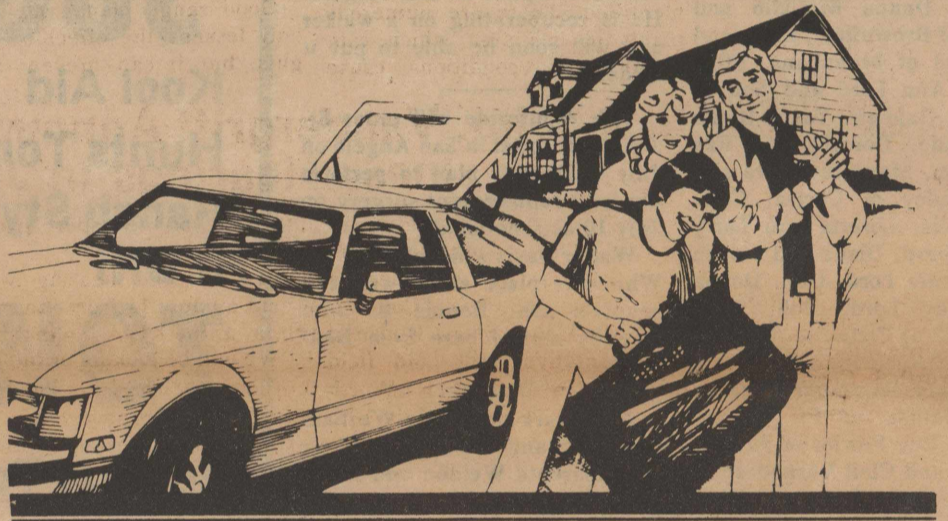

## SOIL CONSERVATION DISTRICT NEWS

**DANGER....POISON!** Probably would be an appropriate title for this column this week. Poisonous plant problems have begun to occur more often than normal in recent months due to the long, severe drought that we are now experiencing. Livestock poisoning from plants is always a problem in Coke County and elsewhere in the Western U.S. One researcher states that a conservative estimate of annual economic loss in livestock in the U.S. is over \$142 million! This amount does not try to account for lowered birth rates, weight loss, birth deformities, reduced longevity of the breeding herd, less efficient use of ranges, fencing, herbicides and other insidious losses due to poisonous plants.

Numerous cases of sheep, cattle (and some goat) poisoning have been reported in this area recently. Vets and range men have identified the following local plants in confirmed cases of poisoning: bitterweed, sacahuista (beargrass), silverleaf nightshade and some other problems where the plant could not be identified. There are numerous plants in our area which can, under certain conditions, cause

losses. Also, some forage crops, such as the sudans, forage and grain sorghums, can under drought stress become toxic. During times like this, hungry or starving animals will eat poisonous plants. Ordinarily livestock would either leave these plants alone or the plants would be mixed into a normal diet of healthy forage and not affect them.

Some of the deadliest poisons known to man or beast are found in some very pretty and innocent looking wildflowers and ornamentals found around our homes, farms and ranches! For example: larkspur, oleander, some lupines, senecios, buttercups, mountain laurel, milkweeds, goldenrods, mistletoe, lantana, ligustrum (privet) hedge, yellow jessamine, hydrangea, iris and poinsetta to name a few.

Very few plant-specific antidotes are available, so it is generally wiser to avoid the poisoning than to try to cure a sick animal. Often, by the time an animal is showing symptoms of plant poisoning, it too late to save them.

Good range management not only lessens the effect of droughts, but it can prevent many

times, losses of livestock to poisoning. By following these general management recommendations often times problems can be eliminated:

1. Don't overuse or overgraze ranges.
2. Don't bed or drive stock into dangerous areas, especially with empty stomachs.
3. Supply adequate salt and nutrients.
4. Don't graze the wrong class of livestock for the poisonous plants on your range (some plants toxic to cattle are not to sheep, etc.).
5. Control or eradicate toxic plants, if possible. If not, control access to them.
6. Plan and use correct watering, salting and feeding sites.

Rotate feeding and salting locations.

7. Graze infested ranges at the least dangerous time.
8. Identify the poisonous plants present on your ranges and learn how to cope with them.
9. Prevent the introducing of new noxious plants (and diseases) by dry-lotting new animals for 48 hours.
10. Feed stock before placing them on a range infested with poisonous plants, especially if they are on an unfamiliar ranch. Hungry animals are careless of what they eat.
11. Improve range condition.
12. Check your stock daily or as often as possible, looking for sick or dead animals. Change pastures and call vet when this occurs.

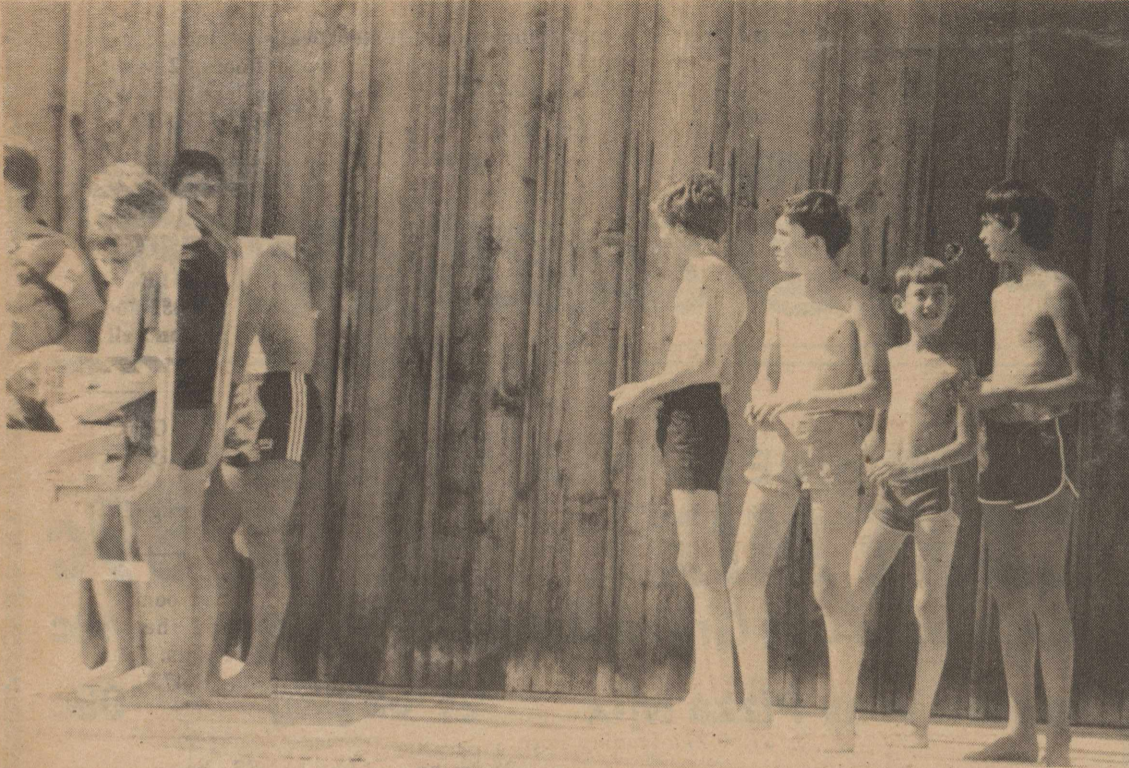

The Robert Lee Baptist Church will hold their evening worship services outdoors at the County Park on Sunday, July 8, at 7:00 p.m.

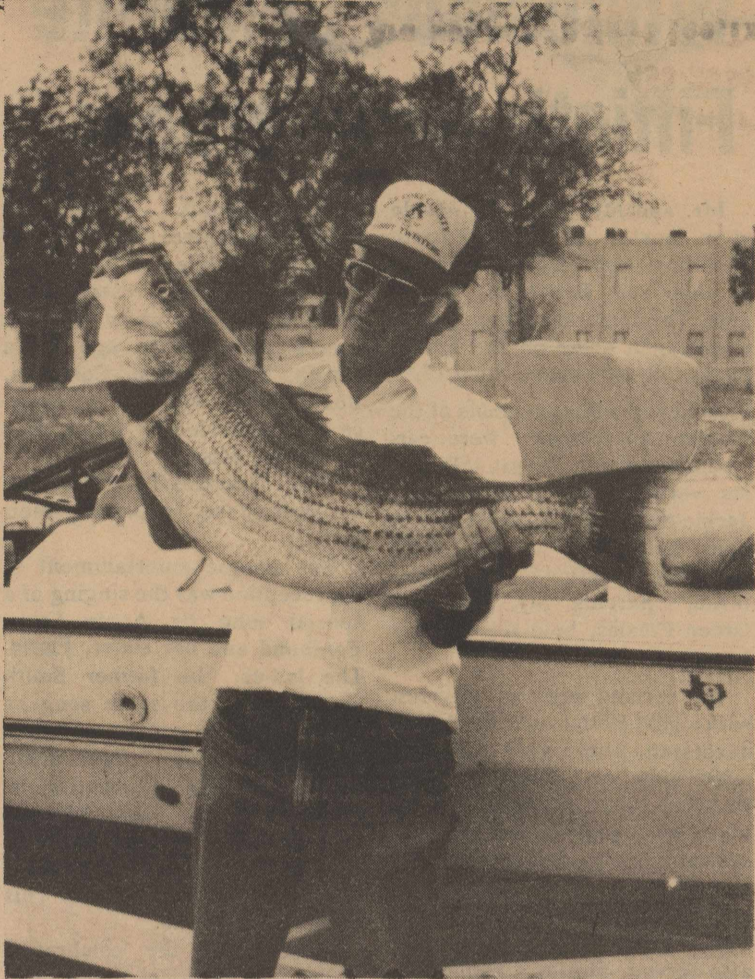
