## Voter registration deadline is Oct. 6

Persons wishing to vote in the Nov. 6, 1984 general election, which includes the Presidential and U.S. Senatorial contests, must obtain a voter's registration card by October 6.

Voter registration applications may be picked up or filled out at the office of O.B. Jacobs, tax-collector-assessor in the Coke County Courthouse, Robert Lee. Mailed applications must be postmarked by midnight of

Oct. 6 for the applicant to be able to vote Nov. 6, or 30 days prior to the election.

There is no waiting period for persons who have recently moved to apply for a voter registration. Persons living on rural routes, or whose mailing address is a post office box must be able to describe the location of their residence to ensure being registered in the proper voting precinct.

The children's slogan is "HELP US LEARN - HELP US PLAY - BECAUSE YOU CARE".

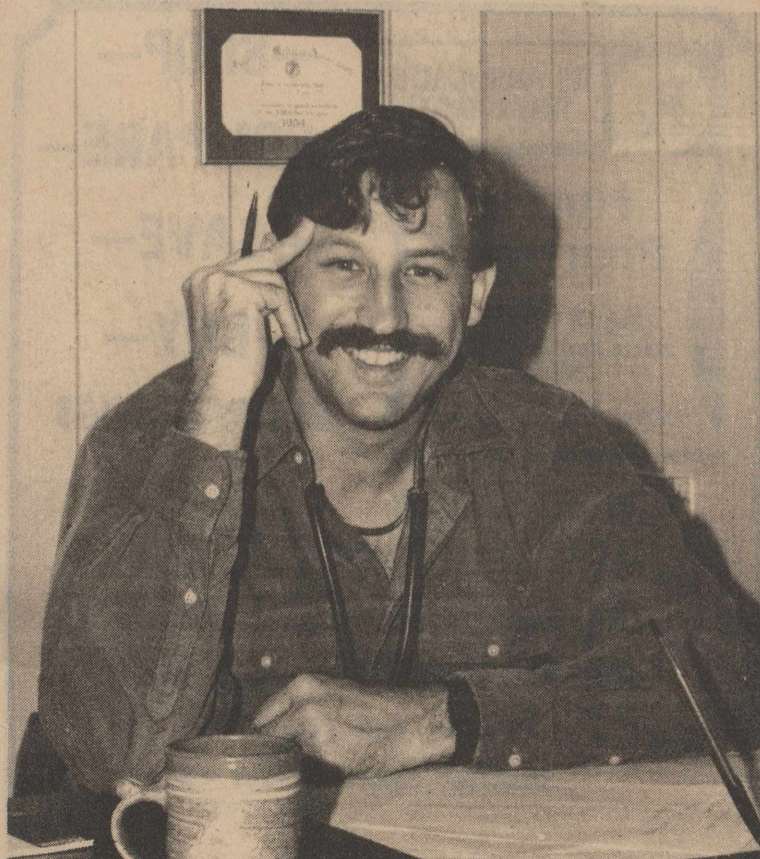
## RL Band Boosters to meet

## Dr. Terry Pulse is new Coke MD

Coke County's new physician, Dr. Terry L. Pulse, has been many places and done many things, but has chosen to return to his small-town, West Texas roots.

A Pampa native, Dr. Pulse has studied everywhere from Canyon to Europe. His most recent venture was with Pulse Care Inc., a minor emergency clinic he established himself. After three years in the emergency room, however, he decided it was time for a "change of pace". He wanted a less hectic existence "and more honest people".

It was Coke County's gain because, though young in years, Dr. Pulse is long in experience and credentials.

He began his college education at Texas Christian University and finished his bachelors of science at West Texas State University at Canyon. He earned his medical degree at the University of Texas Medical Branch, Galveston, and chose a rotating internship with St. Paul Hospital, Dallas, specializing in family practice.

Dr. Pulse did his residency at St. Paul in family practice

and Parkland Hospital in psychiatry and was affiliated with Mesquite Community Hospital during his emergency room practice.

In addition, he has worked with some of the best medical minds in the nation.

He has studied pediatric nephrology with Dr. L. Vernier at the University of Minnesota, St. Paul, and pediatric psychiatry with Stella Chess at New York University's Bellevue Hospital, New York. Chess coined the term "juvenile delinquent" and Vernier literally "wrote the book" on his specialty.

Dr. Pulse has published scientific papers on medical subjects, ghost-written for the late H.L. Hunt, and established his own skin-care company featuring a unique product sold through exclusive outlets in Dallas, Amarillo, Phoenix and London, England.

His professional associations include the American Academy of Family Practice, the Dallas County Medical Society, the American College of Emergency Physicians, and the Texas and

American Medical associations.

His hobbies range from snow-skiing to instrumental music, painting and sculpture, tennis, horseback riding, camping and raising Afghan hounds.

Dr. Pulse will accept appointments at his office in Robert Lee from 9 a.m. to 5 p.m., Monday through Thursday and 9 a.m. to noon on Fridays.

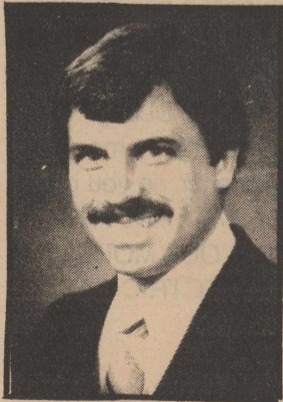

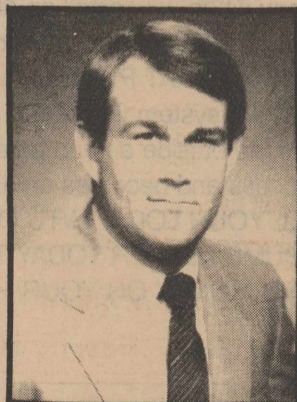

## Steers hold on to first half lead for first victory of season; meet Forsan tonight

The Steers jumped out to a first half lead and then held on for their 1st victory of the year. The 1st half was very impressive as the Steers just about did as they pleased, but when the second half started a cool front blew in and the Steers cooled off. They did well on defense, but the offense sputtered as Loraine held them for 43 yds. total offense in the 2nd half. But there was lots of obstacles as the wind and officiating took its toll on both sides. End of Comment!

### 1st Quarter

The Steers received the opening kickoff with a return to the S.36. The Steers make a 1st at the S.47, but they fumbled the ball and Loraine recovered. But Loraine then runs two plays and they fumble with Grim recovering at the S.42. Then with Loraine thinking run, Rasco flips one out to Grim and with a good cut back behind his blocking, he goes 58 yds. for a Steer TD. The extras fail and the Steers lead 6 to 0. The Steers kickoff to the L.8 with a return to the L.18. Going to the air, Loraine has one picked off by Rasco at the L.40 yd. line. But then Loraine holds and the Steers punt to the Loraine 1 yd. line. Loraine makes a 1st down at their 24, but then the Steers hold and they punt to their 38. The Steers can't take advantage as they fumble and lose it at the L.38. The Bulldogs can't move and on the punt attempt, the snap is bad and they manage to get it to the 38 with the Steers taking over on downs. The Steers make a 1st at the L.27 and another at the 12 as the 1st Quarter ends.

### 2nd Quarter

On the very 1st play, Grim does a little two-step around left end for the score. This

time Boone's kick is good for the extras and the score is 13-Zip. The Steers then get a score as Loraine takes the kickoff from their 28, makes 3-1st downs to the S.12. But the Steers then get tough and hold on downs at the 4 yd. line. The Steers then drive the ball for 4-1st downs to the L.48 where they hold on downs. The Steers then hold and Loraine punts to the S.27. The Steers move again with 2-1st downs to the L.21. Then Rasco tosses one to Bobby Boone in the end zone for another TD. The extras fail and it is now 19-Zip. The Steers kick off with a return to the L.13. Rasco then intercepts another pass as the half ends.

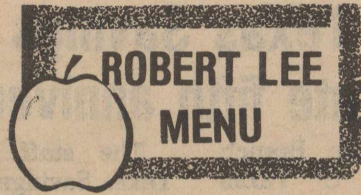
### 3rd Quarter

The 3rd quarter moved real fast with the Steers kicking off to the L.24 with a return to the L.37. But then Grim intercepts a pass and returns it to the L.28. The Steers then falter and Loraine holds on downs. The Steers halt then and they punt to the S.14 with no return. The Steers then make 1st at the S.29, then to the 44, but Loraine holds again and the Steers punt to the 46 after losses. Loraine makes a 1st at the S.33 as the 3rd Quarter ends.

### 4th Quarter

Loraine makes a long 1st down to the S.5 on a pass, and from there they run it in for a TD. Their extras fail and it is now 19 to 6. Loraine kicks off to the S.49 with no return. The Steers make two 1st downs to the L.22 where they fumble again. But the Steers hold and L. punts to the L. 48. The Steers make a 1st at the L.36, but then they are stopped on downs. Loraine then makes 3-1st downs to the S.12, but they use up too much time as time runs out to end the ball game.

The Steers will host the Forsan Buffaloes tonight in their first home game of the 1984 football season. Game time is 8:00 p.m. Come out and support the home team as well as enjoy the most exciting of sports. - high school football - where anything can happen - and usually does!

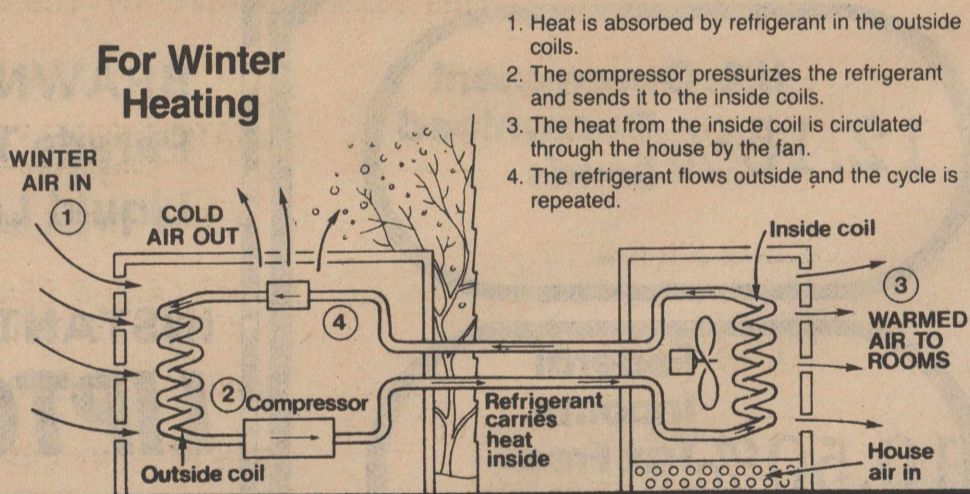

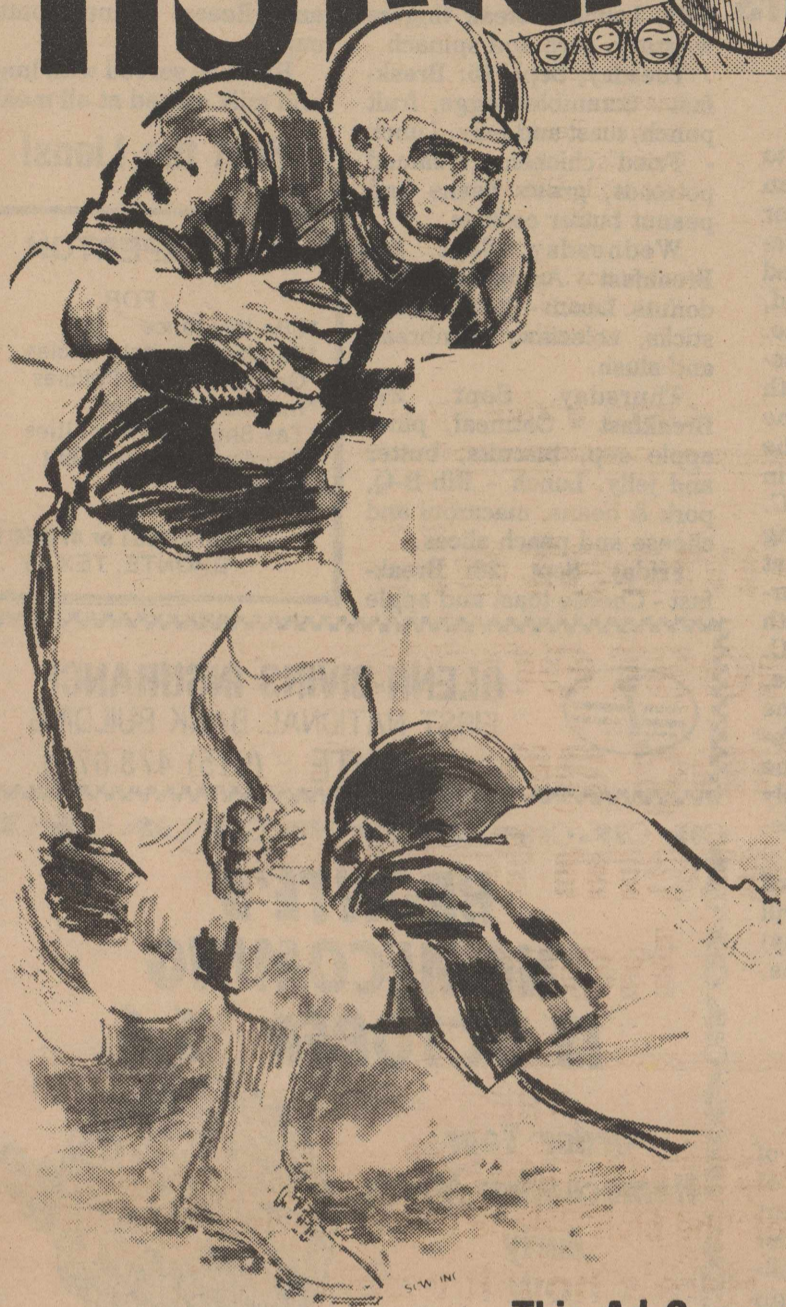

# BRONTE SCHOOL NEWS

## Horns move the ball well; have problems scoring against Kats; rip Lions tonight

As the final seconds ticked off the clock at Bronte's last Friday night football game, a roar of applause and cheers went up from the Garden City stands as if they had won the game. I have never seen people so happy without winning the game. During the course of the game, Bronte had driven the ball inside the Bearkat 10 yard line four times without scoring.

### 1st Half

Bronte won the toss and elected to receive with Kerry Lee returning the kick out to the 33 yd. line. The Horns didn't acquire a 1st down, so Jr., David Phillips punted 36 yds. with out any return to the Bearkat 28.

Garden City went right to work moving the ball out to their 45 yd. line in 5 plays.

On the next play, the Bearkat quarterback dropped back to pass and decided to throw long to a well covered receiver. Chewy Puentez broke in front of the receiver and intercepted the ball at the Horns 35 and returned it to the Bearkat 48. However, a clipping call took the ball back to the Bronte 37 yd. line. Pete Puentez carried the ball 4 times for 27 yards and one 1st down with a penalty slowing progress. On a 3rd down attempt from the G.C. 40 yard line, a McGinnis pass went in and out of the hands of a diving David Phillips. First quarter ended and the Bearkat punt went into the endzone.

Puentez and McGinnis netted a minus one yard in two plays. The next play resulted in the first Bronte turnover. A pass intended for Todd Lee was picked off at the Bronte 40 yd. line and returned to the 28 yd. line before Corby Kelso made the stop. The Bearkats were just inches short of a 1st down in 4 plays, and Bronte took over near their own 18 yd. line. McGinnis gave the Horns a little breathing room on 1st down as he scampered 11 yds. to the 29 yd. line for a 1st down. Three consecutive Pete Puentez carries netted only 3 yds. to the 32 yd. line. A 33 yd. punt off the foot of Phillips was not returned and set G.C. back to their own 36 yd. line. Three plays yield no 1st down for the Bearkats. The punt was fielded by Pete Puentez at the Bronte 14 and returned to the Horns 48. With just a couple minutes left before the half, Coach Gerald Sandusky decided to work in freshman quarterback, Stephen Lee for a little experience. Lee dropped back to pass and fired the ball about 50 yds. in the air to Pete Puentez for a 41 yd. gain to the Bearkat 11 yd. line. The next play Puentez gained six yds. to the 5 yd. line. However, the Bearkats tight-

ened and in 3 consecutive plays, pushed the Horns back out to the 10 yd. line and took over the ball on downs and the half ended.

### 2nd Half

Todd Lee toed the 2nd half kickoff for the Horns. G.C. started from their 25 yd. line and gained one 1st down before punting with Stephen Lee joining the tackling force. Bronte took over on their own 24. McGinnis and Puentez combined for a 1st down before stalling. Phillips set the Bearkats all the way back to their 16 yd. line with a 49 yd. punt. In 3 plays Bronte had pushed the Bearkats back 8 yds. to the 8 yd. line. A 2 yard Garden City punt gave Bronte the ball on the G.C. 10 yd. line. Kerry Lee punched out 2 yds. in the middle. The next play resulted in the only other Horn turnover as the Bearkats pounced on a fumble at their 10 yd. line. G.C. moved the ball 18 yds. in 5 plays before the 3rd quarter ended. Doug Tounget who had limited action due to injury joined in halting the Bearkats. G.C. retained possession four more plays. Pete Puentez recovered a Bearkat fumble at the G.C. 45 yd. line. Corby Kelso picked up 3 yds. on 1st down followed by a 19 yd. completion from Lee to Puentez for a 1st down at the Bearkat 24 yd. line. Kerry Lee busted loose for 15 yds. with one Bearkat defender saving a touchdown. Pete Puentez made one yd. to the 8 yd. line, then two passes fell incomplete and a missed field goal kept the game scoreless. G.C. had the ball six plays with one 1st down and 15 yds. gained out to the Bearkat 35 yd. line before punting. Pete Puentez dashed for 13 yds. and a 1st down. Stephen Lee connected on a 13 yd. strike to Phillips, moving the ball to the Bearkat 33 yd. line. Kelso was thrown for a 3 yd.

loss, followed by two back to back passes directed from Stephen Lee to Todd Lee for 17 yds. and 11 yds. respectively. Stephen Lee fumbled and recovered for a one yd. gain to the six yard line. Second and third down passes fell incomplete. On fourth and goal, Bronte tried the Bronte special to confuse the Bearkats and get the ball in the endzone, but the G.C. defense tightened, stopping the Horns short of a TD at the three. There the Bearkats took over on downs with around 30 seconds left. G.C. tried to get the ball outside, but failed and the game ended with a debatable safety. This brings us back to the Bearkat cheers, probably happiness from escaping defeat.

The Longhorn record stands at 0-1-1 and they will go up to Roby Friday (today) to face the 0-2 Roby Lions. GO LONGHORNS!

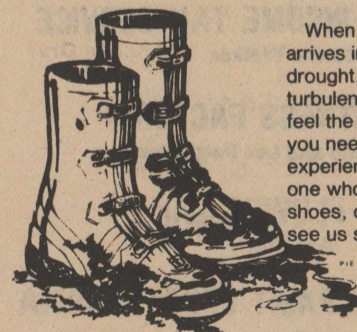

BRIEF EXPLANATORY STATEMENTS  
OF PROPOSED

### CONSTITUTIONAL AMENDMENTS

GENERAL ELECTION

NOVEMBER 6, 1984

#### PROPOSITION NO. 1 ON THE BALLOT

House Joint Resolution 29 proposes a constitutional amendment that provides to state-chartered banks the same rights and privileges that are or may be granted to national banks of the United States domiciled in this state. For example, if national banks become authorized to maintain branch offices, this amendment would extend the same privilege to state banks.

The proposed constitutional amendment will appear on the ballot as follows: "The constitutional amendment to provide state banks the same rights and privileges as national banks."

#### PROPOSITION NO. 2 ON THE BALLOT

House Joint Resolution 19 proposes a constitutional amendment that restructures the Permanent University Fund to provide: (1) for the expansion of the institutions eligible to participate in the bonding capacity of the fund to include the components of The University of Texas and Texas A&M University systems that have been added to those two systems of higher education since the Permanent University Fund was last restructured by constitutional amendment; (2) for the expansion of the purposes for which bond proceeds can be expended from new construction to include major repair and rehabilitation projects and the acquisition of major capital equipment (e.g., computers and laboratory equipment) and library books and materials; (3) for an increase in the bonding capacity from 20% (2/5 for The University of Texas System and 1/3 for the Texas A&M University System) to 30% (20% for The University of Texas System and 10% for Texas A&M University System) of the value of the assets (exclusive of real estate) in the Permanent University Fund in order to provide sufficient bond proceeds to care for the addition of 10 new institutions to those authorized to participate in the Permanent University Fund bonding program and to care for the expanded purposes for which the bond proceeds can be spent; and (4) for the dedication of the dividends, interest, and other income from the Permanent University Fund remaining after payment of principal and interest due on bonds and notes issued, to the provision of support and maintenance (over and above normal legislative appropriations) for Texas A&M University in Brazos County, Prairie View A&M University, and The University of Texas at Austin.

House Joint Resolution 19 also annually appropriates \$100 million in each fiscal year, beginning September 1, 1985 (from the first money coming into the state treasury that is not otherwise appropriated by the constitution) for the use of those

agencies and institutions of higher education which are not included in The University of Texas or Texas A&M University Systems and, therefore, not eligible to participate in the Permanent University Fund bonding program. The amount of this appropriation could be adjusted every five years by a 2/3 vote of the Legislature, but could not be adjusted in such a way as to affect outstanding bonding indebtedness. Each institution of higher education that is eligible to participate (i.e., those institutions of higher education outside The University of Texas and Texas A&M University Systems) would be authorized to expend directly its share (such share to be determined pursuant to an equitable formula) of the \$100 million appropriation for the purposes of acquiring land, constructing and equipping buildings or other permanent improvements, major repair and rehabilitation of other permanent buildings or improvements, and acquisition of major capital equipment (e.g., computers and laboratory equipment) and library books and materials. Additionally, each institution would be authorized to issue bonds backed by a pledge of up to 50% of its share of the \$100 million annual appropriation for the purpose of land acquisition, new construction, and major repair and rehabilitation projects.

Except in the case of fire or natural disaster and in other extraordinary cases, verified by a two-thirds vote of each house of the legislature, all institutions of higher education would be precluded from receiving appropriations of general revenue funds for the purposes of land acquisition, new construction, and major repair and rehabilitation projects.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to create from general revenue a special higher education assistance fund for construction and related activities, to restructure the Permanent University Fund, and to increase the number of institutions eligible to benefit from the Permanent University Fund."

#### PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 65 proposes a constitutional amendment which authorizes the legislature to provide for the payment of assistance to the surviving dependent parents, brothers, and sisters of officers, employees and agents of the state or its political subdivisions, including members of organized volunteer fire departments and members of organized police reserve or auxiliary units authorized to make arrests, who die in the course of performing hazardous official duties. Payments to surviving spouses and dependent children of

such officers, employees, and agents are already authorized by the Constitution.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the legislature to provide for payment of assistance to the surviving dependent parents, brothers, and sisters of certain public servants killed while on duty."

#### PROPOSITION NO. 4 ON THE BALLOT

Senate Joint Resolution 20 proposes a constitutional amendment which abolishes the office of county treasurer in Bexar and Collin counties if a majority of the voters in each of those counties vote in favor of abolishing the office of county treasurer in a local election to be held on the issue. All the powers, duties, and functions of the office of county treasurer in each of these counties would be transferred to the county clerk.

The proposed constitutional amendment will appear on the ballot as follows: "The constitutional amendment to abolish the office of county treasurer in Bexar and Collin counties."

#### PROPOSITION NO. 5 ON THE BALLOT

Senate Joint Resolution 22 proposes a constitutional amendment which provides a new method of filling a vacancy in the office of Lieutenant Governor. The amendment requires the President pro tempore of the Senate to call together the committee of the whole Senate within 30 days after a vacancy occurs in the office of Lieutenant Governor. The committee would be required to elect one of its members to perform the duties of the Lieutenant Governor until the next general election. This individual would continue his duties as Senator at the same time that he performs the Lieutenant Governor's duties. If the Senator who is elected ceases to be a Senator before the next general election, another Senator must be elected according to the above procedure to perform the Lieutenant Governor's duties. The President pro tempore would be required to perform the Lieutenant Governor's duties pending the election of one of its members by the committee of the whole Senate.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing the state senate to fill a vacancy in the office of lieutenant governor."

#### PROPOSITION NO. 6 ON THE BALLOT

House Joint Resolution 73 proposes a constitutional amendment that permits the use of public funds and credit for payment of premiums on non-assessable life, health, or accident insurance policies and annuity contracts issued by a mutual insurance company authorized to do business in this state. The constitutional prohibition against a grant of public money to an individual, association, or corporation or against becoming a stockholder in a corporation, association, or company has limited life and health group policies of political subdivisions to non-mutual insurance companies. The amendment would permit mutual insurance companies to bid for those policies.

The proposed constitutional amendment will appear on the ballot as follows: The constitutional amendment to permit use of public funds and credit for payment of premiums on certain insurance contracts of mutual insurance companies authorized to do business in Texas."

#### PROPOSITION NO. 7 ON THE BALLOT

House Joint Resolution 4 proposes a constitutional amendment to change the membership of the State Commission on Judicial Conduct to include one Judge of a Municipal Court and one Judge of a County Court at Law, who shall be selected at large and appointed by the Supreme Court with the advice and consent of the Senate.

The amendment also provides additional grounds for removal from office of judges or justices of Texas courts, and provides additional disciplinary actions that could be taken in lieu of removal or censure. The amendment would extend the Commission's disciplinary authority to masters, magistrates, and retired or former judges who hear cases by designation. The amendment creates a tribunal to review recommendations of the State Commission on Judicial Conduct for removal or retirement of a judge or justice. The review tribunal would be composed of seven (7) Justices or Judges of the Courts of Appeals selected by lot by the Chief Justice of the Supreme Court. The amendment also provides for appeal of the review tribunal's decision to the Supreme Court of Texas and grants an accused judge the right to discovery of evidence.

The proposition will appear on the ballot as follows: The constitutional amendment relating to the membership of the State Commission on Judicial Conduct and the authority and procedure to discipline active judges, certain retired and former judges, and certain masters and magistrates of the courts."

#### PROPOSITION NO. 8 ON THE BALLOT

House Joint Resolution 22 proposes a constitutional amendment which increases the per diem of members of the Legislature. The amount of per diem allowed during a calendar year would be equal to the maximum amount set in federal income tax statutes as of January 1 of that same year as a deduction for ordinary and necessary business expenses incurred by a state legislator. Current per diem is \$30; the maximum deduction is now \$75.

The proposed constitutional amendment will appear on the ballot as follows: "The constitutional amendment to provide a per diem for members of the legislature equal to the maximum daily amount allowed by federal law as a deduction for ordinary and necessary business expenses incurred by a state legislator."

In the last five years, Mr. Rodriguez has won trips to the Bahamas, Hawaii, England, and Canada. He is

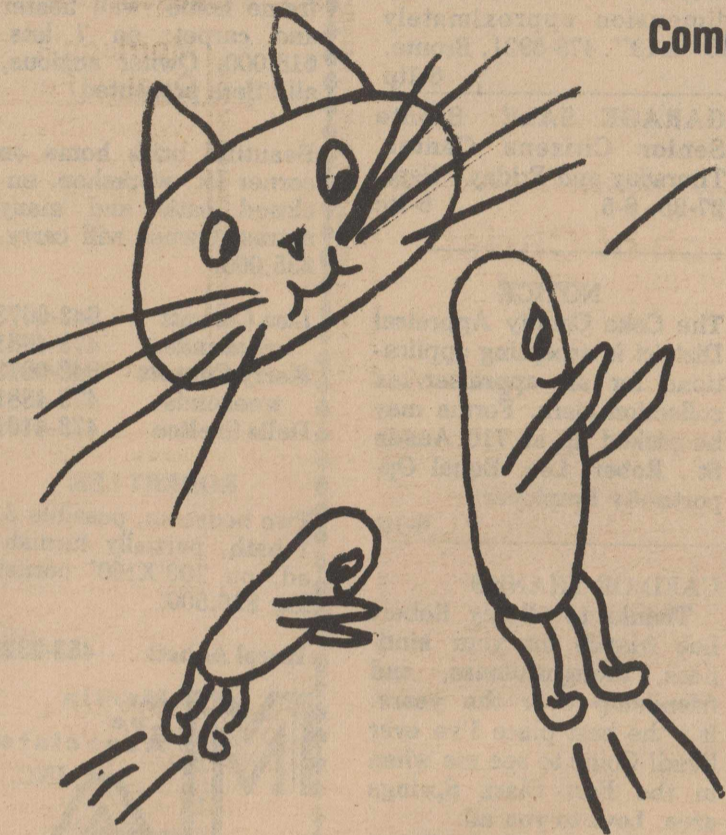

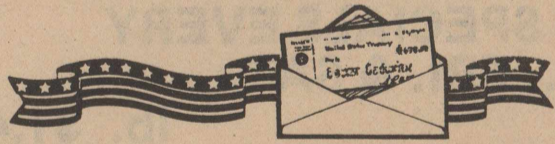
The next junior high game will be Monday, Sept. 24, against Brownwood at their place.
