## County Stock Show winners named

This year's edition of the Coke County Livestock Show has come and gone, with an outstanding number of entries, expanded facilities, good crowds, and an excellent barbecue lunch on Saturday. Although the exact figures are not in on this year's auction sale, the final tally should be in the neighborhood of \$13,500, according to County Agent Tommy Antilley, and that figure is also up from last year.

The list of this year's winners is a long one, with Pammy Millican a multiple winner, as he had the Champion Medium Wool

Lamb, Champion Finewool Lamb, Sheep Showmanship Trophy, and the Grand Champion Lamb. Pammy was also awarded the Ralph Walker Memorial "Top Hand" Award, which is determined on a point system which incorporates the exhibitor's placings with their livestock, and showmanship points.

Lin Long was this year's overall showman, as she accepted the Frank Percifull Memorial "Overall Showmanship" Award, which is determined by showmanship placings in at least two of the three livestock divisions.

Randy Gartman was this year's Swine Showmanship award winner, and Thad Metcalf took top showman honors in the Steer Division.

Shane Kelton won grand champion honors in the Steer Show with his medium weight red roan steer, with Scott Antilley following with reserve champion honors, exhibiting his heavy weight black steer.

Christy Bivins won Re-

serve Grand Champion honors in the Lamb Show with her reserve champion medium wool lamb. In the Finewool classes, Pammy Millican won grand and reserve honors. Jason Wink exhibited the Champion Crossbred, with Pammy Millican showing the Reserve Champion Crossbred Lamb. Pammy also had the Champion Medium Wool, with Christy Bivins exhibiting the Reserve

Champion. In the breeding sheep division, Brande Thomas showed the Champion Ewe, with Jim Bob Thomas exhibiting the Champion Ram.

Kelly Webb took home the bacon so to speak in the Swine Show, showing her barrow to Grand Champion honors, with Doug Tounget

## Bronte, RL girls end successful season; boys still in play-offs

For the Lady Horns, they finished up a very successful season as district and bi-district champs, with a season record of 23-4. In their bi-district game, they poured in 88 points to defeat Novice 88-22, before losing to Aspermont in a close contest by a score of 43-38.

The Lady Steers finished their regular season as district runners-up, and defeated Santa Anna in their bi-district contest by a score of 38-27. In the area competition, they met powerhouse Eula, and lost by a score of 39-25. The Lady Steers ended their season with a 23-6 record.

Both Bronte and Robert Lee girls teams lost their area contests to powerful teams, which are expected to go far in the play-offs. Both are bi-district champs, and the whole county is proud of their accomplishments.

Not to be outdone, both the Bronte and Robert Lee boys teams are still in the state play-off race, as each team will compete for bi-district honors tonight.

The Bronte boys will take on Lohn in Miles tonight at

7:30 for the bi-district championship. This Horn team was the district 27-A winner, after defeating Robert Lee in a play-off game to determine the district representative. This boys team has played one practice game in preparation for the bi-district contest, with Iraan, with Iraan coming out on top 77-70.

As for Robert Lee, they

are the District 27-A runners-up. They are scheduled to play Mozelle at Ballinger tonight at 7:30, for the bi-district championship. Concerning preparation for the contest, the Steers have played two practice games, beating Fort Davis 45-37, and losing to Grayford 56-49.

Approximately thirty people attended a planning meeting for organizing an underground water conservation district for Coke County. The meeting was held in the Coke County Courtroom last Monday evening.

Drew Durham of Sterling City discussed the need of forming such a district. He discussed the alternatives for counties such as Coke in light of the pending water plan legislation in Austin. He also discussed the legal aspects of forming water districts in rural counties.

Those people present at the meeting voted to initiate

the formation of an underground water conservation district for Coke County. The following people were appointed as a steering committee: Arch Mathers, Wayne McCabe, Martin Lee, Otis Smith, Horace Scott, Fred McCabe, Paul Villaret, Bill Hartman, J.T. Henry and Robert Vaughan.

Another planning meeting has been called for Monday, February 25, at 7 p.m. Those who could not attend the meeting last Monday are encouraged to attend this meeting to help provide input for the future of the water resources for Coke County.

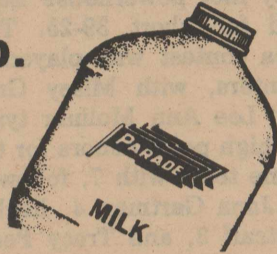

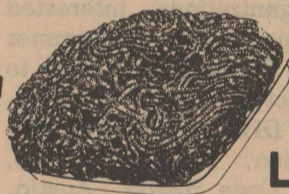

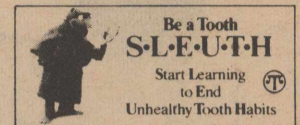

## Don't Get Burned By Smokeless Tobacco

Teen fads may be passing fancies—but too often a real danger lurks under these "in" pastimes. Break dancing can cause injury to young bones and joints. And snuff and chewing tobacco, the smokeless tobaccos, are as unsafe for teens and youngsters as the cigarettes they're substituted for.



Unlike cigarettes, smokeless tobaccos don't carry a health hazard warning. They should. The danger to oral health from these forms of cured tobacco is just as real as that from cigarettes.

Sucking on a wad of tobacco for an extended time can produce a white, leathery patch in the mouth called leukoplakia. And nearly five percent of diagnosed leukoplakias develop into cancer.

In addition, discolored teeth, receding gums, bad breath and other dental problems have been linked with smokeless tobacco.

So although the health warning isn't there on these products, the message is the same: Don't start using snuff or chewing tobacco. If you've already started, stop.

## SS withholding may be excessive

A person who works for more than one employer during the course of a year may have more Social Security taxes withheld than are required by law, Franklin H. Upp, Social Security manager in San Angelo, said recently.

"If this occurs," Upp said, "the person may claim a refund for the excess amount when he or she files an income tax return for that year; however, if the excess withholding occurs because an employer deducts too much in taxes, the person

should ask the employer for a refund.

"Earnings in excess of the maximum amount that counts for Social Security cannot be used in figuring the benefit rate."

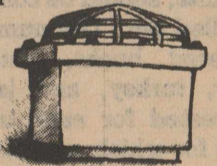

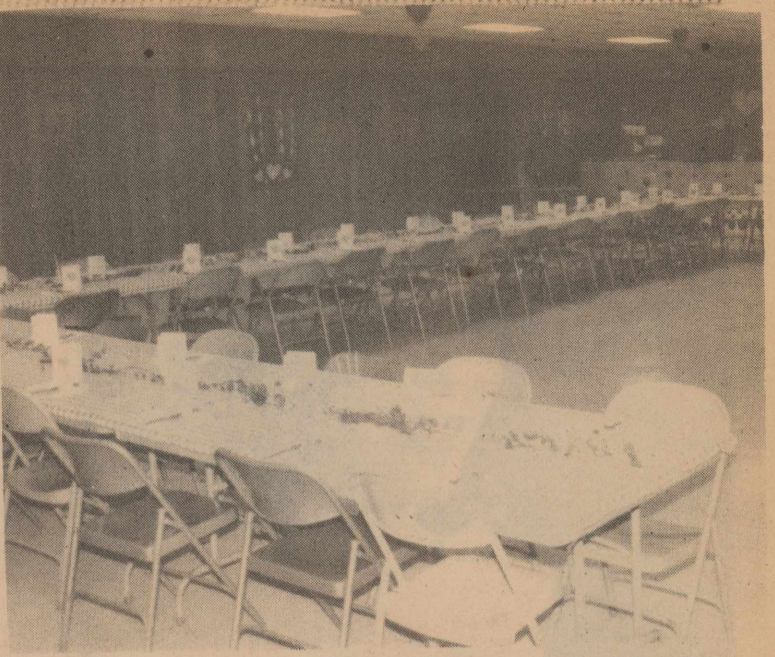

State Rep. Gary Thompson of Abilene will address the county officials earlier that morning. Thompson is chairman of the House

Committee on County Affairs and will have some members of his committee on hand for an open forum and question-and-answer session.

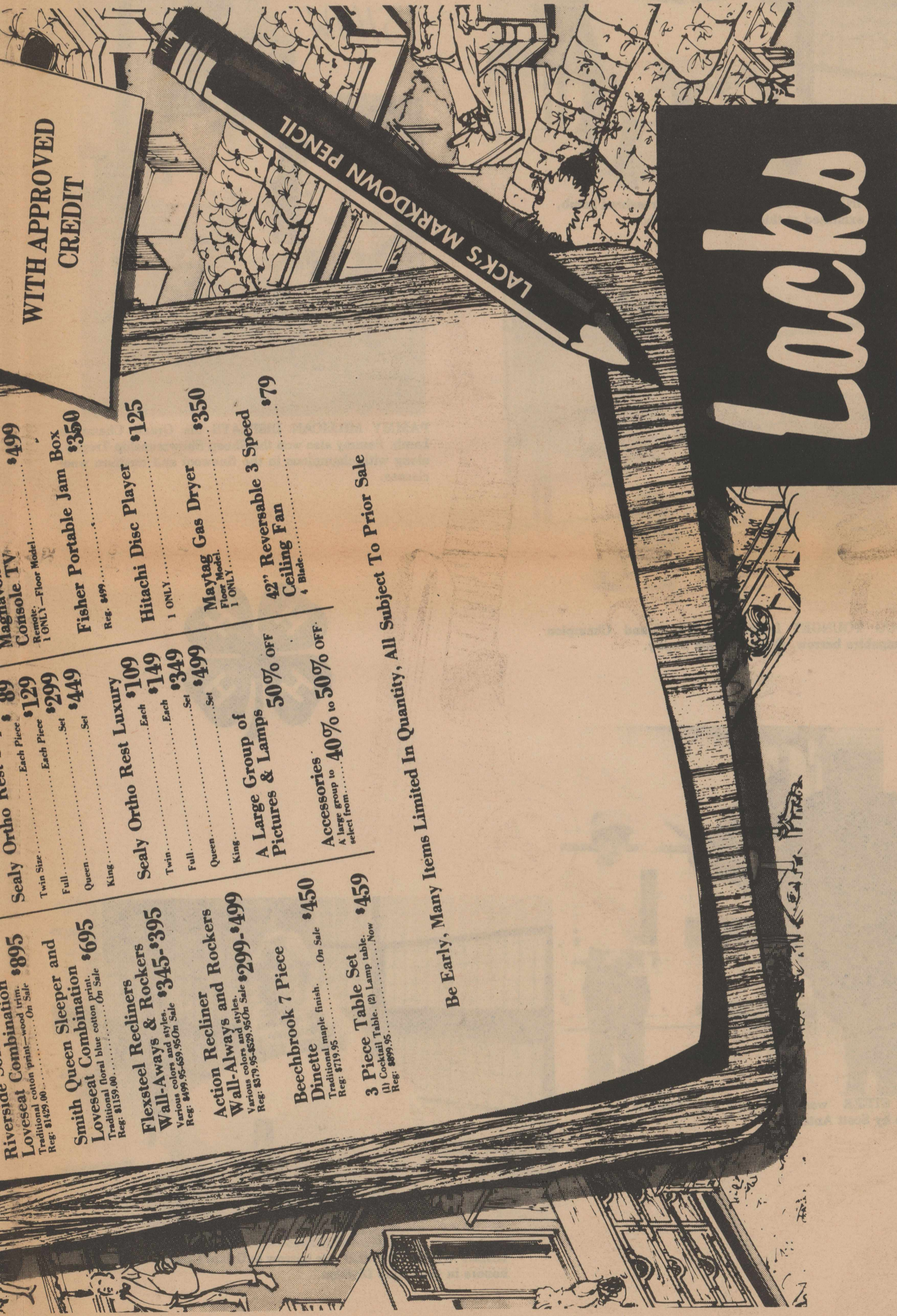
The County Affairs Committee is studying a number of critical issues during the current legislative session, including optional ordinance-making authority, indigent health care and alternative sources of income.

Thompson and members of his committee will also take part in a review of legislation affecting coun-

ties. Major areas of discussions during the three-day conference will deal with "Administrative Responsibilities of Commissioners Courts" and "Relationships in County Government." 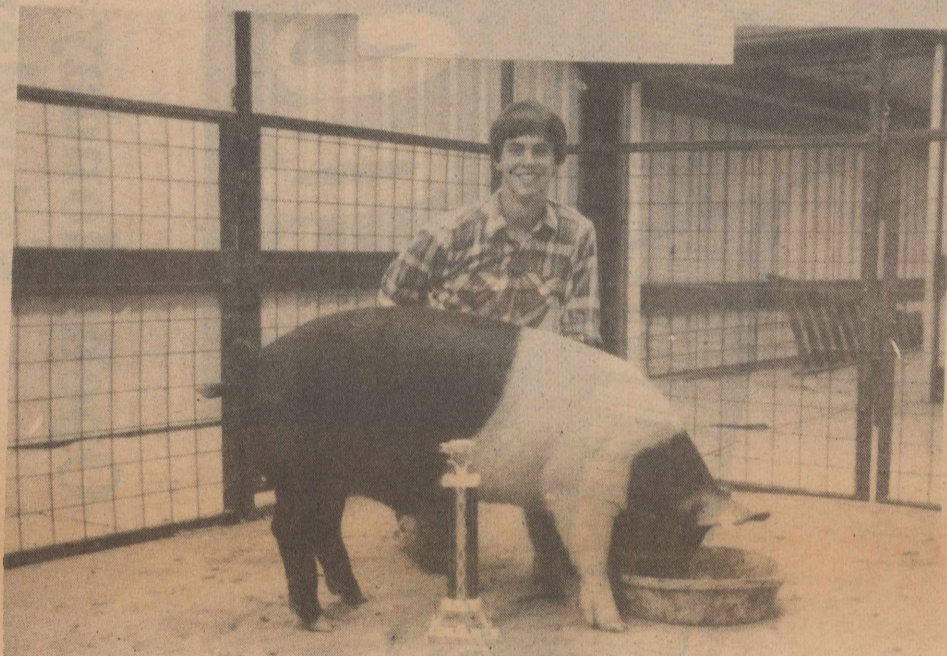

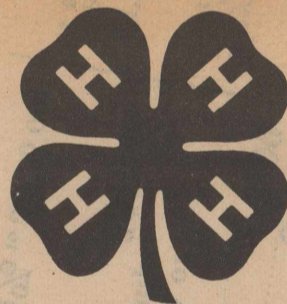

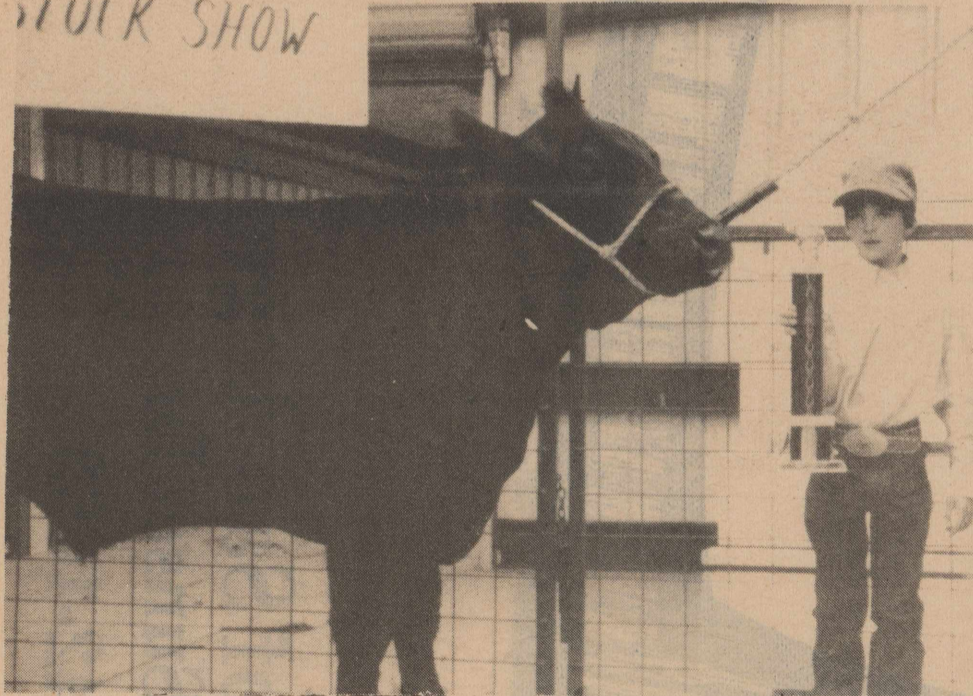

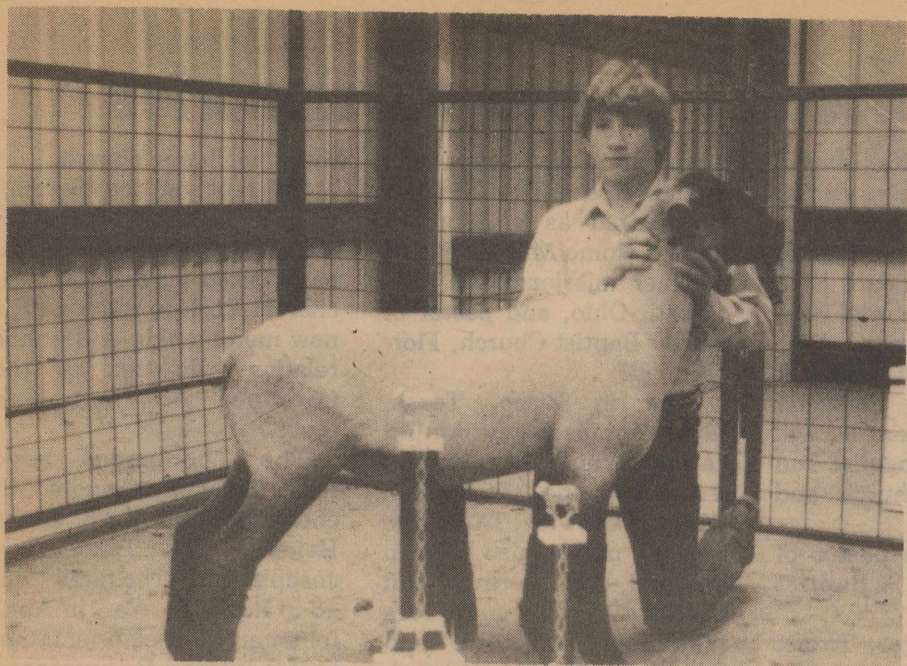

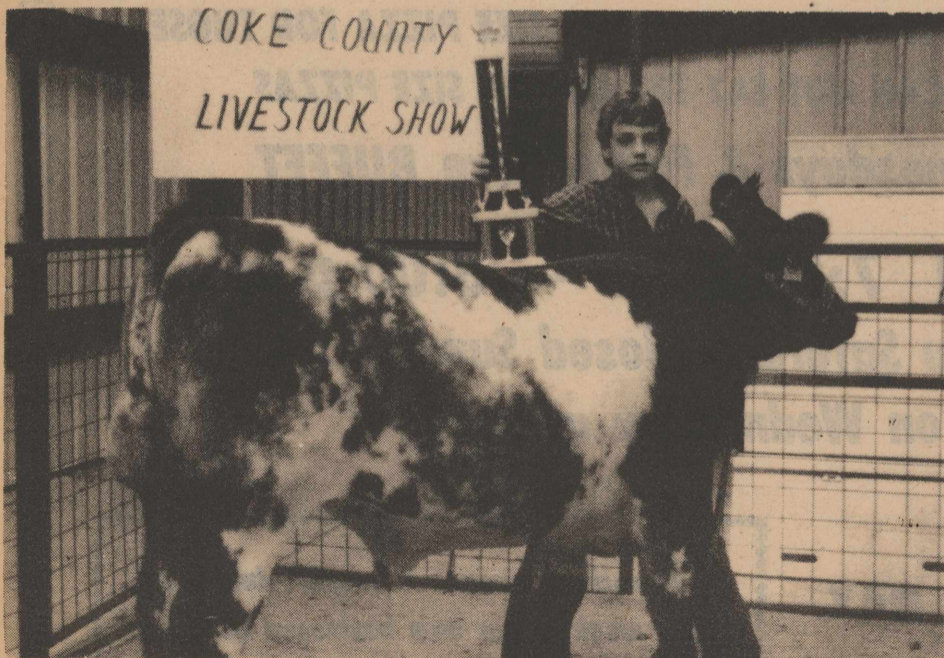

## Postal Pointers

All classes of mail will change rates on Sunday, Feb. 17 at 12:01 a.m. Mailers who have permits need to check with the postmaster about the new rates. All mailing fees will go from \$40 to \$50.

There will also be an increase in box rent fees for #3 and #4 boxes. No. 3 boxes will go from \$11.00 per year to \$13.00 per year. No. 4 boxes will go from \$17.00 to \$20.00 per year. The new fee will be applicable the next time your box rent is due.

The maximum amount for a money order will increase from \$500 to \$700 and there is no limitation as to the number that may be purchased at one time. Amount of fees will remain at \$0.75 up to \$25. From \$25.01 to \$700 - the fee will go down to \$1.00.

Special Delivery fees will go from \$2.10 to \$2.95 for 2

pounds and under. Over 2 pounds but less than 10 pounds, the fee will be \$3.15.

Check with your local post office before dropping those "heavies" in the slot because there will be no "grace" period and your article will go postage due if it is short paid.

8. The Texas Water Commission shall, if requested by at least 25 persons, hold a public hearing in the area where the operation is to be conducted prior to the issuance of a permit. No public hearing will be held on this application unless a request for a hearing is made within 30 days of the date of the first publication of this Notice. 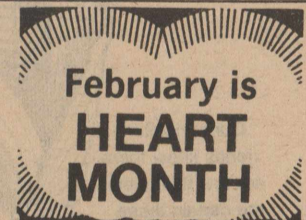

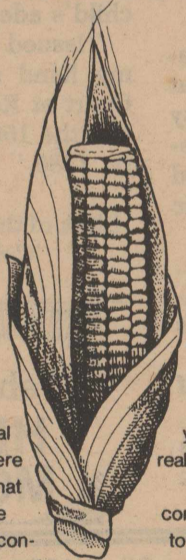
