New X-ray technology installed

Mrs. Charlzie Treece. Administrator of West Coke County Hospital, Robert Lee, has announced the installation of new X-ray technology which will permit a sharp reduction in patient radiation exposure without sacrificing image quality of the X-ray. The 26 bed hospital this week switched to an imaging system combining DuPont's rare earth Quanta III intensifying screen and Cronex 7 X-ray film, which according to Dr. Chunn, the radiologist from San Angelo that reads the films, will reduce radiation dosage to patients in most examinations by 50 percent. An intensifying screen is a thin sheet of phosphorescent material placed between the patient and the X-ray film. The screen changes X-rays to light rays which are more easily "seen" by the X-ray film. West Coke County Hospital monthly X-rays about 110 patients, totaling over 135 separate X-ray examinations. Dr. Pulse and Dr. Hamamcy noted increas-

ing U.S. government concern with radiation dosages as well as rising health care costs. They said, "The X-ray Departments objective is to use as little radiation as possible while still producing a readable X-ray. This new X-ray screen and film system greatly reduces patient do-

sage and at the same time gives a usuable image. It also enables us to increase X-ray tube life and thus help

hold the line on hospital costs. We are very pleased that our hospital can offer this new system to our patients."

Soil Conservation District News

Bill Blair has rootplowed the deeper soils on his ranch located near South Nipple Peak. It has also been rollerchopped and seeded to adapted grasses. These improvements together with the cross-fence built earlier was cost-shared with the USDA through the ASCS office. Technical assistance has been provided by the SCS.

LeDrew Arrott has just completed rootplowing a thick stand of mesquite on some of the deeper soils on his ranch Northwest of Tennyson.

The land was rollerchopped and seeded to a mixture of grasses such as K.R. bluestem, sideoats grama, and Kleingrass. The shallower soils were left in brush to provide cover for various kinds of wildlife. Replacing the thick stand of mesquite with a good stand of the better grasses should use only about 1/3 the amount of water as was used by the heavy stand of mesquite. The water saved will go into underground reservoirs or appear as seeps and springs downstream. Thus more water is available for rivers and lakes downstream. Practices such as this and other good range management practices benefit the urban people as well as the rural people. This is a part of Arrott's Great Plains Conservation Program with the

Lavern Lee, of Odessa, has rootplowed the better soils on his ranch South of Bronte on the Colorado River. The rich bottomland soils and the clay loam and sandy sites in the upland pastures will be seeded to various mixtures of grasses with some wildlife forage plants added to improve their wildlife habitat. Crossfencing and water developments will be constructed also to improve livestock grazing distribution in some of the larger pastures. These improvements are being cost-shared by the Great Plains Conservation Program.

Mrs. Blanton, 81, died on Friday, April 5, at 1:30 p.m. at Presbyterian Hospital in Dallas following a heart at-

Funeral services were held on Monday at 11:00 a.m. at the Robert Lee Baptist Church with interment following at the Robert Lee Cemetery under the direction of Shaffer Funeral Home. Conducting the rites were the Rev. Roy Epperson, assisted by the Rev. Dr. Charles Taylor of Dallas.

Pallbearers for the services included Dean Chenoweth, Walter Thompson and Walt Ray, all of San Angelo, Bill Allen, David Key and Don Fields, all of Robert Lee.

Memorial services for Mrs. Blanton were held on Tuesday at 2 p.m. at Westminister Presbyterian Church in Dallas, officiated by Dr. Taylor.

Naomi Lee Adams was born in Robert Lee Dec. 2, 1903 to Noel Killingsworth Adams of Mississippi and Martha Swann Adams of Gonzales County, Texas. The couple married at the turn of the century and came

west to seek their fortune and raise a family of four. She was the great-granddaughter of J. Alfred Morris who came to Texas with Green DeWitt's colony and was given a Spanish land grant in 1821. He later fought in the battle of San Jacinto.

She attended Robert Lee Schools and graduated in a class of five girls and three boys in 1920; her diploma was signed by her father, president of the school

Mrs. Blanton's teaching career began at the old Union School north of Bronte in 1920 at the age of seventeen. It was the beginning of a dedicated work that spanned 39 years in class rooms in Coke County, twenty-five of which were in the first grade at Robert Lee.

She furthered her own education over the years, receiving a Bachelors Degree from Daniel Baker and her Masters Degree from Hardin-Simmons.

As Mrs. Blanton had no children, she directed her interests and energies toward youth and civic duties. She is remembered fondly for her work as a 4-H leader, Boy Scout den mother, Sunday School teacher, and PTA worker.

She was a member of

Delta Kappa Gamma, a sorority for outstanding teachers, Daughters of the American Revolution, Tom Green County Historical Society, Baptist Memorials Auxiliary, the Retired Teachers Association, and the Presbyterian Church.

On June 10, 1925, she married Samuel S. Powell, a rancher. The couple engaged in ranching their entire married life and she continued to hold ranching interests following his death in 1963.

Following her retirement from her teaching career, she moved to San Angelo to be with her aged mother. As was her nature, she served San Angelo and Tom Green County in many capacities through civic and church organizations.

On May 22, 1981, she and Burt C. Blanton of Dallas were married. They divided their time between San Angelo and Dallas as well as making frequent visits to Robert Lee where she was always warmly welcomed.

Mrs. Blanton's survivors include her husband, Burt, of Dallas; one sister, Dannie Carter, of Harlingen; one brother, S.E. Adams, of Robert Lee; one niece, Kathleen Carter, Harlingen; one nephew, Stanley Adams. Austin; six great-nieces; and six great-nephews.
