Suspected leak causes truck fire

A Chevron Oil Co. IAB Unit west of Sanco near Hwy. 208 burned Tuesday at approximately 2:30 p.m. The truck was a hot oil unit driven by Mike Hamilton of San Angelo, owned by Dan Johnson of Johnson Hot Oil in San Angelo. The driver, alone at the time, was in the process of treating a well near the Ranchhouse on the L.B. Menielle Estate, when his truck caught fire. He had just hooked up to treat the well with hot oil. This is done to clean out the casing and tubing in the well. The cause of the fire was speculated by Chevron officials at the scene to be caused by a leak. The driver, Mike Hamilton was said to have been burned severely on the legs. He was taken to West Coke County Hospital for treatment, and transferred later to San Angelo. The Robert

Lee Volunteer Fire Department responded to the call about 2:45 p.m. along with two units from the Colorado City Volunteer Fire Department, stated Fire Chief J.C. Wallace of Robert Lee.

Agent accepts position

Coke County Extension Home Economist, Debra J. Reber has accepted the position of Home Economist Program Leader and Trainer Agent for Angelina County effective October 16.

In her new position, Mrs. Reber will be responsible for directing all Extension Home Economics activities in the Lufkin and surrounding areas of Angelina County.

Carolyn Gilbert, District 7 Extension Director said that the agent has demonstrated an extensive background in the area of family life education in Coke County. "Mrs. Reber is an exceptionally talented Home Economist, with advanced skills in clothing construction and related areas" said Ms. Gilbert.

Supporting her new position is an extensive and varied background in the home economics field, having garnered a Bachelors Degree in Home Economics Education from Florida State University followed by a Masters Degree in Family Relationships also from Florida State.

While at Florida State, she served as State President of

the Student Organization for the Florida Home Economics Association and was named in Who's Who Among Students in American Colleges and Universities.

"Debbie has been a strong asset to the Home Economics program not only in Coke County, but also in the entire district," said Ms. Gilbert. "We feel the strong foundation she has established in the county can do nothing but strengthen Coke County's Home Economics program."

Coke County Commissioners approved the salary schedule for fiscal year 1986, at their regular meeting held on October 7, 1985. County Librarian - \$4.75 per hour; Part-time to Auditor & Treasurer - not yet determined; County Agricultural

Agent - \$8,001.66 (supplement to state salary), plus \$2,400 travel expense; County Home Economics Agent - \$7759.31 (supplement to state salary; plus \$1,800 travel expense; Veteran's Service Office - \$1,200; County Health Officer - \$300; Drug Counselor - \$2400; Court Reporter Salary (supplement) - \$1,748.40; District Judge (supplement) - \$358.80; District Attorney (supplement) - \$358.80; All extra help to be paid \$4.75 per hour. Travel allowance for county business was set at 20 cents per mile.

In other action, Commissioners granted permission for the Senior Citizens to hold their dances at the Rec Hall on the third Thursday night each month.

- Approved annual report of County Tax Assessor-Collector.

- Granted Dr. Hamamcy's request to construct a hangar at the County airport, subject to contract approval.

- Passed a resolution presented by County Attorney Bill Helwig, concerning additional compensation for the County Attorney's office.

- Passed a resolution in support of Constitutional Amendments #1 and #2, regarding the proposed State Water Plan.

- Accepted proposition from the Texas Highway Commission for the county to pay ten percent of the expenses in purchasing right-of-way and fence moving expenses involved in the road construction on Highway 158, near the Sterling County line, which amounts to 9,000 feet of fencing, and approximately ten acres of right-of-way.

- Approved Extension Agents' reports.

- No action was taken on setting policies for Recreation Building charges.

- Accepted the resignation of Extension Agent Debbie Reber.

- Tabled action concerning nominations for County Appraisal Board, until next meeting.

- There being no further business, the Court paid bills and adjourned.

Antlerless deer tags to be issued

Texas Parks and Wildlife Department will issue special antlerless deer tags for Coke County on Oct. 30, 31 from 8:00 a.m.-12:00 noon and 1:00 p.m.-5:00 p.m. in the County Courthouse in Robert Lee. The special tags are required for any antlerless deer harvested in this county during the upcoming hunting season.

To qualify for tags, a landowner must own or control acreage in Coke County.

After the opening of the hunting season, tags will ONLY be available through Regional Offices located in Rockport, San Angelo, Tyler, Waco and the State Office in Austin. Tags WILL NOT be issued by local department personnel.

Landowners or their agents are urged to pick up tags on the scheduled issuance dates.

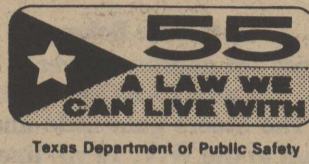

Steers lose close one to Wildcats

The Steers lost one Friday they possibly could have won before a large homecoming crowd that was decided by the all important extra point. Statistic wise, it was a close contest all the way, as the Steers and the Water Valley Wildcats went back and forth, but it was again the youth and experience or lack of it that cost the Steers their chance for victory. Before this season is over the Steers are going to surprise somebody and hopefully it will be this week.

1st QUARTER

The Wildcats took the opening kickoff from their 11 and in a time-consuming march for 5-1st downs to the Steer 14 where they fumbled the ball and Shane Smith recovered. The Steers then march for 3-1st downs to the W.V.46 where they fumble. The Steers then hold on downs at the S.45 as the

quick 1st quarter is over.

2nd QUARTER

The Steers gain little and punt to the W.V. 19 yd. line. Then a big 1st for the Wildcats as they slip through the middle and go 55 yds. to the Steer 26. Then they sweep the end for the other 26 yds. and a T.D. They kick their extra point and they lead 7 to 0.

The Steers take the kickoff and return to the S.45. They make 2-1st downs to the W.V. 18 and then at the 8, they are intercepted and W.V. took over. W.V. then makes 2-1st downs to the W.V. 32 and the Steers held and they punt to the S.41. The Steers make a 1st down, but they are intercepted again at the W.V. 29. Three plays later the 1st half ends.

3rd QUARTER

The Steers take the 2nd half kick off and Garringer returns 42 yds. to the W.V.

37 yd. line. They made a 1st at the 27, but they are then intercepted again. The Steers hold the Wildcats and they punt to the S.40. The Steers then moved again for 3-1st downs to the W.V. 25, but they are then halted on downs. The Wildcats strike again as they slip through the middle again and go 63 yds. for a T.D. They kick their extra and it is 14 to 0. They attempted an on side kick, but the Steers recover it at the S.47. The Steers had to punt and Hood punts to the W.V. 21 after 2 penalties. The Steers then hold and W.V. punts to the W.V. 45. The Steers get rolling then and marched for 3-1st downs to the W.V. 7 yd. line. Then from the 4, Sherrill sweeps the end for the T.D. The extra fail and it is 14 to 6.

The Steers kick off and W.V. returns to the W.V. 43. Two plays later the 3rd quarter ends.

4th QUARTER

The Steers then hold and W.V. punts to the S.28. The Steers can't move and they punt to the W.V. 12 yd. line. The Steers then hold and W.V. punts to the W.V. 43, where Sanchez returns it to the W.V. 18. The Steers seemed fired up then and they drove it in from there, with Garringer scoring from the 9 yd. line. The extras for the tie then fail and W.V. leads, 14 to 12. Then it seemed to be over as neither team could take advantage of a swap of possessions as W.V. ran out the clock at their 49.

The Robert Lee squad must show some intestinal fortitude Friday night (tonight) in Mertzon when they go up against the Irion County Hornets. At 5-0, the Hornets stung Eden 20-12 last week and punished the Miles Bulldogs 62-0 two weeks ago.

However, the Horns defense stiffened and pushed the Eagles back to the Bronte 20 yd. line where the ball became the Horns on downs. The Horns could not manage a 1st down so Stephen Lee punted the ball to mid-field. The Bronte defense held. A bad snap by the Eagle punt team occurred and Pete Puentez hopped on the ball at the Eagle 27 yd. line. A Lee pass to Puentez moved the ball to the Eagle 12 yd. line as Puentez wrestled the ball away from the S.C. defender. Stephen Lee connected with Pete Puentez on a scoring pass with 6 seconds left on the clock. The special was good for two points this time as Puentez tossed a pass to Mark Adams. S.C. nearly got on the scoreboard on the ensuing kickoff as Puentez made a saving shoe-string tackle. 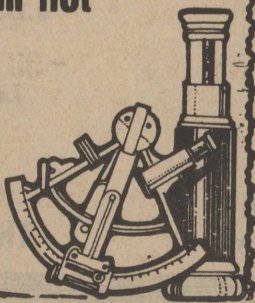

Services were at 2 p.m. Monday, Oct. 7, at Iglesia Bautista Bethel in Robert Lee.

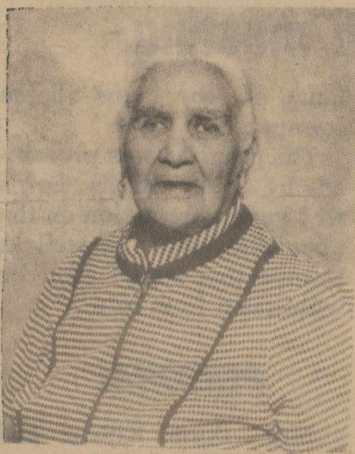
