## Hospital Board to make important decision Monday

The next regular session of the West Coke County Hospital District Board of Directors has been set for this Monday, March 3, 7:00 p.m., in the District Courtroom, Robert Lee.

According to an official representing the board, the final decision concerning the disposition of the hospital will most likely be made at this meeting.

Several different options have been discussed, including closing the hospital, using the facility as an emergency clinic only, or signing an agreement with one of the larger hospitals in San Angelo or Abilene, to assist in the management of the West Coke facility.

The meeting is open to the public, and interested residents are urged to attend.

## Candidate files for council

According to Robert Lee city secretary Edna Havins, one additional candidate for the city council filed for one of two vacancies last Wednesday, Feb. 19, the final deadline. Jim Naico became a candidate in the city election to be held April 5. Mrs. Alice Beaty had previously filed for the council seat she now holds. Wilson Bryan, also a councilman, bypassed that position and filed for city mayor when Mayor Robert Vaughan declined to run again.

In the Robert Lee School Board race, incumbents Jeffie Roberts and Ray Aldridge along with candidate Wayland Drennan, will vie for 2 vacancies. Applications for candidates may be obtained in the school superintendent's office until the March 5 deadline.

No one has yet filed for the

West Coke County Hospital District election on April 5. Three vacancies exist on that board. Petitions for candidates are available in the hospital's business office until the deadline for filing on March 5.

Voters in the upcoming city, school, or hospital elections should be reminded that balloting will require a valid voter registration by March 5 to vote on April 5. If you did not receive one recently by mail, call or go by the Coke County Tax Collector's office in the courthouse.

Cheese and Butter will be distributed Thursday, March 6, 1986 in the Bronte and Robert Lee Senior Citizens' buildings from 7:30 a.m. to 12:00 p.m. All commodities are distributed on a first come, first serve basis.

## Mauzy visits in county

Texas Supreme Court candidate Oscar Mauzy was in Robert Lee on Monday of this week, promoting his campaign for the Texas Supreme Court.

State Senator Mauzy, democrat from Dallas, Texas, was hosted during his visits around the town by county democratic chairman Patti Ivey.

Mauzy, who will face incumbent State Justice Sears McGee and District Judge Hugo Touchy in the democratic primary in May, has made a campaign issue of refusing to accept campaign contributions from the Supreme Court political action committee. Mauzy believes this committee advocates an appointed State Supreme Court, which Mauzy thinks would be more easily controlled by this group than an elected court.

## Horns outpace Throckmorton; face Huckaby for regional today

Playing for the third time around, the Bronte Longhorns and Novice Hornets situation didn't change, only this time the Longhorn victory was for the bi-district title. There was not much suspense in the game as Bronte led 50-27 by halftime and steamed on to a 90-56 win. Soph. Stephen Lee and Sr. David Phillips were responsible for almost half the Horns' score as the two combined for 44 points. S. Lee was the game's leading scorer, making 26 points and gathering in 9 rebounds. Phillips made 18 points and 14 rebounds; Jamie Powers, 11 points, 5 assists; John Morrow, 11

points, 5 steals; Pete Puentez 10 with 12 assists; Kerry Lee and Corby Kelso, 5 each; Terrance Hale and Cody Hartman, 2 pts. each.

The bi-district champions were at the 24-1 season mark as they faced tougher going against Throckmorton in area play on Tuesday evening at Abilene Cooper gym. The Horns captured the Area Championship by a 58-48 score, and qualified for the Regional Tournament at Stephenville Friday.

Dominating the first half, the Horns were ahead 33-25 at the midway point. They gave their fans some anxious moments when they let the

Greyhounds pull within 2, but regained the lead on the strength of Jamie Powers four consecutive free throws in the 4th quarter, and took the important win that sent them higher up the play-off ladder.

David Phillips led scoring with 25 points, Stephen Lee 12, Powers 9, Pete Puentez 8, John Morrow and Kerry Lee 2 each.

In the regional tourney, the Horns will face Huckaby this Friday, at 3:30 p.m., at Tarleton State University, in Stephenville. Broadcast of the game will be on radio station KGKL FM, 97.5 on the FM dial.

Mr. Williams died in the West Coke County Hospital last Thursday at 6:35 a.m. following a short illness.

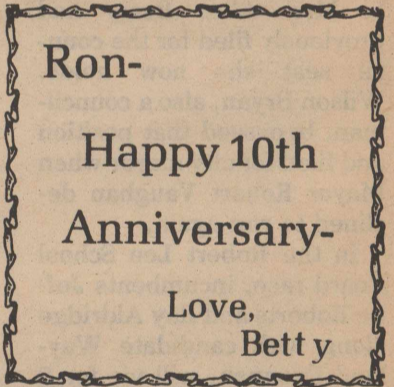

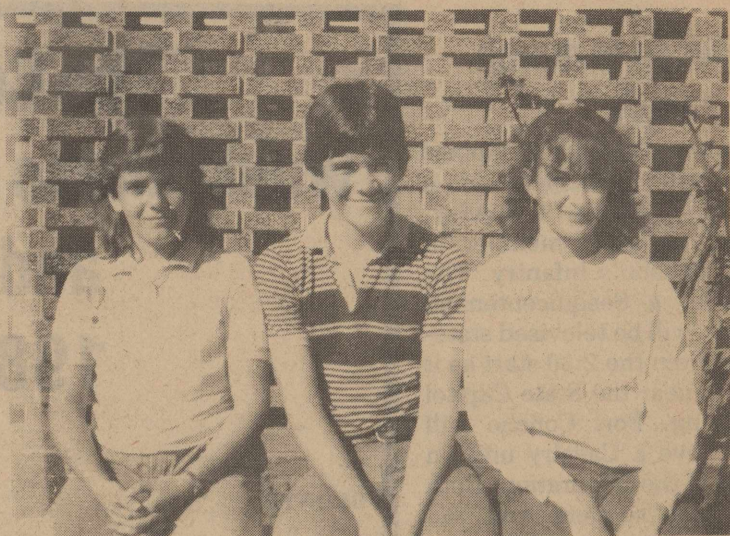

## Oak Creek Fishing News

### News from Oak Creek

The warm water discharged from the power plant has been a real asset to Oak Creek over the year and this year has been no exception. Only a small part of the total fish population is affected by the warmed area, but is enough to make Oak Creek one of the best big bass lakes year in and year out, in this part of the state.

Already the warm water holds hundreds of bass three to six inches and they have a supply of food with shad and minnows by the millions. If you put a poor calf in a green wheat field, that calf is gonna get fat and grow, so do these fish that are attracted to the green pastures of the warm water area. When the water warms in the spring, the fish move out into all areas of the lake two to three months older than the fish that won't spawn until conditions are right in cold areas of the lake.

There have been some nice bass caught out of Oak Creek already this year. The largest has been a fine 7 lb. 14 oz. bass, one at 7-2 and a good number in the six

pound class. This past weekend Craig Knoeller of Midland got two nice bass fishing a worm in about ten feet of water. He caught the fish Saturday morning, one at 6 lbs. even and the other at 5 lbs. 7 oz. Sunday, his brother-in-law from Plano, Doug Quele got himself a fine Oak Creek bass at 5 lbs. 14 oz.

There have been a lot of good crappie caught out of the lake this winter but the best is yet to come when these fish start spawning all over the lake. A lot of these fish are averaging 1¼ to 1½ lbs. and this is good crappie in anybody's lake.

The channel cat are all ready being caught on trotlines like they normally are in April and May. Harold Kennedy of Oak Creek took off 14 fish in one run a few days ago that ran from 1½ to 4 lbs. each.

The lake is in good shape and we expect to see a lot of good fish come out of Oak Creek this spring. Our prayer is that the Good Lord will send the rain and fill all our lakes.

## Establish range vegetation

For farmers who qualify, the USDA Conservation Reserve Program offers an excellent opportunity to establish protective cover on highly erodible cropland.

Since hunting and the sale of hunting rights on land in the program will be permitted, it also provides an opportunity to improve wildlife habitat. Grazing, haying, and commercial timber harvest will not be permitted.

The USDA Agricultural Stabilization and Conservation Service will pay about half the cost of establishing vegetation plus an annual rental for 10 years.

Permanent vegetation includes grasses, legumes, forbs and shrubs.

Producers can plant a combination of plants for livestock forage, or plants that will improve habitat for a variety of wildlife species. Farm wildlife, such as dove and quail can benefit from areas of grass and shrubs within or near the edges of cropland. Range wildlife such as deer and turkey will utilize revegetated areas established to food-producing grasses, forbs and legumes.

Many Texas landowners

have learned that leasing hunting rights to their property can generate needed income at a time when prices for traditional agricultural commodities are depressed. Others like to hunt for their personal enjoyment or to provide for wildlife simply for the pleasure of seeing the animals.

The Soil Conservation Service has been assigned the responsibility for assisting landowners and operators with vegetative plans. SCS personnel can recommend plant species suitable for livestock for desired wildlife species, designs of wildlife plantings, and procedures for vegetative establishment.

If planted primarily for wildlife, the vegetative plan should provide for habitat that is currently deficient at each location.

The first sign-up period for the CRP is the first two weeks in March. SCS personnel assisting soil and water conservation districts can explain the program.

More details will be announced when plans are finalized.

Out of shape? A regular exercise program can start you on the "weigh" to a better looking body, health experts agree.

Any exercise that stimulates your heart and lungs enough to do you some good—get the blood circulating and the heart pumping, but not enough to exhaust you beyond your limits—can be considered good aerobic exercise. Your body gets supplied with more oxygen than before so that your vital organs become stronger, have more endurance and more capacity to do their job right.

There are many ways to get good aerobic exercise. Some people walk regularly — a brisk walk, covering at least a mile in 20 minutes to start. Others jog. Still others enjoy swimming, rowing or dancing.

One of the best ways to get a fine aerobic workout in the privacy and convenience of your own home is with an exercise bicycle. One has innovative features that make the bike comfortable and easy for the whole family to ride.

**Tips must be recorded**

The Internal Revenue Service today reminded taxpayers who receive tips of the need to keep an accurate record of the tip income they receive.

Taxpayers have always been required to keep records to substantiate the amount of their gross income and deductions for income tax purposes. The requirement is a part of the general recordkeeping requirements of the Internal Revenue Code. It applies to records of tip income as well as to all other items. In addition, employees who receive tips as wages or compensation are required to report such tips to his or her employer each month by Section 6053(a) of the Internal Revenue Code. This requirement was added to the Code in 1965.

The Tax Reform Act of 1984 mandated regulations to identify specifically certain kinds of records as adequate under the law to substantiate tip income for income tax purposes. The temporary regulations were published in the Federal Register on July 23, 1985. The purpose of the regulations, in line with the legislative mandate, is to designate certain records as reliable in light of specific recordkeeping problems in industries in which cash tips form a significant part of the employee's compensation.

Under the regulations, a daily record or similar evidence of the tip income received constitutes suffi-

cient evidence to substantiate reported tip income. The IRS publishes Form 4070A to help tipped employees keep a daily record of their tips. Form 4070A was originally published to assist tipped employees to comply with the reporting obligations to employers as described above.

The temporary regulations apply to tips received on or after October 1, 1985. However, evidence considered sufficient by the temporary regulations will also be considered sufficient to substantiate tip income received before October 1, 1985.

The IRS noted, however, that neither the daily record nor other evidence may be sufficient if there are facts and circumstances indicating that the employee received a larger amount of tip income.

## Artherosclerosis controversy

Over the past two decades, a controversy has developed concerning the treatment of persons with hardening of the arteries, or atherosclerosis. The treatment seems to some like a "miracle cure", but to others, chelation therapy provides only false hope. According to the American Heart Association, no clinical proof has been found that chelation therapy is good for anything, except in the treatment of heavy metal poisoning and digitalis toxicity. No double-blind tests have been performed to prove that it relieves hardening of the arteries or helps clear clogged blood vessels.

Chelation therapy involves the administration of a man-made amino acid, called EDTA, intravenously. EDTA naturally seeks out and binds calcium. In the early 1960s, this fact led to speculation that EDTA could be used to remove calcium deposits from atherosclerotic plaque in arteries and veins. The theory proposed that through regular treatments of EDTA, the remainder of the blockage would break up, relieving the narrowing of the arteries.

According to William L. Winters, Jr., M.D., President of the American Heart Assoc. in Texas, this theory is faulty on three levels. "First, the material in atherosclerotic plaque is primarily fiber, not calcium. Second, EDTA has not been proven to remove the calcium from plaques. And, finally, no persuasive evidence from properly controlled studies has established that chelation therapy relieves symptoms," said Winters.

"Therefore," according to Winters, "anyone who accepts chelation therapy becomes a 'guinea pig' and unless the treatment is part of a carefully controlled trial, he or she is a guinea pig without a purpose, as no useful information is going to be obtained."

The dangers of chelation therapy provide further reason to avoid its use. There is a very real danger of kidney failure, and it is also known to cause bone marrow depression, shock, low blood

pressure, convulsion, disturbances of regular heart rhythm, allergic-type reactions and respiratory arrest.

In addition, a number of deaths have been linked to the procedure, not to mention a number of people now on dialysis because of kidney failure linked to chelation therapy treatments.

Dr. Winters is also concerned that the use of chelation therapy will delay the application of proven therapies for people with atherosclerosis.

"The American Heart Association has led the way in providing information on proven ways to reduce the risk of cardiovascular disease. Both in terms of prevention and treatment of disorders of the heart and blood vessels, the American Heart Asso. provides direction based on sound medical and scientific evidence," said Winters. "Our stand on chelation therapy is in agreement with the mission and work of the Amer. Heart Asso. and is designed to save lives."

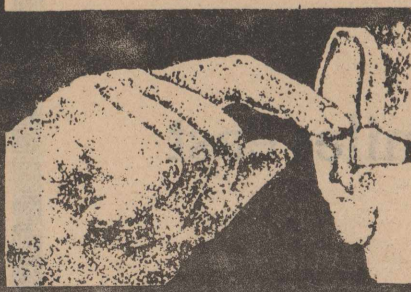
