Exemptions offer tax relief

For homeowners, tax relief is usually in the form of exemptions. An exemption lowers tax payments by deducting part of a property's value from taxation. Homestead exemptions are available for all qualified homeowners, and additional exemptions are available for disabled people and for those aged 65 or older. Elderly homeowners who apply for the over-65 homestead exemption also get a cap, or ceiling, on taxes they pay to the school district. All taxing units offer exemptions to disabled veterans and survivors of those who died on active duty.

Farmers and ranchers who

qualify may have their land taxed on its productive value instead of its market value, which also results in a lower

Application forms for all types of tax relief are available at the Coke County Appraisal District office, 710 Austin Street in Robert Lee and must be in the Appraisal Office before May 1, 1986.

Property owners who last year received homestead exemptions, disabled veteran's exemptions and agricultural-use valuation on land need not reapply in 1986, unless the Chief Appraiser requires a new application to confirm the owner's current qualification.



Judging teams take Snyder contests

Robert Lee High School won first place in overall team awards at the third

Taxpayers pay for traffic fatalities

"Texas taxpayers pay a price for each traffic fatality or injury on the state's roads and highways." That was the message delivered by consumer economics specialist Bonnie Piernot to more than 500 county officials gathered for the 28th annual County judges and Commissioners' Conference, held in College Station, Feb. 25-27. Piernot explained that a traffic fatality costs taxpayers an average of \$12,000 for emergency medical services, police, highway patrol, highway and road repair and other direct costs. She added that each non-fatal injury costs an average of \$7,000. During the first three months after the Texas mandatory safety belt law took effect in Sept. 1985, traffic fatalities decreased 18.2% over the same three month period in 1984, saving 8 million in tax dollars. But the specialist said that studies in other states with similar laws show that safety belt use can decrease over time without continued public education and reinforcement. Piernot, who is a home economist with the Texas A&M University Agricultural Extension Service (TAEX), urged the officials to set an example by wearing safety belts and encourage their employees to wear them in county vehicles as well as their personal cars.

Robert Lee contestants had a total of 1,307 points for top honors in overall team awards, while an Ira High School team took second place with 1,296 points.

The Robert Lee swine judging team took first place with a total of 409 points, while the cattle judging team was third with 522 points. First place in cattle judging went to an Ira team with 548 points.

A Bronte sheep judging team took third place with 377 points. Cody Hartman of Bronte was the top sheep judging individual with 138 points. First place went to Snyder High School with 395 points and second to Borden County High School with 380 points.

In individual honors, Randy Gartman of Robert Lee was third in the top 10 overall individual awards with a total of 447 points. Pammy Millican of Robert Lee was fifth in swine judging with 139 points, just three points behind Lee Morris of Sweetwater and Brett Morton of Snyder who tied for first place with 142 points.

Bob Doty, WTC agriculture instructor, congratulated all the winners and expressed appreciation to all the 23 area high schools which participated in the contests. Thirty-seven teams took part in livestock judging contests and 17 teams in land judging contests.







GARDEN TIPS

With spring gardening about to get into full swing, there are several important tips that will insure a productive garden all summer.

Fertilization is an important key to a healthy productive garden. Soil type, previous fertilization and crops grown effect fertilization rates. A general rule of thumb to follow in absence of a soil test, is to apply one to two pounds of a complete fertilizer like 5-10-10 or 6-12-12 per 100 sq. foot on sandy soils. Tighter clay soils need 2-3 pounds of 10-20-10 or 12-24-12 per 100 sq. foot. Either of these should be applied preplant and tilled into the soil. Additional fertilizer should be applied as a furrow or sidedress application using 1/2-3/4 pound of 21-0-0 per 100 linear feet of row and watered in. Optimum time for this application is at first fruit set for tomatoes, peppers, squash and for leafy crops such as cabbage and lettuce, when they develop several sets of character leaves.

Watering is also very important in gardening. For best production, deep soak the soil to a depth of 6 inches. Wetting the soil to this depth once or twice a week is much better than light watering or sprinkling every day. Check need for watering by observing the soil and not the plants. Scratch the soil at a one inch depth. If moisture is present here, wait a day or two to water. Light frequent watering to keep soil surface moist will cause shallow root development concentrating them in the top inch or two of soil. Under heavy fruit production or hot dry summer days these shallow roots cannot sufficiently supply the plant with needed nutrients, greatly reducing quality of production.

A long handled hoe is the best method of weed control. Chemical controls should not be used as their selectivity to certain crops could damage various garden plants. Cultivate and hoe shallowly to avoid injury to vegetable roots.

BEEF HERD EFFICIENTY IMPORTANT

Because of poor market prices, profit-minded cowcalf producers must give high priority to increasing herd efficiency. Increased efficiency can be accomplished by improving herd management so as to reduce overall costs and thereby reduce the production cost per pound of beef.

One of the foremost management practices in improving herd efficienty is to eliminate unproductive cows -- nonbreeders and those that calve late. The goal

should be for every cow in the herd to produce a calf each year.

The best way to increase the percentage of cows calving every 12 months is to have a single breeding season so that cows calve when forage conditions are generally good. The availability of good quality forage is important to lactation and the rebreeding process.

Calves born in late winter

and early spring generally are the heaviest at weaning because they are old enough to use their mothers' peak milk production. These cows have the most efficient breed-back performance because they are breeding on lush spring grass.

With close culling of the cow herd and a short, wellplanned breeding season, producers can improve their potential for profit.

EMS requirements tola

Volunteers for the ambulance service must meet training standards set by the Texas Dept. of Health. As of Jan. 1, 1986, there must be a least two state certified people on board for each ambulance run. One of these must be trained to the **Emergency Care Attendant** level and one must be at least an Emergency Medical Technician. The West Coke County E.M.S. tries to staff each ambulance call with at least three volunteers. The initial training offered for the volunteers for the Robert Lee-based ambulance service is an EMT class. It requires 100 hours of classroom training, five ambulance runs and 20 in-hospital hours. Once the student completes the course, he takes the state certification exam and if he passes it (70% or better score), he is certified by the State of Texas as an EMT for the next four (4) years. To re-certify, he must then take a total of 80 continuing education hours over the next four years and re-take the state exam.

The local volunteer takes the approved course, passes the state exam and is then asked to volunteer to work on the ambulance. Twelve-hour shifts are scheduled and the volunteer is "on-call". No one stays at the hospital but each on-call volunteer obligates himself to be readily available for that twelvehour period. He may receive the ambulance calls by telephone or by a two-way mobile radio (hand-held) that frees him to go about his routine activities. Once each month, a continuing education class is offered (3 hours in length) to keep skills and knowledge fresh and to meet the state requirement to provide for recertification each four years. The group also mans the monthly blood pressure clinic at the Post Office. In addition, the ambulance is provided on a stand-by basis for all local football games and for other community activities as needed.

There are no dues to pay to belong to the volunteer group and the amount of time needed each month is minimal IF there are enough volunteers.

If YOU volunteer, the group works with you to help you with the necessary training and once you are certified, the group's scheduling committee takes into account your personal schedule (job, vacation, other community activities) and tries to make being on-call as painless as possible. The more volunteers, the easier it is to be a volunteer. The time you commit to this worthwhile program is a service to your community, your neighbors, friends and family that only YOU can give.

The ambulance service volunteers are a proud

group, dedicated to provide emergency medical care to the citizens and visitors of our area. The group received the prestigious Basic Life Support System of the Year award in 1984. This award is given by the Texas Association of EMTs to the outstanding service in the State of Texas. All ambulance services providing basic life support care (paid, volunteer or a combination of both) compete for this honor. Size of the group, its annual payroll or case load doesn't count. What counts is the quality of care given. Help us continue this proud tradi-

To recap, if you volunteer you will be committing yourself to the following:

1. Time to take the basic emergency medical technician class (100 classroom hours, time to make five emergency ambulance runs and 20 in-hospital hours) at a cost of \$25 for tuition and books. This amount is refunded by the West Coke County EMS to persons completing the class, becoming certified by the State and agreeing to serve at least one year as an active volunteer.

2. Three hours per month for the continuing education class held in Robert Lee. No volunteer is required to attend ALL of these classes but participation is encouraged.

3. Several 12-hour shifts "on-call" for ambulance duty. This time is worked to accomodate your work schedule, vacation plans and other personal schedule needs. The more volunteers available, the fewer shifts per month are needed from each person.

3. A willing attitude to care for your family, neighbors and friends.

The volunteer does NOT have to be medically trained before the EMT class nor does he or she have to "like" that kind of "stuff". Physical strength is NOT a requirement although the volunteer should be in reasonably good health and able to move with some agility. Age is NOT a factor with the exception that the volunteer must be at least 18 in order to take the state certifying examination. The most important attribute the volunteer can bring to the group is the ability to care -- to care about and for the patients and to care that an ambulance is available when the need occurs.
