The U.S. Olympic Torch will be in Bronte Sunday, June 29, 1986 at approximately 12:15 p.m. The torch will arrive from San Angelo, circling in front of the Bronte Nursing Home for the pleasure of the residents and continue to the parking lot of the First National Bank in downtown. A short ceremony conducted by Mayor J.T. Henry will be held for the public before the runners travel north on Highway 277 to Abilene.

The Bronte High School State Qualified mile relay team will carry the torch through Bronte city limits. Team members are: Stephen Lee, Pete Puentez, Randy Draper and Todd Brooks.

In preparation for the historical event residents and businesses within the city are working toward presenting a clean, neat, and pretty "face". Persons along route 277 are urged to fly their flag to show pride in America.

The upcoming U.S. Olympic Festival '86 to be held July 25-Aug. 3 in Houston will help prepare the United States athletes for the International Olympics in 1988.

Robert Lee's Salute to the Texas Sesquicentennial celebration will be observed Friday, July 4, 1986.

A Fourth of July Festival is scheduled to open at the Coke County Park in Robert Lee with a breakfast in the large Recreation Hall from 7:30 to 9 a.m. An ABC Golf Tournament at Mountain Creek Golf Course will begin at 8:00 a.m. Food Booths and Arts & Crafts Booths will open at 11:30 a.m., with a variety of foods and craft items for sale.

The U.S. Olympic Festival - '86 Torch Run will arrive in Robert Lee, Saturday, June 28, at 8:00 p.m. Local torch bearers will meet the Torch Run Crew north on Highway 208 - near the City Limits.

At press time, 26 local runners had signed up at City Hall - ALL runners must sign a form and be issued an official T-shirt of the U.S. Olympic Festival '86 Torch Run.

Local runners will relay the torch to the Wilson Bryan Mini-Park at City Hall for a brief ceremony of welcome and will continue the relay of the torch to the city limit south on Hwy. 208.

The 5-week torch relay will end in Houston on July 25 after stops in more than 100 Texas cities and will signal the beginning of the U.S. Olympic Festival '86. The competition will include 4000 athletes in 34 sports.

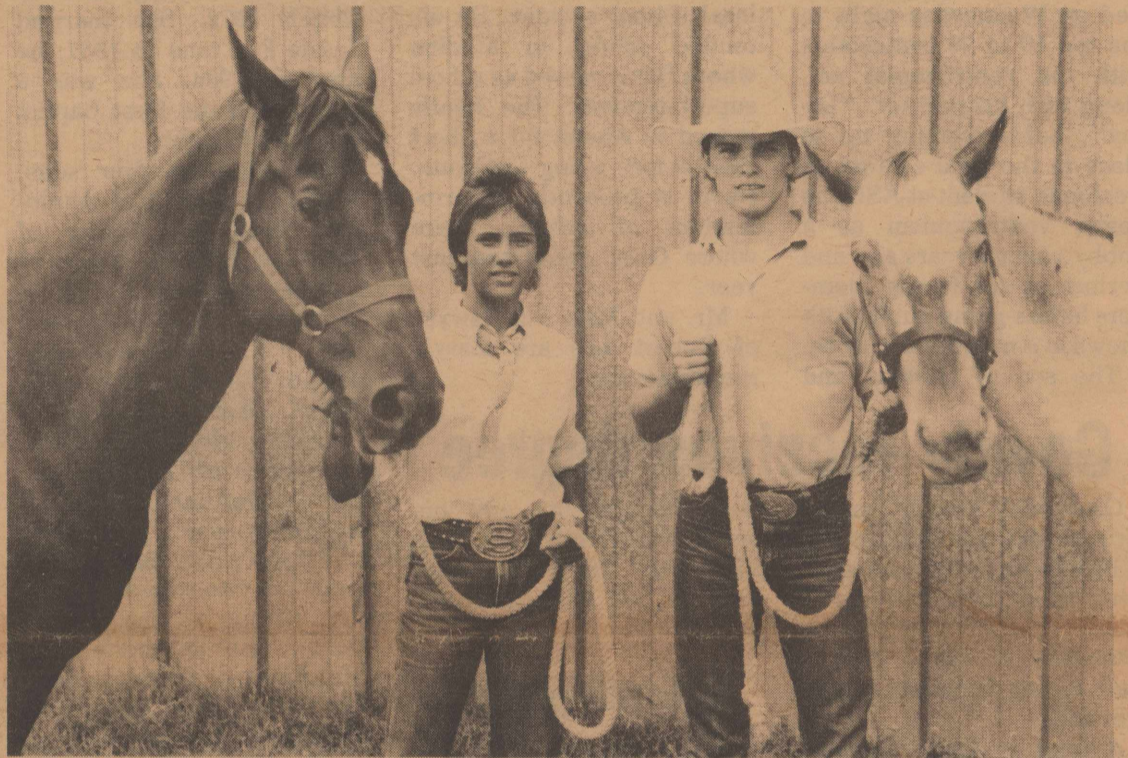
About 15,000 volunteers will have carried the flame across the state by the finish of "A Run Through Texas History".

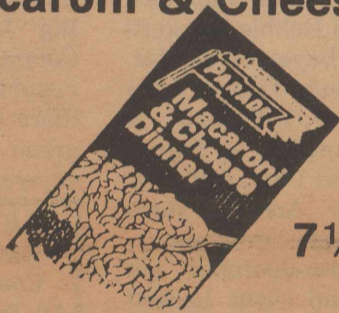

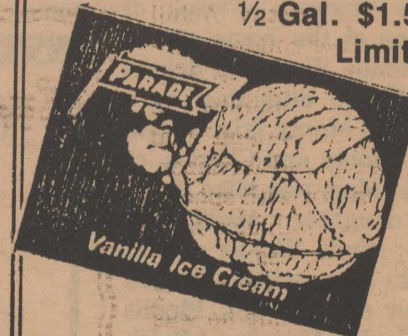

On speaking "postal language" it is often difficult for us to change words we have all been using for years, but change we must as times change, mechanization is taking over more and more, and different terms are used to describe various parts of the postal service.

We have always called routes which operate between cities "Star Routes". We have three such routes out of our office, one from San Angelo and return; one to Sanco and Silver; and one to Edith. These three routes have in the past been called San Angelo Star Route, Sanco Star Route and Edith Star Route. This is no longer correct and these three routes are now called "Highway Contract Routes" or HC-34 for San Angelo; HC-61 for Sanco and HC-60 for Edith. We will be working with all the folks on these routes in the near future so that we can get the addresses changed. The postal service will assist all HCR customers in notifying newspapers, magazines, etc. of the correct address. It will take a little time, but will be well worth it because it will result in faster and more stream-lined service in the future.

The hall took on a festive air with the serving table decorated in a yellow linen

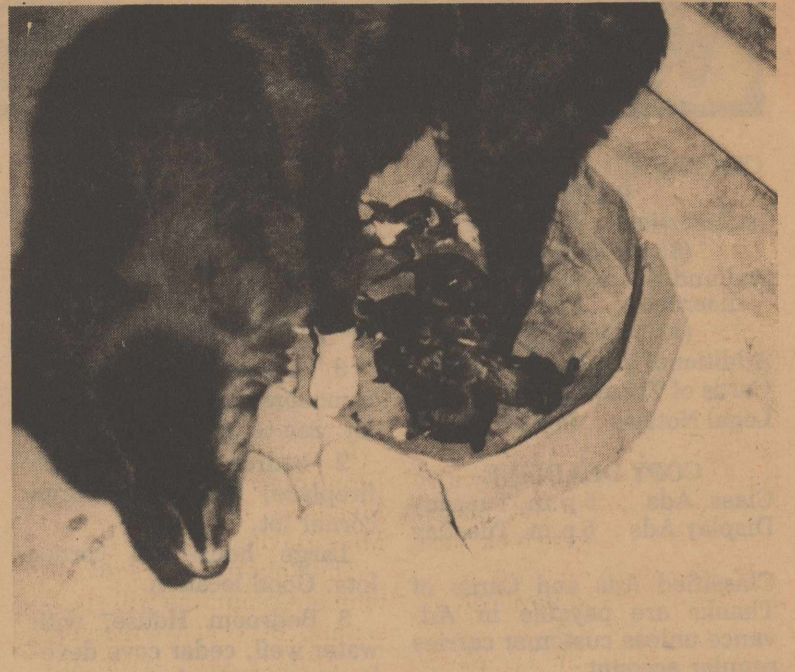

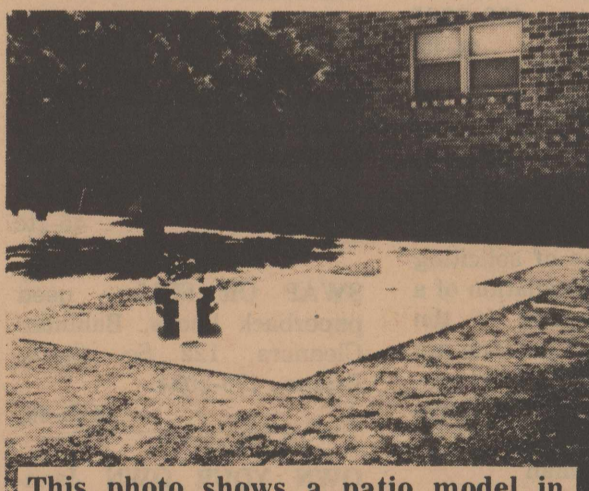
