Tax revenues told

State Comptroller Bob Bullock Friday sent checks totaling \$107.7 million in local sales tax payments to the 1,026 cities that levy the one-percent city tax.

Coke County's revenue from the sales tax totaled \$7,514.95 - \$2,717.48 for the city of Bronte while Robert Lee gained \$4,797.47 for the period. The county's total for the same period last year was \$8,976.06, however, for the first 6 months of 1986 local revenues are ahead of the same period for 1985.

August checks represent taxes collected on sales in June and during the second quarter and reported to the Comptroller by July 20.

Two Robert Lee citizens have recently been arrested by the Coke County Sheriff's office on criminal charges.

Theresa Marie Mecher, 20, has been released on \$5,000 bond following her arrest July 19 in Hurst. She has been charged with unauthorized use of a motor vehicle involving a stolen pickup, a 1978 Chevrolet, from a Robert Lee residence, on July 16.

Ms. Mecher was initially arrested by the Hurst Police Department following a traffic violation and a license check revealed the vehicle was stolen. She was held in custody for Sheriff Marshall Millican who, accompanied by Deputy Yvonne Devoll, returned her to Robert Lee.

Bond has been set at \$20,000 by Coke County Peace Justice Opal Jacoby for Ynes Lara who is charged with burglary of a habitation. Lara, 35, was arrested on Monday south of Robert Lee on a job site by Sheriff Millican. He was being held in the Tom Green County Jail at press time on Wednesday.

According to Millican, a panel of Grand Jurors are scheduled to be called between Aug. 21 and Sept. 1, with a number of cases for consideration on the docket.

During the course of our daily routines, we find some of our customers still are unaware of some of our services. To me, one of our best bargains is a postal money order. You can buy a money order for \$1.00 to \$25.00 for 75c and from \$25.01 to \$700.00, the fee is only \$1.00. This is the safest way to send money through the mail. NEVER send cash in a letter or card because you run a great risk of losing it. It's worth a small fee to make certain that son, daughter, niece or nephew, etc. receives the money you are sending them.

Another good service which is not too well known is "special handling" on a parcel. If you want your parcel to receive just that 'Special Handling' you can pay a fee of \$1.10 for a parcel





For instance, there is much confusion about the effects of saturated fat and cholesterol on human health. But even if you believe the avoidance of such foods is prudent, which meats contain these products?, Uvacek asks. So he offers the following quiz for "diet watchers."

Which of the following meats (equivalent cooked quantities) has the most saturated fat or cholesterol? A large egg or a rib steak?

Shrimp or ground beef? Roast chicken (light meat, skinned) or canned tuna?

Crab meat or ground beef? Extra lean ground beef or roast chicken (dark meat with skin)?

In every example but the last, the first food listed is higher in cholesterol but the second item has more saturated fats, Uvacek points out. In the last comparison, however, the beef and chicken are equal in cholesterol but the chicken has more saturated fat.

Uvacek adds that beef steaks and roasts, ground beef, roast chicken and turkey all have about the same cholesterol content. The really high cholesterol foods are chicken livers, eggs, beef liver and shrimp, he points

Controlling spider mites

Lewis reunion

by Tommy Antilley SPIDER MITES --TINY PESTS

CAUSE BIG PROBLEMS Spider mites are tiny but they can cause big problems in home gardens.

These pests prefer tomatoes, beans and peas and do most of their damage in hot, dry weather.

Spider mites, also called red spiders, are only 1/60inch in length and vary in color from white to green to

The tiny pests can build up quickly and completely engulf plants. They lay eggs on the underside of leaves, which hatch in four to five days. A complete life cycle takes three weeks, and as many as 20 overlapping generations can occur in a single

Mites spin a thin web which often can be seen on the underside of an infested leaf. They feed by inserting their mouth-parts into the tissue and sucking juice from the plant. While feeding,

they inject toxic substances into the plant.

Infestations of spider mites can be indentified by tiny white spots on the underside of a leaf. Heavy infestations cause bleaching or yellowing, first along the main leaf veins and then throughout the plant. The plant may also shed buds and small fruit. Spider mites can completely defoliate a plant if not controlled.

Control of spider mites is often difficult and requires from two to four applications of insecticide at five-day intervals. Plants should be checked frequently for spider mites since the pests can build up rapidly.

Insecticides registered for controlling spider mites in gardens are diazinon, kelthane, malathion, ethion and sulphur. However, avoid using sulphur on vine plants as severe plant change could

As always, read and follow label directions on all insecticides.

Linnenkugel visits in France

[Editor's Note - Below is an interesting writing by Paulette Linnenkugel of Robert Lee. A native of France, she recently returned from a 2 week visit with her family.]

Returning recently from a visit with my family in France, I would like to share with you a few things I experienced during my trip.

First of all, I was born and raised in Metz, on the Moselle River in Alsace Lorraine, right next to the German Border, in the North East corner of France. I visited the American Cemetery in Verdun, where so many Americans were buried during World War II. I know that a lot of men from this area, were on duty there during W.W. II, fighting for our freedom. I was a child then and I remember, so I would like to take this opportunity to say, THANK YOU. I toured Luxembourg, Belgium, the French Alps and Germany. The country was beautiful and green, it rained 15 out of the 17 days I was there!

My cousin Jean Luke took me to the Nuclear Plant located between Metz and Luxembourg, it was quite a sight. He is employed there. Everyone was nice and the French hospitality was overwhelming. It was a wonderful and emotional visit with my mother and family, and an exceptional voyage, but it sure is great to be back home. I am proud to say, that the area of France I come from has taken part in the building of the Statue of Liberty. Following is an article I thought might interest the readers.

In 1865 at Glatigny, a country estate near Versaille, members of the intellectual elite of Paris, France, were having dinner. But one guest was Frederic Auguste

Bartholdi, a 31 year old sculptor from Alsace who had been commissioned to do a bust of his host, Edouard Rene de Laboulaye age 54, a liberal minded law professor, who found great interest in the U.S. Constitution, proposed to have a monument built in America. as a memorial of Independence and a fraternity of feelings between France and the U.S. The remark stuck in the mind of the young sculptor. But it was not until six years later in 1871, that Laboulaye urged Bartholdi to pursue the idea. So on June 21, 1871; Bartholdi came to America to propose to their friends to join the French in making a monument, at the view of the harbor of New York. He was certain that his statue had to rise there, where people get their first view of the New World.

For five months, Bartholdi, equipped with letters of introduction to officials and art patrons toured the nation. He met with President Ulysses S. Grant and poet Henry Wadsworth Longfellow, among others, to promote his project and figure out, as he said "If the dream could become reality".

Back in France, Bartholdi began planning the construction of the lady he called "My American". The internal structure of iron beams were designed by Alexendre Gustave Eiffel. (He later created the famous tower.) The definitive four foot model, made of clay, was finished in 1875. One evening at the Opera, a French Senator noticed an aged woman sitting in a corner. When the light fell on her face, he turned to Bartholdi and said to him, "Why that's your model for the statue of Liberty". Yes, "He answered calmly, "She's my mo-

Laboulaye was trying to raise 600,000 francs or \$250,000 for the organization he named the Franco-American Union. This money was to be for the statue only and the Americans on their side were to raise the money for the pedestal.

A metals industry offered

to provide the copper, the city of Rouen donated 500 francs and other contributions trickled in. The children of France donated their allowance, they placed Liberty Money boxes every where; in schools, churches, banks, post offices and they offered manufacturers the right to use the symbol for a fee. The idea caught hold and by the following year the lady was being used on everything from wine to cheese. To encourage the Americans to begin raising funds, the Union decided to send a section of the statue to the U.S. At last construction was under way, the study model had been enlarged and corrected to a 38 foot version. In Sept. 1876, Liberty's hand holding the torch went on display at the Philadelphia Exposition and inspired a few powerful New Yorkers to create the American Committee for the Statue of Liberty. In 1877 they petitioned for and won from Congress the Bedloe's Island site, (now called Liberty Island).

A year later in Paris, the head and shoulders were displayed. Two years later, the Franco American Union had enough money to finish the statue. The torch was sent back to France and the completed figure was displayed in Paris to the amazement of 300,000 visitors. On July 4th, 1884, a formal presentation was made to the U.S. Ambassador before the gift was disassembled and shipped to its New Land.

Like many other immigrants, however, the figure had no home waiting. In March of 1885, the American Committee could show a handsome design for a \$250,000 pedestal from architect Richard Morris Hunt and a foundation \$100,000 was still needed. Everyone except New Yorkers felt that New Yorkers should bear the cost. The supporter Joseph Pulitzer launched a campaign begging "Give something, however little. Let us hear from people". The people, 121,000 of them, gave and each donor got his name printed in Pulitzer's paper.

The crated statue waited a year, but in April 1886, the pedestal was finished. The statue arrived dismantled in 214 packing cases from Rouen, France, in June 1885. It took seven months to reassemble the statue in place, but finally on Oct. 28, 1886 the last rivet of the statue was driven when President Grover Cleveland dedicated

the monument.

Laboulaye, who had labored so long on his "Treaty of Friendship" had died three years earlier, but sculptor Bartholdi, in the crown awaiting a boy's signal to release the French flag covering the lady's face said, "It is a consolation to know that this statue will exist thousands of years from now, long after our names shall have been forgotten". "Liberty lives only through Truth and Justice, Light and Law," said Edouard Rene de Laboulaye, the law professor who proposed the statue. To Bartholdi, the torch symbolized enlightenment, but, towering 305 feet above sea level, it was later seen as a welcoming beacon.



GET THE MOST FROM BACK-TO-SCHOOL CLOTHING DOLLARS

For many Texas families the economic downturn means beginning a new school year with less money to outfit the kids.

But a number of alternatives are there for stretching the family's back-to-school clothes budget.

Start by going through the childrens' clothes to see what is worn out, what is outgrown and what can be 'restyled''.

A clothing exchange with relatives, friends and neighbors can help everyone get more wear out of outgrown, but not outworn, childrens' clothing. Garage sales and re-sale shops are also a source of inexpensive clothing in good condition.

If you have the time and sewing skills, try altering some dresses, jumpers and other items. Look for deep hems in skirts, pants and sleeves that can be lengthened. Decorative stitching, trim, or a fabric insert will hide marks from the old hem. Tucks in bodices, skirts, pant legs and sleeves may also be released to add length.

When you shop for school clothing, look for durable clothing that can "grow" with the child throughout the school year. Discount and outlet stores carry lessexpensive clothing, but it may also be less durable.

Before buying, inspect clothes for wide seams that won't ravel or pull out, and on knits, narrow seams that are stitched and overcast.

Double stitched seams or tape inserted in seams that receive the most stress, such as pants crotch or armhole seams is another sign of durability.

If the style, fabric, fit and price are right, you can always add needed reinforcements on your home sewing machine to make less durable clothing last longer.

When you shop for new clothing, keep in mind the specific features that will allow for the child's growth. Some of these features include deep hems, adjustable straps and waistbands, raglan sleeves, and stretch fab-

Two piece clothes usually provide more room for growth than one piece items, and dresses without a definite waistline can be worn longer than those with fitted waists.

In general, you'll do best to spend the most money on those clothes that are worn most often, receive the hardest wear and are laundered frequently.

A FIGURE **OF SPEECH**

The Sweet Taste of Success

Traditionally, diets have demanded that you must sacrifice sweets. For many of us, however, that deprivation leads to downfall. Well, forget what you've been told. You can eat sweets while you're losing weight. In fact, eating sweets just may help you reach your goal sooner.

How can this be? How can you • Find low calorie recipes to reeat chocolate mousse or strawberry cheese cake and still lose weight? The answer is that completely avoiding sweets may actually mean more trouble than a little indul-

Deprivation is one of the main reasons for diet failures. If calorieladen sweets tempt you to stray, or worse, forsake your program altogether, then cutting them out of your life completely may only set the stage for failure.

Even if you can live without sweets for months, you're not learning to control the amount of sugar you consume. And learning to control those tempting delights • Avoid feeling guilty. Tell yourself is as important as learning to control other aspects of eating.

The main lesson when incorporating sweets into your diet is portion control. Eating the desserts you crave, in controlled amounts, • will leave you feeling less deprived and more amiable toward your weight loss program.

TEXAS

Unlike most other garden vegetables, such as corn or tomatoes, greens are not immediately recognizable to everyone, probably because there are so many different kinds of greens.

The most familiar of this leafy group of vegetables is mustard greens, but collards, spinach and turnips also are included. All are members of the Cruciferae family of vegetables, except for spinach, which belongs to the Chenopodiaceae family. All the greens are cool-season vegetables and have similar cultural requirements.

Let us look at some of the common needs of all greens.

All greens will do best when planted on raised beds, though it is more important with collards and turnips than with the other greens. It is always a good idea to use raised beds if your garden soil is heavy or drains poorly. To form raised beds, use your shovel or tiller with a bedder to form ridges and furrows that measure about 30 to **How To Grow Healthy, Hardy Winter Greens**



36 inches apart from the top of one ridge to the top of an adjacent ridge. Then, use your rake to form and smooth the ridges into raised beds, which should be 16 to 20 inches wide and approximately 6 inches high. The lower areas can serve as furrows to make watering easier and to provide good drainage.

All greens will benefit from the addition of organic matter to the soil. Generally, it is a good idea to incorporate 2 or 3 inches of well-decomposed leaves, grass clippings, hay or compost into the soil 8 to 10 inches deep.


Well-aged barnyard manure, worked into the soil before planting, will help provide greens with all the fertility they need. For turnips and spinach, use 50 pounds of manure per 35 feet of row or for each 100 square feet; for mustard greens and collards, use 100 pounds of manure. Depending on your soil type and the level of fertility, you may also need to add a small amount of commercial fertilizer to the soil. Generally, a fertilizer with a 1-2-2 ratio, such as 10-20-20, is suitable if you live in East Texas or on the Gulf Coast. In most other areas of the state a fertilizer with a 1-2-1 ratio, such as 10-20-10, is satisfactory. Greens generally will do best on soils with a pH of between 5.5 and 7.0.



FIRE ANT BATTLE RAGES ON-- The battle against the imported fire ant rages on -and it's an uphill battle. With earlier visions of eradication fading, the battle now seems to be one of containment. The pest, brought in from South America, now infests some 115 Texas counties. Its sting has a burning sensation and can be serious to hypersensitive people. Control products are abundant, says an entomologist with the Texas Agricultural Extension Service, and in-

clude mound treatments, baits and, of course, home remedies. All work differently and vary in cost, so an individual planning to do battle with fire ants should first evaluate the situation. To eliminate the pests, control must be intensive and will be costly. If a reduction of mounds is the objective, a broadcast bait likely will do the job. Products containing carbaryl, chlorpyrifos, diazinon, isofenfos, propoxur or resmetrin can be used for spot treatments in and

around the home as well as to establish a barrier around areas such as gardens and patios.

LANDSCAPE IRRIGATION TIPS OFFERED

With the current hot, dry weather, homeowners must give careful attention to watering their yards and gardens. Here are some tips on getting the most from irrigation water so as to keep plants and lawns healthy while keeping water costs down.

1. Practice slow, deep watering to allow roots to penetrate deeper so that plants become more stress-resistant.

2. Soaker hoses and drip irrigation systems work well on trees and shrubs. It's more efficient to water at night or early in the morning because evaporation is less. However, night-time watering can promote more disease problems.

3. Too much water can be as detrimental or ever worse than not enough. The rate at which water is applied should be no more rapid than the rate at which the soil can absorb it. Never fertilize landscape plants when soil is

dry. It's best to water the area one day, apply fertilizer the next day, and then water again. Fertilizer will do no good unless it is dissolved and moved down into the soil.

4. Shrubs and trees near foundations, under eaves or on southern and western exposures need frequent watering because they often get less benefit from rainfall and have to deal with heat reflected from walls.

5. Plants on mounds or slopes suffer from drought stress more easily than those on level areas, so these require more frequent watering.

6. Use an organic mulch of pine bark, chopped straw, hay or similar material to reduce irrigation needs.

7. Treat water as a valuable resource. Use it to water plants when needed but do not waste water. Although considered a renewable resource, good water supplies are becoming scarce in Texas.

Energy assistance available

Some low-income Texas households may be eligible for help in paying their cooling bills this summer through the Home Energy Assistance Program, according to Texas Department of Human Services Commissioner Marlin Johnston.

Commissioner Johnston said the one-time payment is available to many low-income households. Households which this month received food stamps, Aid to Families with Dependent Children, or Supplemental Security Income will be mailed applications automatically. Other low-income households may request an application from DHS during the enrollment period of June 16 through July 18.

Eligibility is limited by gross income. For instance, aid is available for a one-person household having less than a \$547.49 gross income per month. The gross income limit is \$733.49 for a two-person household, \$919.49 for three, \$1,105.49

for four, \$1,291.49 for five, and \$1,477.49 for six.

Eligible households must be subject to energy cost increases - because of bills or rent being higher due to rising energy costs.

Households in privately owned or rented housing are eligible if the cost for cooling is included in the rent payment or if the household pays a portion of its home energy costs.

Energy assistance checks are sent directly to the people who are eligible for assistance. However, the checks are made payable to the energy company for the benefit of the eligible person.

Households receiving one of these energy assistance checks should mail it or take it in person to the energy company business office with the regular energy bill. The check can be cashed only by the energy company. If the HEAP check is more than the energy bill, the additional amount will be

credited to the person's account for the next month's bill. If the energy bill is higher than the check, the person is responsible for paying the difference.
