The fire was mostly confined to the area between the ceiling and roof with fortunately no loss of merchandise or equipment. The electrical short completely destroyed the large sign on top of the roof and damaged the area around the sign.

Store manager Roy Flores credits the prompt and efficient manner of the Bronte Volunteer Fire Department with preventing extensive fire and smoke damage to the store. He said his company is very appreciative of the firefighters for their quick response and work in keeping their losses to a minimum.

In the meantime, the store is awaiting arrival of their new sign and remaining open for business with little interior evidence of the fire other than the tell tale odor and the repair work going



The Bronte Longhorns opened their 1986 football season Friday night with an overpowering 33 to 0 victory over the Jim Ned Indians in Tuscola.

On a cool evening and a surprisingly good field that held up well after a week of rain the Longhorns offense moved at will but was still overshadowed by a dominating defense. Jim Ned was able to cross the fifty yard line only twice; once on a fumble recovery on the opening series and late in the second half after the game was well in hand for Bronte.

The scoring began on Bronte's second possession with 9:22 left in the 1st quarter. A pass interception by Randy Draper left the ball on the Tuscola 40 yard line. Quarterback, Stephen Lee unloaded a long pass aimed at Pete Puentez. The pass sailed over and off a defenders outstretched fingertips into Puentez's arms as he crossed the goal line. Puentez kicked the PAT and it was 7-0 Bronte. Early in the second quarter Bronte got the ball again on a pass interception by Corby Kelso at the Tuscola 49 yard line. The Longhorns marched down the field in ten plays capped by a four yard run by Kelso for the T.D. PAT was good by Puentez and the score was 14-0 with 9:54 left in the first half. Bronte

struck again before the half ended when the Tuscola QB was knocked loose from the ball on his own 23 yard line and the Longhorns recovered. Seven plays later Stephen Lee burst into the end zone on a 10 yard run. The PAT was fumbled and the score was 20-0 with 3:54 to go in the half as it was at the end of the half.

After halftime Bronte again moved the ball easily and with 4:35 left in the third quarter Stephen Lee connected with John Morrow for a 10 yard T.D. pass. Puentez kicked the PAT to make the score 27-0. In the early minutes of the fourth quarter Lee found Morrow again in the end zone for an 11 yard T.D. pass. The PAT failed and Bronte coasted thru the rest of the game to take an impressive 33-0 victory.

Longhorns are 1 win and 0 losses for the young '86 season. Bronte had a fumble, a pass intercepted, and two miscues on extra points to keep the game from being perfect but still one of the most impressive and exciting wins in recent Longhorn history. Bronte's dominating defense as well as a balanced passing and running attack on offense promises a super season. For some real excitement you won't get in an easy chair, come out and back the Longhorns this Friday night Sept. 12 at 8:00 p.m. when the Longhorns play their home opener against Rochelle. The 3rd class mail which is known as "Bulk Business Mail" has to wait until we have finished all the other classes including parcel post.

We have to separate the mail on the cases into sections—then we can start boxing. There are some days when we box mail all day. It takes all hands to keep the mail moving. We will be glad to give you a tour of our facility if you will let us know when you are coming. This way, you can see for yourself how we operate.




Senate Joint Resolution 4 proposes a constitutional amendment that would repeal the prohibition against branch banking by state banks and would allow state banks and national banks domiciled in this state to establish and operate banking facilities at locations within the county or city where they are domiciled. The amendment would also authorize the Legislature to permit a state bank or a national bank domiciled in this state to engage in business at more than one place if it acquires a failed state bank or national bank domiciled in this state.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to provide that a bank may offer full service banking at more than one location within the city or county where its principal facility is located, subject to limitations and restrictions provided by law."
