County monsoon season continues

The monsoon season continues in West Texas! Once in a lifetime late summer and early fall rains have broken records just about everywhere in our part of the state. Reports of over 40 inches to date for the year are not uncommon in many areas. Although no official yearly measurement in Coke County is available, many residents have kept a running total. James Miller who ranches west of Tennyson reported his total so far to be 47 inches of rainfall. His immediate area received 15 inches in May and June that Robert Lee, Bronte, and Blackwell did not get. The

rest has fallen mostly in September and October.

Rainfall of varied intensity from drizzle to real gully washers fell on Bronte this past weekend. Rain guages in the city recorded 6.8 inches. Robert Lee's official measurement stood at 4.8 for the weekend but several folks reported upwards to 7 inches.

Coke County soil, which had already been abundantly blessed by late summer rains, became saturated anew and already swollen reservoirs were spilling over. Oak Creek Lake benefitted greatly from rains on the watershed which resulted in

the lake going over the spillway. Robert Lee's water supply, Mountain Creek Lake, has stood brim-full since last month's rain so only the first showers last Friday night sent it over the spillway into Mountain Creek, then on to the Colorado River below. Lake Spence had already gained about two vertical feet on Monday according to spokesman Mike Ross, with more to come as the river at Silver was running bank-full at that time.

Several roads near the county were closed due to high water over the weekend, including Hwy. 208 between Silver and Colorado City. Rains left Maryneal practically isolated with the two roads leading in covered with water.

Benefits of the rains are too numerous to mention, not the least of which are the awakening of springs around the vicinity, dormant for many years. Cotton farmers and some milo producers are suffering but hopefully they will be helped in the long run with deep moisture.

Texas Parks and Wildlife Department will issue eithersex deer tags for Coke County on Oct. 23, 24, 1986 from 8:00 a.m.-12:00 Noon and 1:00 p.m. - 5:00 p.m. in the County Courthouse in Robert Lee. The either-sex tags are required for any antlerless deer harvested in this County during the upcoming season.

To qualify for tags, a

landowner must own or control acreage in Coke County. After the opening of the hunting season, tags will ONLY be available through regional offices located in Rockport, San Angelo, Tyler, Waco, and the State Office in Austin. Tags WILL NOT be issued by local department personnel. Landowners or their agents are urged to pick up tags on the sche-

duled issuance dates.

Neighboring counties where TPWD will issue tags are: Sterling County, Nov. 3, Courthouse, Sterling City; Tom Green County, Nov. 5 & 6, Courthouse Annex, San Angelo; Runnels County, Oct. 29 & 30, Courthouse, Ballinger; Nolan County, Oct. 23 & 24, Courthouse, Sweetwater.

A continuing price decline in the natural gas market means another refund to West Texas Utilities Co.'s retail customers in Decem-

WTU officials announced Thursday that a request was being filled with the Public **Utility Commission of Texas** for permission to refund a total of \$6.9 million in retain revenues collected in excess of actual fuel costs, and to lower its fuel charge rate for the months of December 1986 through April 1987. The total includes \$6,740,467 in actual fuel cost savings accumulated in July and August, plus \$149,003 in interest.

Under WTU's proposal, all existing retail customers would receive refunds through one-time credits to their bills in December. A typical residential customer would receive about \$17.

The fuel rate--- known as the "fixed fuel factor" -- is approved by the PUC. When the actual cost of fuel is below the approved rate, the over-recovery is returned to the customers, with interest.

WTU's base rates have not changed since December 1984. Company officials have

The Nursing Home residents need a hospital here as badly as those of us who can care for ourselves. Taking people to another county for **URGENT** medical attention



Writing competition

A high school student will win \$10,000 in a writing competition now being staged in conjunction with the 200th anniversary celebration of the U.S. Constitution next year.

Open to all high school students in grades 9-12 during the 1986-87 school year, and to those aged 14-18 not enrolled in college, the competition will involve students from every state, the District of Columbia and the combined territories.

The competition is being co-sponsored by the Commission on the Bicentennial of the United States Constitution, the American Bar Association and USA TODAY/Gannett Co., Inc.

The Constitution was signed on Sept. 17, 1787, in Phildelphia. To celebrate that event, the Bicentennial Commission, headed by Chief Justice Warren E. Burger, is coordinating activities throughout the nation.

Three winners will be selected from each state, the District of Columbia and the combined territories. The first-place winners each will receive \$1,000; second-place winners, \$500; and third-place winners, \$250.

In addition, the first-place winners and a teacher or other adult will receive an all-expense paid, round trip to Washington, D.C., in September 1987 to meet the president, the chief justice, leaders of Congress and members of the Bicentennial Commission. At that time, the national winner will be selected from among the first-place winners.

The topic for the competition is: "The Constitution:

How Does The Separation of Powers Help Make It Work?"

Entries must be limited to 1,500 words, excluding footnotes, and must be typewritten or computer-generated (double-spaced) or written in legible longhand in ink. All entries must be accompanied by an official entry form and must include the original essay and two copies.

Teachers, students and parents seeking more information about the writing competition and wishing to obtain entry forms may send a postcard to the National Bicentennial Writing Competition, Box 50184, Washington, D.C. 2004-0184. The deadline for entries is April 15, 1987.

The squad will travel to Sterling City on Oct. 9 for a tough hit and run game at 6 p.m.







rite recipes now used and those passed down by family members.


A hearty thanks was given to several members of the Cowley family for their hard work cleaning up the Valley View Cemetery.

Crop insurance year ends

October 31 ends the 1986 year insurance period for barley, oats, and wheat grown in Coke, Texas and insured by the Federal Crop Insurance Corporation (FCIC) according to Dottie Sampley, a representative for the Federal Crop Insurance Corporation.

"Under the terms of the policy, any acreage on which harvest will not be completed must be left intact until an inspection is made. Any

claim for indemnity may be rejected if these loss reporting requirements are not met," Sampley stated.

"Any notice of loss must be given promptly after the total destruction of the unit, completion of harvest, or October 31, whichever occurs earlier," according to Sampley. The producer who anticipates a claim should notify his or her crop insurance representative immediately.



Postal Pointers

With Christmas just around the corner, perhaps we should talk a little about sending parcels overseas. There are two kinds of personal parcels which you can use; (1) PAL (parcel airlift mail) and SAM (space available mail). You can only mail PAL and SAM to military personnel. mail can weigh up to 30 pounds and be 60 inches in combined length and girth. These parcels are flown to a military mail dispatch center where it is airlifted overseas on a space available basis. The charge for this service is the regular parcel post rate to the military dispatch center, plus 30c up to two pounds, 60c up to three pounds, 90c up to four pounds and \$1.20 over four pounds, up to 30.

SAM mail can weigh up to 15 pounds and be 60 inches in length and girth. This mail is transported by surface to the military mail dispatch center, then is flown from the United States to the overseas destination. Parcels meeting these specifications are eligible for SAM mail and you should ask the postal clerk to so mark your parcel. All SAM parcels leave the United

States on a space available basis. There is no extra fee.

The time is here for getting your parcels ready for overseas, whether or not it is military. A schedule for mailing to different countries is now available at the post office and deadline dates range from October 17 for regular surface parcels to Armed Forces in Australia, Far East, and South and East Asia-to December 8 for Priority Mail to Alaska and Hawaii.

We realize that not everybody mails overseas, but for those who do, this information is very important and we are ready to help in any way to get your parcels and letters there on time. Another reminder-be sure to enclose your name and address inside your parcel just in case something happens to the outside address. This way you will be sure to at least get your parcel back if something should happen to the outside address and you won't be wondering six months from now what ever happened to your package. Make sure your wrapping is good too and that you use something besides masking tape or scotch tape. Just ask us-we'll tell you the best

Mrs. Martin reports she had a very interesting and enjoyable time in Austin. She was interviewed by the media and was quoted in the Houston Post and San Angelo Standard-Times and appeared on a Houston television program. She will have a more complete report of her experiences in next week's paper.

Clinic hours extended

Ms. Jo Alexander, Clinic Manager of Planned Parenthood Center of San Angelo. Inc. announced today the expansion of the clinic hours to help meet a goal to make family planning information and services affordable, accessible, and understandable to any person desiring those services.

The new hours include one evening clinic a week in addition to opening one half hour earlier in the morning. The new hours will be as follows: Monday thru Wednesday-8:00 am-5:30 pm; Thursday-8:00 am-8:00 pm; Friday-8:00 am-5:30 pm.

All services are offered without regard to age, race, color, marital status, sexual preference, or national origin.

Ms. Alexander states that "Fees for service are based on family size and income, using a sliding fee scale. The fee range for a complete physical exam and contraceptive supplies would be from \$25 to \$70. All services to all patients are strictly confidential. We respect your right to privacy.

Appointments may be made by calling Planned Parenthood of San Angelo at (915) 944-1909 or by using our toll free number (in Texas) at 1-800-237-2161.

Ms. Dustin Munro has been hired at the clinic as the center's new nurse practitioner. Ms. Munroe sees her role at Planned Parenthood of San Angelo as one of providing a complete range of medical services to every person of reproductive age. She recommends that a woman have her first gynecological exam and Pap smear when she becomes sexually active, begins to have gyn-related problems, or turns 18, whichever comes first.

Ms. Munro further states that, "The clinic has undergone a series of dramatic changes that will greatly improve the quality of care that is provided and reduce the amount of time a patient spends in the clinic receiving services. It is now possible for patients to call for appointments and receive them either the same day or within five working days. Also, the amount of time a patient spends in the clinic has been reduced from an average of two hours to a maximum of one hour, with the staff striving for the time to be reduced further to forty-five minutes of less."

Reducing dietary fats

REDUCING VISIBLE AND HIDDEN FATS IN THE DIET - Consumers may associate fat with meat because it is visible, and tend to ignore the hidden fats in other types of food, says Texas A&M University Agricultural Extension Service nutritionist Mary K. Sweeten. "Unless people read food ingredient labels, they are often unaware that coconut oil, palm oil and other saturated fats are frequently used in baked goods and other processed foods," she remarks. Both the U.S. Dietary Guidelines and the American Heart Association Dietary Recommendations advise Americans to cut back on their consumption of fat so that it is no more than one-third of their daily calories. In addition, the Heart Association recommends reducing saturated fats to under 10 percent of daily calories. "That means consumers need to be thinking in terms of their total fat intake' says Sweeten. "They may want to watch their intake of saturated fats from processed foods and baked goods as well as select lean

meat." Using a minimum of fats and oils and choosing to broil, bake, poach or steam foods instead of frying will also help reduce total fat consumption, she says.

TEXAS PECAN CROP SHORT BUT OF HIGH QUALITY - The 1986 pecan crop will be short in Texas as well as in other pecanproducing states, but the quality of the Texas crop will be the best in 10 years, says a horticulturist with the Texas Agricultural Extension Service, The Texas A&M University System. The Texas crop should be between 25 and 30 million pounds, about 40 percent of normal. Prices to growers should be good due to the shorter crop, but consumer prices should be about the same as last year.

New crop pecans should hit the market about the first of November. The lighter the color of the kernel, the better the quality. Pecans should be stored in the home freezer to preserve quality and can be used as needed.



OCTOBER IS FISH AND SEAFOOD MONTH

Fish and Seafood Month is the perfect time to enjoy fish meals that are both nutritious and tasty.

Seafood provides protein, vitamins and minerals and has the extra advantage of having low levels of fat and cholesterol.

Fish also fits well into today's active lifestyle. Seafood cooks quickly, requiring little time in the kitchen. It can be poached and served with a low-calorie sauce, broiled and basted with melted butter or margarine and lemon juice, baked in a casserole or breaded and fried.

For good eating and good nutrition, try some fish or seafood this month.

FAT AND SODIUM IN FISH The amount of fet and

The amount of fat and calories in fish go hand in hand. Fattier fish - meaning a higher oil content - include herring, mackerel, trout, catfish, sardines, tuna and salmon. In general, the darker the color of the flesh, the higher the fat content.

Shellfish, snapper, drum, cod, sole, flounder, haddock, halibut and other white finfish are low in fat. However, the level of fat in all fish is not always constant. Some species put on more in the

summer and fall than at other times. The fat content of certain fish may be as much as 4 times higher in summer than in winter.

But the primary source of fat calories in fish is the butter, margarine, oil, sauces or breaded and fried coatings we add when cooking. For example, a breaded, fried fish fillet may have 4 or 5 times more calories than the white fish broiled alone.

Canned fish packed in oil has double the calories and more than five times the fat of the same fish packed in water. Even though water-packed fish is lower in calories, it's usually not lower in sodium. Both oil-packed and water-packed versions are high in sodium chloride, or salt.

A large portion of the salt that is added in processing can be removed by rinsing and draining the fish in a sieve or colander. Rinsing will not remove the other valuable nutrients.

Some manufacturers have begun to eliminate salt by offering tuna with about half the sodium. If you're on a low-sodium diet, beware of smoked or dried fish because it is preserved with salt. Otherwise, fresh fish, in general is quite low in sodium.
