County Stock Show begins today

The 1987 edition of the Coke County Livestock Show kicks off today (Friday) at the County Show Barn in Robert Lee. There are several changes that have been made for this year's show, that have caused a problem or two this year, but should be beneficial to the exhibitors as well as their livestock projects.

The major change is that the date of this year's show has been moved up about a month to allow the youth involved to exhibit the same projects at the county show and at other winter shows such as Ft. Worth, Houston, and San Antonio. The other change in this year's show is that the times for the market lamb and breeding sheep show have been changed from 5:00 p.m. to noon today to avoid conflict with a district basketball tourney.

Judging this year's market lamb and breeding sheep show is Sam Kuykendahl, Menard County Extension Agent. Serving as this year's sheep division superintendent is J. Lee Ensor. Assisting are Bobby Blaylock, Wilbern Millican, Bob Ragsdale, and Martin Lee.

Bright and early Saturday morning, county 4-H and FFA youths will be getting their projects ready for the swine show, which is set to begin at 8:30 a.m. Judging this year's swine show will be Richard Smith, Hermleigh,

Texas Vocational Agriculture Teacher. Jerry T. Parker is this year's swine division superintendent, and is being assisted by Frank Blair, Billy Tounget, Doug Wilkes, and Darrell Pitcock.

Kirk Lewis, Nolan County Extension Agent, will begin judging the market steer show at 11:30 a.m. Saturday morning. Wayland Drennan is this year's beef cattle division superintendent, assisted by Dub Metcalf.

Showmanship judge for this year's show is Hulan Harris of Big Spring. Sheep classifier will be Charles Alcorn of Winters.

Directors for the 1987 show are: Wilbern Millican - President, Dub Metcalf - Vice-President, Robert Wink - Secretary, Bobby Blaylock, J. Lee Ensor, Tom Lee, Garry Bivins, Doug Wilkes, Wayland Drennan, Darrell Pitcock, Frank Blair, Billy Tounget, Arthur Rynnion, Wibby Millican, Jerry T. Parker, Martin Lee, Bob Ragsdale, Donnie Robertson, Wayne Arrott, and Gaylon Pitcock.

A barbecue lunch will be served immediately following the steer show, with the premium auction set to begin at 2:00 p.m. The public is cordially invited to attend all the stock show activities, and support these youths at the premium sale Saturday afternoon.

Cancer screening slated

West Coke County Hospital Administrator Stephen Goode of Robert Lee Tuesday urged area women to take advantage of the breast cancer detection testing available on Monday, January 26, at the hospital. The mobile unit, an extension of the Breast Imaging Center at St. John's Hospital in San Angelo, is sponsored by the hospital and will be parked near the facility all that day.

Goode said appointments can be made for a screening mammogram by calling the hospital, 453-2511. The test will cost \$55 cash and the results will be sent to the patient's physician who will

go over the results with them. He stated that plenty of appointment slots are still available for the tests.

Women should report approximately 15 minutes prior to the appointment time for registration. Typically, the exam takes less than 30 minutes. A female technologist will perform the examination.

According to the American Cancer Society, one in every 11 women in the United States will develop breast cancer sometime during her lifetime. Every year, over 37,000 women die as a result

of breast cancer which is the number one cancer killer of women.

According to a spokesman from the Breast Imaging Center at St. John's Hospital in San Angelo, "the death rate from breast cancer could be drastically reduced if women would have mammograms done before a problem exists."

By using modern states of

the art X-ray equipment, breast cancers can be found when they are about the size of a grain of rice and well before the cancer can be felt. A woman who is diagnosed with breast cancer at this early stage has a 90-95 percent survival rate. However, a woman who is not diagnosed until a lump can be felt has approximately a 50 percent survival rate in five years.

WTU renovation enhances downtown

Recent renovation and remodeling of the West Texas Utility office has enhanced the downtown heart of Robert Lee. The historic 2-story building on the corner of 7th and Austin Streets has been occupied by WTU since the opening of the local office in 1948. At that time, Dub McAdams moved from Bronte to assume the position of local manager. Bob Boone, present local WTU manager, is only the second to serve in Robert Lee. He is now in his eleventh year here.

The utility company bought the building in June, 1986 from original owner, Hayrick Masonic Lodge, who has also occupied space in it since its finish in 1906. The lodge then built a new hall on Commerce Street on land donated by Gerald Allen, leaving WTU free to carry out any structure changes they desired. Following some research on old writings and pictures, the company decided to give the office building an old look and feel from the past.

Built for the Hayrick Lodge, looking for a Robert Lee home after leaving Hayrick, the contractor formed the concrete blocks which, according to Bob Boone, weigh about 135 lbs. each.

The original cornerstone remains in the northeast corner of the building, honored with a historical marker in 1966.

Most of the renovation is evident on the exterior of the office. Along with cleaning of the "stone" structure, a new walk was poured front and side, new outside canopy, lettering on windows, handsome double doors, Spanish oaks planted down the south side, one special feature was added which the company is especially proud of. The old, new West Texas Utilities sign that graces the corner in front of the office was originally a marker at the company office in Memphis, TX. in the 1940s. The building and sign were sold to a radio station there and used with their call letters on it. Bought back by WTU only 4 months ago, the sign was redone in Abilene for use here.

Some touch-ups remain, but the newly painted front is highlighted by brass hardware and major work is complete. New carpet for the interior was laid this week.

Manager Bob Boone said WTU has no plans at this time for the roomy, open second floor.

An Open House is planned

at a later date to allow everyone to see the new decor.

Now is time to return surveys

Don David of the Texas Parks & Wildlife Department reminds landowners in Coke County who were issued antlerless deer tags for the 1986-87 hunting season that now is the time to return their deer harvest questionnaires. The questionnaires, which are attached to the front of the tags, should be completely filled out. The number of antlered bucks, antlerless deer, and turkey harvested for each tract of land should be recorded. If none were killed, "O" should be marked in the appropriate blank. Please return all cards as soon as possible following the close of deer season. Each postcard questionnaire is self-addressed on the back and should be mailed by the end of January. Davis indicated the information obtained from these harvest questionnaires will be used to help estimate total deer and turkey harvest in Coke County and to evaluate existing harvest regulations.

Fraud costs millions

Each year the American public loses millions of dollars through fraudulent schemes operated through the United States Mails. With the increase of unemployment, especially in the oil related industries, work at home promotions have become prevalent. These promotions are aimed at the elderly, shut-ins, the unemployed, and house wives who want to supplement their family income.

Work at home fraud schemes such as envelope stuffing, home addressing, and multi-level marketing sales distributorships always include "opportunities" to earn an unusually high income with relatively small investment and with little or no effort on the part of the customer, and in most cases, by someone they've never even met. They are usually schemes to sell the plan to do the work rather than doing the work itself, and no one has ever become wealthy through such schemes.

Any promotion where the success of any operator (regardless of whether "a product" is offered) depends on recruiting people to recruit more people, etc., to participate in the program is an endless chain or pyramid. These are forms of lottery and violate the Postal Lottery Statute.

There are three elements of a lottery -- consideration, prize, and chance. In typical work at home promotions involving stuffing envelopes, the consideration is usually called an "application or introduction fee" or could be the price of a "startup kit". Consideration in multi-level marketing schemes is the

money paid to a promoter in order for the participant to become a distributor and to recruit new distributors. The prize is always the promised "big money" that can be made quickly after the promotion has progressed several levels, and the chance is that investors will not recruit all the people necessary to fill the pyramid and recoup the initial investments much less earn the "big money" prize. In fact, the chance that all participants will receive mail is mathematically impossible. If a scheme requires participants to mail to six new participants, who in turn must mail to six, etc., by the eleventh level of mailing, the entire United States population would be exhausted; and the thirteenth level, the world population (over four billion) would be exhausted.

The U.S. Postal Inspection Service, who investigates mail fraud and Postal Lottery Statute violations, says that promoters as well as participants in work at home fraud schemes can be found in violation of Federal law even if they did not realize the promotion was illegal when they first got into it. If you receive information about a work-at-home promotion you feel may be in violation of the law, turn it in to your Postmaster or mail it to the Postal Inspector in Charge,
