If experience is the best teacher, then this year's stock show winners must have studied their lessons well, as the top winners in the market lamb, swine, and steer shows were exact repeats of last year's show. Considering that these youngsters started out with different projects this year, as well as different judges from last year, and the quantity and quality of all the livestock exhibited, this is a phenomenal feat for these county youth.

For two of these three young people, this year's show marks the end of their livestock feeding careers. Pammy Millican and Lin Long are both seniors in high school, and what better way is there than to end up on a winning note? For the third year, Pammy Millican has exhibited the Grand Champion Lamb at the county stock show. He was also awarded the prestigious Frank Percifull Overall Showmanship trophy, as well as the Raiph Walker Top Hand award at

this year's show. For the second year in a row, Lin Long exhibited the Grand Champion Market Hog, which had earlier won Champion Crossbred honors.

Teresa Vaughn, the final member of this trio of repeat winners, exhibited the Grand Champion Steer for the second year in a row. The main difference between Teresa and these other two big winners in that she is in junior high school, and has many years left to add to her trophy case.

Coordinator Neta Schnabel emphasized that the program is beneficial to many people other than Senior Citizens and the public is invited to attend. Main Street sure


looks different

The buildings being torn down are: the old Sav-On Food building, which was damaged by fire last year; Hometown Hardware the warehouse building; and the Bronte Enterprise building. The new office location for The Observer/Enterprise is on the southside of Main Street, next door to Cumbie Arrott Mercantile. Hometown Hardware will utilize another building for storage and will continue business as usual. Opening in mid-summer will be a full size, full service grocery store with off-thestreet parking. There will be a 24 ft. meat counter with a butcher on duty for special order cuts of meat. The produce department will offer 30 ft. of display area for fresh fruits and vegetables. The store will have 7000 square feet of groceries.







Farm loan apps available

Applications for emergency farm loans for losses caused by adverse weather conditions are being accepted at the Farmers Home Administration (FmHA) office located in San Angelo, FmHA County Supervisor, Wyatt B. Nesbit, said today. Coke Co. is one of 50 counties in Texas recently named by Sec. of Ag Richard E. Lyng as eligible for loans to cover part of actual production losses resulting from the adverse weather conditions. Wyatt Nesbit said farmers may be eligible for loans of up to 80% of their actual losses or the operating loan needed to continue in business or \$500,000, whichever is less. For farmers unable to obtain credit from private commercial lenders, the interest rate is 4.5 %. "As a general rule, a farmer must have suffered at least a 30% loss of production to be eligible for an FmHA emergency loan,' Nesbit said. Farmers participating in the PIK or Federal Crop Insurance programs

will have to figure in proceeds from those programs in determining their loss.

"Applications for loans under this emergency designation will be accepted until Sept. 9, 1987 but farmers should apply as soon as possible. Delays in applying could create backlogs in processing and possibly over

Postal Pointers

This is the time of year when our thoughts turn toward income taxes. Your post office has the basic tax forms - 1040, 1040A and 1040 EZ. Also we have schedule A & B and instruction booklets for these forms. Schedule W for married people who both work is also on hand. An other forms you will have to get elsewhere.

A lot of you are going to be sending your income tax return by certified mail with return receipt requested. This is a very inexpensive service and when you get your return receipt back, you know the IRS has received your return. The cost is 75c to certify it, 70c for a return receipt plus your postage. The entire thing will be less than \$2.00 unless you have an unusually heavy return which will require more postage.

Stacy permit pending

The U.S. Army Corps of Engineers, Fort Worth District announced today that the decision is still pending on whether or not to issue a Section 404 permit for the construction of Stacy Dam near San Angelo, a project proposed by the Colorado River Municipal Water District.

The U.S. Army Corps of Engineers is directed by Congress under Section 404 of the Clean Water Act to regulate the discharge of dredged and fill material into all waters of the United States, including their adjacent wetlands.

Col. Albert J. Genetti Jr., Fort Worth District Engineer, is expected to make the decision in mid-March once the final Environmental Impact Statement is complete and the necessary staffing is carried out.

The current schedule is for the statement to be finished Feb. 5 and sent to the Environmental Protective Agency for filing in the Federal Register. This is followed by a thirty day public comment period after which a Record of Decision will be made by Genetti.







CULL OPEN. **SKIPPER COWS**

Pregnancy testing and culling of open and skipper cows (those calving every two years) is one of the quickest ways to improve the reproductive performance of the beef herd.

This has been shown by field demonstrations conducted by the Extension Service in numerous counties.

One such demonstration in Central Texas involved cow herds that were pregnancy tested for at least two consecutive years. In the first herd, no culling was done after pregnancy testing, while in the other herd all skipper and most open cows were removed. A few open heifers were kept in the latter herd to maintain cow numbers. Pregnancy rates before culling were 83.6 percent and 83 percent, respectively. The nutrition and health status and level of bull fertility were essentially unchanged during the two-year study.

In the second herd, pregnancy rates after culling went up to 95.3 percent in the second year, while pregnancy

rates in the herd without culling remained near 84.5 percent.

This clearly shows the importance of pregnancy testing and culling open and skipper cows. Obviously, replacements can be costly, but an economic analysis shows that these initially high cost can be recovered within two to three years and that total dollar income will be higher than without culling.

In addition to pregnancy testing and culling, other management factors also must be considered for a profitable beef herd. These include timely supplemental feeding, necessary reproductive vaccines and highly fertile bulls.





Don't waste your money

Have you ever been asked to participate in a chain letter which is guaranteed to earn you lots of money with one small investment? Don't waste your money - chain letters are a form of lottery and may violate federal mail fraud laws. The same three elements that apply to lotteries (payment, prize and chance) also make chain letter schemes illegal. The payment may be money or any other item of value. The prize is the large amount of money you are led to believe you will receive in the end if you participate. The chance is that the chain will break, and it must, because the chance that all participants in a chain letter will receive mail is mathematically impossible. For example, a typical chain letter may require participants to mail letters containing money to six new participants, each of whom must mail six letters to six more individuals and so on. By the eleventh level of mailing, the entire population of the United States (almost three-hundred million) would be exhausted. By the 13th level, the population of the world (over four billion) would be exhausted. And remember even if the chain letter itself is not mailed, as long as the payment or prize is sent through the mail, the entire scheme is illegal. Some chain letters masquerade as Multi-Level Marketing (MLM) Plans. These require an original promoter to sell a product and enlist several other people to become sellers, who in turn recruit others. Most Multi-Level Marketing Plans are schemes to sell the plan rather than the product, and the fact that selling a product is involved, instead of winning money, or statements saying the plan does not violate federal law, do not ensure legality. Do not confuse regular chain letters or Multi-Level


Marketing Plan chains with prayer chains that promise good luck but require no investment. These are not illegal - they're just a nuisance. You should not be intimidated by implied threats of bad luck, personal injury, or disaster for breaking the chain. Feel free to throw the chain letter away.

Remember, you are under no obligation to participate if you receive a chain letter, and to do so may be a violation of federal law. Turn the letter in to the local post office or send it to the Postal Inspector in Charge, P.O. Box 162929, Fort Worth, TX 76161-2929.
