

## **Arthritis remedy studied**

Arthritis specialists at Baylor College of Medicine are studying a drug they hope will alleviate the ulcers and stomach pains caused by standard arthritis treat-

Dr. Edward J. Fudman, a rheumatology instructor at Baylor, said as many as half of arthritis patients suffer nauseas, indigestion, stomach pain or ulcers as a result of their treatment.

"If people get severe side affects, they are forced to discontinue therapy and people with arthritis may need their treatment indefinitely," Fudman said. "So we are looking for a way to allow these people to take the medication and minimize their stomach side effects."

Baylor is one of 30 centers in the nation studying the experimental drug misoprostol. Early studies indicate misoprostol may prevent ulcers caused by standard arthritis treatments.

Standard treatments for arthritis usually include aspirin or aspirin-like drugs called non-steroidal antiinflammatory drugs (NSA-IDs), which relive the pain and inflammation caused by some types of arthritis.

"The non-steroidals treat the symptoms of osteoarthritis," Fudman said. "There are no treatments to prevent the underlying cause of the disease or to prevent the cartilage from deteriorat-

The Baylor study is limited to people with osteoarthritis, the most common form of arthritis. Osteoarthritis occurs when cartilage, the rubbery tissue at the end of bones, breaks down. This degeneration causes pain and sometimes inflammation in the affected joint. As the disease progresses, it can result in a loss of motion in the joint.

fects joints in the hands, patients can lose the ability to grip. If it's in the knees or hips, the pain can limit the ability to walk," Fudman

The study is funded by Searle Pharmaceuticals.





MAKE MEXICAN FOOD "LIGHT"

If you love Mexican food -but not the extra calories -try making "light" Mexican dishes at home.

Mexican foods served in restaurants and the prepared foods sold in grocery stores often contain a generous amount of fat. But by using lower fat ingredients and alternate cooking methods you can make similar dishes with fewer calories.

Here are some suggestions for adapting Mexican food recipes:

\* For tamales or chili, use lean cuts of meat, or trim off all fat before cooking. Also remove the skin from chicken and trim fat before cooking for chicken tacos and chalupas or chicken with squash.

\* When using ground beef, cook it the day before, refrigerate and then skim off the fat before reheating. Make your own chorizo with ground beef and spices, since the store-bought variety contains a great deal of fat

\* Use low-fat cheese in enchiladas, tacos, chalupas and chiles rellenos.


\* Use vegetable oil rather than lard, and use as little oil as possible when scrambling eggs, cooking rice and fidello and refrying beans. Use chicken broth rather than oil to soften tortillas for enchiladas and other dishes.

\* Avoid frying tortillas. Corn tortillas for tacos can be baked with the meat already in them and brushed lightly with margarine and bake for nachos or chalupas. For soft tacos, microwave the tortilla, then fill with a meat or bean mixture.

The meat, beans and cheese in many Mexican foods are a good source of protein. However, the meal may lack nutrients from fruits and vegetables.

To get a balanced meal, nutritionists, recommend serving vegetables as a side dish or adding chopped vegetables to the main dish. This is also a good way to stretch the meat in fillings for tacos, enchiladas and other dishes.

A fruit salad or fruit dessert will help round out the meal.

FAST FOOD STORES SHARE NUTRITION IN-FORMATION -- In response to consumer interest in nutrition, fast food stores have taken to informing as well as feeding their customers.

"The nutrition information printed on placemats, displays or in pamphlets at many fast food stores can be helpful, if you read it carefully," says Dr. Dymple Cooksey, a nutrition specialist with the Texas A&M University Agricultural Extension Service. Nutrition information from fast food stores is probably most convenient when various food items are listed along with the fat, sodium and calories for each part of the item," notes Cooksey. "You can use this nutrition information to select particular foods or to special order your sandwich so it has less fat or sodium,' she adds. This information will also help you plan the rest of the day's meals to achieve a balanced diet.'

GET GARDEN PESTICIDES OUT OF CLOTHING --

"Spills and spray from common garden pesticides contaminate clothing, so it must be specially treated to avoid potential health hazards,' says clothing specialist Dr. Ann Beard. "Pesticide residues from less toxic or dilute pesticides can usually be washed out in one maching washing," she says. "However, use both pre-washing and several maching washings on spills from wettable powder or concentrated liquid pesticides." After washing contaminated clothes, she advises rinsing the washing machine with an

empty load using hot water and detergent. "Exposure to garden pesticides can cause skin rashes, headaches, nausea and a number of other problems," says Beard. "It just makes good sense to adequately wash gardening clothes so these hazards are minimized." Hughes, Ritchey reunion held

## Underground water reps attend session

Several representatives of the Coke County Underground Water Conservation District recently attended a legislative planning session in Lubbock. Seven other water districts had people present at the meeting. It was called to develop a plan of action to prevent legislation from being passed that would be detrimental to underground water districts and private property rights.

There were 49 bills presented during the last session of the legislature that affected underground water districts. A few of these bills were good, but most of them would have been very destructive to district operations and local property rights.

Following are the results of some of the proposed bills would have become law: (1) One bill conveyed very broad authority to the Texas Water Commission to totally regulate the ground water resources of the state; (2) In another proposed bill the Texas Water Commission could regulate the use of


ground water to any degree it chose. It could make rules without gathering evidence or holding public hearings; (3) Another would set minimum standards for districts which are operating under rules and regulations as set forth on a local level; (4) Another bill had a section which in essence says, "use it or lose it!" A \$450 meter would be necessary on each of 75,000 irrigation wells on the high plains at a cost of over 33 million dollars; and (5) Another bill would provide absolute state control of ground water in Texas. The Texas Water Commission would be required to inspect

all newly drilled wells and

charge a one time fee of up to \$100 for each well.

From the above examples, it is obvious that many people in the legislature do not believe in the long held principal that the landowner has control and management of groundwater under the land. The local district plans to be more active in passing along information on proposed legislation that would adversely affect the conservation and management of underground water in Coke County.





#### **TEST SOILS NOW FOR FALL WHEAT**

With planting time for fall wheat and other small grains rapidly approaching, farmers need to collect soil samples for a reading on nutrient requirements. Those nutrients can then be incorporated into the soil during final seedbed preparation.

Soil incorporation or knifing of fettilizer nutrients into a moist seedbed is important to reduce nitrogen volatilization losses associated with surface applied urea or ureacontaining fertilizers. It also allows placement of nonmobile nutrients such as phosphorus into the higher moisture and more active root zone of plants.

A soil test is still the best way to determine fertilizer needs. The amount of given nutrient to apply depends on the level of that nutrient in the soil, crop residue levels, cropping history, available moisture, grazing practices and management schemes. A soil test will determine the amount of residual nitrate-amount of residual nitratenitrogen in a soil and will reduce nitrogen recommendations by that amount, resulting in a direct savings to the farmer.

Producers who have not yet made a final decision to plant wheat on a particular field this fall, but who wish to leave the door open to plant cotton, sorghum or hay later in the spring, should submit a soil sample now and request fertilizer recommendations for these crops as well. Fertilizer recommendations for each of the crops can then be used to make cropping decisions.

The Extension Service Soil Testing Laboratories at College Station and Lubbock will analyze soil samples and make fertilizer recommendations. New automated laboratory equipment and computerized integration and reporting of soil test results have improved speed and precision. However, soil test recommendations are no better than the quality of the soil sample analyzed. Therefore, soil samples should be collected which are truly representative of the field being tested.

Information on properly collecting and submitting a soil sample, along with fees



### - Postal Pointers -

I cannot stress too much the importance of "not falling into the traps" of advertisers who are daily flooding the mail with fabulous offers of "prizes" won and good luck charms that will assure you of winning millions of dollars.

In today's mail, I got a notice on a green card stamped "First Class" that told me "You Are A Winner". On the back they proceed to tell me I have been selected by computer to receive a "Sportster Runabout Outdoor Motor Boat". It describes in detail at the bottom of the card all the features of the boat -- like a 12V trolling motor - battery and battery charger, battery holder, etc., etc. What all this means is that if you are lucky, the 12V motor will get

you all the way across the bath tub. All I have to do is send them \$165.38 to cover shipping, and services and handling for release and insured "motor" delivery.

What this really means is they will spend maybe \$5.00 to ship it parcel post or other carrier and all I have to do is send them my check. The last time I got one of these rubber boats - it was for visiting a fort near Del Rio and it only cost me \$50.00 to get the piece of junk shipped.

Also in today's mail I received a white post card-also marked "First Class" which told me to send only \$1.00 and I would receive an award - a 34" square and clad in Pure 24K Gold. It has the power-- along with my abilities to receive \$21,000.-00 in cash. Now-- I already have two of these little squares and each of them add up to 21 - across, down or diagonal and even though I've had them for quite a while-- I still haven't received my \$21,000.00 cash. What do you suppose could have gone wrong? I average 5 or 6 of these "something for nothing" things every day. (These two pieces of mail are on display at the post office).

Bear in mind that even when you receive one of these fantastic offers like the one last week marked "Certified Notice"-- in the top right corner it said "Bulk Mail - U.S. Postage Paid". This type mail is sent out nationwide and the senders must have a minimum of 200 pieces to even mail. They can have 20,000 maximum or more but they must have 200

minimum. Always look for the "Bulk Rate" when you think you have won something. The post cards that have "First Class" are sometimes metered and have "Presorted First Class" which means they had to have a minimum of 500 pieces and they mailed them for 12c each.

Please check this mail carefully. I hate to see these people getting rich simply because people do not know enough about the post office to sort the bad from the good.

#### OLD FASHIONED PEACH COBBLER

Pastry:

3 cups sifted Martha White All-Purpose Flour

1 tsp. salt1 c. shortening

about 8 T. water Preheat oven to 400 degrees F. Combine flour and salt; cut in half of shortening until mixture resembles coarse cornmeal. Cut in remaining shortening until mixture is consistency of small peas. Sprinkle water mixture and stir gently with a fork until mixture holds together. Press into a smooth ball. Divide dough into thirds. On lightly floured board or pastry cloth, roll out one-third of dough to 1/8-inch thickness; cut into small pieces, about 1x3 inches. Place on ungreased baking sheet and bake until lightly browned, about 8 minutes. Cover remaining dough and continue with filling directions.

Filling: 2 C. sugar

3 T. Martha White All-Purpose Flour

7 c. sliced fresh peaches 1 c. water

½ tsp. almond extract ½ c. (1 stick) butter or margarine, divided

Reduce oven temperature to 375 degrees F. Grease a 3-qt. baking dish. Stir together sugar and flour. Add peaches, water and extract; blend carefully. Roll out one-third of dough to 1/8-inch thickness, shaping to fit into bottom and up sides of dish with a 1-inch overhang. Spoon half of peach mixture into pastry; dot with half the butter. Place cooked pastry strips over filling. Spoon

remaining filling over cooked pastry; dot with remaining butter. Roll out remaining one-third dough to 1/8-inch thickness; cut into ¾-inch wide strips and arrange lattice-fashion over filling. Trim edges, seal and flute. Bake 50 to 60 minutes.


