## Doe tags not required in county

The Texas Parks and Wildlife Department announces significant changes in the procedures for landowners to obtain antlerless deer permits for the 1987-88 deer season in the Possum Kingdom Regulatory District. In an effort to reduce expenses associated with the issuance of antlerless deer permits, an automated system will be implemented this year.

About the second week of August, landowners and land operators who were issued antlerless deer permits last year will receive a self addressed renewal notice which must be signed, stamped, and returned by September 1, 1987, if they wish to receive antlerless deer permits for the 1987 deer season. Any correction of information listed on the application card should be made at this time. Following annual deer surveys, recommended issuance rates for antlerless deer will be formulated by compartments and antlerless deer permits will be issued by mail in early October.

Counties in the Possum Kingdom Regulatory District that will be involved in

automated issuance of antlerless deer permits includes Wise, Jack, Throckmorton, Shackelford, Stephens, Palo Pinto, Parker, Callahan, Eastland, Erath, Hood, Somervell, Comanche, McLennan, Glasscock, and Reagan.

Landowners that qualify for antlerless deer permits but did not receive them last year will be able to make application for antlerless deer permits. Procedures for making application for antlerless deer permits will be announced at a later time.

No antlerless deer permits will be issued or required for the 1987-88 fall gun season in Bosque, Hamilton, Mills, Brown, Coleman, Concho, Runnels, Tom Green, Irion, Coke, Sterling or south of IH 20 in Howard, Mitchell, Nolan, and Taylor Counties. Antlerless deer taken during the hunting season need only to be tagged with the appropriate tag from the hunting license in these counties. Please refer to the 1987-88 Hunting Guide for information concerning seasons, bag limits and means and methods for taking wildlife in various counties.

The Thrift Shop, sponsored by the Auxiliary, will conduct a 1/2 price sale on summer clothing as well as

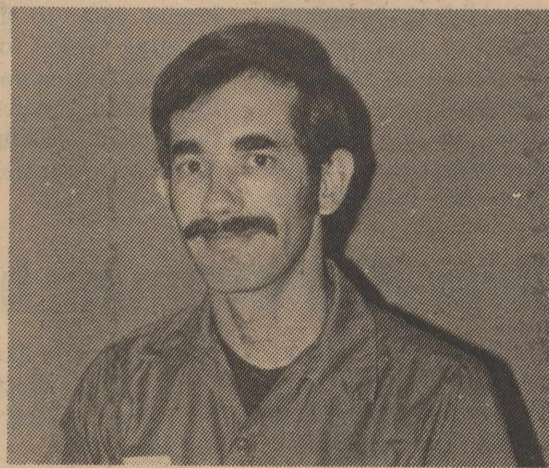

**BRONTE INDEPENDENT SCHOOL DISTRICT** today announced its policy for free and reduced price meals for children unable to pay the full price of meals served under the National School Lunch Program and School Breakfast program. Each school and the office of the Bronte ISD has a copy of the policy, which may be reviewed by an interested party.

The following household size and income criteria will be used for determining eligibility:

(These guidelines should be used by the school to determine eligibility for free or reduced-price meals and should be provided to the media for public release.)

Children from households whose income is at or below the levels shown are eligible for free or reduced price meals.

Application forms are being sent to all homes with a letter to parents or guardians. To apply for free or reduced price meals, households should fill out the application and return it to the school. Additional copies are available at the principal's office in each school. The information provided on the application will be used for the purpose of determining eligibility and may be verified at any time during the school year by school or other program officials.

For the school officials to determine eligibility, the household must provide the following information listed on the application: Names of all household members; social security numbers of all adult household members or a statement that the household member does not possess one; total household income or the household's food stamp case number, AFDC case number if they currently receive food stamps or AFDC case number if they currently receive Aid to Families with Dependent Children and the signature of an adult household member certifying that the information provided is correct.

Applications may be submitted at any time during the year.

Under the provisions of the free and reduced price policy the Bronte ISD Superintendent Michael Hartman, will review applications and determine eligibility. Parents or guardians dissatisfied with the ruling of the official may wish to discuss the decision with the determining official on an informal basis. Parents wishing to make a formal appeal may make a request either orally or in writing to Superintendent Michael Hartman, Bronte I.S.D., Box 670, Bronte, Texas 76933, 473-2511 for a hearing on the decision.

Households are required to report increases in household income of over \$50 per month or \$600 per year and decreases in household size. Also, if a household member becomes unemployed, or if the household size increases, the household should contact the school. Such changes may make the children of the household eligible for reduced meals or for free meals if the household's income falls at or below the levels shown above.

In certain cases foster children are also eligible for school meal benefits. If a household has foster children living with them and wishes to apply for them, the household should contact the school for more information.

The information provided by the household is confidential and will be used only for purposes of determining eligibility and verifying data.

In the operation of child feeding programs administered by the U.S. Department of Agriculture, no child will be discriminated against because of race, color, sex, national origin, age or handicap. If any member of a household believes they have been discriminated against, they should write immediately to the Secretary of Agriculture, Washington, D.C. 20250.



# Bronte teachers return from Boston

Bronte science teacher Jerita Taylor and mathematics teacher Marifrances Mackey returned Friday, August 7, from a six day trip to Dallas and Boston, Massachusetts. The two Bronte teachers are recent recipients of the GTE GIFT (Growth Initiative for Teachers), a grant program for public and private secondary school mathematics and science teachers sponsored by the GTE Foundation. The GIFT Seminar which they attended was an opportunity for all GIFT winning teams to come together to visit with research scientists, tour laboratory facilities, attend presentations by noted science educators as well as GTE recruiters and personnel specialists, and to understand more fully the real world applications of mathematics and science. All expenses of the seminar are paid by the GTE GIFT program.

The twenty teams from Texas began their activities in Dallas, Sunday, August 2. The forty teachers were given a tour of GTE'S INFOMART, the world's finest information processing center. Its design is a replica of the Crystal Palace, which was constructed in 1851 for the first World's Fair in London. As the original Crystal Palace was built to give a living picture of the point of development at which all

nations would be able to direct their future exertions, the INFOMART is the home of more than 60 permanent demonstrations of the most advanced concepts in electronic technology. After this most exciting tour, the group was taken to Texas Stadium to see the home of the Cowboys. After walking through Tex Schram's private box, visiting the press-box, and walking on the artificial turf, each was given a Cowboy's souvenir.

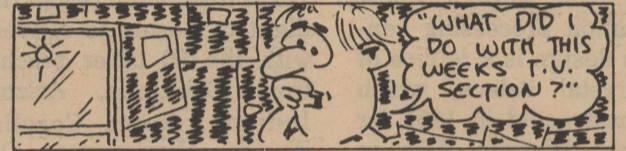

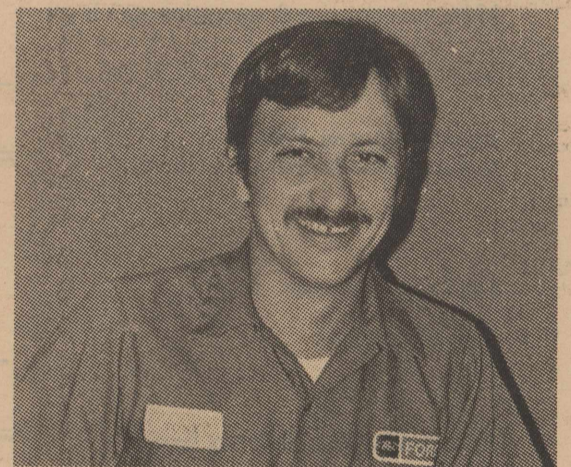

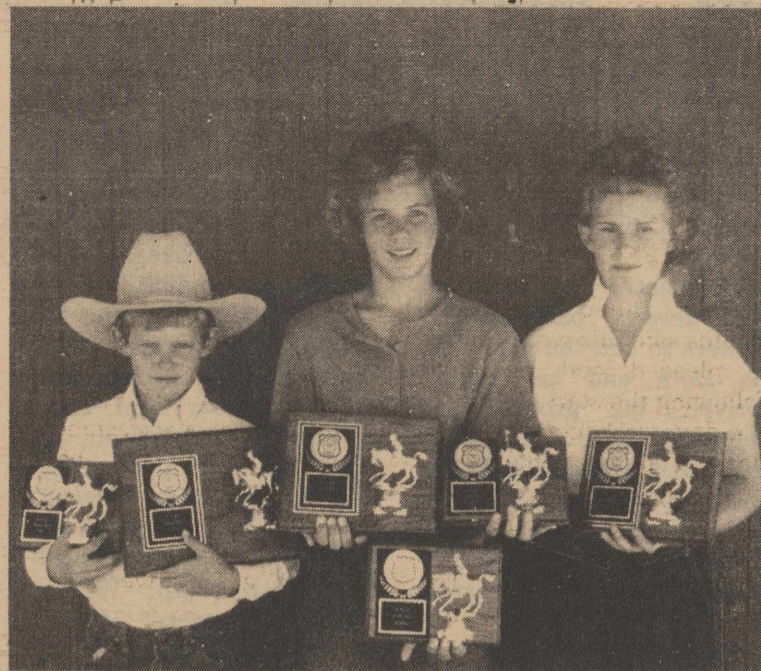

## Bitterweed - endangered plant?

Bitterweed, a noxious plant found over much of West Texas, is mainly known for causing sickness or death for sheep that occasionally consume it.

But recently it has caused even more consternation for some West Texas ranchers who were accused of destroying an endangered plant.

The problem was one of misidentification, according to officials of the Texas Parks and Wildlife Department. The endangered plant is the Texas bitterweed (*Hymenoxys texana*), which is found only at isolated locations in

Harris County near Houston.

The bitterweed of West Texas is widespread in the Western Edwards Plateau, and it is not an endangered species. It is a low-growing weed with dime-sized flowers that appear in the spring, according to Raymond Custer, law enforcement regional supervisor for the department in San Angelo.

Officials said Texas bitterweed, which is classified as endangered by both the state and the U.S. Fish & Wildlife Service, was documented in LaSalle County in 1880 but recent attempts to locate it failed.
