In a very strong barrow show in Houston, DeAnn Parker placed 10th in the Mediumweight crossbreds and Julie Blair placed 11th. In the Light Chester White class Cory Thorn placed 13th.

At the San Angelo Stock Show, in the steer show, Debra Drennan placed 3rd and 6th in the Light Middleweight class, Jason Blaylock placed tooth ewes and 8th in pen of 5th in the Light class, Blake Pitcock placed 8th in the Lights, and Shane Kelton placed 9th in the Middleweights.

Brande Burrows placed 8th in the Light Middleweight Market Lamb show for finewool crosses. In the breeding sheep show, Blake Payne placed 14th in the buck lambs and 9th in the 2 tooth bucks. Jaclyn Waldrop placed 7th in the 2 tooth bucks, 7th in ewe lambs, 9th and 12th in 2 tooth ewes and 9th in pen of three. Stewart remains in custody following filing of charges

Johnny Dewayne Stewart remains in custody in the Tom Green County Jail this week following charges of felony criminal mischief, filed after several incidents occurred in Bronte in the early morning hours on Monday, March 7. Sheriff Marshall Millican indicated that another charge of criminal mischief and a felony arson charge will also be filed against the 19-year-old Bronte resident. His bond has been set at \$7,500.

Stewart allegedly drove a vehicle through the double doors of the Recreation Hall in Bronte, into the Bronte School's greenhouse facility, and damaged the overhead door of the school's ag shop. The vo-ag pickup sustained damage also. Damage estimates have not been completed at this time but about \$1,600 will be needed to replace the large doors alone.

Other charges against Stewart concern vandalism of a state highway sweeper and signs near the junction of Highway 70 and 277. A stateowned road-grader was doused with diesel and set on fire at the same time.

The suspect was arrested at his home by Deputies Wayne Peters and J. Lee Ensor when they discovered the damaged vehicle and certain matching physical evidence at

Nichols fund established

Debra and Scott Nichols of Robert Lee are seeking monetary aid for their 9-year-old daughter, Heather. Heather, an elementary student in Robert Lee schools, has been diagnosed in recent years as having glycogenosis, although the parents and doctors knew she had an enlarged spleen and liver since birth. The disease represents a breakdown in the processing and storage of foods and

chemicals, especially sugars. Doctors are considering the removal of Heather's spleen.

The elusive, rare disease is not easily pinpointed but doctors at the Galveston University of Texas Medical Branch confirmed the presence of the disease in 1983. They will see her again at Spring Break, March 29 since she is experiencing severe pain periodically in her side and stomach. Her organs have become more enlarged and doctors warn that a blow or fall could cause liver failure or rupture her spleen. Physical activity must be curtailed and that seems difficult to an active 9-yr.-old child.

Mounting doctor bills, along with expensive tests and CAT scans, have almost bankrupted the family and their relatives. An account has been opened in Heather's name at the Robert Lee State Bank to






