Numbers of grassfires have tripled this year. Dry conditions, controlled burning, and high winds have caused many late and long hours for the firemen. Many calls have been made to controlled burn areas unnecessarily. Passersby saw the remains of a controlled burn, possibly still smoldering and thinking it a wildfire, they called the department. However, all calls have quickly and willingly been responded to by the volunteers, including a call a few minutes after the dinner Saturday night. The fire was reported to be 8 miles north of Bronte, but though the firemen responded, they still could not find a blaze. They were too full of roast beef to fight fire anyway.

Farmers to receive refund

a matter of here and then. If you were a farmer in the 1970s, you are entitled to a refund for some of your fuel expenses. But you have to act before June 30, reports

Tommy Antilley, county agent with the Texas Agricultural Extension Service.

The refund is a result of a settlement reached by the Dept. of Energy with oil companies that allegedly overcharged for crude oil during a period regulated by price

Consequently, farmers can get back about \$80.00 or more for every 100,000 gallons of fuel used between August 19, 1973 and January 27, 1981, says Antilley. That equates to a little over \$14.00

Antilley notes that this refund should not be confused with the income tax credit for federal excise taxes on fuel.

The Dept. of Energy will base refunds on actual gallons purchased, estimated gallons used or a USDA estimate of 23.8 gallons per acre of cropland per year. An explanation of filing procedures for the refund and a simple two-page filing form can be obtained at the County Extension Office.




