Absentee balloting continues in RL

Absentee balloting in three local elections in Robert Lee will continue through Tuesday, May 3. Robert Lee I.S.D., the City of Robert Lee, and the West Coke County Hospital District elections for their governing panels are upcoming on May 7

Voters wishing to vote absentee for the school board trustees may do so at the superintendent's office. A slate of 7 candidates has filed for the three, 3 year terms including the incumbents, Mary Herring, Gaylon Pitcock, Donald Robertson, and new candidates, James D. Clendennen, Edwin G. Davis, Richard Daves, and Donna Millican. Voting will take place Saturday, May 7 in the school foyer.

Two vacant seats for the Robert Lee City Council drew three candidates -- A.L. Brasuell, incumbent, B.W. Braucum, and Joe Barrett. Incumbent Mayor Wilson Bryan will be the only candidate on the city ballot for mayor. Voters may vote absentee at the City Hall where the election will be held May 7. Voters must reside in the city limits to be eligible to vote.

West Coke County Hospital District ballots will show 5 candidates for 3 slots on the hospital board. Incumbent Bill Helwig, Barbara Chesney, and Linda Arledge, plus newcomers Pat Brasuel and Judy Williams will be vying for the seats on May 7. Patti Ivey, who originally filed for the panel, dropped from the campaign citing conflicting business schedules. Absentee balloting is underway in the clerk's office with Mildred Reese as election judge. The May 7 election will be held in the commissioner's courtroom at the county courthouse.

HPT to recall old plates

Some vehicle owners will see a new message on their registration renewal forms beginning in May: "New Plates Required".

The State Department of Highways and Public Transportation will start a program of recalling plates more than eight years old to comply with a state law that calls for issuance of "safety plates".

Highway department testing personnel have found that "the reflective value of license plate sheeting begins to deteriorate dramatically after eight years," said Dian Neill, head of the department's Motor Vehicle Division. The dull plates are difficult to see in the dark.

Over the next 12 months, the department expects to issue 1.4 million replacement plates for all light trucks and passenger cars with tags originally issued from 1975 through 1980. Next year, recalls for 1981 plates will go out in the continuing program, conducted through county tax assessor-collector offices.

Vehicle owners who volunteer to trade their 5-to-8-year old plates may still do so free. "The state collects fees sufficient to replace license plates every five years, so you're just getting your money's worth if you trade them in on time," said Maurine Vosburg, tax assessor-collector for Coke



CALORIES AND FAT "STORE-VARY IN BOUGHT" COOKIES --The way the cookie crumbles can give you a clue to the fat content of most "storebought" cookies. "In general, the soft-style cookies have a higher fat content, because the extra fat is what creates the softer texture," says Dr. Dumple Cooksey, a nutritionist with the Texas A&M University Agricultural Extension Service. She says regularstyle ginger snaps, for example, have about 23% of their calories from fat and vanilla wafers about 28%. By contrast, about 45% of the calories in soft-style chocolate chip cookies, and 48% of the calories in soft peanut butter cookies are from fat.



Resolving complaints

CONSUMERS CAN RESOLVE THEIR COMPLAINTS

When you have a problem with a product or service, what do you do? Forget about it, complain to your friends or seek recourse? Few people try to get satisfaction when they have a complaint.

Unfortunately, consumers often believe their complaints won't be heard, or they don't know who to contact.

In general, the best place to start is at the place where you bought the item or service. If you aren't satisfied with the response in a reasonable amount of time, however, don't give up, since you have other options for resolving the problem. There are many sources available for resolving consumer complaints.

Many national companies have corporate consumer affairs offices to answer questions or handle complaints. Often these offices will have a toll-free 800 number of consumers to call.

If you can't resolve a problem with an automobile dealer, check with the manufacturer, since most have regional offices for handling consumer complaints.

There are 17 non-profit Better Business Bureaus in Texas. Many of the BBBs accept written complaints and will contact a firm on your behalf.

In addition, the Consumer Protection Division of the Attorney General's Office operates offices in Austin, Dallas, El Paso, Houston, Lubbock, McAllen and San Antonio. Dallas and Harris Counties have Consumer Fraud Divisions and the cities of Dallas and Ft. Worth have Consumer Affairs offices.

Local libraries typically have reference materials that can guide you in your efforts to resolve consumer complaints. For example, they will have books listing trade associations and occupational and professional licensing boards, many of which handle consumer problems.

One of the best sources of assistance, the "Consumer's Resource Handbook," is published by the U.S. Office of Consumer Affairs and available free by writing the Consumer Information Center Pueblo, Colorado 81009.

SALMONELLA IN EGGS A SAFETY ISSUE - Recent reports of salmonella in eggs have caused some concern among consumers. But according to Marilyn Haggard, a food safety expert with the Texas A&M University Agricultural Extension Service, the possibilities of contracting a food-borne illness from salmonella in eggs is remote. "As with any food-borne illness, the very young, the elderly and people whose immune systems are compromised due to illness are most vulnerable," Haggard noted. "But none of this means people have to stop eating eggs if they are thoroughly cooked," she said. "That means a hard yolk rather than soft-boiled or sunny-side up eggs. "She also advises

taking the same precautions with eggs as other perishable foods; keep them refrigerated before preparation and don't let them sit out at room temperature for more than two hours, before or after cooking.

Beef vote set for May 10

The U.S. Department of Agriculture will hold the beef checkoff referendum vote on May 10.

The vote, by eligible cattle producers and importers of beef or beef products, is to decide whether to continue the beef checkoff program, says Tommy Antilley, Coke County Extension agent with the Texas Agriculture Extension Service, The Texas A&M University System. Producers are being assessed \$1 a head on all cattle they sell. Funds from the checkoff are presently financing the Beef Promotion and Research Program.

Eligible voters are producers who owned cattle between Oct. 1, 1986 and March 31, 1988 or persons who imported cattle or beef products during the same period, An-

tilley says.

Voting will be by secret ballot in the local Extension office of the county where a producer or importer resides.

Persons who need to cast an absentee ballot must request one between April 1-29. Eligible Texas voters may request absentee ballots from Dr. Milo Shult, Associate Director, Texas Agricultural Extension Service, System 105-A, Texas A&M University, College Station, TX 77843.

"Mark the absentee ballot and return it by May 3 to the Extension office in the county of your residence," Antilley says.

The Agricultural Stabilization and Conservation Service will count ballots, determine the eligibility of challenged voters and ballots, and report Referendum results.
