Dates are freshness guide

Most products in food stores have dates and handling directions on them, even though manufacturers are not required to put this information on packaging.

The date stamped on product packages can indicate product freshness and serve as a guide to safe storage time, if you know how to use

The "sell-by" date is the last day the product should be sold, the "use-by" date indicates how long the product will retain top eating quality after purchase, and the "expiration date" tells the last day the food should be eaten or used.

Reading handling directions can also help you make sure food remains safe to eat.

All perishable products

must give handling instructions, such as "keep frozen" or "keep refrigerated". Some meat and poultry products may be labeled "ready-to-eat" or "fully cooked", which means no further cooking is necessary.

Specialists advise checking the labels of aseptically packaged products, since many will require refrigeration after opening.

Although some product labels carry directions on how long and at what temperature to cook a product, the directions are not required or verified by the U.S. Department of Agriculture.

When cooking instructions are not included on the label or you have some doubts about them, the safest course is to cook the product thoroughly.

Livestock Management for Winter

With recent rains we should be in pretty good shape going into this winter. Our grass has considerably more protein than last year but management will still be the key.

Now is the time to take a hard look at our herds and make some management decisions. To begin with, calves should be weaned during October to allow the cow to "mend" before going to winter. A fleshy cow will raise a heavy weaned calf next year.

Another tool for range management is to cull any open or late calvers. Demonstration results have definitely shown open cows to cost the producer. If she is open and kept, you will have to "board" her at least two winters before she brings you a coupon.

Figuring on maintenance cost, this could mean as much as \$400.00 - \$450.00 to get that \$300.00 calf. Even late calvers, going 15-18 months can cost on today's prices due to the extra three to six months maintenance cost. Good calving records or palpation can greatly offset their time and cost in reduced maintenance costs.


