## Youth place projects at all major shows

Youth from Coke County recently completed a very successful year with their livestock projects by placing animals in every major stock show entered in Texas this spring. Besides the various awards received, premium sale monies totaled more than \$15,000.

To begin with, at the Fort Worth Stock Show, Julie Blair showed the Champion York and 7th cross, Bryan Arrott had the 3rd heavy Hampshire and Gary Blair had the 19th cross in a very tough barrow show. In the market lamb show, Tracy Millican showed the 22nd middle finewool. Scott Antilley had the 16th heavy Angus and Shane Kelton the 17th light European Cross in the steer show. In the Breeding Rambouillet show, Jaclyn Waldrop placed 3rd

with her ram.

In the El Paso lamb show, Michael Lee showed finewool lambs to 5th and 7th.

Next came the San Antonio show where Julie Blair had a 4th place crossbred barrow, Michael Lee a 3rd heavy Finewool, Chad Wagley an 8th place light finewool, Brande Burrows 15th Mediumwool and J. J. Tennison a 20th place cross in the lamb show. In the market steer show Shane Kelton placed 4th in the Lightweight Simmental followed in 5th by Korey Pitcock and Scott Antilley showed the 6th heavy Angus.

At the largest stock show in the world, Houston, Michael Lee had the 3rd light finewool, Brande Burrows the 3rd Crossbred, Melissa Bivins 10th medium cross and Melissa Arrott the 20th medi-

um mediumwool. Julie Blair had the 2nd heavy Hampshire, Gary Blair the 5th medium cross, Corey Thorn the 10th Medium Hampshire, Donya Cooper the 19th light Chester White and Michelle Parker the 15th medium Hampshire. Also the Grand Champion Market Barrow in Houston this year was bred in Coke County by Blair and Blair Hog Farm. The steer show had Shae Kelton exhibiting the 4th light Shorthorn and Scott Antilley the 19th middle Limousin.

At the final show of the year in San Angelo, Danielle Parker showed the 6th heavy OPB barrow, Tracy Millican the 29th medium crossbred lamb, Brande Burrows the 11th lighthheavy cross and Michael

## Filing deadline nears

The March 22nd filing deadline is approaching for three local elections coming up on Saturday, May 6 in Robert Lee.

Eligible city voters will elect 3 council members. Applications for a place on the ballot may be obtained at the city hall and filed with the city secretary before 5 pm on Wednesday, March 22. Current members of the council whose terms expire are those of Richard Johnson, Pete Prentice, and Jim Dunklin. Only Richard Johnson has filed for a place on the ballot.

Robert Lee Independent School District will hold an election to select two school trustees. Expiring at this time are the terms of Jeffie Roberts and Ray Aldridge. At presstime Wednesday, Mary Herring, a past school board member, was the only candidate for the ballot. Applications for a place on the ballot may be filed in the superintendent's office at the school until March 22nd.

Two vacancies exist on the West Coke County Hospital Board with the expiration of the terms of Roy Epperson

and Joy Bagwell. Joy Bagwell and newcomer Dot Starling have filed application as candidates for the governing board. Candidates for the hospital district must file a petition with the endorsed names of 25 eligible voters in order to be placed on the ballot. The petition forms may be picked up at the office of Administrator Larry Melton and filed by the March 22, 5 pm deadline.

**Tax rendition deadline posted**

The deadline for local property owners to complete, sign, and submit rendition forms to the Coke County Appraisal District is March 31, 1989.


A rendition form is a document on which a property owner lists taxable property. The owner can also estimate the property's value on the form. It is filed at the appraisal district office at 710 Austin St. in Robert Lee. Property owners who ask in writing for an extension for a good cause, before the deadline have 30 extra days to file the rendition.

Property owners who own or manage income-producing tangible personal property must file renditions. Examples of such property are business inventory, office furniture and fixtures, and business vehicles. Livestock, farm machinery, and personal vehicles are now tax exempt.

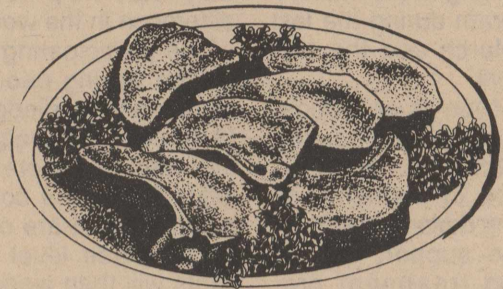

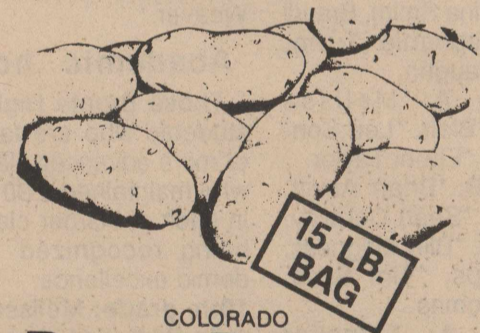

### Students set for Math-A-Thon program

Students at Bronte ISD will be participating in the Math-A-Thon program during the last week of March and the first week of April.

Math-A-Thon is an educational activity which focuses public attention on the important science of mathematics while raising dollars which will be used to support the research and treatment programs of St. Jude Children's Research Hospital. The Hospital is an International research facility, which is dedicated solely to research to eliminate those catastrophic diseases which threaten the lives of children.

Math-A-Thon involves a coordinated effort on the part of students, parents and community if it is to be a success. The students are not required to participate. The program is voluntary, but by participating,

our children are learning that they can help to make a difference in the world.

The participating students will be asking people in the community to pledge money (3-10 cents) for each problem that they complete successfully. The books contain 200 problems that are on the students' grade level. The students will then work as many problems as they can from their booklet. These booklets will be graded, and then the students will return to those who made pledges to collect the money they earned.

This money will be turned in to their teacher and then sent directly to St. Jude's Hospital where it will be used for research and treatment of terminally ill children.

All students who participate will receive a certificate of recognition. Students who

earn \$25.00 or more will receive a t-shirt. Students who earn \$100.00 or more will receive a t-shirt and a tote bag. Schools raising \$3,000 to \$4,999 will receive 15 Texas Instruments hand-held calculators. Schools raising \$5,000 or more will receive a Videocassette Player.

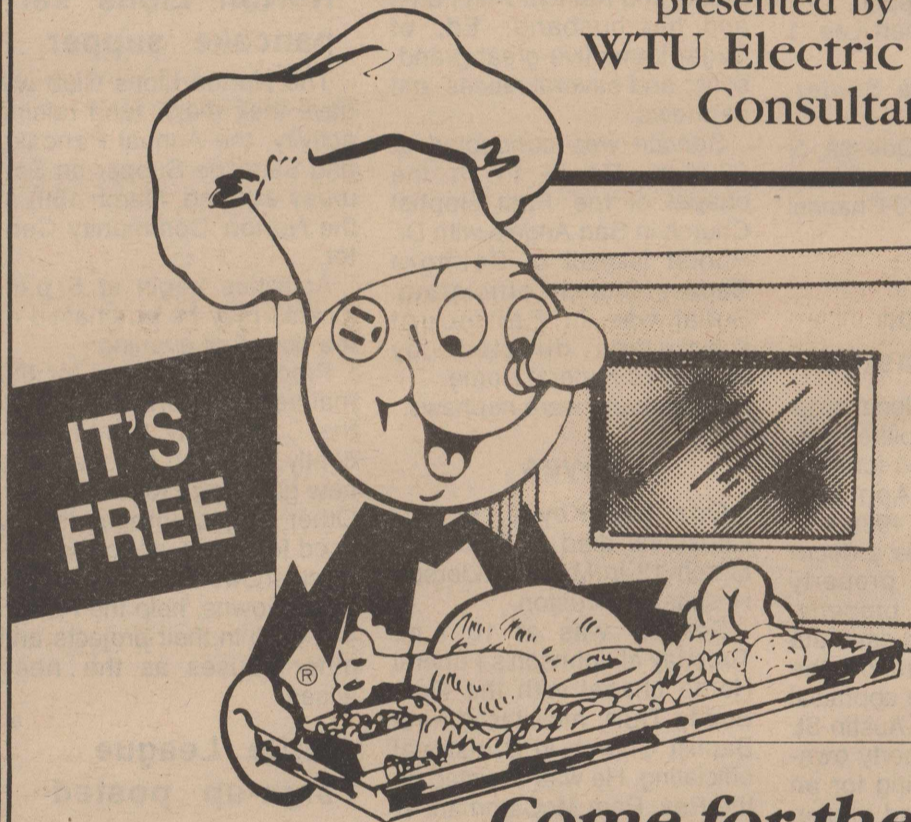

1. There is a need for better attendance of monthly drills.

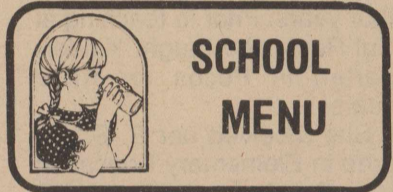
2. There is a need for more members (a minimum of 20).

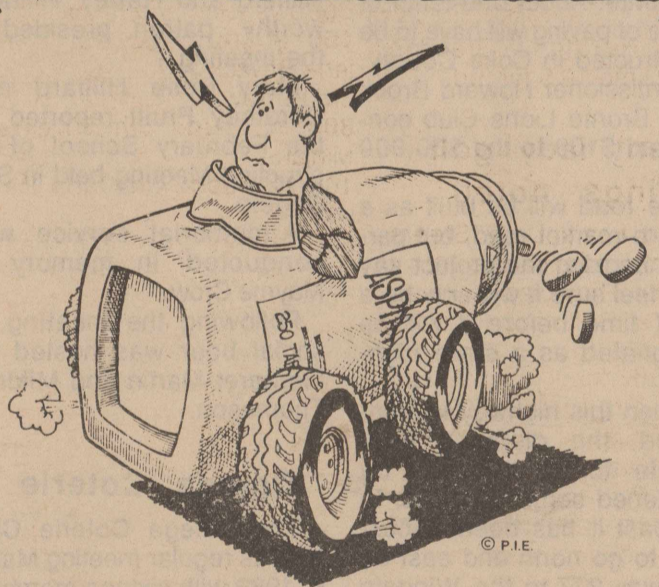

PUBLIC NOTICE

Pursuant to Section 52.151 of the Texas Water Code, the Coke County Underground Water Conservation District gives public notice of the promulgation of Rules and Regulations relevant to the District. A brief resume of the rules are as follows:

RULE 1- DEFINITION-contains definition of terms within the rules.

RULE 2-WASTE-provides that no person shall permit waste nor shall they pollute or harmfully alter the underground water.

RULE 3-PERMIT REQUIRED-provides that a permit is required for wells in excess of 25,000 gallons of water per day.

RULE 4-DEPOSITS-provides that each application for a permit to drill a well shall be accompanied by a \$50.00 deposit to be returned when a well log is received by the District.

RULE 5-ISSUANCE OF PERMITS-provides for developing an application form for permits.

RULE 6-REQUIREMENT OF DRILLER'S LOG, CASING AND PUMP DATA-provides that logs, casing and pump data be delivered to the District within 60 days of completion.

RULE 7-MINIMUM SPACING OF WELLS-provides that no well shall be located nearer than 300 feet from the nearest property line, and no more than 16 wells per section.

RULE 8-EXCEPTION TO SPACING RULE-provides that the board may grant an exception to the above spacing regulations.

RULE 9-DEPTH OF DRILLING A WELL-provides that a well must be drilled within 10 yards of the location specified in the permit.

RULE 10-REWORKING OR REPLACING A WELL-provides that no person shall rework, redrill or reequip a well without first making application to the board.

RULE 11-TIME DURING WHICH A PERMIT SHALL REMAIN VALID-provides that permits shall be valid if the work has been completed within 4 months from the filing date of the application.

RULE 12-CHANGED CONDITIONS-provides that decisions made by the board may be reconsidered upon its own motion or motion showing changed conditions.

RULE 13-RIGHT TO INSPECT AND TEST WELLS-provides that any representative of the District shall have the right to enter upon the lands for the purpose of inspecting and testing wells.

RULE 14-OPEN WELLS TO BE CAPPED-provides that the owner or operator shall be required to close or cap the well permanently, except when said well is in actual use.

RULE 15-FINAL ORDERS OF THE BOARD-provides that orders of the board in uncontested proceedings shall become final on the day the order is entered by the board.

RULE 16-HEARINGS-provides any person whose application is denied, or who is not granted relief, may file a motion for rehearing within 15 days from the board's decision.

RULE 17-RULES GOVERNING PROTESTS-provides that any person who wishes to protest or oppose any pending matter shall make written notice to the Board before the date the matter is set for hearing.

RULE 18-GENERAL RULES OF PROCEDURE FOR HEARINGS-provides that hearings shall be conducted in such a manner as the board deems suitable, and technical rules of local and court procedure need not be applied.

RULE 19-CHARGES, RULES-Provides for computing time, time limit, and show cause orders and complaints as covered by this rule.

RULE 20-WELL VALIDATION-provides a method of well validation on existing wells when location and wellhead equipment is determined by district personnel.

RULE 21-TRANSPORTATION OF WATER FROM THE DISTRICT-establishes a procedure for transportation of water from the district.

RULE 22-WELL DRILLING, COMPLETION, CAPPING AND PLUMBING-provides for standards of completion and location of domestic, industrial, injection and irrigation wells, and provides standards for completion and production of undesirable water.

RULE 23-REPORTING UNDESIRABLE WATER-requires reporting undesirable water encountered while drilling or deepening of wells.

RULE 24-DISPOSAL AND STORAGE OF WASTES-requires a permit for disposal and storage of wastes and provides for exceptions.

Complete copies of the proposed Rules and Regulations can be obtained and inspected at the Coke County Underground Water Conservation District office in Robert Lee, Texas. A Public Hearing will be held on March 27 at 7:00 P.M. at the Coke County Courthouse to review and discuss the proposed Rules and Regulations of the Coke County Underground Water Conservation District.

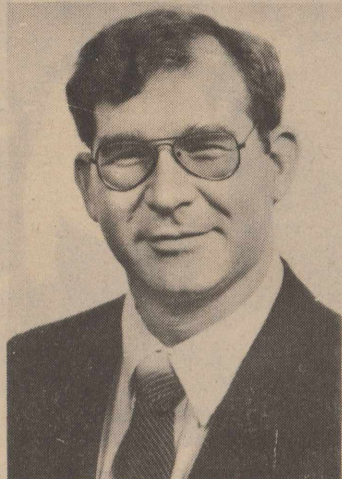
## Turner guides meat board

## Centennial Celebration Bronte Enterprise

### January 14, 1955 Bronte - Winters Highway to Be Constructed in Near Future

A paved highway from Bronte to Winters is going to be a reality, it was determined at a meeting at Winters Thursday night of last week. Bronte, Winters and Coleman civic leaders have been working for the project for many years.

A delegation of seven men from Bronte attended the meeting with the Winters Chamber of Commerce last Thursday night. At this meeting sufficient money was raised to reach a total of \$30,000 necessary to purchase right-of-way for the road from Wilmeth to the Coke County line. At this point it will connect up with the farm-to-market road running northeast of Bronte. About one-tenth of a mile of paving will have to be constructed in Coke County, Commissioner Howard Brock said. Bronte Lions Club contributed \$100 to the \$30,000 fund.

The road will be built as a farm-to-market road, but persons backing the project say they feel sure it will only be a short time before it will be designated as a state highway.

When this highway is completed, the distance from Bronte to Winters will be shortened some 10 miles. In the past it has been necessary to go north and east on Highway 277 to the Wingate cut off and then turn back southeast to Winters, or to go southeast from here on the Ballinger highway to Norton road and then cut through the country through Norton and on to Winters.

With the paving of this strip of highway the last gap in a proposed Trans - Texas highway will also be closed. This route is being backed by a group of Central Texas civic leaders who have proclaimed it to be the shortest distance across Texas. Another advantage of this route, it was pointed out, is that it will miss

all the big towns through the state.

Attending the meeting from Bronte were Commissioners Howard Brock, and Claude Ditmore, L. T. Youngblood, Ernest Ivey, J. A. Stephenson, Charlie Boecking, and C. E. Bruton, a large delegation from Coleman was also present.

Commissioner Brock said this week that it will probably take most of this year to acquire and fence the right-of-way and that he expects actual construction to begin about the beginning of 1956.

3. The purpose of the weather modification operation is to increase natural precipitation over the drainage area feeding surface reservoirs and tributaries which provide the municipal water supply of San Angelo, Texas. The period of the permit is from April 15th to October 15th in each of the two successive years 1989 and 1990.

4. The proposed weather modification operation is to be conducted for and on behalf of the City of San Angelo, P. O. Box 1751, San Angelo, Texas, 76902.

5. The proposed weather modification operation is to be carried out in both an "operational area" and a "target area" to cause the intended effects to occur only in the target area. This operational area of about 8,000 sq. miles is bounded by the following points.

Beginning at the southeast corner of Schleicher County due west to Ozona in Crockett County, thence northwest to a point three miles west of the southeast corner of Upton County, thence due north to a point three miles west of the northeast corner of Midland County, thence due east to the Colorado River at its intersection with the northern boundary of Coke County, thence southeast to a point three miles due south to its intersection with Highway 67, thence due east to the northwest corner of Concho County, thence due south to the point of origin at the southeast corner of Schleicher County.

6. The area to be affected by the proposed weather modification operation is the target area. The target area is an area about 4,700 sq. miles with boundaries parallel to and 10 miles inside the boundaries of the operational area noted above.

7. The methods and materials to be used in conducting this operation are summarized herein:

A licensed meteorologist will select cumuliiform clouds for cloud-seeding using a weather radar display, standard meteorological analyses, forecast techniques, observations, and pilot reports to direct an aircraft equipped to dispense the seeding particles, silver iodide crystals, into the updraft air near cloud base or while flying at an altitude where the ambient air temperature is in the range of -10 Degree C to -12 Degree C.

8. Persons interested in knowing more about the technical aspects of the proposed operation should contact the applicant or the Weather and Climate Specialist of the Commission.

9. A public hearing on this

application may be called by mailing a petition that requests a hearing to the Executive Director, Texas Water Commission, P. O. Box 13087, Captiol Station, Austin, Texas, 78711. The petition must contain (1) the signature, full name, address and phone number of each person requesting; (2) a statement that each person is at least 18 years of age and resides or owns property in the operational area; and (3) a description of each person's interest and how that interest would be adversely affected. Requests for hearing must be received by the Commission within 30 days of the date of the first publication of this notice. ## Memberships available

Sheriff Marshall Millican today announced that Coke County citizens who would like to join in the fight against crime are invited to become Associate Members of the Sheriffs' Association of Texas.

The Sheriffs' Association of Texas is a professional and educational organization dedicated to the preservation of peace and the protection of the lives and property of the citizens of Texas, according to the Sheriff.

The Associate Membership program was begun to provide citizens with an opportunity to lend their support to more effective law enforce-

### Forgotten funds?

State Treasurer Ann W. Richards said recently that more than 110,000 Texans have \$60 million in lost or forgotten money coming to them this year.

"Each year we try to locate as many people as we can and return this money to them," Mrs. Richards said. "Last year about \$22 million was given back to the rightful owners."

All listed accounts, other than those from safe deposit boxes, are worth at least \$50 with the largest account worth more than \$177,000. All safe deposit boxes are listed regardless of the value of the contents.

Generally, accounts on the list are from checking and savings accounts, utility deposits, oil royalties, and corporate stocks.

Most accounts must be dormant from three to five years before they are turned over to the state.

"There is no set time to make a claim on these accounts," Treasurer Richards said. "Money turned over to the State Treasury can be claimed at any time in the future by the original owner or his or her heirs."

Persons who find their names on the list can call the Texas State Treasury on its toll-free telephone line at 1-800-654-3463 or they can write the State Treasury at PO Box 17728, Austin, Texas 78745. The toll free line opens at noon on March 5.

During the first few weeks after the list is published, the toll-free line is often tied up by the volume of calls. The lines, however, are kept open for an extended period and there is no time limit for making a claim.

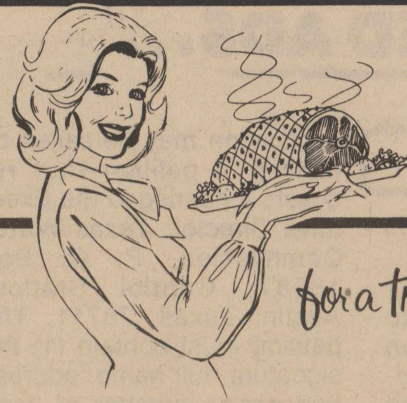
