He was the recipient of the Soil Conservationist Award of the Year in 1968. In 1977, the Texas Agricultural Extension Agency presented him with the Distringuished 4-H Adult Leader award.

Marie Hudgens, daughter of Nick and Ina Holland Hudgens, was born in Christoval November 11, 1904. She and Clarence Arrott were united in marriage December 9, 1928 in San Angelo.

Marie's activities with the youth included 4-H leader, 1943-1950 and Bronte school room mother, 1938-1950. As a member of the United Methodist Church of

Bronte, she served on the & M University. Retiring in board for ten years as a worship chairman since 1972. She is a charter member of the Coke County Home Extension Club, organized in 1945, receiving an award in 1978 for special recognition from the Texas Agricultural Extension Service of Texas A

Over 350 citizens and visitors attended the Coke County Centennial Celebration Saturday, July 22, according to Fran Lomas, Coke County Historical Commission Chairman, co-sponsor with the County Commissioners' Court, of the day.

Festivities began at 1:30 p.m. with a balloon lift-off by the West Coke County Board of Community Development and released by Phelan Wrinkle and Mrs. Lomas.



After a wedding trip to Hawaii, the couple will live in Robert Lee.



The ordinance states that a recommendation will be prepared and submitted to the City Council at which time the City Council will give notice to the owner of the proposed Open Sundays, 3 pm - 5 pm. demand for repair or demoli-

tion. A public hearing will be scheduled to determine whether the City should order the repair or demolition and how long should be given to allow the same to occur.

The ordinance further states certain rights of rehearing in the event demolition is required. Additionally, notice is provided to the owner of the property in regard to the actions of the City.

The ordinance states further that in the event repair or demolition is not completed, the City may act to demolish the same and may impose a lien upon the property to the extent of expenses incurred in demolition. The ordinance specifies parties authorized to file the lien claim as well as releases at times of reimbursement.
