



TP&W sets new season

The Texas Parks and Wildlife Commission, in a public meeting in Austin last week, reduced the whitetailed deer bag limit in some counties for the 1989-90 hunting seasons and authorized a longer spring turkey hunting season for 1990.

All the proposed changes were discussed in public hearings across the state during May, and the new regulations will go into effect Sept. 1.

The general white-tailed deer season was set for Nov. 4, 1989, through Jan. 7, 1990, in most of Texas. In all or portions of 28 South Texas counties, the whitetail season is Nov. 11, 1989, through Jan. 14, 1990. The special late anterless-only season for Angelina, Houston, Nacogdoches (south of State Highway 7), Polk, Trinity and Walker Counties was shortened and set for Oct. 21-29.

The spring turkey gobbler season was lengthened by approximately one week. The dates are April 7-May 6, 1990. In the portions of East Texas where a spring season is authorized for turkeys, the season also will open April 7, but closes April 22. A spring season was also authorized for Jackson and Matagorda

The mule deer season for Panhandle counties was set for Nov. 18-Dec. 3. The Trans-Pecos season is Nov. 25-Dec. 10. As in the past, the mule deer bag limit is two mule deer, no more than one buck, anterless by permit only.

Archery season for mule and white-tailed deer is Oct. 7-





Dilapidated - Hazardous -Substandard Buildings

Notice is hereby given pursuant to the terms and provisions of Section 52.01 of the Local Government Code, Texas Statutes, that the City of Bronte is considering the adoption of an ordiance regarding dilapidated, substandard, and hazardous buildings within the city limits of the City of Bronte and authority to give notice of demand of repair or demolition and in the event there is no compliance, the right of the City to proceed to demolish buildings and impose a lien upon the property.

The proposed ordinance creates a Building Standards Commission which will review properties on a semi-annual basis make and recommendations to the City Council as to existing substandard, dilapidated, or hazardous buildings which are unfit for human habitation and/or create a danger to the public health and welfare. The ordinance defines various criteria for ascertainment of dilapidated or substandard buildings as to particulars of the residential property, lot, and condition of the same. The ordinance states that a recommendation will be prepared and submitted to the City Council at which time the City Council will give notice to the owner of the proposed demand for repair or demolition. A public hearing will be scheduled to determine whether the City should order the repair or demolition and how long should be given to allow the same to occur.

The ordinance further states certain rights of rehearing in the event demolition is required. Additionally, notice is provided to the owner of the property in regard to the actions of the City.

The ordinance states further that in the event repair or demolition is not completed, the City may act to demolish the same and may impose a lien upon the property to the extent of expenses incurred in demolition. The ordinance specifies parties authorized to file the lien claim as well as releases at times of reimbursement.



Chewable tablets may cause Dental Health problems

People who attempt to ward off the common cold by munching on chewable vitamin C tablets could be damaging their teeth.

The ascorbic acid in vitamin C has been associated with dental erosion in the past, but the problem has become more acute with increased sales of extremely high levels of the vitamin in chewable tablet forms.

The chewable vitamin C tablets that contain megadose levels of the vitamin may present possible dental health problems according to latest research.

A recent American Dental Association report indicated

by Jan Hohensee Coke County **Extension Agent**

that the acidic level of three 500-milligram chewable vitamin C tablets, when dissolved in distilled water, about equals that of stomach acid.

While saliva has a certain buffering effect, it can provide only limited protection when there is daily direct contact between ascorbic acid and teeth.

When people attempt to chase the common cold, vitamin C cough syrup which clings to the teeth also is not recommended, since it may cause dental problems.

It is recommended that persons who use chewable vitamin C tablets on a regular basis should check with a dentist for any signs of dental problems.
