

Pioneer Woman Dies

Mrs. Sarah Elizabeth Scott died at her home in Bronte, early Saturday morning, January 16, 1932. Deceased was born at Talapoosa, Alabama, March 6, 1844, making her to be 87 years, 9 months and 10 days old when death called her to her reward.

The tired, worn out body was buried in the Bronte cemetery, Sunday afternoon, following religious services at the home, conducted by the pastor of deceased, Rev. J. A. Branaman, pastor of the Kickapoo Baptist Church, assisted by Rev. N. A. Pitts and the writer. In keeping with the request of deceased the funeral services were simple, consisting of the singing of hymns, reading of the Scriptures, prayer by Rev. Pitts, a brief talk by the writer and funeral address by the pastor. A great throng assembled and paid tribute to this grandmother in Israel.

Deceased was twice married. Her maiden name was Anderson. She was married first to Wm. Waldrop, May 1, 1862, who died in the Confederate hospital.

August 17, 1867 deceased was married to Daniel E. Scott. To this union seven children were born, only three of whom survive, namely, Mrs. Emma Thomason, Alamagorda, New Mexico, Collins Scott, Wellington and Dewitt Scott of California. Only the daughter could be present for the funeral. There are 28 grandchildren and 41 great grandchil-





Factors that affect consumer buying behavior

AM I BUYING THIS PROD-UCT OR SERVICE TO GAIN SOCIAL APPROVAL?

What people buy is influenced by society. Purchasing goods or services to gain social approval can be a problem when this behavior costs more than the person can afford. If you really can't afford it, don't buy it.

AM I PURCHASING THESE GOODS AND SERVICES BECAUSE IT IS A GOOD

When people purchase goods and services because they think they are getting a good deal, many times they are buying items they don't really need or want. Purchasing items you had not planned to buy can put a strain on your budget. You may end up not having money for necessary

items. In addition, the purchase may not be such a good deal, but even if it is a good deal, you may never have use for it.

DID I PURCHASE THE ITEM BECAUSE THE SALES-PERSON PRESSURED ME INTO IT?

Mamy salespersons will try to make you feel bad if you do not purchase whatever item it is they are selling. Beware of such lines as "You've waisted my time." or "How could you pass up such a good deal?" Remember, these are sales strategies, and you are not a bad person if you do not want or need the item being sold. Be assertive and say "no."

DID I BUY THE ITEM AS A RESULT OF WATCHING OR LISTENING TO ADVERTISE-MENTS?

Advertisements are designed to persuade people to purchase goods or services. If you have not planned to purchase whatever item is being advertised, you probably don't need it or want it. Take some time to think about it before acting.

Stop and analyze your buying behavior. If you have not planned a purchase, you may have been influenced by one or several of these factors. Remember, these factors may be preventing you from effectively managing your money.



News from Oak Creek

The summer is winding down in a hurry now and before we know it school will be starting, football and all the other activities that keep us busy. If you are planning a trip in the next few weeks before the Labor Day weekend we suggest you consider coming to Oak Creek. No matter what you enjoy, fishing, playing, visiting are what ever we think you will enjoy your visit.

We have seen some fine fish caught the past month even though the hot weather has kept many from trying except during the cool hours of the day. This time of the year is the best time to use top water baits for the bass in the first light of morning and from sundown to dark. If you want to troll for the whites or sand bass you can fill a stringer.

Tell you for sure we have had some big ol bass caught the past few weeks. We will just start with the best - Lee Wommach of Odessa got a real trophy going 9 pounds 14 ozs. This bass was caught in about 3 foot water using a worm. Chester Gillard of Dyess AFB also got a trophy going 8 lbs. 2 ozs. Tommy Smith of Abilene got one at 6 lbs. 1 oz. and lost two more before he had fished from the boat ramp to the dam. There have been a lot of big bass caught from around this string of docks where Tommy got his bass.

The bass are not the only fish being caught by any means. The Dick Johnson family of Odessa found a nest of good crappie and before it was over had 52 nice fish going up to 1 1/4 lbs. dressed to take home. Some have found how to catch the channel and

blue cat. The best action is coming during the late evening and after dark using big grasshoppers as bait. One group that was in the tent section of the RV park here at the Sportsmans Lodge got a big string of catfish in twenty five to thirty foot water along the rocky bank. If you want to catch some of the big bream they are a dime a dozen in spots all over the lake.

The two feet of water the lake caught from the rains back in June was a real help to Oak Creek. Even though it was late we got a spawn of fish that was something and it's still going on. Around docks under lights the minnows and shad about an inch long also number in the thousands. These are food for everything from bream to trophy bass. Wonder why we think Oak Creek is going to be a good place to fish in the months ahead?
