Specifically, Robert Lee received \$5,734.50, a 6.07% increase from last year. Bronte received \$4,163.56, an 11.46% drop from last year's total. These figures both represent an increase in revenue over 1988 payments to date.




The Robert Lee Observer, now in its fiftieth year, was started at Hayrick the first county seat in June, 1889. Brady and Shores formed the first firm, and afterward J. S. Brady bought out Shores and moved the plant to Robert Lee.

It was first located where the South Side Filling Station is now, then was moved to its present location. After some time the plant was moved to a location near the present Coke Motor Company, and later moved back to the previous location, where it stands today.

The first few issues were called "The Democrat", a tabloid size. "Then the new paper in the new town in the new ounty was given the name of Coke County Rustler." which it bore for

several years. But the name "Rustler" was none too popular on the frontier, and the publisher asked for suggestions for a name, and adopted the present name.

There are some gaps in the files and it may be that the following are not in the exact order in which they came, but with the help of R. L. Hall who is now associated with Felix Puett in publishing the paper, and of Gray Reed, now a merchant and landowner at Lawn, we give you the following names of the editors following Mr. Brady: Tom Durham, Irvin and Pritchard, Hubert Pearce, M. H. Davis, Sam Wilkins, Merchant and Reed, G. A. Beeman, Joe Rankin, George Cowan, J. G. Berryman, Berryman and Lamb, A. W. Puett, and the present owner, Mrs. A. W. Puett. The plant is now operated by her son, F.

Bronte -- A live Wire on the Orient

Seizing time by the forelock, the enterprising town of Bronte moved onto the line of the Orient railroad, about three years ago, and now that the trains are running through its center, it is experiencing a boom and "go" excelled by few places on the map.

The business men of Bronte are FOR Bronte first. last and all the time, and much after the manner of the people of San Angelo, they are fast acquiring a reputation of getting what they are after and getting it quick.

After Oil Mill

Just now Bronte is after an oil mill. Some eastern capitalists went to the people and made a proposition and a mighty good one. They said that if Bronte would buy \$15,000 worth of stock in a \$75,000 company that the enterprise would be established. And with characteristic hustle, the Business Club, headed by its president, R. B. Hudson, called a mass meeting, raised a good solid bunch of change for a starter, and now has about half the \$15,000 subscribed, with the rest in sight and the new plant assured.

Up in Coke county, the name "Bronte" is getting to be synonymous with "enterprise," just as the local newspaper owned and operated by Mayor C. H. Bently, is apply named " The Bronte Enterprise."

The Situation

Situated almost exactly half way between San Angelo and Sweetwater on the Orient, in the beautiful valley of the Colorado. Bronte is these days enjoying a wonderful prosperity.

All the merchants declare business is good. The farmers declare that they have the best crops in Texas. Where a large portion of the state has made but a quarter or a third of a crop during the past season, the good people out in Coke County have brought out at least a half crop, and in many cases have done even better

A glance across the fertile fields of cotton or feed stuff is proof of the claim, that the valley of the Colorado has been blessed beyond many others, this year. The cotton growers have brought out about 6,000 bales and the crop is all in. The crop of feed stuff is also such size that Bronte is getting to be an important shipping point on the Orient.

Good Looks

Bronte is one of the cleanest and prettiest towns of its size in this part of the country

Early Coke Co. cowboy listed

E. C. Rawlings, Bronte cattle-cattleman, was one of the first cowboys in Coke county, working on HXW, a part of which is the present Arledge ranch. Mr. Rawlings later became owner of the outfit. He remembers that the old line fence ran north of the present Sanco to Silver Peak.

The Standard Oct. 31, in a prohibition county, the local officer of the peace has little trouble in the maintenance of law and order. The doctor and the deputy are declared to have little work to do. In addition to its general good behavior. In a civil and criminal way. Bronte is one of the healthiest spots on the face of the earth.

> There have been but 16 deaths this year from all causes, and not one case of typhoid fever has been known in the last 12 months. Well water is abundant and plans are on foot, promulgated by the ever live business club, to pipe the good water of the Colorado river the two miles to town and build big reservoirs for the establishment of a modern, first class water

> > Some Good Features

The town is lighted by electricity throughout; has perfect natural roads; 18 stone business houses; a handsome \$10,000 school house; two \$5,000 church buildings, a state bank capitalized at \$35,000; two lumber yards; two cotton gins, two livery stables; two hotels and is already incorporated for school and municipal purposes, and the live and active Business Club has a membership of thirty prominent men. With all this the real Bronte of today is but three years old.

When San Angelo was in the throes of her purchase of \$50,000 of Orient bonds, Bronte came right across by taking several bonds at the suggestion of Maj. J. R. Daugherty, who got the subscription in the town in one day. Since the advent of the railroad, the people have been pushing their community along at a fast clip, land values have gone up sharply, and all are looking forward to that growth and prosperity which their typical West Texas energy and vim will surely bring them.

Bronte is now the main shipping post for all Coke county and the western half of Runnels. New comers are no longer mare in the town, which already has a population of 1,500 people, increasing at a rapid rate.

R. B. Hudson, the president of Bronte's Business Club and one of the towns most prominent men, is one who has pinned his faith on the community and stayed with his proposition to the last stand. He is enthusiastically for Bronte in everything.

"Values on Rise"

"Values have gone up at a remarkable rate," he said in speaking of the town's future, yesterday. "The crops have been very good and everybody is feeling confident of prosperity in the future and the development of the town

into a good center of indus-

Mr. Hudson is a dealer in real estate, town and country lands, and is foremost in the town's activity along all lines.

The First State Bank at Bronte capitalized at \$35,000, has W. F. Key for its president and J. B. Reilly for its cashier. It is the consolidation of two former banks, and is the solid rock of Bronte's financial life. Occupying a handsome twostory stone building, its officers are fitted up in a most tasteful manner, and the whole atmosphere of the institution is one of snug prosperity.

Fine High School

Bronte's High School is under the able tutelage of Prof. J. M. Skinner, well known throughout this part of the country for his learning as well as his executive ability. Three hundred school children have him for their guide, a position he fills to the great satisfaction of all the citizens.

T. L. Rose is the local manager of the telephone system for the Rust Brothers of San Angelo, and has a plant in perfect running condition, though he admits that lately the number of "line's buzzing, answers to suscribers, has been increasing at an alarming

"Bob" Knerim runs the electric light plant, one of the modern conveniences of Bronte which make it such a good place to live in.

A. J. Nelson is the principle gin operator in Bronte. Mr. Nelson is head of the firm of A. J. Nelson and Company, operating one cotton gin, and also; interested in the firm of Nelson and Caudle, which run another plant of good capacity. A big field near the Orient station is covered, with big bales turned out from these two plants, the result of the good Coke county rains and the diligence of the surrounding farmers. As mentioned, there is a crop of about 6,000 bales, marketed at Bronte this year.

The Town Health

Bronte's health is ably taken care of by two practicing physicians and two dentists. Drs. T. P. Pipkin and J. D. Leonard look after the practice. They are recognized physicians of great worth over a large area and in all the surrounding territory.

Drs. B. T. Owens and Frank Dickinson are the dentists at Bronte and both are popular with the people.



Application forms are being sent to all homes with a letter to parents or guardians. To apply for free or reduced price meals, households should fill out the application and return it to the school. Additional copies are available at the principal's office in each school. The information provided on the application will be used for the purpose of determining eligibility and may be verified at any time during the school year by school or

For the school officials to determine eligiblity, the household must provide the following information listed on the application: Names of all household members; social security numbers of all adult household members or a statement that the household member does not possess one; total household income or the household's food stamp case number, AFDC case number if they currently receive food stamps or AFDC case number if they currently receive Aid to Families with Dependent Children and the signature of an adult household member certifying that the information provided is correct.

Applications may be submitted at any time during the year. Under the provisions of the free and reduced price policy the Bronte ISD Superintendent Michael Hartman, will review applications and determine eligiblity. Parents of guardians dissatisfied with the ruling of the official may wish to discuss the decision with the determining official on an informal basis. Parents wishing to make a formal appeal may make a request either orally or in writing to Superintendent Michael Hartman,

Bronte I.S.D., Box 670, Bronte, Texas 76933, 473-2511 for a hearing on the decision. Households are required to report increases in household income of over \$50 per month or \$600 per ear and decreases in household size. Also, if a household member becomes unemployed, or if the household size increases, the household should contact the school. Such changes may make the children of the household eligible for reduced meals or for free meals if the household's income falls at or below the

In certain cases foster children are also eligible for school meal benefits. If a household has foster children living with them and wishes to apply for them, the household should contact the school for more informa-

The information provided by the household is confidential and will be used only for purposes of determining eligibility and verifying data.

In the operation of child feeding programs administered by the U.S. Department of Agriculture, no child will be discriminated against because of race, color, sex, national origin, age or handicap. Centennial Celebration

J. A. Clift in Robert Lee Since 1904, Reviews Early Days of 20th Century

Thirty five years of business in the capitol of Coke county is reviewed by J. A. Clift.

Mr. Clift moved to Robert Lee in 1904, when he was deputy sheriff under W. T. Hazelwood, then sheriff of Coke county. Two years later he became connected with McCallum Reed company in which connection he continued 21 years. Gray Reed, of this firm, is now a citizen of Lawn, in Taylor county.

Mr. Clift came to Robert Lee from Ft. Chadbourne, where his father, the late W. M. Clift, was in business during his lifetime, and he recalls some of the first here in 1904. L. Scott had a tin shop west of the square, and in that block Dr. Adams had a drug store, which was sold to Dr. P. D. Coulson soon afterwards.

In 1906 the Odd Fellows built a building just east of the square, of concrete block construction, and McCallum-Reed occupied it three years, them moved to the building on the corner that bears yet the sign "Robert Lee Mer-cantile company." The Odd Fellows building was sold and in later years the blocks used in constructing the present Coke Motor Company build-

In 1908 the Masons built their present building, occupied on the ground floor by the City Drug Store. It was damaged by fire in 1907 and repaired. D. Coulson moved his store there in 1912.

Boarders at Tubb Hotel

When Mr. Clift first came to Robert Lee, he stayed at the Tubb Hotel, well remembered by Coke citizens of those years. Also boarding there at that time were Charlie Coulson, Dr. P. D. Coulson, Sheriff W. T. Hazelwood, and Tom Goss among others.

Business in Robert Lee was good at that time -- mostly on a credit, but everybody paid up once a year, and some twice -spring and fall. Grocery bills didn't run so high then. There were no oranges, except at Christmas time. Hard flint candy was all the candy children expected. There was no ice and no bakers bread to buy.

Trade flourished, however, with plenty of brown beans, spuds, salt pork, and molasses, bought by the barrel and sold often five gallons at a time, the buyer bringing his keg with him to town.

Albert Baze 33 Years Harris Foreman

Mr. and Mrs. Albert A. Baze moved to Coke County in January 1906. Mr. Baze was foreman of the Harris Bros. Ranch in the south part of Coke county. They had one son at that time, Mike. Albert E. and Winford were both born on the ranch.

Mr. Baze has been foreman of one or the other of the Harris ranches ever since then. A few short periods he was away from Coke county ranches but was on some of the other ranches of Mr. Harris, either at the Water Valley Ranch or one of the Pecos River Ranches.

Before 1906 Mr. Baze made short trips to Coke county from San Angelo with his father, Polk Baze, who was a buffalo hunter by profession but in the '80's and 90's as the buffalo became scarce turned his attention to ranching.

Mike is a Baptist minister in Lynwood Baptist Church of Los Angeles, Calif. He married but has no children. He, at one time was a marathon runner, he has competed in several cross country races, and was in a race from Los Angeles to New York and the next year in one from New York to Los Angeles.

Albert E. graduated from Robert Lee high school in 1929. Since then he has been assistant cashier of the bank at Balmorrhea, Texas, and cashier of the First State Bank of Robert Lee, also was in the accounting department of the State Highway Department at Pecos, and now is in the auditing department of the highway department at San Angelo.

Winford graduated from Robert Lee in 1932. He played football 4 years at Robert Lee, two years at Schreiner Institute, where they won the state junior college championship. He played three years at Texas Tech and one year with the Philadelphia Eagles professional team. He is now football coach and physical education instructor at Mt. Pleasant high school.

he was emphaticin his praise of what he had already been accomplished and believed that all interested would move to the new townsite and put their shoulder to the wheel and pull for Bronte.



"State law require commercial and non-commercial licensees of restricted pesticides to earn a minimum of five continuing education credits each calendar year in order to renew their license for the following year," said Dr. Tom Fuchs, San Angelo based Extension Entomologist. "The necessary continuing education credits are earned by participating in this type of courses."

These courses are offered jointly by the Texas Agricultural Extension Service (TAEX) and the Texas Department of Agriculture (TDA).

Fuchs said the courses apply only to commercial and non-commercial applicators. Private applicators he said, do not need to attend.

VA Questions & Answers

Editor's Note: Following are representative questions answered daily by VA counselors. Full information is available at any VA office.

Q -- I am a woman veteran. Can I obtain gender-related medical treatment at a VA

A -- Yes, provided you meet the general eligibility requirements for medical care. Women veteran coordinators have been designated at each VA medical center and at many regional offices to counsel women veterans seeking treatment.

Q -- I will complete VA's vocational rehabilitation program shortly. Can I draw additional subsistence while I'm receiving assistance with job place-

A -- Yes. A veteran who has completed his or her vocational rehabilitation program is entitled to subsistence allowance at the full-time rate for two months following completion of the program.

Q -- Did the change on March 15, 1989, making the Veterans Administration the Department of Veterans Af-

fairs affect my VA benefits? A -- No. The law making the VA a cabinet department only involved changing its name and making a few organizational changes. The new Department of Veterans Affairs assumed responsibility for all laws and regulations administered by the VA that provide benefits and services to vet-
