County commissioner filing date extended

Patti Ivey, Coke County Democratic Chairman, advised the Observer/Enterprise on Tuesday of the legal ruling made by Secretary of State George S. Bayoud, Jr. concerning the filing date for Precinct 1 commissioner hopefuls. Due to the accepted resignation of Precinct 1 Commissioner George Newby, the filing date for the remainder of his term will be extended to January 12, 1990 at 5 pm. The term of that office does not expire until December 31, 1992.

According to the election code of the State of Texas, the county judge initially appoints someone to fill the vacancy. That appointment expires on November 6, 1990.

Paul Burns, who was a candidate for the office during the last election, was named to fill the vacancy on Friday, December 29. The appointment does not automatically give him the office for the remainder of the term and he must file in the March primary to seek that unexpired term.

Following the November 6 general election and the offi-

cial canvass of votes, the person elected may immediately take office instead of waiting for the January, 1992 swearing in. He or she would assume the office then in place of the appointed official.

Candidates may file against the appointed official until the January 12 deadline. Whoever goes on to win in the general election in November will assume the office.

Complete filings listed

Filing period for those seeking various positions on the March 13 primary ballot ended Tuesday, January 2, at 6 pm.

Drawing the most candi-

dates for any office in Coke County was the county judge's position. Filing for that office were Royce Lee of Bronte, Kenneth Green, Bob Cox and Jeffie Harmon Roberts, all of Robert Lee. County judge Aubrey Denman will not seek re-election.

Incumbent Coke County District Clerk Ettie Hubbard will not have an opponent for the primary election.

The county treasurer office drew no opposition for incumbent Phelan Wrinkle in the upcoming election.

County Commissioner of Precinct 2, Billy Joe Luckett is also unopposed in his bid for another term. On Tuesday, Jerry Parker filed for the







to begin corresponding prior to the student's arrival.

ASSE is also seeking local high school students to become ASSE exchange students abroad. Students should be between 15 and 18 years old and interested in living with a host family, attending school and learning about the lands and people of Scandinavia, France, Italy, Spain, Germany, Holland, Britain, Switzerland, Canada, Mexico, Australia or New Zealand. Students should have a good academic record and desire to experience another culture and language through living with a warm and giving volunteer family. Academic year and shorter term summer vacation programs are available.






Craig Bessent

payment eligibility

Are you in financial need and age 65 or older? Maybe you are eligible for monthly Supplemental Security Income (SSI) payments. This is a Federal program that makes cash payments to persons in financial need who are aged, blind, or disabled.

If you are a blind person whose vision is less that 20/200 with the use of correcting lens in the better eye, or you have tunnel vision of 20 degrees or less, you should apply for SSI payments if you don't own much or have much income. There is no minimum or maximum age limit for blind or disabled

If you are unable to engage in substantial gainful activity because of a physical or mental impairment that can be expected to last at least 12 months, or can result in death, you should apply for SSI payments. This program makes monthly payments to disabled persons regardless of age. A child under age 18 is eligible if he or she suffers from an impairment comparable to one which would prevent an adult from engaging in substantial gainful activity.

SSI is administered by the Social Security Administration and is financed from the general funds of the U.S. Treasurv. not from the Social Security or Medicare Trust Funds. Applications for SSI Jare handled by Social Security offices.

There are rules to know if a person or a couple is in "financial need". For example, an eligible individual or couple cannot have countable income in excess of the maximum SSI payment for individuals or couples. In 1989, the payment for an individual is \$368 a month and for a couple, \$553. For 1990, payments will increase to \$386 a month for an individual

and \$579 for a couple.


Some might get less than the maximum if they have income from other sources, and some might get more if their States add money to the Federal payment.

We consider as income a Social Security check, any salary, pensions, or any money received, as well as housing, clothes, and food paid by another person in your behalf. If you are a single person and your income is less than \$368 (\$386 in 1990) a month or if you are married and your income is less than \$553 (\$579 in 1990) a month, some SSI money may be paid.

In addition to the income limitation, an individual cannot have resources in excess of \$2,000 and a couple cannot have resources of more than \$3,000. These limits will remain the same in 1990. Resources are mainly savings and checking accounts, bonds, stocks, life insurance, a car in certain situations, real and personal property. Funds set apart to be used for the funeral and burial of an individual and his or her spouse are limited to \$1,500 each.

Not all income and resources are counted. There are some exclusions and exemptions that reduce the countable earned or unearned income and resources used to determine both eligibility and the amount of SSI payments.

So, if you are a citizen of the United States or an alien lawfully admitted for permanent residence and you think you are not eligible for SSI payments because of your income or resources, get in touch with a Social Security office. Ask them to explain the income and resource rules. They will be glad to tell you whether you are eligible for Supplemental Security In-

Getting Souped up Over Homemade Soup!

There's nothing like coming homemade stock does produce in from the cold to a crackling fire and the rich aroma of homemade soup simmering on the stove. Nothing warms the soul quicker or tastes better than a hearty soup, especially if it's Mom's.

Soup appeal has always been universal, and traditional recipes have lasted through the centuries. And, according to the November/December 1989 issue of Philip Morris Magazine, as the vogue of nouvelle cuisine tapers off, these one-dish meals are being adapted by American cooks and are making a comeback. From a Russian borscht to a robust Italian minestrone, soup has become a dish to complement anyone's table year-round.

Soups today truly reflect the ingenuity of the everyday cook, using a wealth of vegetables available year-round. Also, soups can be made in large quantities and frozen for later use. And they are an economical way to feed a large group or today's working person who still wants to savor a homecooked meal.

Making good soups is not difficult. The trick is determining which ingredients work well together. The soup pot should never be a haphazard catchall for whatever one has around. Each vegetable's character should be respected.

A good stock is a cook's best friend. It makes a new cook a good one, and a good cook, a great one. However, while a

a more full-bodied soup, great results can be achieved with a doctored commercial broth or a bouillon-cube broth, as long as the vegetables are very fresh. Fresh produce is the most important ingredient. Root Vegetable Soup

Serves 4 to 6

2 large leeks, white part only 4 tablespoons unsalted butter

2½ tablespoons all-purpose

6 cups homemade chicken stock 3 medium carrots, peeled and

3 medium turnips, peeled and cubed

2 medium parsnips, peeled and

2 medium red potatoes, peeled and cubed

2 hearts of Bibb lettuce, leaves separated and rinsed

11/2 to 2 cups fresh spinach Jeaves, stemmed and rinsed Salt and white pepper to taste ½ cup heavy cream Garnish: 2 tablespoons finely

1. Cut leeks in half lengthwise and then crosswise into thin slices. Run under warm water in colander to remove all traces of

minced chives and parsley

sand. Drain and set aside. 2. In large casserole, melt butter over low heat. Add flour and cook, stirring constantly for one minute without browning. Add chicken stock and whisk until well-blended.

3. Add reserved leeks, carrots, turnips, parsnips and potatoes. Bring to a boil, reduce heat and simmer until vegetables are almost tender.

4. Add lettuce and spinach leaves, and season with salt and pepper. Lettuce should just wilt, but still remain crisp. Do not overcook.

5. Before serving, add heavy cream and heat soup through without bringing to a boil. Sprinkle with chives and parsley and serve hot with thin slices of black bread.





Texas is friendly state

While it isn't advertised on state license plates, Texas friendliness does not go unnoticed by visitors to the Lone Star State.

"'The Friendship State' may not be so far off after all," said J. Don Clark, director of the highway department's Travel and Information Division, after seeing results of the division's 1989 Auto Visitor Survey.

When visitors to the department's 12 Travel Information Centers were asked what they enjoyed about Texas, "friendliness" was the number-one answer, Clark noted. Although Texans rejected a proposal last summer to promote their friendly attitude on license plates, "they apparently lived the slogan, impressing, their guests with good humor and helpfullness," Clark added.

Scenery, good highways, and Texas food all ranked high, too, among the 3-1/2 million visitors to the Travel Information Centers.

People who come to Texas are staying longer than their counterparts last year, the survey shows, with average stays up 6 percent over 1988. "This shows that the state

continues to provide additional recreational, historical, and entertainment facilities that extend the visitors' Texas experience," Clark said.

Oklahoma continued to provide the most out-of-state visitors, with California remaining in second place. Missouri jumped from sixth place in 1988 to third in 1989, replacing Louisiana, which dropped to fifth.

San Antonio is still the most -visited city by both short-term visitors and those who stay longer than 30 days. Shortterm visitors identified Dallas and Houston as their next most popular destinations, while the long-term visitors listed the winter havens of Brownsville and Harlingen.

The report lists the 30 top Texas destinations as well as statistics on visitor spending, miles driven, activities, purpose of trips, accommodations used, ages of visitors, and other data. In addition to the 1989 totals, figures for the winter, spring, summer, and fall quarters are presented in the survey report.
