County primary election slated Tuesday

Serving Coke County

Coke Countians will go to the polls on Tuesday, March 13, to cast ballots in the Democratic and Republican party primaries. At that time voters will nominate candidates for the U. S. Senate, governor, lieutenant governor, various judges, and a number of county offices.

In Coke County, much attention has been directed to the judge's race where 4 candidates are campaigning for that office. Judge Aubrey Denman chose not to file for re-election. Candidates for the position are Bob Cox, Royce Lee, Kenneth Green, and Jeffie Harmon Roberts.

County and district clerk Ettie Hubbard is unopposed in her bid for re-election, as is treasurer Phelan Wrinkle.

County commissioner, Precinct I, Paul Burns is an appointee for that position until November 6 and is unopposed in his campaign to be elected to the office. Billy Joe Luckett, county commissioner of Precinct 2, is also unopposed. Jerry Parker is challenging incumbent James Tidwell as the county commissioner of Precinct 4.

Joan Davis is unopposed for Justice of the Peace, Precinct I, with the retirement of Peace Justice Opal Jacoby.

Gary Shaffer, an appointed Peace Justice to fill an unexpired term as Precinct 2 Justice of the Peace, is opposed by Marty Boyd.

Of local interest also are the unopposed campaigns of 66th District State representative Robert Junell and 17th Congressional District, U. S. representative Charles Stenholm.

Deadline for absentee voting in person is Friday, March 9, at 5 pm in the county clerk's office. At presstime, 37 absentee ballots had been cast in the office and 31 ballots had been mailed out.

Runoff elections will come on the heels of the March 13 primaries, on Tuesday, April 10. Although the deadline has passed for registration to vote in the primaries, voters may register until March 12 and cast ballots in the runoffs. Contact the county tax assessor/collector's office, 453-2614, for more information.

Secretary of State George Bayoud, the state's chief elections officer, has announced that Texas has reached an all-time high with almost 8.3 million people registered to vote in the March 13 primaries.

Polling locations in Coke County include Precinct I - the Senior Citizen Building; Precint 3 - the courthouse, and Precinct 9 - the Pecan Baptist Church, all Robert Lee voting boxes, and Precinct 2 - City Hall, Precinct 4 - Community Building, Tennyson; and Precinct 5 - Old Depot, all in Bronte. All polling places listed are Democratic voting boxes.

According to County Clerk Ettie Hubbard, a Republican Primary will not be held in Coke County March 13.

This put the Horns on a run as the first quarter ended with Bronte leading 13-5. Santo was not willing to let the Horns run away with the game and came out in the 2nd quarter and pecked away at the Horns' lead and ended up on top at the half.

The 2nd half saw the Horns fall behind as much as 12 points at one time, but they came right back and took the lead once again in the 3rd quarter. The lead changed hands off and on during the remainder of the game. At the end of the 4th quarter, Santo was in the lead and went into a

spread offense that torced the Horns to foul and put their opponents at the free throw line. After capitolizing on the free throw shooting, the Wildcats were on top at the final buzzer, defeating the Longhorns 60-54. Three of the Longhorn players scored in double digits with Phillips, Windham and Badgett putting in 19, 16 and 15 points respectively. Seales and Pierce each added 2 points.

TMF termed counter-productive

HIS FINAL MONTHS

Editorial by Guno G. Kletter,

When I first met Woodrow, he had symptoms and signs of possible lung cancer in an advanced stage. When I explained that we had no objective proof of cancer, no biopsy was done, no cancer cells found in his sputum, he said, "I don't want any more diagnostic procedures". I respected his decision and treated his symptoms, such as his stomach pain, his nausea or vomiting, either in my office or at his home.

I was always impressed by his modesty, "Doc, I hate to bother you", he said repeated, forcing himself to smile, while hardly able to stand or walk without assistance. He seemed more concerned about bothering me than about his own misery. From his wife's account and my own observations, I knew he suffered a lot. As time went on he developed severe abdominal pain, wasn't able to keep any fluid in his stomach and became dehydrated. He was admitted to the hospital and treated with intravenous fluids and pain medication. According to his wishes, no diagnostic procedures were His condition improved some and after three days he returned home to end his heroic struggle two months later.

A few months after Woodrow's admission, a nurse employed by the Texas Medical Foundation, looks into his records and decides in her wisdom that he should not have been admitted. My patient was terminally ill, his appearance didn't leave room for doubt, with a height of 5'11", his weight had dropped to 126 lbs. Notwithstanding his severe abdominal pain, his inabiliy to retain fluid or food, he didn't qualify for hospitalization.....

The root of the problem is the TMF, an organization which employs nurses (\$13.00 per hour) and doctors (\$60.00 per hour) to scrutinize medical records in order to find out if any patient was unnecessarily admitted. The system was devised to save money. Many doctors can tell amazing stories of admission denials in patients so ill that there cannot be the slightest doubt about the need for hospitalization. One doctor mentioned that his patient, severely ill on admission, died in the hospital.....TMF came, looked into the records and denied. One

wonders how such a system for media coverage. A drug can possibly exist. addicted mayor of Washing-

One reason: the doctors. We seem amazingly placid, gifted with an astonishing lack of fighting spirit. Instead of confronting the issue head on, we opt for a policy of complying with the rules, even though these rules interfere directly with the very reason of practicing medicine, namely to offer help to the sick. Asset protection is often too much our concern.

Another reason: the patients and in general the public are not made aware of TMF's dealings, so there is no way for them to understand how Woodrow's admission denial today is going to affect their own family tomorrow. Most victims of TMF are elderly patients, lacking the strength and the means to generate a strong and effective protest, their problems are not sensational enough

for media coverage. A drug addicted mayor of Washington is on the screen three times a week.

Our elderly patients deserve more respect, their efforts, many times under adverse conditions, laid the foundation for the more comfortable lifestyle of the present generation. Allowing doctors to treat their elderly patient in the hospital if needed should be an accepted fact of daily life in a civilized society, that we feel the need to discuss this speaks for itself.

An institution like TMF fails to contribute in a positive way to improve our medical care, on the contrary, it is counterproductive in its outrageous denials.

The Texas Medical Association should prepare for the funeral of TMF, its brainchild. There will be no lack of volunteers to deliver the graveside speech.







Unclaimed funds listed

State Treasurer Ann W. Richards said Friday that more than 120,000 Texans have \$99 million in lost or forgotten money coming to them this year - up 65 percent from last year's \$60 million.

The 120,000 are named in the 1990 version of the Texas Treasury Unclaimed Money Fund List which will be published statewide on Sunday, March 4 in 27 newspapers. Among these are the following Coke County accounts: Bronte - Barry Hilliard; Robert Lee - Calla Mae Cargile, Russell Jones, Jo Ella Leeper, Mary Jo Pentecost, Sherry Ross, J. D. Rudd, West Texas Artist Association.

"Each year we try to locate as many people as we can and return this money to them," Richards said. "Last year about \$26 million was given back to rightful owners."

All listed accounts are worth at least \$50 with the largest account worth close to \$103,000. All safe deposit boxes and stocks are listed regardless of the value.

Generally, accounts on the list are from checking and savings accounts, utility de-

posits, oil royalties, and corporate stocks.

Most accounts must be dormant from three to five years before they are turned over to the state.

"There is no set time to make a claim on these accounts," Treasurer Richards said. "Money turned over to the State Treasury can be claimed at any time in the future by the original owner or his or her heirs.'

Persons who find their names on the list can call the Texas State Treasury on its toll-free telephone line at 1-800-654-3463 or they can write the State Treasury at P. O. Box 17728, Austin, Texas 78760. The toll-free line opens at noon on March 4.

During the first few weeks after the list is published, the toll-free line is often tied up by the volume of calls. The lines, however, are kept open for an extended period and there is no time limit for making a claim.

The telephone hours are 8 am to 8 pm Monday through Friday from March 5 through April 6. After April 7, the hours will be from 8 am to 5

Tax Law Changes

The following are some of the highlights of recent tax law changes: ■ The amount of each personal and dependency exemption has increased to \$2,000 for 1989-up from last year's amount of \$1,950. (As was previously the case, if you are entitled to claim another taxpayer as a dependent, that person cannot claim himself or herself as an exemption too.)

- Personal interest expenses (interest on a personal loan, bank credit card interest, etc.) that can be deducted will drop to 20 percent for
- Now you are required to give the social security number of any dependent you claim who will be two years old or older at the end of the tax year. Applications and information can be obtained from the Social Security Administration.
- Beginning in 1990, most taxpayers age 24 or older may exclude from income, interest on redeemed Series EE U.S. savings bonds issued after 1989 if the taxpayers pay tuition and required fees for themselves, their spouses, or dependents at an eligible educational institu-
- Starting with this year's federal tax return, if a child has more than \$500 but less than \$5,000 in interest or dividends (including Alaska Permanent Fund dividend), no Federal income tax withheld, and no earned income, the parents may be able to choose to include this unearned income on their own return. However, the child must be under 14 years of age at the end of the parent's tax year. If this is done, the child does not have to file a tax
- Beginning in 1989, if part of a child's income is taxed at the parent's tax rate, the child is not eligible for the regular exemption amount when figuring alternative minimum tax. The child's alternative minimum tax exemption amount will be limited to \$1,000 plus the child's earned income. (The alternative minimum tax is a special tax designed to ensure that all taxpayers pay at least some tax regardless of the deductions and tax credits to which they may be entitled).
- Both self-employed individuals and now their employees may choose to be exempt from paying social security taxes if they are members of a religious faith that is **program**.

conscientiously opposed to the acceptance of public or private insurance benefits.

- The targeted-jobs credit that permits employers to claim a tax credit for wages paid to members of certain targeted groups was extended through 1989. Further information can be found in free IRS Publication 572, General Business Credit.
- The cash wages of some seasonal hand-harvest laborers, as of 1988 are no longer subject to social security tax. More details appear in free IRS Publication 225, Farmer's Tax
- Some purchasers of diesel and nongasoline aviation fuels for offhighway business uses became, as of January 1, 1989, exempt from paying excise tax on these purchases.
- Self-employed artists, writers and photographers were subject to the rules of uniform capitalization, which required them to add to the basis or include in inventory direct and indirect costs of producing an item. However, they are no longer subject to these rules and this is retroactive to 1986.

VA Questions & Answers

Q - Are veterans with a service-connected disability seeking Department of Veterans Affairs medical care exempt from VA's Means Test?

A - All veterans with serviceconnected illnesses or diabilities are provided no-cost care regardless of income. Certain other veterans also are exempt from the Means Test, including former prisoners of war, veterans exposed to radiation or herbicides, and veterans of the Spanish-American War, the Mexican Border period and World War I.

Q - When a veteran is training under a VA Vocational Rehabilitation Program, does the receipt of subsistence allowance cause any reduction in VA compensation payments?

A - No. The veteran may receive both subsistence allowance and disability compensation to which entitled. In addition, VA will pay for the cost of tuition, books and fees involved in the rehabilitation

COUNTRY AGENTS

by Tommy Antilley Coke County Agent

Vegetable gardeners planning on producing a bumper crop should begin their spring preparations by instituting a soil insect control program.

The initial step to defeating soil insects is mixing insecticides into the soil at a depth of 4-6 inches at least two weeks before the garden plot is planted. If this procedure is neglected, soil insects can reduce vegetables quality and yields.

Destructive soil insects include wireworms, white grubs, seed corn maggots, cabbage maggots, mole crickets, sowbugs, slugs, snails and cutworms. Some destroy plant seeds, roots, tubers and underground stem parts while others cut off young plants at or near the soil surface.

Diazinon 25% liquid concentration or Spectracide 6000 applied as a 5% granule provide the best results for

controlling soil insects. Broadcasting 5 percent Sevin bait over the soil surface can help control cutworms or sowbugs if they become a problem after the garden has been planted.

Garden sites planted for the first time or those previously in grass or weeds are more likely to harbor damaging numbers

of soil pests.

Before treating with an insecticide, inspect the garden site by taking soil samples at several locations to a depth of 5 to 6 inches. Remove one square-foot section of soil from each location and record the number of soil insect pests present. As a general rule, an average of one or more soil insects per sample suggests the need for insecticide treatment. Always thoroughly read and follow the label instructions before applying insecticides.

Getting in shape doesn't have to mean a rigorous exercise program of weightlifting, jogging or high impact aerobics everyday. There's an easier way.

Actually, for a fitness difference, all you need is four 30minute workouts each week.

People who are too busy to include exercise in their schedule can get up 30 minutes earlier or go to bed 30 minutes later. If that sounds impossible, exercise at noon and eat a quick lunch afterwards at your desk. Or exercise at home while you watch a television program.

Start any exercise program slowly and gradually increase your pace and time. Be sure to include warm-up and cooldown periods to avoid unnecessary soreness and stiffness.

If you feel you don't have enough stamina, remember that exercise ultimately gives you more energy both during and after workouts. You will feel less sluggish and discover a renewed sense of

A simple exercise program combined with a proper diet will result in a painless payoff.

If you decrease your caloric intake by eating a high-fiber, low-fat diet and start an exercise program, you will be slimmer by the first day of spring. Not only will you look and feel better, but you also will increase your flexibility, build muscle strength and increase cardiovascular endurance.

A creative approach to exercise should not interfere with family time. In fact, a fitness activity is a great way to spend time together. Family bike rides, walks, and backyard basketball games are healthful and fun.

You don't need fancy clothing or expensive equipment to start an exercise program. Just wear comfortable clothes and walking shoes.

Varying activities will help you stay interested in an exercise program. Alternate walking, for example, with aerobics, swimming or an occasional volleyball game.

The important thing, is to find a way to stay physically active on a regular basis.
