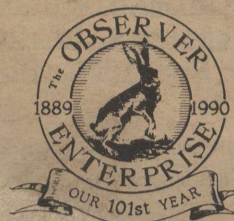

County-wide bond election slated Tuesday

The Coke County Commissioners Court has ordered a county-wide bond election for Tuesday, November 27. Eligible voters will be called on to determine whether commissioners will be authorized to issue bonds for the designated use of seal coating and repair of county streets and road systems.

Consulting engineers, hired by the county, made a study prior to the request for the bond election. Based on a number of their findings, the commissioners opted for calling the elections. Engineers informed them that life expectancy of streets and roads

similar to Coke County's is 10.9 years, without repair. Eleven years have elapsed since the last seal-coating project. County leaders were advised that work should be done regularly to protect taxpayers existing investment.

On the down side of the issue is the ever-present cost of any project. The bond election notice calls for a principal amount of \$970,000.

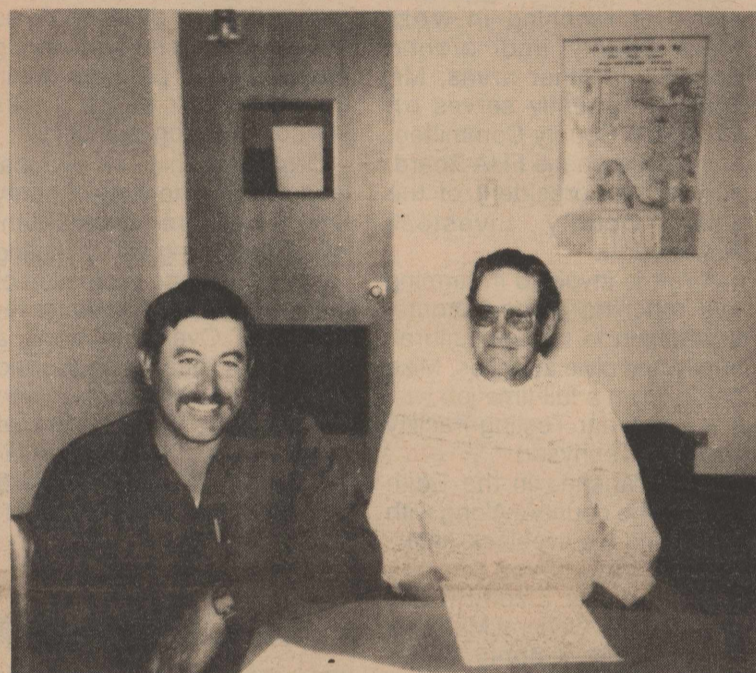

in order to devote more time to his new duties as County Commissioner.

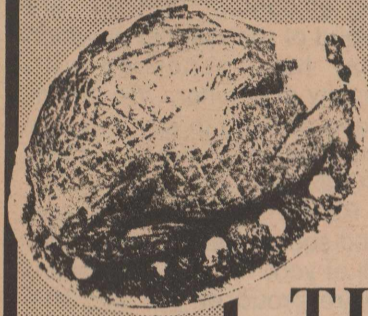

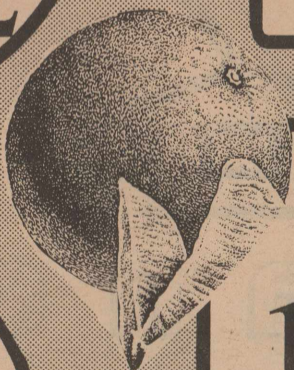

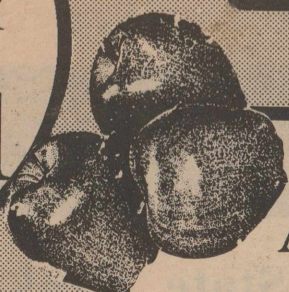

PUBLIC NOTICE

On July 19, 1990, GTE Southwest Incorporated ("GTE-SW") filed revisions to the company's tariff pertaining to the features and associated equipment for providing emergency number services (9-1-1).

In this filing, GTE-SW proposes to modify its existing 9-1-1 tariff and to add more than 200 new service offerings. The new items of service and equipment in this application have been added to meet the company's increasing 9-1-1 customer demands and to allow GTE-SW to compete more effectively in the 9-1-1 equipment market.

The product line in the new offerings consists of a mini-computer and specialized console package for larger communities, as well as a personal computer with Automatic Number Identification (ANI) display for smaller communities. (ANI displays a caller's telephone number on the emergency dispatcher's computer screen.) In addition, the product line will include ANI and Automatic Location Information (ALI) display units compatible with, and similar to, those offered by Southwestern Bell Telephone Company and other local exchange carriers in Texas. (The ALI feature displays a caller's address on the computer screen.) The rate charged existing 9-1-1 customers may be revised at the expiration of their contracts with GTE-SW if the proposed tariff is approved.

This filing has been assigned Docket No 9667. The hearing on the merits is scheduled for February 25, 1991, at the offices of the Public Utility Commission of Texas. The deadline to intervene in this docket is December 31, 1990.

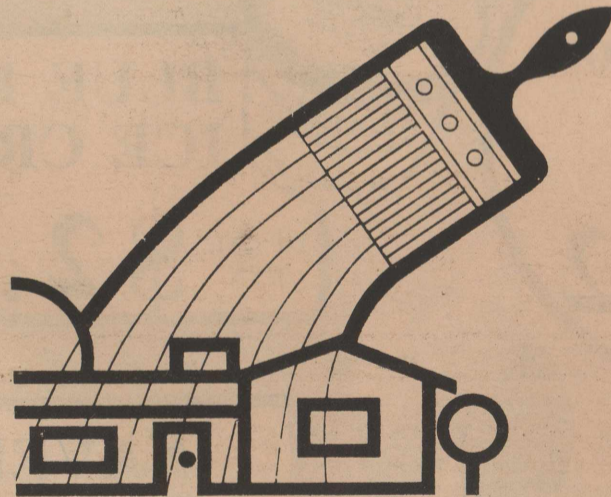

Horns finish season 8-2 over Lions

The Bronte Longhorns ended the 1990 football season with another win to give them an 8-2 winning season. Their record tied them for second in the district with Rotan, but because of the loss to the Yellowhammers, the Horns' season has come to an end.

The Horns came ready to play Friday night in front of a large hometown crowd. They watched the Seniors play their last high school football game with excitement before and during the game and the emotion after the last game.

This week, the Seniors were the captains. They included Justin Phillips, Brandon Marshall, Bill Windham, Sean Conway, Jason Pierce,

Tim Sims, Steven Shults, and Billy Magness.

Again, this week's offensive blocking helped Marshall gain another 100+ yard game. Super effort guys!

The Horns won the toss and received the opening kickoff. On the second play, Windham broke for a 39 yard gain to put the ball on the Roby 41 yard line. Marshall gained 9 yards on the ground and then Phillips connected with Gary Bilbrey for a 21 yard pass. Two plays later, Marshall scored on an 8 yard run. Lucas kicked the PAT with 10:16 remaining in the first quarter.

On the second play of defense, Sims recovered a fumble on the Roby 49 yard line. Eight plays later, Marshall scored on a 17 yard run. Lucas kicked the PAT with 5:32 left in the first quarter.

Each team exchanged possessions and then the Horns started on their own 22 yard line. Excellent blocking from the line consisting of Magness, Conway, Rudy Sanchez, Sims, and Pierce enabled the offense to gain yardage on the ground and through the air. The backs and receivers provided the blocks downfield as this was a total team drive which took ten plays before Phillips connected with Darrell Lucas for a 35 yard touchdown pass with :01 left in the half. The Bronte special worked when Phillips

passed to Windham for the two point PAT. Roby 0 - Bronte 28.

The Horns kicked to Roby to start the third quarter. Roby came out passing to test the Horns' secondary. Conway nailed the quarterback, creating a fumble which was recovered by Roby. Sanchez and Jacob Golson had good defensive plays. Marshall intercepted to end Roby's first drive of the second half. After one first down, three passes, and a penalty, the Horns had to punt for the first and only time of the game. Again, good defense from Phillips, Bilbrey, and Pierce made the Lions go to the pass when they scored their touchdown on a hitch and pitch with 1:18 remaining in the third quarter.

The Longhorns responded on their next possession with Lucas breaking for a 46 yard touchdown run with 9:59 remaining in the game. The PAT was a run by Lucas. The defense held two more drives by Roby to end the 1990 season.

This season had one disabling injury when Jay Parker suffered a broken collarbone. Friday, he received his doctor's release.

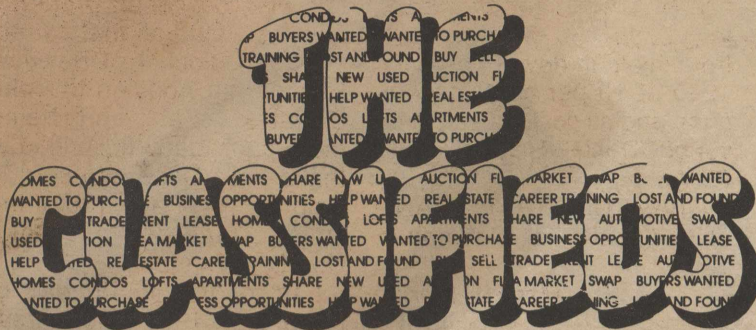

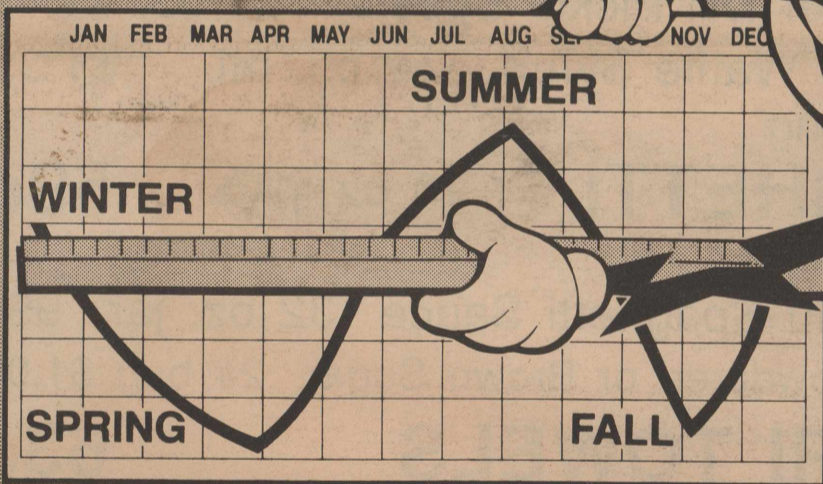

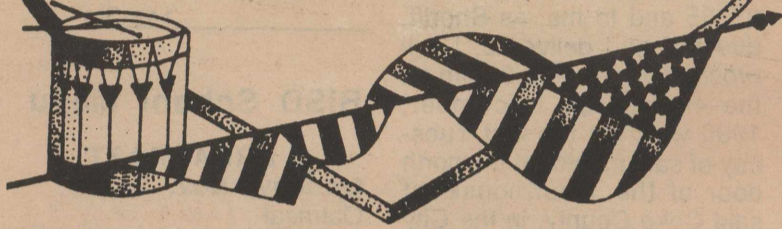

Results from the seminar will be shared in a community meeting in January.

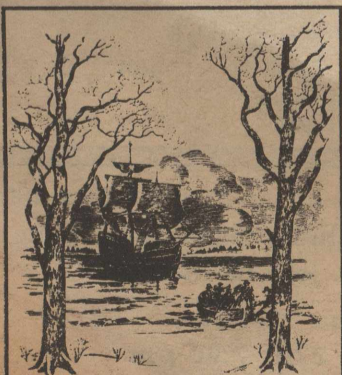
