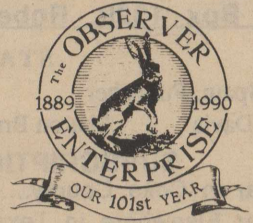

Filings complete for upcoming elections

Bronte

Ballots are set in the elections for Bronte City Council, Bronte Independent School District Board of Trustees, and the East Coke County Hospital District Board of Directors.

Bronte City Council incumbents Martin Lee and Beverly Sims will be running for re-election.

On the ballot for the BISD Board of Trustees will be incumbents Nick Arrott, Richard Hembree, and Andra Arrott.

Jane Cumbie and R. W. Blackmon, incumbents, will be on the ballot for the East Coke County Hospital District Board of Directors.

Elections will be held May 4, 1991, with polls open from 7

am until 7 pm at the Bronte City Hall at 114 S. Washington.

Absentee voting will begin Monday, April 15, and continue through Tuesday, April 30, with the exceptions of Saturdays, Sundays, and official state holidays.

Absentee voting by personal appearance will be at Bronte City Hall for the Bronte City Council election, at the Bronte Nursing Home for the East Coke County Hospital District Board of Directors election, and at the BISD superintendent's office for the BISD Board of Trustees election.

All absentee voting hours will be from 8 am until 4 pm at all three locations.

Robert Lee

Regular filing deadlines for all vacant positions in the upcoming Coke County elections passed Wednesday, March 20, with only one late filing in Robert Lee that could affect the outcome of an election. In the Robert Lee City Council contest, Johnny Sevier, a local construction contractor, will face Joe Brazier, the only incumbent alderman, Mary Cherry, an employee of West Coke County Hospital District, and Coke County Game Warden Sparks Burdett. The four will vie for three regular vacancies.

A. L. "Speedy" Brasuell is a candidate for the unexpired term to which he had been appointed, to fill Joe Barrett's term.

Absentee balloting in each of the May 4 elections will be held from April 15-30.

CCUWC District

An election will be held on May 4, 1991, to elect two directors for the Coke County Underground Water Conservation District. Polling places will be at the Coke County Courthouse for voters in Precinct 3 and at the Old Railroad Depot in Bronte for voters in Precinct 4.

Absentee voting will be held in the County Clerk's office from April 15 thru April 30, 1991.

Fred H. McCabe, Jr., has filed to have his name included on the ballot for Precinct 3. No one had filed to be on the ballot in Precinct 4 at the time of this release.

Those elected will serve a term of two years as director of the Coke County Underground Water Conservation District.

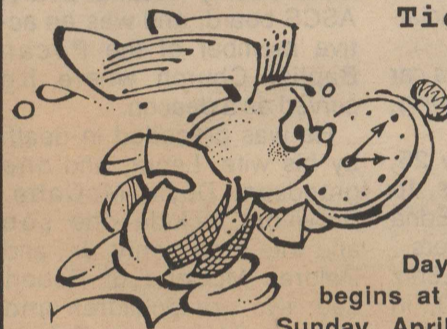
Br. Reg., Titling

Accident claims Masters

Coke County residents were shocked and saddened last Friday, March 29, by the tragic accident and death of Bronte resident Don Masters.

Mr. Masters was killed when the car he was driving crashed through the Colorado River bridge railing and fell about 50 feet into the river below. The one-vehicle accident happened about 10 am.

Masters was pronounced dead of massive head injuries by Peace Justice Gary Shaffer of Bronte.

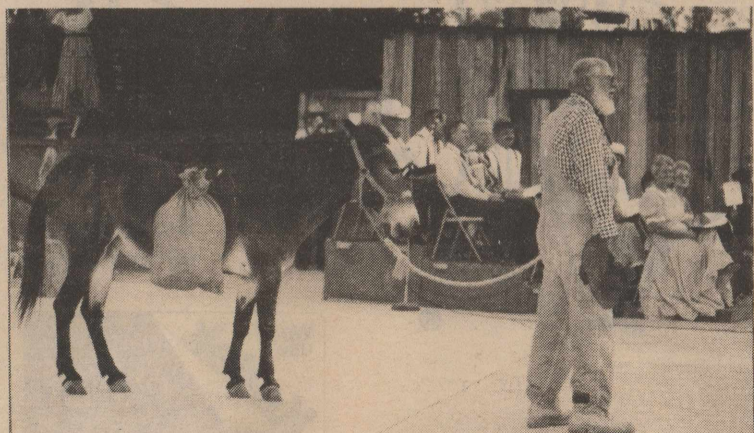
DPS Trooper Richard Treece said Martin was traveling south on Highway 277 when the car veered off the road and struck the guardrail. Treece said a 54 foot section of the rail gave away allowing the car to plunge off the

bridge and land upside down, crushing the top of the car.

The Trooper suspected the car went out of control when the left tire blew out, but he couldn't be certain due to the extensive damage to the vehicle.

East Coke County Ambulance Service was called to the scene. Serving on the ambulance were Randall Maxwell, Fran Pierce, and Sandra Arrott. Bronte Fire Department trucks and personnel followed. Coke County Sheriff Marshall Millikan arrived soon after receiving the call about the accident.

Funeral services were held for Mr. Masters Monday, April 1, in Johnson's Funeral Chapel followed by burial in Fairmount Cemetery.

Masters

Funeral services were held Monday, April 1, at 2 pm for Robert Donald "Don" Masters of Bronte at Johnson's Funeral Home Chapel. Interment was in Fairmount Cemetery. Pastor William Pierce of Trinity Baptist Church officiated.

Mr. Masters, 62, died in a car accident Friday morning, March 29.

He was born February 25, 1929, in Windom, Texas, to Jimmie Ory Masters and Edna Leah Maurine Dixon Masters.

He married Laura Ann Lentz on September 28, 1950, in Austin. In 1954, he graduated from the University of Texas and joined the Army. For 20 years, he was an information officer and a photographer, serving three tours of duty in Southeast Asia, during which time he was involved in radio broadcasts and publishing articles for the Austin paper. He won 1964 Best Photo of the Year award from a news press agency.

Mr. Masters retired as a major in 1972 and worked for four years at KCTV Television in San Angelo as weatherman and news director. In 1977, he and his wife moved to Bronte to restore a 90-year-old box house. He was a member of the First Baptist Church in Bronte. He wrote scripts and appeared as the "Old Timer" in the Coke County Pageant in recent years. He was president of the Night Writers Association in 1989.

Survivors include his wife, Ann Masters of Bronte; daughter, Laura Griffin of San Angelo; sons, Steven of Midland, and Robert and Walter, both of San Angelo; and granddaughters, Lisa, Jennifer, Stephanie, Kimberly, and Ashley.

The family requests memorials be made to a favorite charity.

Lions recognize members for service

Eighty-five years of Lionism service were recognized at the Robert Lee-Silver Lions Club meeting and dinner Tuesday evening. Ernest Clendennen and Zeddie Beal were awarded 35 year service pins while Jim Dunklin received a pin for 15 years service. The men's wives pinned their awards to the Lions vests. The long-time members noted they felt gratified with the work done over the years in service and support to youth, those in need, and the community. Their honors coincide with the 35th anniversary celebration of the local Lions Club with was chartered April 11, 1956.

President Kenneth Green conducted a short business meeting before Mandi Johnston, the Club's adopted Lioness, drew two lucky winners for the lots of frozen, packaged beef. The members had been taking donations for tickets as a fundraiser. Kaye Pitcock of Robert Lee was the first name drawn, followed by that of Monroe Lynch of Lubbock.

One new Lions member, Raymond Lewis, was introduced to the good crowd attending the dinner. Lewis is a salesman with Ivey Motor Company.

Speaking to the group was Fred Foy of Baird, representing Texas Monument Company. He presented a slide program showing granite quarries, initial work on monuments and examples of poor workmanship. County Hospital is to be aware of when purchasing a stone.

Spring turkey season to open

Spring turkey gobbler season is set to open Saturday for a full five weekend run - April 6 thru May 5. According to Coke County Game Warden Sparks Burdett, local shotgunners can only expect a mediocre season. He reported he has not observed many young birds, indicating a poor production year last year. After two years of droughty conditions, some nesting was wiped out by hard rains in early July. Burdett said that although the long season may not be warranted in Coke County, other areas such as McCulloch County have lots of turkeys.

This will be the second consecutive year for a 30-day spring season on Rio Grande turkeys. The Parks and Wildlife Commission authorized the longer season last year in order to give hunters a better opportunity to hunt during the periods of peak gobbling activity which can vary from spring to spring.

Most of the same regulations apply to both fall and spring seasons. Shooting hours are 1/2 hour before sunrise to 1/2 hour after sunset. Only two gobblers are allowed for spring hunting. If the hunter has used two tags during the fall season, he may only take one gobbler. The statewide bag limit is no more than three turkeys for both seasons. One turkey tag on the hunting license specifies "Fall or Spring." This tag may

be used at the discretion of the hunter for either the Fall or Spring season. The other two tags must be used in the season specified on the tag.

No restrictions exist as to number of shells a shotgun may hold when hunting turkeys (only migratory birds).

Don Wilson, small game program leader for Texas Parks and Wildlife Department, said hunters harvested 56,391 turkeys in the spring of 1989, the most ever in Texas, while the fall of 1989-90 had 31,000 taken, he said. The 1989-90 fall season was

the second lowest number of turkeys harvested since the 1980-81 hunting season when 26,800 were taken. "In 1989-90, we had pretty good range conditions and were expecting better production than what we got." Harvest figures from spring and fall 1990 are not complete.

Wilson said, although Texas had a record harvest in the spring of 1989, it should level off, unless spring hunter numbers continue to rise. In 1981, there were 40,000 spring hunters while 1990 increased to 100,000.

Lease listings available

Although this is springtime, many hunters are beginning to look for a deer lease. The Texas Parks and Wildlife Department publishes the Deer Hunting Lease Register, a listing of lands available for lease.

The list is maintained by the department and provided free upon request. It currently lists more than 2 million acres of land offered by 327 landowners.

Hunters wishing to obtain a copy of the list, or landowners who wish to list lands, should

write to the Wildlife Division, TPWD, 4200 Smith School Road, Austin, Texas 78744, or call 1-800-792-1112 or (512) 389-4505. Specify the region of the state you wish to hunt: central, east, south, or west. If a listed landowner has already leased his land, he should call the department so his name can be removed from the list.

Officials stress that the department acts as a reference for lease information, but plays no role in negotiations between hunters and landowners.

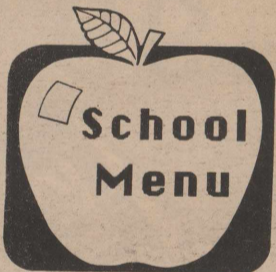

COUNTRY AGENTS NEWS

About this time of the year, home lawns need a boost to get them in shape for the upcoming spring season.

There are three suggestions that can get your lawn off to a good start - scalping, fertilizing and applying a weed killer.

Scalping a lawn in early spring serves to revitalize it and promote early spring green-up.

Begin the operation by lowering the blade of your lawnmower 1/2 to 1 inch below normal mowing height. Then mow the lawn in two directions that are at right angles to each other. Remove the clippings after each mowing. They are excellent to add to a compost or to use as a mulch in your garden and landscape plants. Keep the blade lowered until early summer.

After scalping the lawn, apply a complete fertilizer (one containing nitrogen, phosphorus and potassium) to promote leaf and root growth. Use 1.5 pounds of nitrogen per 1,000 square feet of lawn area. This is equal to 18 pounds of an 8-8-8 fertilizer or 12 pounds of a 12-4-8 fertilizer. Repeat the application in the early summer and fall.

For a dark green lawn, you can apply nitrogen every 50 days at the rate of one pound to 1,000 square feet. Monthly application of iron chelate or iron sulfate during the spring and summer promotes a

healthy color in St. Augustine lawns. Adding these extra nitrogen applications will cause a deep green color but will also greatly increase the maintenance and number of times the lawn will have to be mowed. Heavy fertilization will also require more watering to keep this lush green color.

To keep crabgrass or other unsightly weeds from becoming a problem, apply a preemergence herbicide (weed killer) in early spring after the grass has recovered from winter. Applying a pre-emergence herbicide too early could further weaken turfgrass injured by winter conditions. Always read and follow label directions on any chemical and be extremely careful which type you purchase as some of them can cause extensive damage to trees and landscape plants.

Proper maintenance is essential for a healthy lawn, and these practices will give new life to a dormant, weedy lawn.

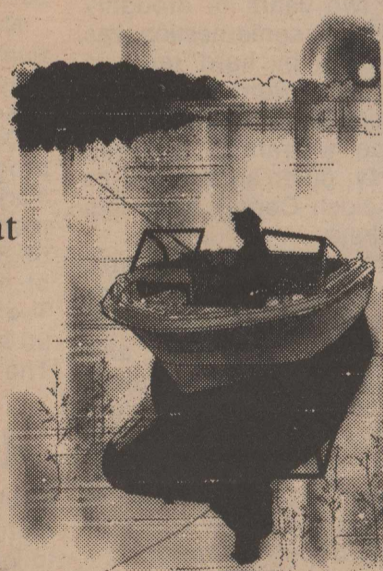

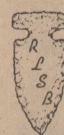

DPS slates CPL testing

The DPS is now testing all currently licensed commercial truck and bus drivers and to ensure that all commercial drivers in Texas who must have the CDLs obtain them in time to avoid penalties, the DPS Troopers have set a special date for CDL testing in this area. The test will be conducted on April 22, 1991, from 3 pm to 7 pm at the High School Cafeteria, Robert Lee, Texas. For applications and details on taking this test, you must contact your local Department of Public Safety Office as soon as possible.

All commercial motorists who drive vehicles in excess of 26,000 pounds or transport hazardous materials that require the vehicle to be placarded are required to have a commercial drivers license (CDL) by April 1, 1992. Bus drivers, including school bus and church bus drivers, who drive buses designed to carry 16 or more passengers, including the driver, will also be required to obtain a CDL by the same date.

Exempts from the CDL requirements are farmers, when they are driving within 150 miles of their farm, military personnel, recreational vehicle operators, emergency vehicle operators, and fire fighters when operating fire fighting vehicles or equipment.

Commercial drivers who must carry the new CDLs cannot renew their current licenses due to expire between now and April 1, 1992. All drivers should plan to take the required test at the earliest possible time to avoid the long lines in the Drivers License Offices that are expected as this deadline nears. Free CDL handbooks are available at all drivers license offices and we encourage everyone to prepare and take advantage of this opportunity to test.

This testing date is in cooperation of Robert Lee High School and the Texas Department of Public Safety.

DPS Director Colonel Joe Milner cautions that the Texas truck and bus industries are going to find themselves without properly licensed drivers on April 1, 1992 if they do not contact their nearest DPS Driver License office to schedule commercial driver's license (CDL) testing as soon as possible.

The DPS began issuing CDLs on September 17, 1990. However, as of March 29, 1991, only 50,000 CDLs had been issued (an average of 370 licenses a day). "Texas has approximately 962,000 commercial drivers who must be tested before their current license expires or April 1, 1992, whichever date comes first," Colonel Milner said. In order to license the remaining 912,000 CDL drivers before the deadline, DPS must average testing and issuing licenses to 3,648 drivers each working day.

More than two-thirds of the drivers hold Class A and B licenses that will not expire until after the April 1, 1992,

deadline. However, after that date, the drivers cannot legally drive a commercial motor vehicle without a CDL. The drivers will be given credit for each full year of validity on their present Texas driver's license when obtaining a CDL. The cost of the CDL is \$40. There is no fee for making application or taking as many tests as are necessary to qualify for the CDL.

"Drivers operating vehicles exceeding 26,000 pounds, or transporting hazardous materials, must obtain the new CDL," Colonel Milner indicates. Also, drivers who drive buses designed to carry 16 or more passengers including the driver must have a CDL. Drivers of school and church buses are included. Exempt from the CDL requirements are farmers (when operating within 150 miles of their farm), military personnel, recreational vehicle drivers, emergency vehicle operators, and fire fighters when operating fire-fighting vehicles or equipment.

"The DPS can test at the truck or bus company if the company has at least 15 drivers available for testing," Colonel Milner said. The DPS official believes that the DPS Driver License offices will have long lines of commercial drivers waiting to be tested as the April 1, 1992, deadline approaches if CDL test scheduling is not increased immediately.

Junell votes against bill

Representative Robert Junell voted against the Education Finance plan last Wednesday. The bill failed in the Texas House of Representatives by a 63-87 vote.

Rep. Junell stated, "The bill devastated some of the schools in my district while other schools showed no significant gains." He continued by saying the bill would cost the state's taxpayers over \$7 billion in new property taxes and \$6 billion in new state taxes over the next five years.

"This bill would have created a new layer of bureaucracy," Junell said, "taking away more control from the local school boards." Local tax rates would be set at the state level while tax abatements and homestead exemptions would not be allowed under this plan.

Protestant Hour broadcasts told

The 1991 Presbyterian Series of the Protestant Hour is being broadcast every Sunday from March 17 through June 2. Based on the church's 1991 stewardship theme "what does love require," the series features three ministers from different parts of the United States. Rev. Rex Bell is pastor at Wabash Presbyterian Church in Auburn, Washington.

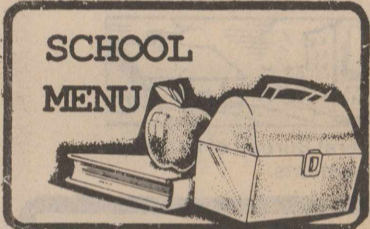

Rogers retires from Hunt at age 62

[Editor's Note: Lonnie Rogers, a former resident of Bronte, retired January 31, 1991, at the age of 62. His present address is Route 2, Box 2883, Athens, Texas 75751.]

ROGERS KEEPS ENGINES RUNNING

When Lonnie Rogers joined Hunt in 1960 as a mechanic 2nd class, much of the company's equipment gained a second life. A wizard with his tools, Lonnie helped keep the engines at Fairway Gas Plant running round the clock for 25 years.

Raised in Bronte, a small town in Coke County in West Texas, Lonnie went to work for Hunt's West Texas District at the Wilshire Gas Plant near Crane on June 6, 1960. Because he had worked on the same type of engines used at Wilshire in a previous job, Lonnie was a natural for the position.

When the company sold the plant in 1966 to El Paso Natural Gas, Lonnie was transferred to the Fairway (James Lime) Unit, which had begun operations in Poynor, Texas, several years before. A compressor mechanic, Lonnie gradually became expert at running the compressors that reinjected gas into the fields

of the Fairway (production) District. In 1970, he was promoted to compressor mechanic 1st class, and two years later he became a maintenance mechanic 1st class.

"I developed my abilities and learned to be careful. You've got a lot of pressure in those compressors and you've got to be careful. You have to really watch it. I never had lost time for an accident," Lonnie said.

Lonnie, however, did occasionally lose sleep because of the compressors. On call day and night, he worked on the compressors whenever they went down.

"Whenever I went to bed in real bad weather, I sort of lay awake waiting for a phone call," Lonnie said. "Once we got 12 inches of snow and I got a call from Bill Scott, who knew I had chains on my pickup. The machinery was freezing up. I picked him up and we began to thaw out the compressors with hot water from three or four garden hoses. We worked for about 30 minutes, but the water was freezing because the wind was blowing so hard. We'd thaw out one patch of three or four feet, but the patch we'd just left would already be frozen. The whole area on top where we were working was about 25 by 30 feet, so there was no way we could keep up with it all."

"So we thought about it and

decided to wrap the equipment in plastic - which kept the water from freezing but didn't keep it from thawing out the compressors. We saved the company about half a million dollars in equipment that night."

Despite working with Hunt more than 30 years, Lonnie said the technology hasn't changed all that much.

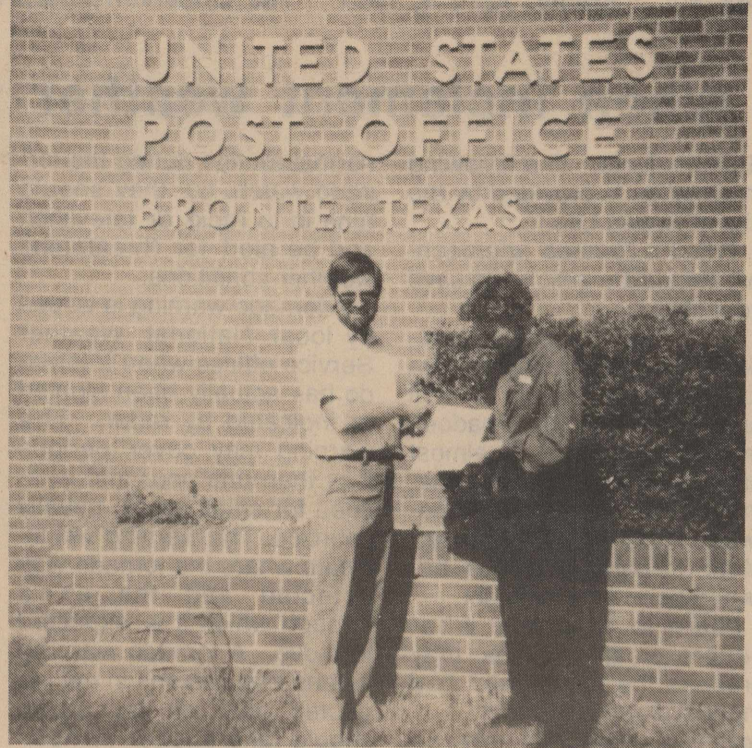
"It was new to me when I started, but it hasn't changed that much since I've learned it," he said. "Of course, we've added to the plant three or four times, which has changed some things. But generally, things haven't changed that much."

Keeping the gas injection plant running continually for 25 years, Lonnie said, is his proudest accomplishment in his three decades at Hunt. But he's also proud of having stayed at Hunt for most of his career.

"Boy, I really wanted to stay with the company after I'd started. I tried to make 'em a good hand and make their equipment run as long as I could. I wished I'd started with the company earlier."

The company does, too, especially after seeing what a "good hand" Lonnie has been. No doubt the compressors also will miss his kindly, competent touch.

In his retirement, Lonnie will continue to nurse his wife, Valetta, who has been in convalescent care since suffering a brain aneurism in 1988.

TEHA reps attend district meeting

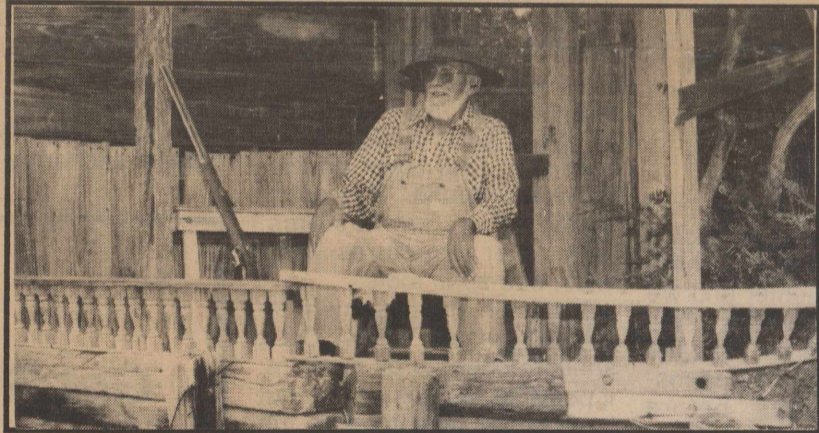

When inclement weather threatens...

[Editor's Note: The following information is provided by the city of Robert Lee.]

When a tornado approaches, immediate action can save your life.

Know how to spot a tornado. Know the tornado season for your area, which is April and May. Although tornadoes may strike in the U. S. almost anywhere and at any time, they occur most often between March and September. Most tornadoes occur between noon and midnight.

Learn to recognize what severe weather signs may precede the tornadoes: bad thunderstorms--thunder, lightning, hard rain, strong winds, hail; roaring noise--like a hundred locomotives or jet planes; and the funnel--dark, spinning "rope" or column from the sky to the ground.

Know the difference between a watch and a warning. A tornado watch indicates that weather conditions may cause tornadoes or severe thunderstorms to develop in or near the watch area. A watch does not mean that a tornado has been sighted. It is usually issued for periods of six hours or less. Residents of the designated area need not seek shelter or disrupt their

normal routine during the tornado watch, but they should tune in to radio or television and be alert for threatening weather conditions.

A tornado warning is issued by local National Weather Service offices when a tornado has actually been sighted or indicated by radar. The warning may cover periods less than one hour and is issued for small areas, usually counties. The warning will indicate where the tornado was detected and the area through which it is expected to move. A tornado warning means that persons in the expected path of the storm should take shelter immediately.

Know where to go during a tornado -- the key word is "low." When time permits, go to a tornado cellar, cave or underground excavation. It should be kept fit for use, free from water, gas or debris; and preferably equipped with a pick and shovel. Stock it with a flashlight, radio and spare batteries, along with a first aid kit.

In office buildings, go to an interior hallway on the lowest floor or to the designated shelter area.

In factories, workers should move quickly to the section of the plant offering the greatest protection in accordance with advance plans.

In shopping centers, go to a designated shelter area (not to your parked car).

In schools, follow advance plans to an interior hallway on the lowest floor. If the building is not of reinforced construction, go to a nearby one that is, or take cover on low, protected ground. Stay out of auditoriums, gymnasiums, and other structures with wide, free-span roofs.

In homes, the basement offers the greatest safety. Seek shelter under sturdy furniture, if possible. In homes without basements, take cover in the center part of the house on the lowest floor, in a small room such as a closet or bathroom, or under sturdy furniture. Stay away from windows.

Mobile homes are particularly vulnerable to destructive winds. There should be a designated community shelter where residents can assemble during a tornado warning. If there is no such shelter, do not stay in a mobile home during a tornado warning. Seek refuge in a sturdy building or a ditch, culvert or ravine.

If there is not time to find suitable shelter, lie flat in the nearest depression, such as a ditch or ravine, but be aware of danger of it flooding.

Move at right angles to the tornado's path. Tornadoes usually move ahead at about 25 to 40 miles per hour.

Know how to protect yourself. Most deaths associated with tornadoes are caused by flying debris. Serious injuries result from being struck in the head or chest. To protect these sensitive areas, curl up so that your head and chest are protected.

Be aware of possible dangers during the tornado. Be aware of flying objects, falling

trees, breaking windows, collapsing buildings, and breaking power lines.

Keep tuned to your radio or tv for the latest advisory. Do not call the National Weather Service except to report a tornado. Individual requests may tie up telephone lines urgently needed to receive special reports or to relay advisories to radio and television stations for dissemination to thousands in the critical area.

If you live in a storm-prone area, take long-range precautions. Keep important papers--including policies, titles, will, and other records--in a safe place where they're not apt to be damaged by water, wind, or fire, but where they can be easily retrieved.

With your important papers, keep an up-to-date list of personal items such as jewelry, clothing, cameras, and firearms, together with an up-to-date property inventory.

Store a flashlight, portable radio with fresh, spare batteries and a first aid kit in the corner of your basement or in your "storm closet."

ters submitted, and the "Volunteer of the Year" will be selected and will be presented with a plaque at the dinner on April 25th.

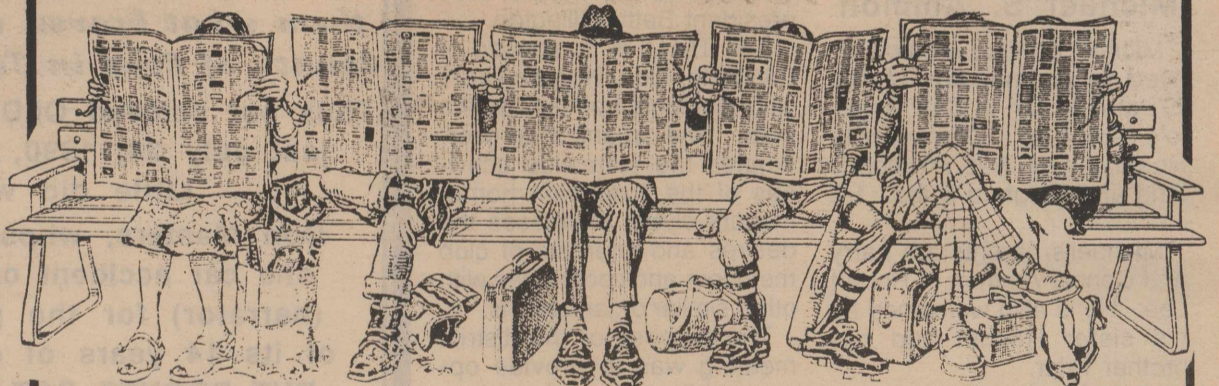


