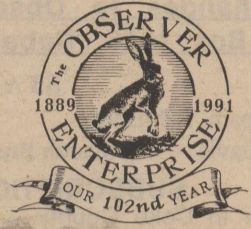

15th annual pageant begins tonight

WHAT: The 15th annual production of Coke County's past in action and music, an entertaining production of lives and experiences of our own ancestors.

(Coming from San Angelo or Bronte, turn west at the first blinking light, turn north under the banner at the second blinking light which is on Austin Street. Coming from Silver, turn left under the banner at the first blinking

light.) The theatre is on the right on Austin, behind the second - not the first - baseball field.

WHEN: The pre-time Red, White, and Blue Salute by the Pageant Choir starts at 8 pm this Friday & Saturday, July 19-20. Also, next Friday & Saturday, July 26-27, same time, same place.

HOW MUCH: Children through five, free; 6-12, \$3; teens and up, \$6. Groups of 20 or more will receive a 20% discount.

SPECIAL FEATURES: Concession stand, souvenirs, free fans and programs.

WHAT TO EXPECT: Around 100 Coke County citizens and out-of-town relatives on stage in costume, well-rehearsed, all loving to be part of a fast-moving performance dating from Indian days, 1854, through 1910 when "likker" was voted out. (If you doubt some of the events really happened, you will have to admit that "It could have happened!")

NARRATOR: People have asked, "What will you do without The Old Timer, the late Don Masters?" He is sorely missed. (See a full-page dedicated to his treasured memory in the program book.) Harrell Johnston, Post Master at Robert Lee, is narrator this year, - The Rabbit Twister. He is not attempting to imitate our well-loved Old Timer, but he is successfully attempting to establish a new personality to tie scenes together for viewers.

production.

He was selected based on his academic achievement, FFA and Agri-Science activities including the Supervised Agricultural Experience Program, leadership in school and community, and interviews.

While in high school, Brent was yearbook editor and a 4-H club and church youth group member.

Brent, who plans to major in agricultural economics at Texas Tech University, was one of 50 Houston Livestock Show and Rodeo FFA scholarship winners honored. FFA is a vocational organization made up of students enrolled in Agriculture Science and Technology classes. Texas FFA has over 54,000 members in nearly 950 local chapters. More than 2,000 members were recognized for achievement and nearly \$600,000 in scholarships were awarded at the recent State FFA Convention.

The FFA scholarship recipients were chosen by members of the Texas Education Agency.

The presentation of the scholarship to McPeek was made by Dan Gattis, General

Manager of the Houston Livestock Show.

The Houston Livestock Show also awarded 50 \$8,000, four-year scholarships to the Texas 4-H at that organization's annual roundup in June.

Scholarship funding is provided by revenues earned at the annual Houston Livestock Show and Rodeo. The Show has committed more than \$1.4 million in educational funds for upcoming school year.

In addition to the 4-H scholarships, other educational funding included in this commitment are 43 \$8,000, four-year metropolitan scholarships, awarded at a special Million Dollar Scholarship Luncheon in June; the Area Go Texan scholarships, presented at rodeo performances during the 1991 Show; 96 Hispanic scholarships, with a total commitment of \$100,000, awarded in June at special Go Tejano Committee ceremonies; and, school art and photography scholarships, at a total commitment of \$28,800, awarded to recipients selected during this year's school art contest.

Ag heritage preservation

Texas farmers and ranchers once again have an opportunity to preserve their families' agricultural heritage as partici-pants in the Texas Family Land Heritage Program.

Join us in this year's search to locate Texas farms and ranches which have been continuously owned and operated by members of the same family for 100 years or more.

The program is designed to recognize much more than mere ownership. It seeks to chronicle the uniquely personal histories of agricultural productivity in this state, a proud record which might otherwise be lost forever.

Since its institution in 1974, over 2,500 properties have been enrolled in the program throughout the state.

Participants who qualify in the program receive a certificate of honor in the name of the land.

Under provisions of the program, Texas residents who own agricultural land may apply if they can trace the line of ownership from the first family

member to the present either through direct relatives or by marriage.

The land, which must be currently productive, must also fit the old U. S. Census definition of a farm: 10 acres or more with agricultural sales of \$50 or more a year; or if less than 10 acres, sales of at least \$250 a year.

If all of the land has ever been rented outside the family, it will not qualify. Also, owners must live on the land and work the property or, if living elsewhere, must actively manage the day-to-day operation.

Texas residents who own agricultural property which they think may qualify can obtain application forms and information about the program by contacting their local county judge or county Historical Commission chairperson. Forms and information may be obtained from any Texas Department of Agriculture (TDA) district office or the main Austin TDA office, PO Box 12847, Austin, Texas 78711.

Camp launches fund drive

Dr. Dan Murray, pastor of First Baptist Church, Stephenville, announced this week that trustees of the Heart of Texas Baptist Encampment at Lake Brown-wood have launched a \$300,000 fund drive to finance construction of a waste-water treatment plant at the encampment.

Murray, who is president of the Board of Trustees, stated that the present system of septic tanks is becoming inadequate for the increasing number of campers using the facilities. Camps, retreats, and conferences now use the encampment throughout the year.

"To replace the present system with another septic system required by new stringent Health Department rules would be financially prohibitive and physically impos-sible. The only viable option left to the trustees is a waste-water treatment plant," Murray said.

Rev. Ferris Akins of

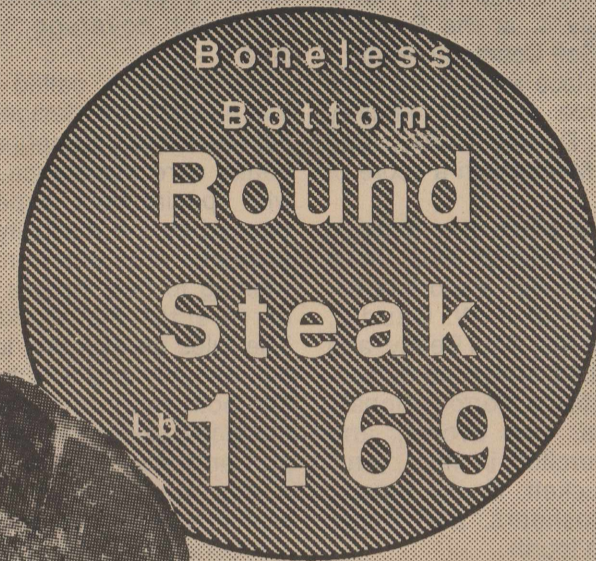
Ballinger, chairman of the Capital Funds Improvement Finance Committee, reported that his committee is already implementing details of the campaign approved by trustees.

Three banquets for Central Texas area pastors were held to acquaint them with the critical need for the waste-water treatment plant, and to seek their cooperation and support of the fund raising efforts.

During the month of September, meetings will be conducted in the ten Baptist Associations of the encampment area to acquaint people with the need and to seek cash gifts from churches, Baptist Associations and from individuals. 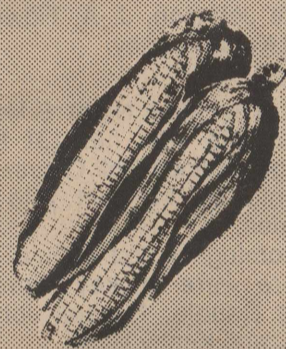

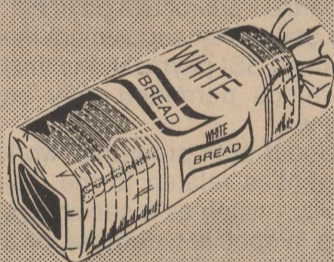

SSI earning levels change

People with disabilities may work and still receive Social Security disability insurance benefits or Supplemental Security Income (SSI) disability

payments. And, they may be able to earn more than they think under changes in the law, according to Franklin H. Upp, Social Security manager in San Angelo, Texas.

"The law has changed considerably in recent years, and many people may not be aware of how much they can earn and still keep their cash benefits and Medicare or Medicaid coverage," Upp said.

Special rules, called "work incentives," are designed to continue cash benefits and health care assistance, help with special work expenses caused by the disability, and provide rehabilitation and training to help people enter or re-enter the workforce. The rules are different for Social Security and SSI, but under both programs they are designed to provide the support and assistance a person needs while attempting to work in spite of a disability.

A beneficiary who returns to work gets a "trial work period" of nine months (not necessarily consecutive) during which he or she can earn any amount without current benefits being affected. After the trial work period, benefits will stop if average monthly earnings exceeded \$500. However, there is a 36-month "extended period of eligibility" during which a person may receive a benefit for any month earnings fall below \$500. Medicare may continue for at least 39 months after the end of the trial work period.

Under SSI, cash payments continue as long as a person does not exceed the SSI income limits. In addition, Medicaid may continue after cash payments stop if a person needs the Medicaid in order to work and is unable to afford similar health care coverage.

SSI does not count the first \$65 of earnings and only half of earnings over that. Because of the earnings exclusion, a person could earn as much as \$899 and still receive a partial Federal SSI payment. (In States that supplement the Federal SSI payment, the total earnings permitted may be higher.)

Under both programs, work expenses related to the disability -- such as a seeing eye dog, a special typewriter, or a specially-equipped car to get to and from work -- may be deducted in figuring if your work affects your benefits, even if they are also useful in regular daily activities, Upp said.

Also under both programs, disabled beneficiaries are referred to State vocational rehabilitation agencies for training. Benefits continue for disabled people who medically recover while involved in an approved vocational rehabilitation program until the program is over.

"Using these work incentives, people find that their total income is usually greater by working than by not working," Upp said. "And, many find that their earnings increase to the point where they are no longer dependent on their disability benefits."

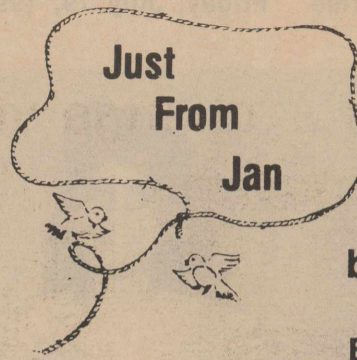

More than 75% of American households use a microwave oven to thaw, cook, and re-heat food in minutes, even seconds. A microwave saves time, dirty dishes, retains more nutrients, and allows cooking with less fat.

Despite the advantages and the growing popularity of microwave ovens, they are still new enough so that many traditional cooks are unaware of necessary safety precautions. To insure that food is safe from harmful, food borne bacteria as well as from certain other contaminants, observe these tips:

- Do not partially cook a food ahead of time to make microwaving faster. Cooking ahead is fine, but raw foods should be cooked thoroughly

during the first cooking. Partially cooking can be dangerous if the food does not get hot enough to kill the bacteria that may be in raw meat.

- Do not refreeze meat or poultry that has been thawed in a microwave oven. Foods thawed in the microwave are subject to very low cooking temperatures. Some areas of the food may even begin to cook. If you thaw food in the microwave, you should cook it all immediately.

- Take care to avoid uneven cooking. Arrange meat and poultry pieces uniformly in a covered dish so steam can help kill bacteria and promote uniform heating. Stir and turn the dish several times. Observe standing time.

- Discard food that was

forgotten and left for more than two hours in the microwave after thawing. Subsequent ordinary cooking won't destroy some harmful bacteria that could form.

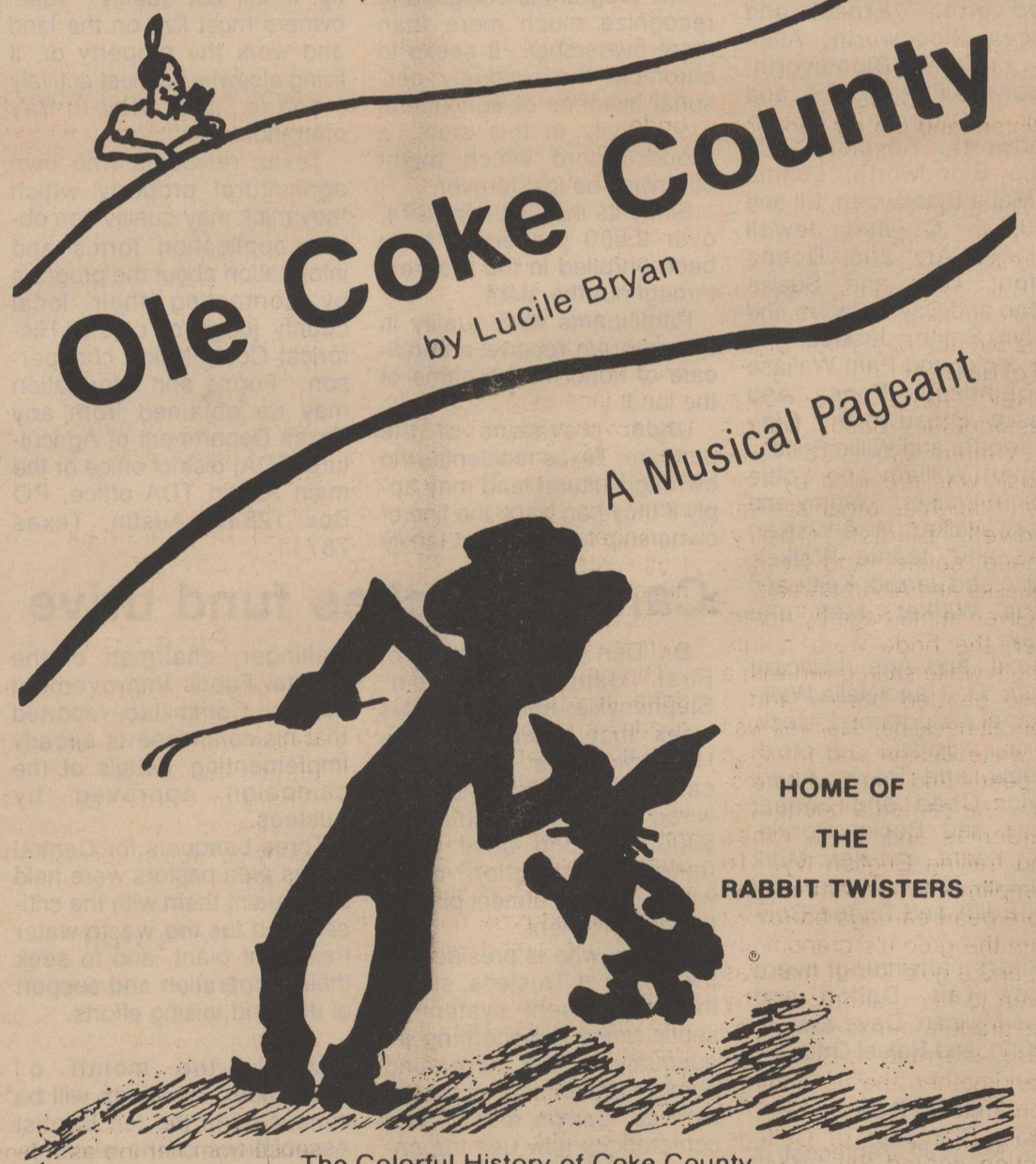
- Use only the type of dishes that are designed for microwave ovens. Materials in freezer bags, margarine tubs or other plastic containers were approved for storing food, but not for microwave cooking. When heated,

chemicals in the containers could migrate into food. Also, do not use recycled paper products in microwaves. They can contain contaminating chemicals or cause fires.

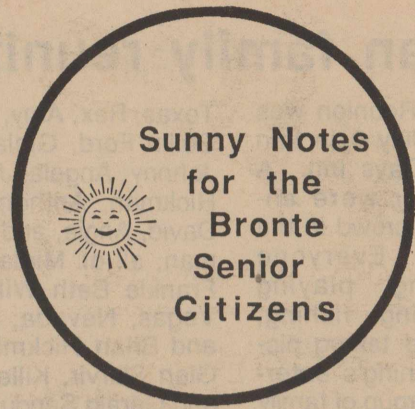

Fall Gardens Mean Summer Work

For a successful fall garden, you can't wait until fall to get started.

Soil preparation, fertilization and planting all have to be done during the heat of the summer.

Like preparation for a spring garden, fall gardens benefit from generous amounts of organic matter such as hay, peat moss, shredded leaves, grass clippings, compost or even shredded newspaper.

A 3-4 inch layer of organic matter is necessary to physically change the structure of the soil. Till the material into the garden at least 6-8 inches deep.

Fertilizer should be applied at the same time. If your soil is high in phosphorous or you used a high phosphorous fertilizer such as 10-20-10 in

the spring, then nitrogen is probably all you will need to add.

About 1 pound of the high-nitrogen fertilizer, such as ammonium sulphate or ammonium nitrate, can be used for each 100 square feet of garden area. This can be broadcast on top of the organic matter and tilled in together.

After the summer soil preparation, August to early September is the time to plant most vegetables for fall harvest.

Time to Treat For Cattle Grubs

Cattle grubs are internal parasites and their damage is largely unseen, yet they cause greater economic losses to the U. S. beef cattle industry than any other insect pest.

Grubs are the larvae or worm stage of heel flies and adult

heel flies are active over most of the state from March through May.

The time to control grubs is from now through August when the grubs are small and before infested animals suffer stress, weight loss and decreased feed efficiency. Considerable hide damage will occur if infested animals are slaughtered.

There are several ways to treat for cattle grubs including systemic pour-on type which are absorbed through the skin and dispersed throughout the body and injectable types that are circulated in the animal's body fluids to kill the invading pests.

These insecticides come in various forms - dips, sprays, pour-on, injections, and spot-on treatments. For more information, you can contact the County Agriculture Extension office.

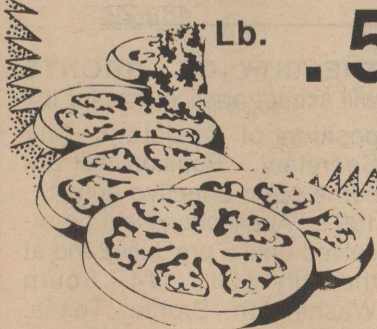

Treatments for allergy symptoms

An allergy is the result of an abnormal response to a normally harmless substance known as an allergen. These allergens can be inhaled, swallowed, injected or have direct contact with the skin. Common examples include pollens of plants, spores of molds, household dust, and animal dander. Some foods, medications, and industrial chemicals can similarly cause an allergic response.

"In allergic individuals, allergens stimulate the production of antibodies which result in an inflammatory response," said Dr. Robert J. Mamlok, an allergist on Lubbock's Methodist Hospital's medical staff.

This may result in a runny nose, itchy eyes, asthma, or other disorders of the lungs, stomach, or skin.

Many forms of treatment are available for allergy sufferers. The first step involves recognizing potential triggers of allergic reactions and removing them from the environment.

"For example, some allergic patients on a lot of medications have been essentially cured when they got their cat out of the bed or exercised appropriate house dust mite control measures," said Dr. Mamlok.

Several safe, effective medications are also available to treat the symptoms of allergic illnesses. Finally, immunotherapy (or allergy shots) may be considered by your allergist if symptoms persist. This form of treatment involves a gradual introduction of the offending allergen with the goal of desensitization.

New loan program soon to be available

The Farmers Home Administration (FmHA) is preparing to activate a loan program designed to help members of socially disadvantaged groups, including minorities, acquire land for farming. This program is also designed to help members of socially disadvantaged groups get loans for operating loans, Neal Sox Johnson, FmHA Director, said.

Under the new program, FmHA will try to find persons in those categories who are

interested in farming and can qualify for an FmHA farm ownership loan or an FmHA operating loan. The agency would also be prepared to sell or lease to them a farm held in its inventory if they are available in that county, Johnson said.

FmHA can also provide other loan and technical assistance, if needed to help the borrower get started.

The new program was included in the agricultural credit act signed in 1988, Johnson said, and funds have

been reserved for farm purchases based on the population of socially disadvantaged persons.

The population of such persons range from as low as one percent in some New England and midwestern states to highs of 68 percent in Hawaii, 57 percent in New Mexico, and somewhat lower percentages in southeastern states. Population groups involved are Hispanics, Native Americans, Blacks, Asians, and Pacific Islanders.

Angel Food Cake

This cake is anything but devilish! It's a light, flavorful alternative that the whole family will enjoy.

| 1 cup | sifted cake flour | 1 tsp. | cream of tartar |
| 1 1/4 cups | sugar | 1/2 tsp. | vanilla |
| 1 1/4 cups | (10 to 12) egg whites, room temperature | 1/2 tsp. | almond extract |

Preheat oven to 350° F.

In 2 medium bowls, sift flour and 1/2 cup sugar together 3 times. In a large mixing bowl, beat egg whites until foamy. Add cream of tartar, vanilla and almond extract. Continue beating until soft, moist, glossy peaks form. Gradually add remaining sugar and continue beating at high speed until volume increases and stiff peaks form. By hand, gently fold in sifted flour-sugar mixture only until all flour is moistened.

Pour into 9-inch tube pan. Cut through batter carefully with a thin spatula to break up large air pockets. Bake 40 to 45 minutes.

Remove from oven and invert pan for 1 1/2 hours or until cold. Remove cake from pan before storing.

Makes 12 servings.

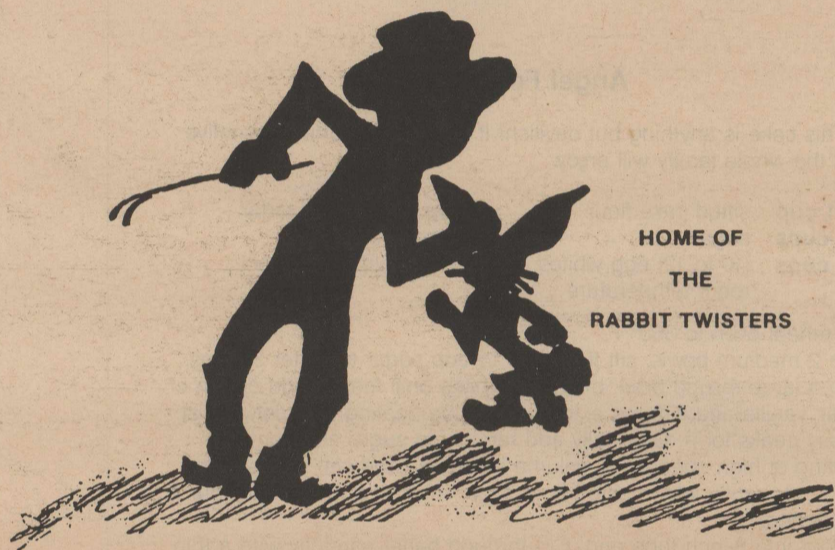

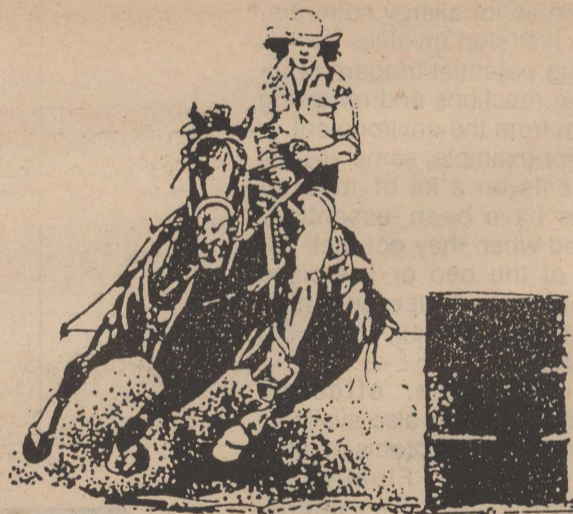
