# Shamrock Clinic greets crowd at opening

Robert Lee's Shamrock affiliate of Shannon Medical Clinic opened its doors Monday morning with an official Open House, attended by about 250 community residents.

A beautiful buffet table of cheeses, crackers, cakes, cookies, coffee, and punch greeted visitors. An unusual floral centerpiece featured vegetables such as curly lettuce and dyed turnip slices rolled into blooms.

The clinic is located at 722 South Washington, across from the West Coke County

Center of San Angelo. Regular hours for the facility will be 8 am until 12 noon and 1-5 pm Monday through Friday.

Physician for the clinic will be a San Angelo native, Dr. Chris Mickelson, who will commute. According to personnel, the facility will be operated as a minor emergency and family practice

Shamrock Clinic offered flu shots and free cholesterol from the West Coke County testing during the Open Nursing Home and is an House. Mrs. Janie Munoz,

receptionist for the clinic, said Tuesday that approximately 250 attended Monday, with 216 of those receiving the timely flu shots, along with several who saw Dr. Mickelson or made appointments.

# 709 county voters

Election draws

Approximately one-third of the eligible voters in Coke County, 709, cast ballots in the Special Election Tuesday as they struggled with 13 proposed constitutional amendments.

County voters were against Amendments #2, #5, #6, #7, and #11. They passed #4, to provide for more prison facilities which passed statewide but were one of the few counties to fail #11, permission to conduct a lottery. The lottery issue did pass on a statewide level by approximately a 65%-35% split, while Coke County turned it down 361 to 319.

#### Solid waste plan to be discussed

A meeting on the regional solid waste plan faced by Texas counties will be held in Robert Lee Monday evening, November 11, at 6 pm in the city hall. This is an important county meeting, concerning both Robert Lee and Bronte landfills and the problems soon to be faced.

The Concho Valley Council of Governments has begun work on the regional solid waste management plan, as required by the Texas Department of Health. The regional solid waste management plan will address the increasing cost of regulatory requirements for landfilling waste; the achievement of the state goal of recycling or reducing waste by 40% by January of 1994; an integrated

waste management approach to resolve solid waste problems; and the establishment of a partnership with public and private interests at local, regional, and state levels.

CVCOG has hired the Austin consulting and engineering firm of Tribble & Richardson, Inc. to conduct the research and planning effort. In an effort to solicit input, to be included in the final plan, from elected officials as well as interested citizens. Tribble & Richardson will hold a series of public meetings

beginning November 5, 1991, in the area. At these meetings, Tribble & Richardson will provide an overview of the proposed solid waste planning effort, excerpts from the EPA document "A Decision Maker's Guide to Solid Waste Management," and a review of current solid waste management legislation.

Residents of both communities are urged to attend to better understand the enforced guidelines which will eventually have to be addressed by both city governments.


# Sixth grade named Red Ribbon winners

The Beefmaster breed of cattle, which was founded in South Texas in the early 1930s, was developed on selection for traits of economic importance which have become known as "The Six Essentials." These traits are fertility, milking ability, growth, conformation, hardiness, and disposition. Beefmasters were recognized as a pure breed by the USDA in 1954. BBU, headquartered in San Antonio, is the national breed registry for BBU Beefmaster cattle and was chartered in 1961. Since that time, it has grown to rank as the largest of the American Breed registry associations.

With membership in BBU, they join more than 4,200 cattlemen in 36 states and seven foreign countries who hold membership in this progressive association.



The history of late 1800s forts in Texas will come to life December 6, 7, and 8 this year during "Christmas at Old Fort Concho" in San Angelo.




3rd Quarter

#### Cervical cancer rates decline

Cervical cancer rates are on the decline because diagnosis and treatment have improved.

"Physicians can now detect abnormal cells in the cervical lining before cancer has time to develop," said Dr. Alan L. Kaplan, an obstetrician and gynecologist at Baylor College of Medicine in Houston.

Once diagnosed, often through a Pap smear, most of these pre-cancers are easily treated in a physician's office using a laser or a freezing procedure called cryotherapy.

This particular training program began as a pilot project this past summer with a great deal of cooperation between WTC, NRH, WHS, and Shannon Medical Center in San Angelo. The curriculum

(registered by the Texas Department of Health) involves at least 80 hours of classroom and clinical experience. This training involves developing knowledge and technical skills with the personal care of the patients, mental and physical rehabilitation, safety and sanitation within the facility, infection control, needs of the aging patient, making beds, lifting patients, and every facet of nursing care a patient

Upon completion of the 27), each student will take the skills test and written examination administered by the Texas Department of

Health. Tentative exam dates are April 4th and 5th, 1992. The last class had an impressive 100% passing rate with the state exam.

The cost of the program is \$250, which includes books, workbooks, tuition, and state exam fees. Financial aid is available through the West Central Texas Council of Governments. 
