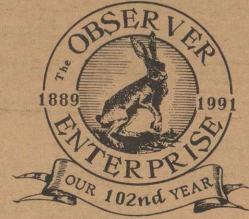

## #1 Lady Horns claim area championship

The Bronte Lady Longhorn volleyball team claimed the Area Championship Tuesday night in a match with Harrold in the Aspermont gymnasium.

Ranked #1 in the state by the THSGC Association, the Lady Horns won the match 15-5, 15-13, improving their record to 24-3 for the season.

The first game was a display of power & finesse as the Ladies pulled away and claimed a 15-5 victory. The second game was a battle at the net as Harrold pulled ahead 8-13. The Hornets used strong blocking at the net as well as great tenacity to hold the lead. However, the

Lady Horns' depth and experience enabled them to pull out the victory.

"Our serve-receive was

poor, but we showed a lot of character coming back from 8-13," Coach Connie Bozarth said later.

As Area Champions, the Lady Horns now move to their second consecutive Regional I-A Tournament to be held this Saturday, November 16, at the Texas Tech Recreation Center in Lubbock. The Ladies will play Ft. Davis at 10:15 am. If they are successful, they will play the winner of the 9 am Plains/Wink match at 3 pm for the Championship.

A downtown send-off will be held Friday as the team departs. Fans are urged to check the sign at the mini-park for time and details.

## RL defeats Bronte in county shoot-out

Bronte and Robert Lee's annual "Coke County Shoot-out" football game saw Robert Lee skimming past Bronte to win, 15-8, this year.

The first half of the game saw plenty of runs by Gary Bilbrey, Lee Reyes, and Jacob Golson. Many of Bronte's plays were stopped short by

an aggressive Robert Lee defense. With 10 seconds left in the first quarter, Golson recovered a fumble to put the ball in Bronte's possession. After a stunning quarterback sack by Gary Bilbrey and an impressive extra point block by Randy Bilbrey, the Horns ran into a series of penalties, including a safety on Bronte. The score was 8-0, leaving the Steers with a short lead.

In second half action, the ball was continuously passed from Bronte's possession back to Robert Lee. Lee Reyes intercepted a Steer pass to put the ball back in the Longhorns' hands where they gained some yardage and placed a penalty on the

Steers for clipping with 52 seconds left in the third quarter. The score now stood at 15-0.

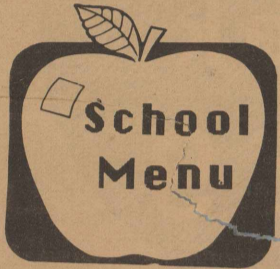
Reyes and Gary Bilbrey together put Bronte's offense into motion to help them gain their only touchdown of the game. Reyes led with rushing in the fourth quarter with a total of 77 yards on 10 carries.

"It was a typical Bronte/Robert Lee football game, lots of hard hits and excitement," Coach Keith McCutchen said, "Basically, lots of kids just trying hard."

### PUBLIC NOTICE

On April 16, 1991, GTE Corporation ("GTE") and Contel Corporation ("Contel") filed a joint petition for declaratory relief with respect to the obligations or requirements of GTE or Contel and/or any of its subsidiaries relating to the merger of GTE and Contel. GTE and Contel have requested a ruling from the Public Utility Commission of Texas that neither GTE nor Contel is required to report the merger of GTE and Contel pursuant to Section 63 of the Public Utility Regulatory Act ("PURA"), TEX. REV. CIV. STAT. ANN. art. 1446c (Vernon Supp. 1991), that no investigation of the merger by the Commission is required. In the alternative, GTE and Contel seek a determination that the merger is consistent with the public interest.

The Commission is investigating the merger between GTE and Contel Corporations to determine whether the merger is consistent with the public interest. In reaching its determination, the Commission shall take into consideration the reasonable value of the property, facilities or securities to be acquired, disposed of, merged or consolidated. If the Commission finds that the merger is not in the public interest, the Commission shall take the effect of the transaction into consideration in GTE Southwest Incorporated's and Contel of Texas, Inc.'s next ratemaking proceeding and disallow the effect of such transaction if it will unreasonably affect rates or services.

This filing has been assigned Docket No. 10212. Persons who wish to intervene or otherwise participate in these proceedings should notify the Commission. **The Purple Cow**

This cow is in every beef herd in Coke County. This cow has been palpated OPEN today. She does not have a calf at least 48 days old.

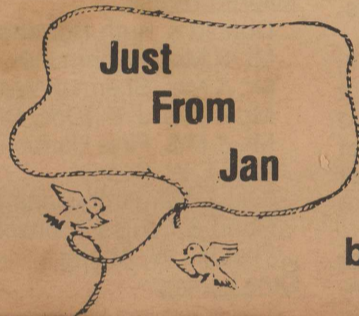
How far down the road or distance in the future before this Purple Cow delivers you a PAYCHECK if she is bred and conceives today? Gestation time is 283 days, lactation to weaning is 205 days, hauling to sale and selling is 2 days, and 3 days to get the check in the mail. This is a total of 493 days total time before you can present the check to the banker.

With current estimates on cost of breeding and maintaining a beef cow for one year ranging from \$365-\$425, let's assume the cost will be \$1 per day for maintaining a cow. With this, we can conclude that an open cow bred today costs you \$493 to own her from today to selling a calf. Will she raise a calf that will sell

for \$493 - 493 days from now? Palpation can determine these Purple Cows. Every cow must provide cash flow during the year by one of two methods, she produces a calf to be sold or added to inventory or we sell the cow.

Should we keep these Purple Cows in our herds, calving percentage will determine the size of the burden the calving cows must carry to allow this "Free Loader" to grace our cow herds. Say you have 20 cows and have a 90% calf crop, this will result in 18 calves that must carry the burden of the two Purple Cow loss of \$986 or \$54.77 per calving cow. If calving percentage drops to 80%, the burden per calving cow doubles.

As you can see from this example, these Purple Cows get pretty heavy for her pasture mates and your pocket book before she provides some sort of calf to sell.

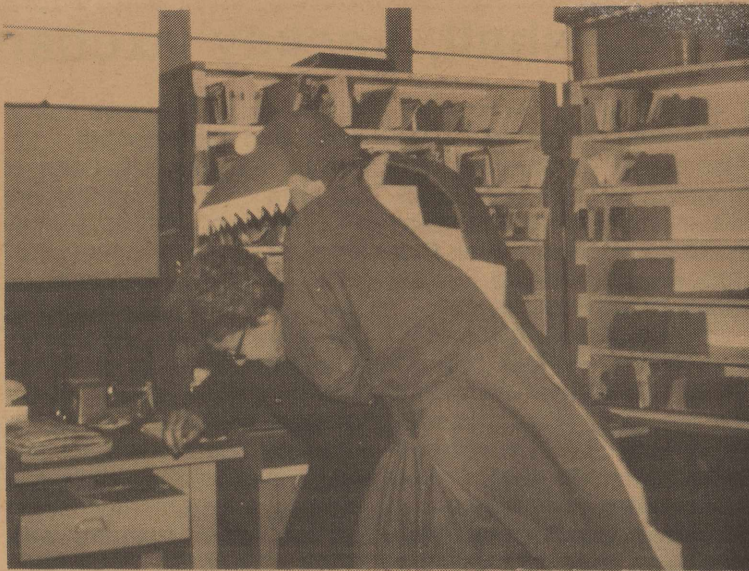

name drugs. If you purchase drugs through a health care plan, find out how the plan pays for generic and brand name drugs. Different amounts paid for generic or brand names may affect your final cost.

Mail-order pharmacies provide another savings alternative, typically offering 10% or more discount on drugs. Most maintain a toll-free phone line for orders and fill prescriptions quickly. Mail order is most useful for drugs which are taken on a regular basis, since the mailing time must be considered when filling a prescription. Although some mail-order pharmacies offer overnight delivery, the customer expense of rush delivery usually outweighs any cost savings on the drug. Mail-order firms offer customer benefits such as refill reminders and low-cost non-prescription medications. Ask your doctor for recommendations of reliable mail order pharmacies.

For drugs bought locally, comparison shop to save money. Discount drugstores, neighborhood pharmacies, discount variety stores, and some grocery stores offer prescription services. The price of prescription medications varies from store to store. Costs can usually be compared over the telephone.

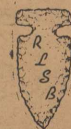

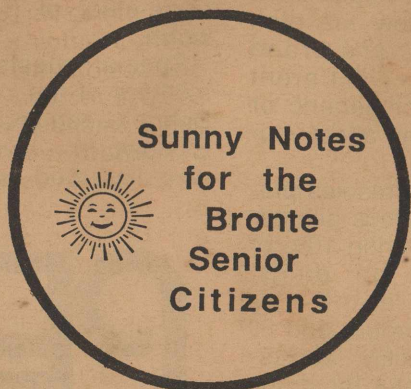
