All county ballots will contain the proposition to adopt the County Road System in Coke County.

# CD taking orders for windbreak trees

One aspect of West Texas weather that can always be counted on is the wind. Although it provides such benefits as cooling breezes and power for windmills, it can also cause a variety of problems for Coke County residents. Wind erosion strips bare fields of valuable topsoil and deposits it where it is neither needed nor wanted, such as fence lines, roads, and dining room tables. Cold winter winds raise utility bills and are dangerous to unprotected livestock.

Windbreaks help reduce many of the problems associated with the wind. Field windbreaks significantly reduce soil erosion. Windbreaks around a homesite help reduce dust and protect the home from cold winds. Likewise, properly placed windbreaks protect livestock in confinement or in open pasture.

In an effort to assist landowners in this area, the Coke County Soil and Water Conservation District, in cooperation with the Texas Forest Service, is providing tree and shrub species for conservation planting. Firstyear seedlings of evergreens (6-12 inches) and bareroot hardwoods (10-18 inches) are available at reasonable rates.

### Evergreens

Evergreens are sold in multiples of 20 per species only. No order for less can be accepted. The following species come in a 28 cubic inch felt container and sell for \$32.00 per 20. Afghan pine(also known as Eldarica or Mondale pine), Arizona Cypress, Eastern Redcedar, Ponderosa pine, and Austrian

In addition, smaller Afghan pine seedlings are available in a 10 cubic inch "bullet" and sell for \$20.00 per 20.

### Hardwoods

Hardwoods are packaged bareroot, sold in multiples of 25 per species only, sell for \$13.25 per 25, and are available in the following species. Catalpa, Pecan, Green ash, Red Oak, Desert willow, Honeylocust, Sandcherry,

Mulberry (fruiting), Osage orange, Little Walnut, Russian olive, and Skunkbush sumac.

Wildlife packets for quail, deer, turkey and sqirrel are also available. Each packet contains 4 species and 25 seedlings of each species. totaling 100 seedlings. Packets sell for \$53.00.

All prices include sales tax. Statewide interest in the program is very high and the quantity of available species is down this year. Most of the more popular species sell out very quickly. Interested parties should place their orders as soon as possible.

Orders can be placed at the Coke County SWCD/Soil Conservation office at 11 East 6th street. The seedlings will be delivered to the office by the Forest Service on February 17, 1993. To help insure successful establishment, they should be collected and planted as soon as possible after delivery.

The district can also provide drip irrigation supplies at a reasonable price. Drip irrigation greatly increases the seedling's chances of survival, particularly in the first two years. Drip is a highly efficient way to water and has many applications in areas with low availability or high cost of water. More

# Job Strain May Raise BP

A high-strain job increases your chance of having high blood pressure. Job strain is defined as high psychological demands, but not much choice in making on-the-job decisions. The study of male workers in New York City, used small, portable devices to record the blood pressure of patients every fifteen minutes while they went about their normal daily activities. The study by Dr. Thomas Pickering and his colleagues at New York Hospital-Cornell Medical College showed workers who considered themselves in high-strain jobs had higher sustained blood pressure which continued even away from work. They were also found to have enlarged hearts.

The study, published in the American Heart Association journal, *Hypertension* (5-92), shows high-strain jobs tended not to affect men in their thirties as much as men in their forties and fifties. That may mean people become more vulnerable to job strain as they get older.

# WTU offers incentives to new business

Boosting the area economy just got a little easier. West Texas Utilities Co. now has available a new economic development service designed to offer significant incentives to new or expanding businesses. The service option was approved September 30 by the Public Utilities Commission of Texas.

"The Economic Development service is a rate that offers a discount on electricity to qualifying businesses such as manufacturing and industrial facilities" said Paul Brower, vice president of marketing and business would development for WTU. To qualify a new business would have to locate in WTU's service territory. An existing business would have to, among other things, add more employees and equipment to their operation and be served by WTU.

The amount of the discount a qualifying company could receive depends on the number of new jobs they

create. An industry that adds 21 or more employees would enjoy the greatest discount.

The new rates will not mean higher costs for other consumers. "Actually other customers will benefit from improved economic oppurtunities which this service can help produce" Brower said.

The discount for a new or expanding business will gradually be phased out over a four year period, allowing time for the business to establish itself.

The service allows any community industrial development program within the WTU service territory to include the new Economic Development service rate in their portfolio to attract and encourage new business and promote growth in existing business.

The Honorable Royce Lee Coke County County Courthouse, Box 57 Robert Lee, TX 76945

Dear Sir

In 1956, Collingsworth County had outstanding debts of \$295,700.00, this was when a group of local taxpayers began trying to help the Commissioners' Court improve the finances of the county. We circulated a petition calling for an election for the adoption of the unit system in Collingsworth County. The election carried and the unit system was adopted. The Commissioners' Court at that time did not want the unit system, but did set it up because it was the desire of the people that the unit system be installed. Since that time Collingsworth County has paid off all its outstanding debts. The roads in Collingsworth County are in the best condition with more all-weather roads than they have had in the history of the county. At the present time we have the best road machinery the county has ever owned and it is all paid for.

In our small county, we did not feel we were able to hire an engineer to handle our road work; so we used a Road Administrator. The Road Administrator is responsible for the operation of the complete road system in Collingsworth County. The Commissioners' Court is the policy making body. We set up the policies and the Road Administrator carries them out.

I think our Commissioners will agree that the unit system having a Road Administrator to be responsible for the maintenance of the roads has helped them avoid political pressure. The entire Commissioners' Court considers the request regarding road construction and improvements and then makes the decision as to whether the road will be built or improved.

I believe that 90 percent of the people of Collingsworth County would tell you that the unit system is the best thing that has ever happened to Collingsworth County.

The County Road Department in the average county in the State of Texas is big business. Most large businesses that I am acquainted with operate with a Board of Directors, we all know that it is more business-like to have two or more people involved in making decisions. I think the unit road law puts the road department on a business basis. One of the major duties of a Commissioners' Court is handling county finances.

Under the unit road law, each commissioner is involved in making decisions that affect every part of the county. In other words, it encourages a commissioner to be a County Commissioner instead of a precinct commissioner. Our Commissioners are good men dedicated to making Collingsworth County a better place to live.

Enclosed is a copy of a resolution passed by our Commissioners after Unit Road Law was adopted. If we can be of further assistance, please let us hear from you.

# Water is program topic

The Texas Agricultural Extension Service (TAEX) is sponsoring a statewide water issues program October 22 in the San Angelo Convention Center. The symposium, "Water in 2020: Will It Be There?", will begin with registration from 8:00-8:45 am.

Rural and urban demand on Texas water is at an all-time high. State and federal legislation dictating water priorities is changing rapidly. The purpose of Water 2020 is two-fold: 1) to explain the new water legislative issues; 2) to present the newest information on water quality and conservation technology.

The morning session deals with legislative matters. Delbert Caffey, Tom Green County Commissioner, will open the program with a welcome to San Angelo. The morning's moderator is State Representative Robert Junell of San Angelo.

The first formal speaker is State Senator Bill Sims of San Angelo. Sims, a key figure in much of the state's water reform, will discuss West Texas water issues at 9:00 am.

At 9:20 am, John Hall, Chairman of the Texas Water Commission (TWC), will give an explanation of Texas water surface and groundwater rights.

At 9:00 am, Allen Lange, manager of Lipan-Kickapoo Water Conservation District here, will present "Underground Water Districts: Functions and Authority".

O. H. Ivie, general manager of the Colorado River Municipal Water District and for whom Texas' newest reservoir is named, will discuss river basin authorities and watershed planning at 10:00 am.

Following a 10:20 am refreshment break sponsored by the West Texas Underground Water Districts, the morning session will resume with a presentation on the current status of water quality assessment in Texas. Giving the status report is Arthur Talley, Non-Point Pollution Source (NPS), Pollution Abatement Coordinator with TWC.

"Federal Water Policy and Legislation: What's in Store?" will be presented by Dr. John Sweeten, Associate Department Head and Extension Program Leader for Agricultural Engineering at Texas A&M University.

The morning will conclude with Texas Water Resource (TRW) Director Wayne Jordan discussing the setting of the state's water agenda concerning research, policy and funding needs.

After a catered lunch from noon until 1:15 pm the remainder of the afternoon will be broken into two concurrent sessions.

Session A moderated by Bob Turner, State Representative from Coleman, features topics and speakers including: "Irrigation Water use Efficiency", Dr. Guy Fipps, TAEX Agricultural Engineer, Amarillo; "Conservation Tillage", Norman Bade, Soil Conservation Service resource Conservationist, Temple; and

"Crop Chemicals and Groundwater", Steve Frazier, Sales Specialist, Miles Inc., Harlingen.


After visiting the Terry Memorial Cemetery, they all attended Church services at Pecan where their parents all had attended in the early nineteen hundreds.

### Treating Allergies

For many people, the fall season means allergy flareups. Doctors call it seasonal allergic rhinitis, and it's a common problem which affects more than 15 million Americans. In the fall, it's most commonly caused by ragweed pollen.

D., allergist on staff at Methodist Hospital, there are several nasal sprays currently available which, when used during the season with or without an antihistamine, can effectively control allergic symptoms such as nasal congestion, runny nose, watery eyes, an itchy or sore throat and sneezing. \*Beclomethasone and Flunisolide - these steroid based sprays work by blocking the infammatory reaction that results from the effects of pollens or allergens. These sprays have some minor side effects such as brief stinging or occasional nosebleeds. \*Cromolyn sodium - this nose spray is most effective if regular use starts early in the allergy season. It rarely causes side effects other than occasional mild burning and dryness of the nose. "These prescription drugs should not be confused with over-thecounter drops or nose sprays, which temporarily relieve allergy symptoms, but cause more congestion or the 'rebound effect' when used for more than a couple of days. These drugs instead offer more of a preventive treatment," said Dr. Mehdiabadi. "In severe cases of alsymptoms, immunotherapy should also be considered for long lasting results." For more information on allergies, consult your physician.


