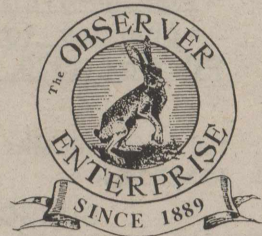

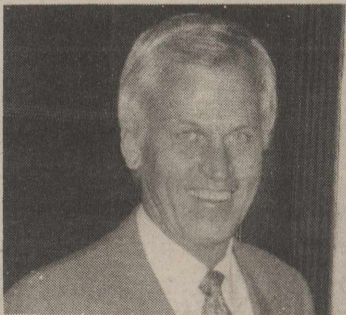

Amendment re-submitted



U.S. Rep. Stenholm

Congressman Charles Stenholm (D-TX) has once again introduced a Balanced Budget Amendment to the U.S. Constitution. The legislation, to be numbered, H. J. Res. 103, has been co-sponsored by nearly 250 Members, and represents the consensus language agreed to last summer by several House and Senate Members prior to the House's consideration of a balanced budget amendment. A companion bill has been introduced in the Senate.

"A balanced Budget Amendment will provide a Constitutional guarantee that

we will adhere to a tough deficit reduction plan," said Stenholm. "While this amendment will not solve the deficit problem by itself, it will give us a necessary tool to balance the budget."

The amendment has gained strong bi-partisan support, including the endorsement of many individuals who had opposed a balanced budget amendment in the past. It will require the President to submit a balanced budget for each upcoming fiscal year, and mandates that an increase in the national debt would require a three-fifths vote in both Houses. Increasing taxes would require a majority vote of the total membership in both Houses on a rollcall vote. The amendment could be waived during a war or military conflict declared by Congress.

According to recent estimates by the Congressional Budget Office, gross interest payments will exceed \$407 billion by 1998 without change in current policies.

Powell to speak in RL

Reverend Mike Powell, newly approved Assemblies of God missionary to Mexico, will be speaking at Victory Assembly of God, in Robert Lee, on Sunday, Feb. 28, at 6:00 pm, according to Reverend Raymond McGuire, pastor.

Mike has already had several opportunities to gain missions experience in Mexico. One avenue has been through participation in Ambassadors in Mission (AIM). AIM is an Assemblies of God

sponsored program that places volunteers on short-term ministry trips with missionaries around the world. "I've ministered in AIM trips, food distributions, crusades and construction teams in San Louis Potosi, Guadalajara, and Nuevo Laredo, Mexico," he explains.

After working in his father's construction business for nearly 20 years, Mike entered the full-time ministry. He held youth pastorates in Lavon and Rockwall, Texas before accepting a pastorate in Royse City. He has also held sectional and district youth positions while pastoring. During these years of ministry in Texas and his trips to Mexico, Mike began to sense God's call to full-time missions. "My heart was touched each time I went to Mexico," he shares, "but it was the death of missionary Mark Buntain in Calcutta, India, that God used to solidify that call."

Mike and his wife, Renay, will be moving to Mexico with their three children. They will be living in San Louis Potosi, an industrial city in central Mexico with a rapidly growing population. An estimated 97 percent of Mexico's 88 million people are professing Catholics, however, the majority have no practical relationship with God or any church. "The people of Mexico are religious," Mike observes, "yet many of them are entrapped in empty tradition and mysticism. We plan to work in Bible school instruction and pastoral training as well as evangelism and church planting."

The public is invited to attend the Powell's missions presentation on February 28. "I want to share my love for the people of Mexico," Mike emphasizes, "as well as the importance of missionary commitment on the part of all Christians everywhere."

Free Tax Assistance

Lower-income working families may be eligible for government checks of up to \$2,211 from the Internal Revenue Service.

Local IRS employee Dawn Sanders said volunteers in an IRS sponsored community program known as the Volunteer Income Tax Assistance (VITA) program will provide free tax help that includes determining if a family qualifies for government refunds through the earned-income tax credit program. "If a family made less than \$22,370 in 1992, they may qualify for the earned-income credit", Sanders said.

VITA volunteers have gone through special IRS sponsored training and are qualified to assist taxpayers with basic tax questions involving filing status, dependent exemptions, tax-credits, and itemized deductions. VITA volunteers can also prepare 1040EZ, 1040A and basic from 1040 for taxpayers. "VITA volunteers do not handle complicated tax returns nor answer questions outside the scope of their expertise", Sanders said.

A VITA site will be located in our community this year on:

Wednesday, February 3rd, at the Robert Lee Senior Center between 9:00 am and 12:00 noon.

"Taxpayers going to a VITA site should bring this year's tax package received in the mail, W-2s, information on any other income and expenses, and a copy of last year's income tax return if available", Sanders added. Additional information about VITA sites is available by contacting;

Youth prepare for Houston Stock Show

Seven 4-H members, and two FFA members from Coke County will be joining other 4-H and FFA members from throughout Texas for show ring competition at the upcoming Houston Livestock Show, Feb. 20 through March 7 at the Astrodome.

These FFA and 4-H exhibitors compete in one of two divisions of the Houston Livestock Show - the junior division. The other division, the open show, attracts its exhibitors from the world's agricultural industry, who are primarily professional breeders and ranchers.

Entries in both the open and junior shows combine with horse show entries to make the Houston Livestock Show the world's largest.

Coke County 4-H, sponsored by Tommy Antilley has Casey Antilley with one market steer, Andy Blair with one market barrow, Kimberly Blair with one market barrow, Michael Blair with one market barrow, Shelley Burrows with one market lamb, Shea Kelton with one market steer, and Dane Smith with one market steer.

Bronte FFA, sponsored by Jay Henderson has Nathan Barnett with one market lamb.

Robert Lee FFA, sponsored by Jeff York, has Brent Jameson with one market barrow.

Representing 862 Texas 4-H clubs and FFA Chapters, the junior show is expected to exceed 11,000 entries this year. A variety of animals are shown in the junior show division: market steers, market swine, market sheep, market poultry, beef and dairy heifers, breeding sheep, goats and commercial steers and breeding rabbits.

The four market animal categories (steers, sheep, swine and poultry) represent animals raised by the exhibitor as food sources. Top animals in each of these categories are eligible for their individual market auctions. Total money paid in 1992 at the four junior show auctions exceeded \$3 million.

"Our junior show is the highlight of our livestock show, placing an emphasis on education, supervised in-

struction and fair competition," said Steve Woodley, Houston Livestock Show and Rodeo manager.

In addition to the upcoming livestock show competition, a series of lectures, seminars and live animal demonstrations again will be on the calendar for the month of February -- the International Livestock Congress. Held February 24-26, 1993, at the Sheraton Astrodome Hotel, this school focuses on lectures and seminars delivered by agricultural experts from throughout the world.

Returning to the horse show arena is the International Cutting Horse Contest, featuring competitors from several nations. This contest helps kick off the upcoming Houston Livestock Show and Rodeo beginning Wednesday, Feb. 17. The National Cutting Horse Association World's Championship Finals is scheduled for Thursday - Sunday, Feb. 18-21. The 1993 Horse Show also will feature competition from six different breeds.

Bar-b-que cooking fans can enjoy the World's Championship Bar-B-Que Contest beginning Friday, Feb. 19, at 4 pm in the northwest corner of the Astrodome parking lot and the contest continues through Saturday, Feb. 20.

Also on Feb. 20, the streets of downtown Houston will fill with hundreds of thousands of spectators for the 55th annual downtown parade. The parade, featuring more than 6,000 trailriders, marching bands and colorful floats, will begin following the Conoco

10K Rodeo Run.

Starting at 9:45 am downtown, this year's race is expected to draw 4,500 to 5,000 runners. All entry fees will be donated to the Show's scholarship fund. A total of \$278,000 in entry fees has been donated to the Show by Conoco since the race's inception in 1988.

Also scheduled for Saturday, Feb. 20 at the Astrodome complex are dominoes, horseshoe pitching and washer pitching contest. Winning quilts from the Go Texan quilt contest also will be on display in the Astrodome's west wing through March 7.

All net proceeds from the annual Houston Livestock Show and Rodeo provide funds for scholarships and research projects throughout the state. This year's aluminum recycling program, sponsored by Browning Ferris Industries and KHOU-TV, will add to the scholarship fund through money collected in this project.

The 1993 Houston Livestock Show and Rodeo begins with horse show competition, Wednesday, Feb. 17 followed by other livestock competition beginning Saturday, Feb. 20. The first rodeo performance will be held at 4 pm Sunday, Feb. 21. All events conclude March 7.

Saturday matinee performances begin at 11 am and the Sunday, Feb. 28 matinee performance begins at 1 pm. The first and final Sunday performances, Feb. 21 and March 7, will be held at 4 pm. All evening performances begin at 7:15 pm.

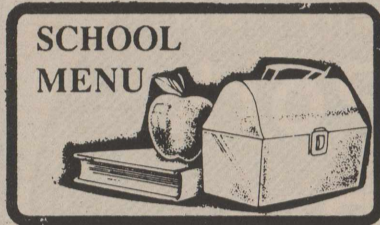

TX. Dept. Human Services

The state spent a total of \$1,850,784 last year for major welfare programs in Coke County, according to David Maberry, Regional Administrator for the Texas Department of Human Services.

"Medical assistance had the biggest impact, with \$159,345 spent for families and children and \$154,319 for the aged and disabled for hospitals, physicians, laboratory, x-ray and other services. Also, \$12,493 was spent for families and children and \$100,132 for the aged and disabled in Coke County for prescribed medicines. Nursing home costs of approximately \$1,003,842 were paid for aged and disabled residents. Community Care for Aged and Disabled spent \$131,347," Maberry said.

Food stamps worth \$241,127 were issued for the fiscal year which ended August 31, while Aide to Families with Dependent Children (AFDC) totaled \$48,179. Food stamps are funded entirely by the federal government, while the department determines eligibility of applicants and issues the food coupons.

The state and federal gov-

ernments share in the cost of AFDC to families where needy children are deprived of support because of the absence or disability of one or both parents.

Passive Smoking Risks

Public awareness is increasing to the health dangers from second-hand cigarette smoke, but the increased awareness has not eliminated exposure to those around people who continue to smoke - especially co-workers and spouses and children of smokers. That's the reason for a new campaign for a smoke-free society from the American Heart Association, American Lung Association and American Cancer Society.

The coalition estimates that fifty million non-smoking adults over the age of thirty-five are regularly exposed to second-hand smoke. If there's an argument that some of this exposure is voluntary, then consider those who have no say in the matter - the fifty percent of all children who live in families with one or more smokers.

The scientific position paper calls second-hand smoke, or environmental tobacco smoke, a major preventable cause of heart and circulatory disease and death.

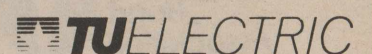

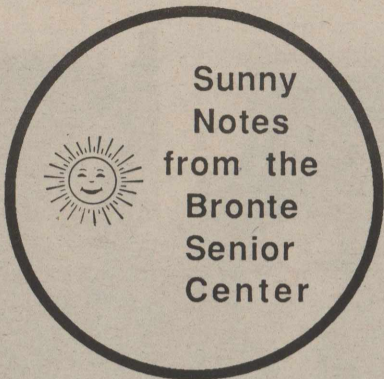

PNEUMONICS: Use a series of letters or sounds that spell a word to remember items on a list. If you have four errands to run--get gasoline, pick up laundry, buy apples, make a deposit at the bank--remember then with the word GLAD (gasoline, laundry, apples, deposit.)

Disabled rehabilitation help available

Jason Carroll (the name is changed to protect his privacy), a diabetic since the age of 13, had unsuccessful eye surgery in 1978 and developed an infection that resulted in amputation of both legs above the knee. Jason ap-

plied for and received Social Security disability benefits. He also received vocational rehabilitation services from a State agency. With this support, he returned to college and in 1983 graduated with a bachelors degree in social work and business administration. Today, he is a State vocational rehabilitation counselor and is teaching others what he learned through both his studies and his life experiences.

This is a true story, and one that illustrates a fact that far too many people may not know about -- that is, rehabilitation help is available if they become disabled. Every State has a vocational rehabilitation agency designed to assist people with disabilities in returning to the workplace. Services include counseling, training, job placement, transportation to and from work, and on-the-job assistance.

Every applicant for Social Security disability benefits is considered for referral to the State Rehabilitation Agency for help, even if they do not qualify for disability benefits. If they do get disability benefits, Social Security pays for the cost of the rehabilitation services if the services result in the individual being able to work. People are accepted for vocational rehabilitation services based on an evaluation of their rehabilitation potential. Counselors look at such factors as age, education, work experience, and -- most importantly, they say -- motivation. "If the person is motivated and really wants to

work, generally we can help him," a counselor stated.

In addition, Social Security has a number of special rules designed to assist people with disabilities by providing extended cash benefits and Medicare or Medicaid coverage while they attempt to work. In Jason's case, for example, a month after he graduated from college he became a case service manager with the County Senior Services Agency. During this time, he received full Social Security benefits for a nine-month "trial work period" and then for a three month "grace period" before his Social Security checks stopped. Over the next several years, he experienced additional health problems, including kidney transplant. Each time he fought back. For 36 months after his trial work period, Jason was allowed to receive Social Security disability benefits for any month he was unable to work enough to earn at least \$500. Medicare coverage continued during this period, providing help with doctor bills.

If you are disabled and want help in getting back to work, you should call your State Vocational Rehabilitation Agency, listed in the telephone book under "State Government." You should also contact your local Social Security office or call Social Security's toll-free number 1-800-772-1213, business days between 7:00 am and 7:00 pm to find out how work incentives can help you while you are on the road back to work.

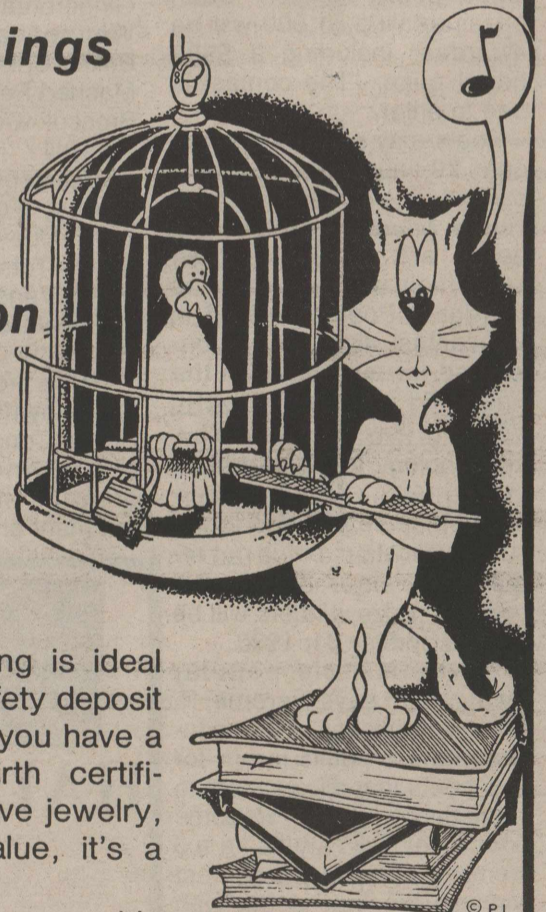

Toll-free call preferred

Social Security's toll-free number has become the preferred way to do business for millions of people since it began three years ago. Today, the average number of calls to this service on any weekday exceeds 200,000 -- likely the largest number of calls to any 800 number service in the United States.

The Social Security Administration changed its 800 number in the fall of 1991 as a result of legislation that required most Federal agencies to convert to a new telecommunications system. The new number is 1-800-772-1213. It can be reached from 7:00 am to 7:00 pm weekdays. Although using this number often is the quickest way to get information, you can call our local office or visit us when you have a Social Security question or a claim to file.

If you call the 800 number service, a Social Security teleservice representative can answer most of your questions. When you want to apply for benefits, you can ask the teleservice representative to schedule an appointment for you with our local office.

If you have a touch tone telephone, you may be able to take advantage of several automated messages. For example, callers using a touch tone telephone can:

**request an application for Social Security number or replacement of a lost or stolen Social Security card;

**request a benefit verification statement showing the

amount of a Social Security or Supplemental Security Income payment;

**request an application for a Personal Earnings and Benefit Estimate Statement form;

**obtain general (non-claims related) information about Medicare enrollment;

**order publications about Social Security programs

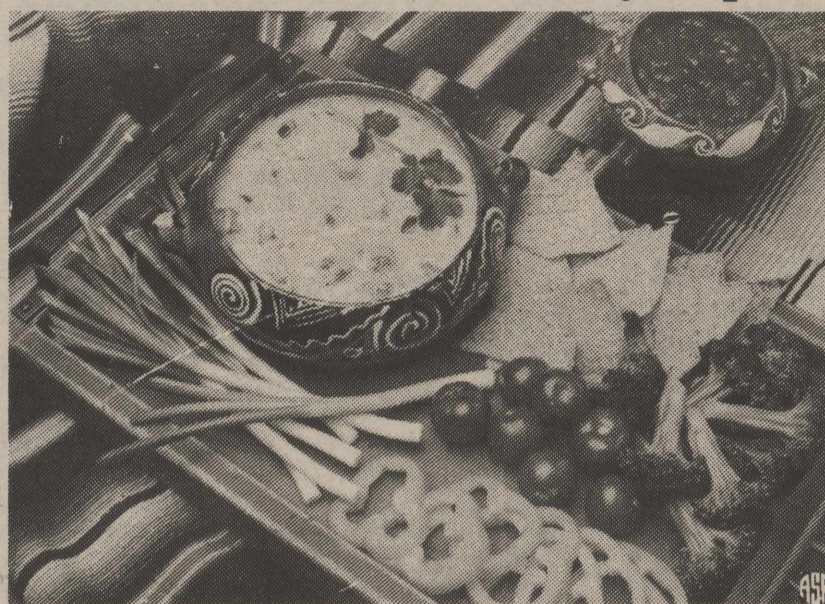
**and obtain general information.

As convenient as these automated messages can be, you always have the option of speaking with a teleservice representative at any time.

A recent survey conducted by our agency found that 88% of the people who have used the 800 number would prefer doing business by phone again. And, a study by the Department of Health and Human Services gave our 800 number service high marks for the level of service and information accuracy they provide callers.

At certain times of the day or month, the volume of calls may exceed the capacity of the 800 number teleservice representative to respond quickly to calls. These peak phone periods are Mondays, the day after a federal holiday, and the first week of each month (the time when Social Security checks are mailed). If your business with Social Security isn't urgent, the best times to call are early in the morning or late in the afternoon, Wednesday through Friday.
