





#### Solve summer boredom with reading

Now that summer is here, parents are faced with the age old "I'm bored!" statement from their children.

One suggestion is "Why don't you read something?" Although parents may have to do a little work to get their children to read. The reward for the effort is more than just filling a few empty hours. Summer reading may introduce children to a new way of enjoying life and give a boost to their education. What are some ways parents can encourage their child to read?

Practice what you preach. Let your child see you reading. Children will see by your reactions that reading is important. Remember that action speaks louder than words.

An enjoyable introduction to reading is reading aloud. Choose a "good time" to share a book. Extend the text by asking questions about how the story or characters make the child feel.

Establish a family custom of storytelling. Storytelling allows the use of language and imagination.

Take a family trip to the supermarket for purchasing magazines of their choice. These could be used as rewards for some house or yard work. By making the trip a family outing, children are encouraged to browse the variety of magazines and may become interested in new and different topics.

Another family trip could be to the local library. Going together to get library cards and becoming familiar with the library encourages children to model their parent's behavior.

Make sure children have a special place in their bedroom for library and personal books. This gives added value to those library books.



# SHANNON HEALTH NOTES

#### CAFFEINE, EXERCISE, & HYPERTENSION

Men whose blood pressure is slightly higher than normal, with diastolic readings between ninety and one hundred-five, may be encouraged to lower their blood pressure through regular exercise. However, if they drink coffee or other caffeinated beverages before exercising, their blood pressure and their heart rates tend to be significantly higher than when not consuming caffeine. The blood pressures were still elevated three hours after exercising.

The study by Dr. Bong Hee Sung and her colleagues at the State University of New York at Buffalo, also shows that men with normal blood pressure did not have increases in distolic blood pressure when they were on caffeine. The study suggests that men with mild hypertension put an extra stress on an already burdened cardiovascular system.

## Fall vegetables for flower beds

Fresh vegetables are not out of the question, even if your planting space is limited to a few flower beds around your house.

Many vegetables do well in flower beds and planter boxes with only a little extra care.

Leaf lettuce makes an ideal border plant and it will grow in many areas that receive only partial sunlight. Harvest time for most varieties is 45 to 60 days after planting.

The red-leaf variety, Ruby, not only provides food for the table, but also adds color to your fall flower bed.

Another flower bed vegetable, onions, also does well with limited sunlight. This also applies to chives, leeks and garlic. Parsley is another good border planting fall crop.

For flower beds that receive five to six hours of sun a day,

broccoli, cabbage, spinach, beets and carrots will do exceptionally well.

Depending on your location in Texas, harvest may continue through the fall and well into the winter.

If your beds or boxes receive eight hours or more of sun, tomatoes, eggplants and peppers are a good fall crop.

There are some additional considerations for fall vegetables planted in flower beds. You should plant cold-susceptible crops on the south side of your home for added protection.

Also, water the plants regularly to keep them out of stress, especially during the late summer and fall as the crops near maturity.

Small amounts of fertilizer around the vegetable plants during the season will help produce high yields, as will disease and insect control measures.

#### Role of Representative Payee

Among the 40 million people getting Social Security benefits each month are 5 million who do not receive their check directly. It goes to someone else -- a representative payee -- who is responsible for assuring that the funds are used on the person's behalf.

Representative payees are selected when it is found that a person is unable to manage his or her own funds. A payee may be a parent, legal guardian, a relative, neighbor, friend, member of a volunteer organization, or an official of an institution in which the person is staying.

Minor children require representative payees. The law also requires that drug addicts and alcoholics who receive Supplemental Security Income (SSI) payments because of disability have representative payees.

Representative payees are held accountable for the proper use of the funds and will be called upon to make an accounting periodically. In general, the representative payee must first make sure the person's day-to-day basic needs for food, shelter, clothing, and personal items are met. If he or she can manage, small amounts of spending money should be made available.

If these basic needs are met, benefits can be used for special needs the person has, such as school expenses, rehabilitation or medical expenses, insurance premiums, current payments on a house in which the person has an interest, tax payments, and certain similar expenses. Any money not used for meeting basic and special needs must be saved or invested. Preferred investments are U.S. savings bonds. The people at Social Security can tell you how they should be regis-

Representative payees are also responsible for promptly reporting any event to Social Security which may affect the person's monthly benefit.

It's also important that the representative payee tell Social Security in advance if he or she is no longer able to serve as representative payee. This will give Social Security time to select a new payee and avoid any interruption of benefits.
