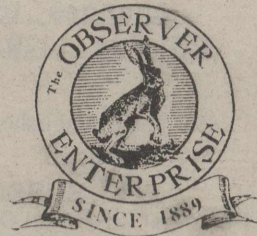

Dorris of Iraan, Mrs. John C. Burleson of Abilene; and several nieces, nephews, grandnieces, and grandnephews. Survivors include a niece, Ava Lou Tubb Davis of Robert Lee and a nephew, Mack Tubb, of Cisco.

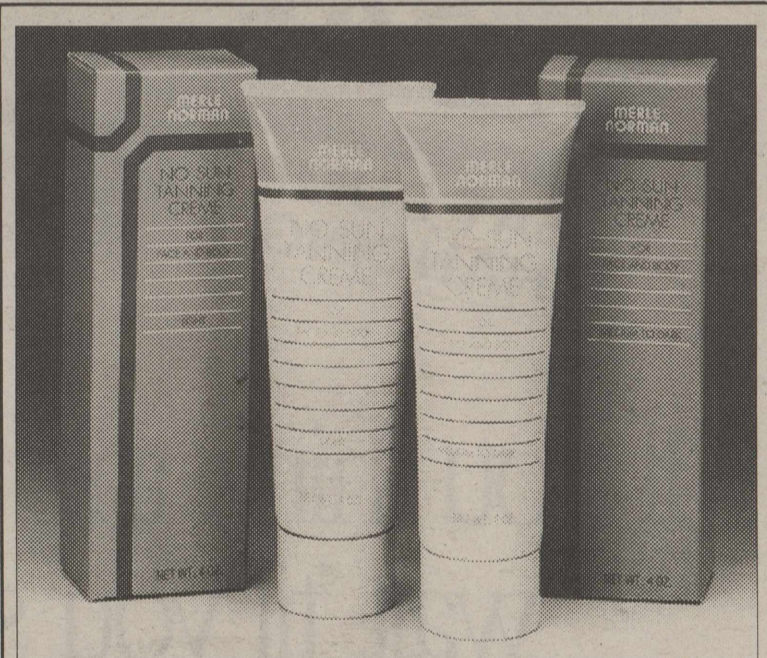

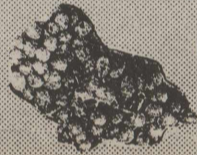

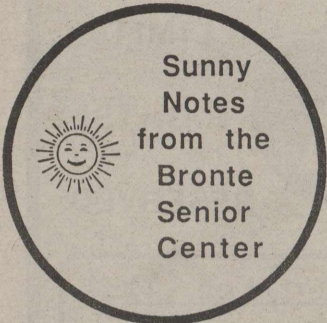

STRESS INTENSIFIES VDT SYMPTOMS

Long hours at a computer terminal are likely to result in eye strain, fatigue, muscle stiffness, and headache. A study of newsroom employees at the San Francisco Chronicle also showed the amount of stress experienced by the worker intensified the complaints. Job stress may come from the psychological work load, little control over job decision, or poor relationships with co-workers and supervisors.

Researchers from the University of California, San Francisco, presented their findings to a meeting on work stress sponsored by the American Psychological Association and National Institute of Occupational Safety and Health. Stress also seemed to play a role in the complaints from muscle injuries resulting from repetitive motions, or cumulative trauma disorders, which affect a growing number of office workers.

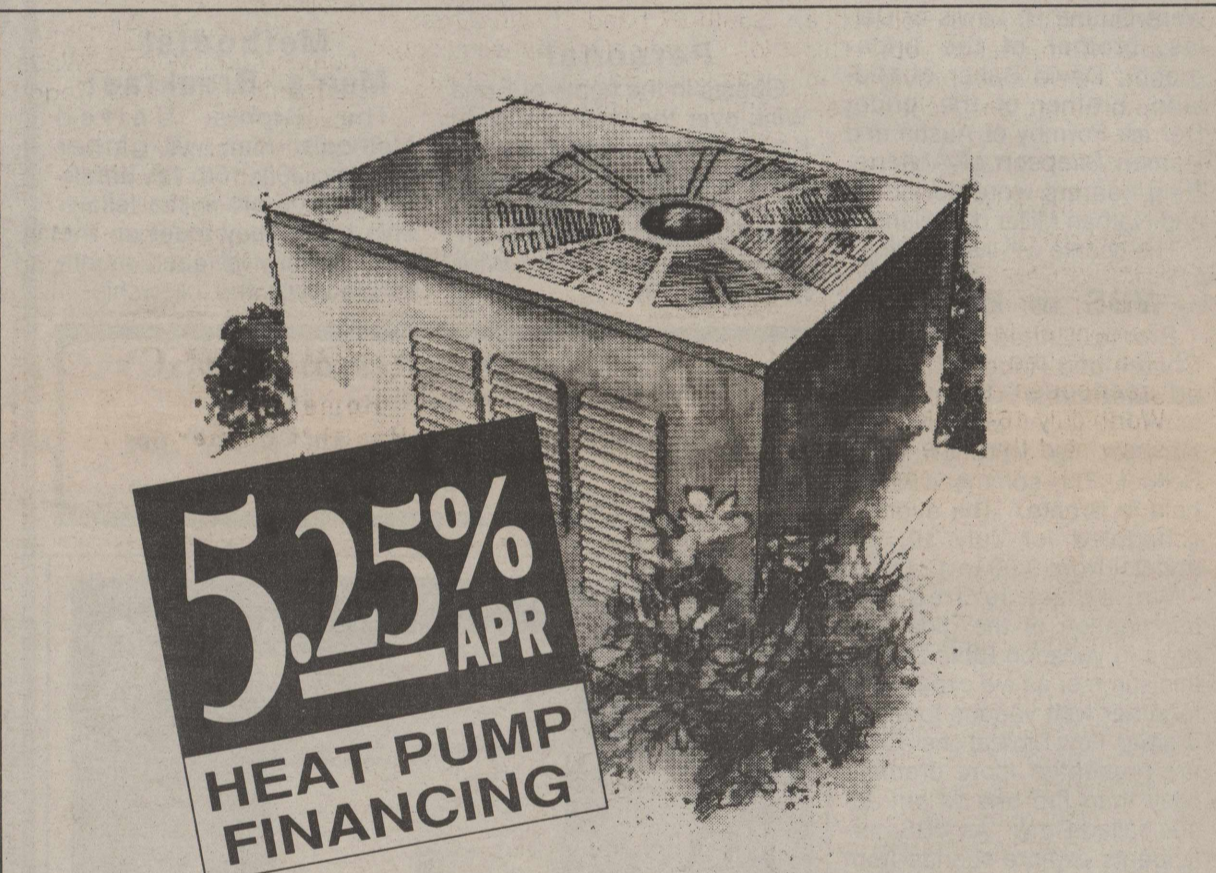

Free Health Screening

Our Area Agency on Aging has given Coke County funds for health screenings. Arrangements have been made for low income men to have the PSA test, which is a blood test which measures a substance in the blood called Prostate Specific Antigens. PSA blood levels increase in cases of prostate cancer and other prostate diseases. The test is used to confirm a diagnosis of prostate cancer, to monitor response to therapy and screen for recurrence. If you are over 65 and think you might qualify, call Mary Perciful at the Bronte Senior Center and get more details. This blood test will be taken at Shamrock Clinic in Robert Lee and at no cost to you. This service will be provided in both Bronte and Robert Lee.
