The Market Swine show begins Saturday at 8:30 am judged by Joe Dan Tarter, McCulloch County Extension Agent followed by the Breeding Heifers and Market Steers at 11:00 am being judged by



All incumbent candidates will hold their positions until December 31, 1994.







### -Counselor's Comments-

by Vicky McCutchen Homework serves an important function in a youngster's school life. It is a means for the student to review and reinforce the lessons taught in school. It is also a method by which a youngster can develop sound work and study habits that will assist him or her throughout the remaining school years.

As a parent, you are a vital link to the school in a homework/study program that includes helping your youngster develop routines to successfully handle assigned homework. Read the following tips, as you work with your

youngster.

1. Always ask your child if he/she has homework on a given day. Homework is generally assigned Monday through Thursday, except for holiday periods. (Older children often have long-term assignments that require work on holidays or weekends.) Asking him/her every day will help the youngster develop a habit of self-inquiry.

Be interested in the

homework. Seeing what he/she is doing helps in two ways: You can get a sense of the child's progress in various subject areas; your youngster will sense that homework is important and that you care about his/her efforts.

3. Homework is the child's work, not yours. Be sure that he/she does it himself or herself. If the youngster has difficulty, write a note to the teacher; the teacher can then make the proper adustments, such as making the assignment more clear, providing more practice in class, explaining in a different manner,

4. Set up a time for homework that is acceptable for your particular family routine, and teach your child to fulfill that commitment.


5. Make sure your child has a quiet place to study and is unhampered by other people and their activities.

Learning to work well at homework increases your youngster's self-esteem: He/she has a responsibility that when fulfilled means success!



### HEALTH NOTES

### Panic Attacks

Chest pain, heart palpitations, shortness of breath, numbness, and nausea are classic symptoms of a heart attack. They are also symptoms of a panic attack and many people experiencing a panic attack get their initial treatment in an emergency room until a heart attack or gastrointestinal condition can be ruled out. Although a panic attack is a common psychiatric disorder, affecting one out of every seventy-five people, scientists believe it has a biological basis.

Professor Philip Ninan, of Emory University School of Medicine, says one theory is that an alarm center in the brain for detecting suffocation is too easily triggered, throwing the body into an emergency survival mode, even when it is perfectly safe. Panic disorder patients tend not to have highly charged, anxious type-A personalities, rather they tend to be shy or depressed. Dr. Ninan says much can be done to manage panic disorder, and new medications make it an easily treatable illness.

## Commodity Recertification Butter & Cheese

Any resident of Coke County who thinks they may qualify for the Emergency Food Assistance Program should go by the Bronte or Robert Lee Senior Citizens Buildings from 8 am to 5 pm, Monday - Wednesday - Friday, Jan. 3-13, 1994, and make application. In Robert Lee, see Kelly Millican or Zola Hatley. In Bronte see Mary Percifull, Geneva Minnick, or Lois Wallace. Stover Taylor is also available in the courthouse. If you are handicapped, shut-in, or do not have transportation, arrangements will be made to help you by calling the following numbers: Bronte 473-6471; Robert Lee 453-2314 or 453-2922. If you do not speak English, a Spanish speaking person will be made available for you. If you are already receiving commodities, you must recertify if you want to receive commodities in 1994.

The Emergency Food Assistance Program was established by Public Law 98-8 and was amended by Public Law 98-92. The United States Department of Agriculture (USDA) administrates the program on the federal level. The Department of Human Services Resources (DHR) administers the program in Texas. Through the **Emergency Food Assistance** Program, DHR provides needy people including low income and unemployed people with USDA food (commodities) to relieve situations of emergency stress.

If eligible and commodities are available, all people have the right to apply for and receive emergency food assistance without regard to race, religion, sex, political beliefs, age, national origin, or handicap. You also have the right to appeal the eligibility decision. All commodities are distributed on a first come - first serve basis.
